WHEREAS by Section 196 of "The Road Districts Act, 1919," and "The Cattle Trespass, Fencing, and Impounding Act, 1882," the Board of any Road District is empowered to make By-laws for any of the purposes mentioned in the said Acts: Now, therefore, the said Road Board doth, in the exercise of the powers aforesaid and of every other power enabling it in this behalf, hereby make and publish the following By-law:—

All stock found straying on any road within the Irwin Road District are liable to be impounded in the public pound of the Board. Should any accident or damage be caused to the property or person of any traveller on any road within the said Road District through any stock straying or trespassing on such road, then the owner of such stock will be personally liable for any loss or damage that may be caused through such stock straying on such road.
