WHEREAS on the 24th day of March, 1920, the Administrator of the State of Western Australia did, pursuant to "The Oyster Fisheries Act, 1881," grant unto Christopher Louis Smith, Frederick Henry Smith, Louis James Smith, and Ernest Julius Smith (hereinafter James Smith, and Ernest Julius Smith (herematter called "the licensees") a license in the form of Schedule "A" to the said Act to form or plant an oyster bed or fishery within the limits described in the map or plan attached thereto and for the term therein stated, subject to the licensees paying the yearly sums therein mentioned by half-yearly instalments; and whereas a reduction was made by the Governor in the amount of the said yearly sum but the payment of portion of the half-yearly instalments thereof is nevertheless in arrear and has been in arrear for twenty-one days and upand has been in arrear for twenty-one days and upwards; and whereas it was provided by the said license that if the said half-yearly sums or any part thereof should be in arrear for twenty-one days the said license should be determinable in accordance with the said Act, and it is desirable to determine the said license: therefore I, the Governor of the said State, acting with the advice and consent of the Executive Council, do hereby proclaim and declare that I am satisfied that part of the said half-yearly instalments is so in arrear as aforesaid, and I do hereby, with the advice and consent aforesaid, determine such license.

ORDER IN COUNCIL.

WHEREAS by "The Water Boards Act, 1904," the Governor is empowered by Order in Council to constitute the District of a Local Authority or the districts of two or more Local Authorities, or any part or parts of such a district or districts, a Water Area, under such name as may be directed; and whereas, under the provisions of the said Act, the Governor is empowered by Order in Council to constitute a Water Board to manage and control such Area: Now, therefore, His Excellency the Governor, by and with the advice of the Executive Council, does hereby constitute an area, having the boundaries described in the Schedule hereunder, a Water Area, for the purpose of the said Act, under the name of the Pinjarra Water Area, and does hereby appoint the Murray Road Board to be a Water Board, under the name of the Pinjarra Water Board, for the administration of the Act within such area.

Starting at a point on the right bank of the Murray River, situate in the Eastern prolongation of the Northern boundary of Murray Location 3 and extending Westerly to and along part of the said boundary to the South-West corner of Pinjarra Townsite; thence North along its Western boundary to the South boundary of Location 13; thence Easterly along part of the said boundary and onwards to the right bank of the said river; thence in a general South-Easterly direction along said bank to point about 3 chains North of the present bridge over the said river on the Perth-Pinjarra Road; thence South-Easterly to the intersection of the North-Western side of said road with the Eastern side of the Pinjarra-Fremantle Road; thence North-Easterly along said side of first-mentioned road to its intersec-Starting at a point on the right bank of the Murray of the Pinjarra-Fremantle Road; thence North-Easterly along said side of first-mentioned road to its intersection with the Northerly prolongation of the Eastern boundary of the Pinjarra Railway Station Yard Reserve; thence 173deg. 46min. 28 chains 1.9 links along said Eastern boundary; thence about 89deg. 38min. 10 chains 50 links; thence 173deg. 46min. about 2 chains 88 links; thence 144deg. 46min. about 8 chains; thence 269deg. 38min. to and along the Southern boundaries of Lots 11 to 2 on L.T.O. Plan 3242, and onwards to the right bank of the aforesaid river, and thence in a general South-Westerly direction along said bank to the starting point. starting point.
