WHEREAS by Sections 222 and 227 of "The Municipal Corporations Act, 1906" (6 Edwardi, No. 32), it shall be lawful for the Governor, on request of the Council, by notice in the Government Gazette, to declare any land reserved, used, or by purchase or exchange acquired for a street or way, or any place, bridge, or thoroughfare, to be a public highway, and such land shall thereupon and theneeforth, from the date of such proclamation, become and be absolutely dedicated to the public as a public highway within the meaning of any law now or hereafter in force: And whereas the City of Perth Municipal Council has requested that certain land named and described in the Schedule hereunder, which has been used for street or way within the Municipality of the City of Perth, be declared public highways: Now therefore I, the said Governor, by and with the advice and consent of the Executive Council, do by this my proclamation declare the said lands to be public highways, and such lands shall, from the date of this proclamation, be absolutely dedicated to the public as highways within the meaning of any law now or hereafter in force.

The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 5/26.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister of Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend Water Works, Sewerage Works, and Stormwater Drainage Works; and whereas it is further provided that the Governor may exempt reticulation works from certain sections of this Act: Now, therefore, His Exellency the Governor, with the advice of the Executive Council, hereby approves of the construction and extension by the Minister of Water Supply, Sewerage, and Drainage of the following works under the said Act.

Description and Location of Reticulation Works approved and exempted.

Metropolitan Water Supply Improvements. City of Perth-North Perth Ward.

Proposed 4-inch diameter cast-iron water main along the East side of Shakespeare Street from the existing main in Hobart Street Northerly to Lot 156, together with valves, hydrants, and all necessary apparatus (length about $27\frac{1}{2}$ chains), as indicated in red on M.W.S., S., and D.D., W.A., Plan No. 4485.

This Order in Council shall take effect from the 19th day of February, 1926.

The Land Act, 1898.

ORDER IN COUNCIL.

Corr. No. 5192/96.

WHEREAS by Section 42 of "The Land Act, 1898," it is made lawful for the Governor to direct that any reserve shall vest in, and be held by any Municipality, Road Board, or other person or persons to be named in the order, in trust for any of the purposes set forth in Section 39 of the said Act, or for the like or other public purposes to be specified in such order, and with power of leasing for any term not exceeding twentyone years from the data of the lease: And whereas it is deemed expedient that Reserve "A" 18325, near Mt. deemed expectient that Reserve A 10020, heat and Lawley, should vest in and be held by the Perth Road Board: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the before-mentioned reserve shall vest in and be held by the Perth Road Board for Recreation purposes, with power to the said Perth Road Board to lease the whole or any portion of the said reserve for any term not exceeding fifty years from the date of the lease, subject also to the condition that any lease or any improvements made by the Board shall be subject to the approval of the Governor.
