WHEREAS Section 5 of "The Workers' Compensation Act Amendment Act, 1924," whereby a section numbered 6A and the Third Schedule relating to industrial diseases was inserted in "The Workers' Compensation Act, 1912," was by Proclamation brought into operation throughout the State on the 1st day of March, 1925, except so far as the said section and schedule extends to pneumoconiosis, miner's phthisis, ankylostomiasis, and nystagmus: And whereas by a Proclamation published in the *Gazette* on the 4th day of June instant the said section and schedule were brought into operation so as to extend to those diseases in certain portions of the State therein defined: And whereas it is desirable to extend the operation as aforesaid of the said section and schedule to other defined portions of the State: Now, therefore I, the said Governor, with the advice and consent of the Executive Council, do hereby proclaim that Section 5 of "The Workers' Compensation Act Amendment Act, 1924," whereby Section 6A is inserted in the principal Act (such section being numbered 7 in the principal Act as reprinted with amendments as "The Workers' Compensation Act, 1912-1924"), and the section so inserted and the Third Schedule, inclusive of the diseases of pneumoconiosis, miner's phthisis, ankylostomiasis, and nystagmus shall also come into operation on the 15th day of June, 1926, when the employment at the time of disablement was in some portion of the State as hereinafter defined (as well as those portions of the State defined by the said Proclamation of the 4th day of June instant) that is to say: those portions of the State comprised within the boundaries of the land demised by Gold Mining Lease 33S, Carbine, in the Coolgardie Goldfield; Gold Mining Lease 1906W, Ora Banda, and 1933W, Broad Arrow, in the Broad Arrow Goldfield; Gold Mining Leases 4931Z, 4935Z, 5074Z, 5260Z, 5315Z, 4934Z, 4936Z, 5075Z, and 5261Z, Yundaga, in the North Coolgardie Goldfield; Gold Mining Leases 4770E and 5377E, Mount Monger, in

the East Coolgardie Goldfield; Gold Mining Leases 4732, 4720, 4722, 4721, and 5201, St. Ives, in the Coolgardie Goldfield; Gold Mining Lease 5159E, Kalgoorlie, in the East Coolgardie Goldfield; the Celebration Gold Mine on Hampton Plains Location 50; Gold Mining Leases 4905 and 5195, St. Ives, in the Coolgardie Goldfield; Gold Mining Lease 5345E, Boulder, in the East Coolgardie Goldfield; Gold Mining Lease 4766E, Mount Monger, in the East Coolgardie Goldfield; Gold Mining Lease 2994, Manxman, in the Yilgarn Goldfield; Prospecting Area 2106E, Kalgoorlie, in the East Coolgardie Goldfield; Gold Mining Leases 719, 944, 945, 1227, 1228, 1606, and 3307, Nevoria, in the Yilgarn Goldfield; as the said portions of the State are delineated on plans marked L18, L18, L17A/17, L24D/24, M165, M164, L9A/9, Hampton Plains No. 2, M164, L9A/9, M165, L49A, L9A/9, and L55A; and deposited at the Department of Mines in Perth.

THE COUNCIL OF THE MUNICIPALITY OF
COTTESLOE.

By-laws relating to Reserves A6613, A1664, and A6271.

1. No game of cricket, football, hockey or baseball shall be allowed on any part of the said reserves, except on the portion set apart for the purpose and with the previous consent of the Council.

2. No game of golf shall be allowed on any part of the said reserves, excepting on the portion set apart for the purpose and with the previous consent of the Council.

3. No game of bowls shall be allowed on any part of the said reserves, excepting on the portion hereafter set apart for the purpose and with the previous consent of the Council.

4. No game of lawn tennis shall be allowed on any part of the said reserves, excepting on the portion now or hereafter set apart for the purpose and with the previous consent of the Council.

5. No other game or sport whatever shall be played or hereafter set apart for the purpose and with the previous consent of the Council.

6. The Council may fix the day or days and the time of the day for any games or sports to be permitted to take place within the reserves, or may prohibit such games from taking place within the reserves.

7. No person shall suffer any horse, cattle, or any animal whatsoever to stray or depasture on the said reserve or any part thereof, except with the consent of the Council in writing.

8. No person shall ride or drive over or upon the reserves or any part thereof, or allow any cart, bicycle, or other vehicle to enter or pass through the reserves, or any part thereof, without the permission of the Council first obtained.

9. No person shall in any way injure or destroy any tree, shrub, or flower within the reserve.

10. No person shall damage or disfigure the soil, turf, or any part of the reserves, or the paths thereof, nor interfere with any part of the fences, buildings, or improvements thereof.

11. No person shall misconduct himself in any way by indulging in any riotous or indecent conduct, or make use of any indecent or improper language, or commit any nuisance on the said reserves or any part thereof.

12. No person shall stick or mark any bills, placards, advertisements or any document whatsoever, or cause such to be stuck or marked on any fence, wall, tree, building, or anything within the reserves.

13. No person shall discharge any firearms or fireworks, or make a fire within the reserves, excepting in a fireplace provided by the Council, without the previous consent of the Council.

14. No person shall sell or expose for sale any goods, wares, or anything within the reserves without the previous consent of the Council.

15. Every person offending against any of the provisions of these By-laws shall be liable, on conviction, to a penalty not exceeding £20.
