WHEREAS under the provisions of "The Vermin Act, 1918," "Vermin" means and includes any animal or bird mentioned in the Third Schedule to the said Act, and such other animals or birds the names of which the Governor may by Proclamation add to the said Schedule: And whereas it is desirable that tamars shall be declared vermin within the boundaries of the Upper Chapman Vermin Within the boundaries of the Opper Chapman Vermin District as constituted under the said Act: Now, therefore, His Excellency the Governor, in exercise of the powers conferred by the said Act and of all other powers him in that behalf enabling, and by and with the advice and consent of the Executive Council, doth hereby declare tamars to be vermin within the boun-daria of the Unary Chapman Vermin District as can hereby declare tanars to be vermin within the boun-daries of the Upper Chapman Vermin District as con-stituted under "The Vermin Act, 1918," for the purposes of the said Act, and that the word "Tamars" is hereby added to the Third Schedule accordingly; but the opera-tion of this Proclamation is restricted to that portion of the State comprised within the boundaries of the said Vermin Dictide Vermin District.

# The Traffic Act, 1919. Ashburton Road Board.

ORDER IN COUNCIL.

P.W. 1193/26.

WHEREAS under the provisions of "The Traffic Act, 1919," the Governor may by Order in Council empower a Local Authority to exercise within its district any power of making regulations which the Governor can exercise under Division 4 of Part IV. of the said Act; and whereas it is advisable to empower the Ashburton Road Board to prohibit the passage of heavy traffic over specified roads in part of the townsite of Onslow previously known as Beadon, as notified in *Government Gazette* of 25th January, 1924 page 102, within its dis-trict and to define what shall be deemed heavy traffic for such purpose: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, under the provisions of the said Act and all other powers enabling him in this healt doth hereby other powers enabling him in this behalf, doth hereby empower the Ashburton Road Board, by the Lolaw in Schedule hereto, to prohibit the passage of heavy traffic over specified roads in part of the townsite of Onslow, previously known as Beadon, as notified in *Government Gazette* of 25th January, 1924, page 102, within its dis-trict and to define what shall be deemed heavy traffic for that purpose, and to impose a penalty not exceeding £20 for the breach thereof.

The Ashburton Road Board, pursuant to an Order in Council under Section 42 of "The Traffic Act, 1919," and in exercise of the power thereby conferred, doth hereby make the following By-law, to have effect within the Ashburton Road District :-

The passage of heavy traffic over the following roads, viz.: First Avenue, Second Avenue, Third Avenue, Fourth Avenue, First Street, Second Street, Third Fourth Avenue, First Street, Second Street, Third Street, Fourth Street, and Fifth Street, in part of the townsite of Onslow, previously known as Beadon, as notified in *Government Gazette* of the 25th January, 1924, page 102, in the Ashburton Road District during the months of July, August, September, October, Nov-ember, and December of the year 1926, and the months of January, Febuary, March, April, May, and June of the year 1927, is prohibited.

For the purposes of this By-law "Heavy Traffic" shall be as set out in Regulation 149 of the regulations to "The Traffic Act, 1919," as published in the Gov-ernment Gazette dated the 5th September, 1924.

Any person who commits a breach of this By-law shall be liable on conviction to a fine of not exceeding £20.
