WHEREAS by "The Road Districts Act, 1919," the Road Board of any district is empowered to make By-laws for all or any purposes in the said Act mentioned, the Goomalling Road Board, in pursuance of the powers vested in the said Board, under and by virtue of the said Act and of every other authority enabling it in that behalf, doth hereby make and publish the following By-laws:—

GOOMALLING ROAD BOARD.

By-laws for Regulating and Licensing of Hawkers and Stallholders.

1. No person shall hawk any fruit, fish, vegetables, or merchandise within the Goomalling Road Board District without first having obtained a license from the Board.

2. Any person who trades or travels on foot with any vehicle or animal, or otherwise carrying to sell or expose or offer for sale within the said district, or any article or things aforesaid, shall be deemed to hawk the same: Provided always, that nothing contained in this section shall apply to any person or persons paying rates, or liable to pay rates, for any shop or store carrying on the usual business, trade, and delivery trade, or delivery of goods therefrom.

3. No person shall keep, manage, or conduct any moveable or temporary fixed stall in or near any street for the sale of meat, fruit, vegetables, drinks, eatables, or articles of clothing or merchandise without having obtained a license from the Board and payment of the license fee as set forth in this By-law.

4. Any place, tent, or other temporary structure wherein goods are exposed or offered for sale shall be deemed a stall within the meaning of this By-law.

5. License for "Hawkers" shall be in the Form "G" in the Schedule, and for stalls in the Form "H" in the Schedule hereto attached.

6. Every hawker whilst employed in hawking must produce his license upon being required by any Constable or Officer of the Board, and shall at all times have affixed to some conspicuous part of his cart, barrow, basket, or vehicle a board or plate bearing his name and the words "Licensed Hawker" legibly written thereon in letters not less than one inch in length.

7. No licensed stall shall be placed or allowed to stand in any street or position other than that allowed by the Board and endorsed on such license.

8. No person to whom a Hawker's License or Stallholder's License shall have been granted shall lend, transfer, or assign his license, and no person shall borrow or make use of such license granted to a person other than himself.

9. The following fees shall be paid for licenses issued to hawkers and stallholders, and shall be paid in advance, and if any payment be not made when due the license shall be void:—

- 10. Hawker's license—
 - (a) For every hawker with hand basket or tray—12s. per half-year.
 - (b) For every hawker with wheel-barrow or hand-cart—15s. per year.
 - (c) For every hawker with motor vehicle or with vehicle drawn by horse or other animal power—40s. per annum perishable goods, £5 merchandise.

11. Stallholder's license—
For every stall the license fee shall be fixed from time to time by the Board, but in no case shall the fee be less than 10s. per week, payable in advance.

Any person offending against the provisions of this By-law shall forfeit or pay on conviction, a penalty not exceeding (£10) Ten pounds.

THE ROAD DISTRICTS ACT, 1919

Goomalling Road Board—Building By-laws.

P.W. 2707/23.

WHEREAS by "The Road Districts Act, 1919," the Road Board of any District is empowered to make By-laws for all or any purposes under the above-mentioned Act, the Goomalling Road Board, in pursuance of powers vested under the said Act, and of every other authority enabling it in that behalf, doth hereby make the following, which shall be known and cited as "The Building By-laws":—

1. Interpretation:—Unless the context otherwise indicates, the following terms shall bear the meanings set against them:—

"Board"—The Goomalling Road Board.
"District"—The Goomalling District.

“Building”—Any house, store, shop, stable, shed, verandah, lean-to, bough shed, or tent.

“Owner”—The owner of any land, as interpreted under the provisions of “The Road Districts Act, 1919.”

“Builder”—Any builder, contractor, painter, or person engaged in the erection of any “building” within the meaning of these By-laws.

“Townsite”—Any townsite situated within the Goomalling Road District.

“Footpath” shall include any part of a street set apart for the sole use of pedestrians, and whether the footpath be made or kerbed or otherwise.

“Chairman”—The Chairman of the Goomalling Road Board.

“Secretary”—The Secretary of the Goomalling Road Board.

2. No owner or builder within the meaning of these By-laws shall erect any building upon any land in any townsite within the district, unless he first submits to the Board a copy of the plans and specifications of the building to be erected, and setting out clearly the number of buildings proposed to be built on each particular townsite, lot, or parcel of land, the measurements, material of construction, and use for which the building is intended.

3. No building shall be commenced unless a copy of the plans and specifications shall have been laid before and approved by the Board, and such copy of the plans and specifications shall receive approval by endorsement set thereto by the hands of the Chairman and Secretary.

4. The Board may reject any plans or specifications which have not, by reason of inflammable material proposed to be used, or other reason, proper regard for the safety of persons or other buildings in the event of fire.

5. The Board may reject any plans or specifications which, in the opinion of the Board, do not bear proper consideration of size or design of construction or architecture to the adjacent buildings.

6. No builder or owner shall open up any road or footpath which by reason of building operations is found necessary, unless he first obtains a permit from the Board, and such openings shall be covered or railed and provided with lights, to ensure safety to the general public using the road or footpath.

7. Every builder or owner shall, within reasonable time from the completion of any building, fill in and repair to the satisfaction of the Board's authorised inspecting officer all openings on any road or footpath which by reason of building operations it has been found necessary to open.

8. Any persons who do any act contrary to, or neglect or omit to do any act required to be done within the meaning of these By-laws, shall incur a penalty not exceeding Twenty-five pounds, and a further penalty of not more than Twenty shillings for each day the offence continues.

Subject to the approval of His Excellency the Governor in Council these By-laws shall come into force from the date of publication in the *Government Gazette* for the town of Goomalling.

3. A list of such candidates will be sent by the Secretary to the Board forthwith to each registered fruitgrower, who is required to make his election by placing numerals in arithmetical sequence (1, 2, 3, and

so on) against the names of all the candidates whose names are on the list, in the order of his preference, and to return the list so marked by post addressed to the Secretary to the Board at the office of the Board so as to be received by him not later than the 17th day of December, 1927.

4. The Secretary to the Board shall, as returning officer, at a meeting of the Board convened for the purpose, scrutinise the returns and ascertain from the marking of the lists as aforesaid the candidates who have been so elected by the registered fruitgrowers for appointment as the five members of the Board. The scrutiny shall be conducted and the candidates who have been elected shall be ascertained in the manner prescribed by the Commonwealth Electoral Act for the scrutiny of votes at a Senate election, and such provisions shall, *mutatis mutandis*, apply.

5. The names of the five candidates who have been so elected for appointment as members of the Board shall be published in the *Gazette* by the Secretary to the Board, and such notification shall be conclusive that the persons whose names are so published were duly elected as representatives of the growers.

6. The expenses incurred by the Board shall be deemed expenditure incurred in the administration of the Act.

INDUSTRIAL ARBITRATION ACT, 1912-25.

Industrial Agreement.

No. 25 of 1927.

THIS Agreement, made in pursuance of "The Industrial Arbitration Act, 1912-25," this 27th day of September, 1927, between The Hospital Employees' Industrial Union of Workers (W.A. Coastal Branch), of the one part, and The Honourable Alexander McCallum, M.L.A., Minister for Works, on behalf of the State Government, of the other part.

1. All full time wages employees in the service of the Government (except the Government Railways) who are not by Award or Agreement already entitled to long service leave, and who have served continuously for ten or more years after attaining the age of eighteen years, will be entitled under this Agreement, subject as hereinafter provided, to three months' long service leave, to be granted at the convenience of the Department concerned.

2. Such employees shall be similarly entitled to three months' long service leave for ten years' continuous service after the first period of long service leave; and to a further period of three months for seven years' continuous service after the second period of long service leave; and thereafter to a further period of three months' long service leave in respect of each seven years' subsequent continuous service. The words "continuous service" do not include the period during which an employee is on long service leave.

3. Every application for long service leave shall be made in the prescribed form.

4. Every full time wages employee who, on the 31st day of December, 1926, had been employed continuously for at least ten years shall, upon making application in the prescribed form, be entitled to a period of three months' leave, such leave to be granted in order of length of service as far as may be convenient.

5. The qualifying period for the second grant of long service leave to wages employees having more than ten years' continuous service on 1st January, 1927,

will, without regard to the grant of the first period of such leave, commence as follows:—

- To employees of more than twenty-eight years' service on 1st January, 1927—1st January, 1927.
- To employees of more than twenty-two years' service, and of less than 28 years' service, on 1st January, 1927—1st July, 1927.
- To employees of more than sixteen years' service and of less than 22 years' service on 1st January, 1927—1st July, 1928.
- To employees of more than thirteen years' service and of less than sixteen years' service on 1st January, 1927—1st July, 1929.
- To employees of more than ten years' service and of less than thirteen years' service on 1st January, 1927—1st January, 1930.
- To employees of less than ten years' service on 1st January, 1927, but who have completed ten years' service on 1st July, 1930—1st July, 1930.

6. Any public holidays occurring during the period in which an employee is on long service leave will be calculated as portion of the long service leave, and extra days in lieu thereof will not be granted.

7. Long service leave is granted solely for recuperative purposes. No employee of the Department is to undertake during long service leave any form of employment for hire or reward without the consent of the Under Secretary for Labour. Contravention of this provision will be followed by dismissal.

8. An employee dismissed from the service shall not be entitled to payment in respect of long service leave, other than for leave that had accrued due to him prior to the date of the offence for which he was dismissed.

9. Employees may be paid their wages in advance, at their permanent classified rate of pay, for a period equivalent to the leave taken, provided such period does not extend into the next financial year. Any balance may be paid on the 1st July next ensuing.

10. Any employee who is eligible for three months' long service leave and who resigns or is retired from the service, may be paid for such long service leave due.

11. Any employee who is retired for any reason other than misconduct or unsatisfactory service, and who has served continuously for at least twelve months next before his retirement, may be paid for long service leave *pro rata* to the day of retirement.

12. If a deceased employee who has served continuously for at least twelve months next before his death leaves a widow, dependent children, mother, or invalid sister, payment *pro rata* of long service leave up to the date of such employee's death shall be granted to such dependant or dependants.

13. During the period of long service leave District Allowance will not be paid except where the family or dependants of the employee remain in the district.

14. An employee whose service is broken owing to the exigencies of his particular work for a period not exceeding two weeks shall, in respect of such period, be deemed on leave without pay.

15. So far as practicable an employee shall not be booked off for long service leave without receiving one month's notice of the date of the commencement of such leave.

16. This Agreement has effect over workers employed at the "Old Men's Home," in the State of Western Australia.

17. This Agreement is for the term of three years from the date thereof.

Industrial Agreement.

No. 27 of 1927.

THIS Agreement, made in pursuance of "The Industrial Arbitration Act, 1912-25," this 27th day of September, 1927, between the Hospital Employees' Industrial Union of Workers (W.A. Coastal Branch), of the one part, and The Honourable Alexander McCallum, M.L.A., Minister for Works, on behalf of the State Government, of the other part.

1. All full time wages employees in the service of the Government (except the Government Railways) who are not by Award or Agreement already entitled to long service leave, and who have served continuously for ten or more years after attaining the age of eighteen years, will be entitled under this Agreement, subject as hereinafter provided, to three months' long service leave, to be granted at the convenience of the Department concerned.

2. Such employees shall be similarly entitled to three months' long service leave for ten years' continuous service after the first period of long service leave; and to a further period of three months for seven years' continuous service after the second period of long service leave; and thereafter to a further period of three months' long service leave in respect of each seven years' subsequent continuous service. The words "continuous service" do not include the period during which an employee is on long service leave.

3. Every application for long service leave shall be made in the prescribed form.

4. Every full time wages employee who, on the 31st day of December, 1926, had been employed continuously for at least ten years shall, upon making application in the prescribed form, be entitled to a period of three months' leave, such leave to be granted in order of length of service as far as may be convenient.

5. The qualifying period for the second grant of long service leave to wages employees having more than ten years' continuous service on 1st January, 1927, will, without regard to the grant of the first period of such leave, commence as follows:—

To employees of more than twenty-eight years' service on 1st January, 1927—1st January, 1927.

To employees of more than twenty-two years' service, and of less than 28 years' service, on 1st January, 1927—1st July, 1927.

To employees of more than sixteen years' service and of less than 22 years' service on 1st January, 1927—1st July, 1928.

To employees of more than thirteen years' service and of less than sixteen years' service on 1st January, 1927—1st July, 1929.

To employees of more than ten years' service and of less than thirteen years' service on 1st January, 1927—1st January, 1930.

To employees of less than ten years' service on 1st January, 1927, but who have completed ten years' service on 1st July, 1930—1st July, 1930.

6. Any public holidays occurring during the period in which an employee is on long service leave will be calculated as portion of the long service leave, and extra days in lieu thereof will not be granted.

7. Long service leave is granted solely for recuperative purposes. No employee of the Department is to undertake during long service leave any form of employment for hire or reward without the consent of the Under Secretary for Labour. Contravention of this provision will be followed by dismissal.

8. An employee dismissed from the service shall not be entitled to payment in respect of long service leave, other than for leave that had accrued due to him prior to the date of the offence for which he was dismissed.

9. Employees may be paid their wages in advance, at their permanent classified rate of pay, for a period equivalent to the leave taken, provided such period does not extend into the next financial year. Any balance may be paid on the 1st July next ensuing.

13. During the period of long service leave District Allowance will not be paid except where the family or dependants of the employee remain in the district.

14. An employee whose service is broken owing to the exigencies of his particular work for a period not exceeding two weeks shall, in respect of such period, be deemed on leave without pay.

15. So far as practicable an employee shall not be booked off for long service leave without receiving one month's notice of the date of the commencement of such leave.
