WHEREAS by Section 13 of "The Main Roads Act, 1925," the Governor may on the recommendation of the Board declare by Proclamation that any road shall be a main road: And whereas the Main Roads Board has recommended that the road specified in the Schedule hereto be so declared: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, hereby declares that the road specified in the Schedule hereto shall be a main road within the meaning of "The Main Roads Act, 1925," and that the footpaths, if any, of such road be excluded from the main road.

Road through Location 6, past Broadwater and continuing through Location 10 to Molloy's Ditch; thence crossing the bridge at this point and continuing in a North-Westerly direction through Locations 5 and 13 to the North of Reserve No. 391; thence crossing the bridge at this point and continuing in a North-Westerly direction along Road No. 118 to the North-Eastern corner of Location 536; thence continuing in a Westerly and South-Westerly direction along Road No. 1791 to its junction with Roads Nos. 374 and 371 at the South-Western corner of Reserve No. 12495; thence continuing in a South-Westerly direction along Road No. 371 to Gnyulgup at the South-Eastern corner of Location 77; thence continuing in a Southerly direction along Road No. 2182 through Location 731 (Caves Road) to the South-Western boundary of Location 341; thence crossing Road No. 1408 at this point and continuing in a Southerly direction through Woodlands, crossing Red Gully, and continuing through Location 920 and following the Eastern boundary of Location 1081 to the Southern boundary of the Sussex Road Board District, as shown on Plan M.R.B., W.A., 195.

At a meeting of the Executive Council, held in the Executive Council Chambers, at Perth, this tenth day of November, 1926, the following Order in Council was authorised to be issued:—

*Land Drainage Act, 1925.*

*State Drains in Busselton Area.*

ORDER IN COUNCIL.

P.W.W.S. 118/26.

WHEREAS by Section 9 of "The Land Drainage Act, 1925," the Governor may by Order in Council declare any drains not within the boundaries of a Drainage District State drains: And whereas it is desirable to declare certain drains in the Busselton Area to be State drains for the purposes of the said Act: Now, therefore, His Excellency the Governor, with the advice of the Executive Council, doth hereby declare the drains described in the following Schedule to be State drains.

Schedule.

*Description of Drains on P.W.D., W.A., 24448.*

Vasse No. 1: This is a river improvement from the North-East corner of Location 333 and proceeds Northwards; from the North-East corner of Location 333 the drain runs to the South-West corner of the same block and continues in the same direction to midway across Location 2320, where it turns due West across Location 2319, 2318, 2317, and 2316.

Vasse No. 2: This drain starts at a point on Location 2320 where the No. 1 drain turns due West; from this point No. 2 drain runs Westerly across Location 2319 and nearly due West across Locations 2318, 2317, and 2316. Where this drain strikes the boundary between Locations 2316 and 2315 it turns due South between Locations 2305 (on the East part) and 2333, 2307, and 2306 (on the West part), continuing due South across Location P.V.; this drain finishes on the South-East corner of Location 2053.

Sabina Drains: The main drain is a river improvement starting by the bridge on the North side of Location 8 and follows the river bed across Locations 1370, 1974, 1975, 1976, 1978, 1979, and on the South boundary of 1980 turns due East to No. 6 Main Drain, running South-West across Location 601, due East along Location 581 (Southern side), due South down the West side of Location 681, and due East along the North side of Location 1823 till the junction of Locations 1823 and 1824, where the No. 6 drain turns due South, but A.S. 9 drain starts and runs due East along the North of Locations 1824 and 1825. On the latter location a Northern branch (No. 8) runs up through Location 1820 and terminates in the North-West corner of Location 1819, whilst a Southern branch A.S. 10 starts from the same spot and runs Southerly across Location 1825, terminating in the South-East corner of that location.

A further drain on the Sabina system is the No. 7 Main Drain. This drain starts near the North-East corner of Location 839 and proceeds South-Easterly across Locations 401, 530, 604, 799, 2048, and 2047; at the boundary between Locations 2047 and 441 the drain turns East-North-East across Location 441, South-East by East down the boundary of Locations 443 and 441 to the North-East corner of Location 442, where this drain turns North-East across Locations 443, 1827, and finishes in Location 1263.

Abba System: The main drain is a river improvement starting at the South-East corner of Location 352 and follows the river to the South-West corner of Location 745, from here onwards it is a mixture of river improvement or new drain running from the North-West corner of Location 1830, across that location and also Locations 1451, 681, 582, 1609, 650, between Locations 1763 (on the North part) and Locations 655 and 1765 (on the South part), across Locations 1764, 1761, and through the South-East corner of Location 760, where it continues across a large vacant location and enters Location 1778; thence on through Locations 1769, 1777, 1776, 1772, 1773, finishing on the Railway embankment. Where this drain cuts the North-West corner of Location 1451 is the junction with No. 2 subdrain, which runs due East along the boundaries of Locations 1830 and 1832 on the North part, and 1451 and 1833 on the South part. At the meet of boundaries of 1832, 1833 and 1451, A.S. 2 drain junctions and runs due South between Locations 1833 and 1451 to the South-West corner of Location 1833, where it turns due East and runs between the boundaries of 1833 and 1757 on the North part, and 957 and 8321 on the South part till the meet of Locations 8321 and 1759, where it turns due South, terminating on the North-West corner of Location 1760.

No. 3 subdrain junctions with the main drain near the South-East corner of Location 687 and runs due East between Locations 1136 and 697 at the North part and Locations 582, 583, on the South part.

There are several disconnected drains around this main drain and these are located thus:—

Drain A.S. 16, from the South-West corner of Location 1815 to the North-West corner of Location 1814; thence North-East to the South side of Location 652.

A.S. 15. This starts on the North-East corner of Location 656 and runs South-East by East across Location 1766, terminating in Location 1789.

A.S. 14 junctions with the North end of A.S. 14 and runs up into the middle of Location 1765.

A.S. 12 is a small drain in Location 1786.

A.S. 6 starts from the South boundary of Location 1775, runs due North till it meets A.S. 7, which drain starts in the North-East corner of Location 1774 and runs along the North boundary of Locations 1775 and 1776 till it meets the Main drain.

A.S. 5 starts in the North-East corner of Location 1777 and runs due West along the North side of this location and Locations 1769 and 1768, where it ends.

A.S. 19 runs across the Northern boundaries of Locations 1770, 1771, 1772.

A.S. 13 starts on Location 1759, North boundary, and runs across the boundary of Locations 1757 and 1758 through Locations 808, 1832, and 1831, where on the West side it junctions with A.S. 11, which is a local drain in this location; these two drains junction with A.S. 1 on the boundary of Locations 1831 and 856, and then A.S. 1 drain runs due East and West across this block.

The remaining Abba System is the "L" system.

This system starts at Location 745 but it is not joined to the existing systems in that location; it runs into Location 856 and thence due East between Locations 822, 847 835 on the North part and 856 on the South part, at the South-East corner of Location 835 this drain turns North-East by North but No. 1 subdrain branches off at the boundary of Locations 835 and 1452, and

finishes in the North-East corner of the latter block. Continuing L1, this runs under the railway, where it meets L6 and proceeds as L6 through Locations 1721, 1996, 1995. On the North side of Location 1995 L5 branches off, terminating in the South-West corner of Location 1459. L6 meanwhile proceeds through Location 1994 and at Location 2010 junctions with L8, the latter bifurcates along Location 2008. L6 proceeds along the North side of Location 2011 and ends in Location 2018.

Where L6 and L1 junction by the railway L1 proceeds parallel to the railway as far as Location 2003, where L2 forms the drain on the East side of Location 600.

L3 runs off L1 on the South-West corner of Location 2000 and terminates in Location 2006.

The remaining drains are disconnected from any system and are L11 in Locations 2023 and 2021; L9 in Location 1328; L13 running from Location 1992 to 1985; L4 in Location 1431; L12 from Location 1985 to Location 1995.

All are shown in red and green lines on Plan P.W.D., W.A., 24448.

WHEREAS by "The Forests Act, 1918," it is provided that the Governor may by an Order in Council declare any Crown Lands as Timber Reserves within the meaning and for the purpose of that Act: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, doth hereby declare the Crown Lands described in schedule hereto a Timber Reserve (No. 84/25) within the meaning and for the purpose of "The Forests Act, 1918."

Bounded by lines starting from the South-Western corner of Hay Location 956 and extending Easterly along the Southern boundary of Location 956 aforesaid and to and along that of Location 867; thence Southerly along part of the Western boundary of Location 596 and continuing to and along a Western boundary of B 3 of Location 37 to the South-Eastern corner of Plantagenet Location 95; thence Southerly to and along the Eastern boundary of Hay Location 28; thence Westerly along the Southern boundary of the latter location; thence Southerly and Westerly along part of an Eastern and part of the Southern boundary of Reserve 1923 to the Eastern boundary of Location 1164; thence Southerly along the latter boundary and continuing to the Southern side of a three-chain road (No. 1217); thence Easterly and South-Easterly along said side of road to the Northern side of a one-chain road; thence generally South-Westerly along said side of the latter road to the prolongation Northerly of an Eastern boundary of Location 502; thence Southerly to and along the latter boundary; thence Westerly and Southerly along the Northern and a Western boundary of Location 1784 to the Northernmost boundary of Reserve 12266; thence Westerly along the latter boundary and continuing to the prolongation Southerly of the Western boundary of Location 949; thence Northerly to and along the latter boundary, and the Western boundary of Location 361 to the South-Western side of Road No. 1217 aforesaid; thence South-Easterly along said side of road to a point opposite the road post at the South-Western corner of Location 598; thence North-Easterly to said corner and Northerly along the Eastern side of a one-chain road to the starting point.

Excluding Reserve 1923, all roads, and Pardelup Lagoon, Hay Locations 493, 415, 28, 598, 1164, 361, 224, 823, 502, 1192, and Plantagenet Locations 62, 70, 90, 98, 95, and 373, (Plans 444/8) and 452/80, Hay District.)

*The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.*

ORDER IN COUNCIL.

M.W.S. 2013/26.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister of Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works, and stormwater drainage works; and whereas it is further provided that the Governor may exempt reticulation works from certain sections of this Act: Now, therefore, His Excellency the Governor, with the advice of the Executive Council, hereby approves of the construction and extension by the Minister of Water Supply, Sewerage, and Drainage of the following works under the said Act, and does hereby exempt such works from the operations of Sections 20, 21, 22, and 23 of the said Act.

Description and Location of Reticulation Works approved and exempted—Metropolitan Reticulation Main Improvements and Extensions, Bassendean Road District.—(a) Proposed four-inch diameter cast-iron water main commencing at existing four-inch main at the junction of Ivanhoe Street and Broadway and proceeding thence in a Westerly direction along the Northern side of Broadway to the existing two-inch wrought-iron tubing at the intersection of Penzance Street and Broadway (length about thirty-three chains); and (b) Proposed two-inch wrought-iron tube main commencing at the existing two-inch tube main in Broadway opposite Lot 905, and proceeding thence in a Westerly direction along the Northern side of Broadway to a point opposite Lot 958 (length about eleven and a-half chains).

*Amendment of Regulations.*

The regulations published in the *Gazette* on the 5th day of August, 1927, are amended as follows:—

1. Paragraph (5) of Regulation 4 is repealed and a paragraph is inserted in place thereof as follows:—

(5.) The Minister may, by a notice in the *Gazette*, constitute and declare any portion of the State to be a quarantine area for the purposes of these regulations, and by any subsequent notice in the *Gazette* revoke such previous notice.

2. Paragraph (1) of Regulation 69 is hereby amended by inserting at the beginning thereof the words, "Swine shall not be removed from any holding within a quarantine area to any other holding or place without a permit granted by an Inspector of Stock."

*Nungarin Road Board—By-law re Gates.*

WHEREAS by "The Road Districts Act, 1919," the Road Board of any district is empowered to make By-laws for all or any purposes in the said Act mentioned, the Nungarin Road Board, in pursuance of the powers vested in the said Board, under and by virtue of the said Act, and of every other authority enabling it in that behalf, doth hereby make and publish the following By-law:—

*Gate Permits.*

All gates erected across roads must be subject to permission from the Board, and shall conform to the following By-laws:—

(a) All gates, except those across motor roads, shall be 20 feet in width, to be optional whether in one or two sections, hung to substantial posts and swinging freely, and opening to a width of not less than 19 feet. To be provided with suitable stops to prevent swinging

in when stock or vehicles are passing through, and a convenient fastening when closed.

(b) The gates shall be placed at right angles to the line of road, and in the centre of the line of survey, and an approach cleared for a width of 33 feet for a distance of 1½ chains in either direction from the gate.

(c) At cross roads, or where one road joins another, the gates shall be placed not less than one chain back from such junction of the roads, and wing fences erected from the gate site to the junction.

(d) Gates must not be erected where the grade is steeper than 1 in 20, nor within one chain of where any watercourse crosses the road.

(e) The applicant for a permit must lodge the consent in writing of at least two users of the road, and must post a notice of their intention to apply for a permit at the gate site for at least 21 days previous.

## INDUSTRIAL ARBITRATION ACT, 1912-25.

*Industrial Agreement.*

No. 53 of 1927.

THIS Agreement, made in pursuance of "The Industrial Arbitration Act, 1912-25," this tenth day of November, 1927, between the Amalgamated Road Transport Union of Workers, Perth, of the one part, and the Honourable Alexander McCallum, M.L.A., Minister for Works, on behalf of the State Government, of the other part.

1. All full time wages employees in the service of the Government (except the Government Railways) who are not by Award or Agreement already entitled to long service leave, and who have served continuously for ten or more years after attaining the age of eighteen years, will be entitled under this Agreement, subject as hereinafter provided, to three months' long service leave, to be granted at the convenience of the department concerned.

2. Such employees shall be similarly entitled to three months' long service leave for ten years' continuous service after the first period of long service leave; and to a further period of three months for seven years' continuous service after the second period of long service leave; and thereafter to a further period of three months' long service leave in respect of each seven years' subsequent continuous service. The words "continuous service" do not include the period during which an employee is on long service leave.

3. Every application for long service leave shall be made in the prescribed form.

4. Every full time wages employee who, on the 31st day of December, 1926, had been employed continuously for at least ten years shall, upon making application in the prescribed form, be entitled to a period of three months' leave, such leave to be granted in order of length of service as far as may be convenient.

5. The qualifying period for the second grant of long service leave to wages employees having more than ten years' continuous service on 1st January, 1927, will, without regard to the grant of the first period of such leave, commence as follows:—

To employees of more than twenty-eight years' service on 1st January, 1927—1st January, 1927.

To employees of more than twenty-two years' service, and of less than 28 years' service, on 1st January, 1927—1st July, 1927.

To employees of more than sixteen years' service, and of less than 22 years' service, on 1st January, 1927—1st July, 1928.

To employees of more than thirteen years' service, and of less than sixteen years' service, on 1st January, 1927—1st July, 1929.

To employees of more than ten years' service, and of less than thirteen years' service, on 1st January, 1927—1st January, 1930.

To employees of less than ten years' service on 1st January, 1927, but who have completed ten years' service on 1st July, 1930—1st July, 1930.

6. Any public holidays occurring during the period in which an employee is on long service leave will be calculated as portion of the long service leave, and extra days in lieu thereof will not be granted.

7. Long service leave is granted solely for recuperative purposes. No employee of the Department is to undertake during long service leave any form of employment for hire or reward without the consent of the Under Secretary for Labour. Contravention of this provision will be followed by dismissal.

8. An employee dismissed from the service shall not be entitled to payment in respect of long service leave, other than for leave that had accrued due to him prior to the date of the offence for which he was dismissed.

9. Employees may be paid their wages in advance, at their permanent classified rate of pay, for a period

equivalent to the leave taken, provided such period does not extend into the next financial year. Any balance may be paid on the 1st July next ensuing.

10. Any employee who is eligible for three months' long service leave and who resigns or is retired from the service, may be paid for such long service leave due.

11. Any employee who is retired for any reason other than misconduct or unsatisfactory service, and who has served continuously for at least twelve months next before his retirement, may be paid for long service leave *pro rata* to the day of retirement.

12. If a deceased employee who has served continuously for at least twelve months next before his death leaves a widow, dependent children, mother, or invalid sister, payment *pro rata* of long service leave up to the date of such employee's death shall be granted to such dependant or dependants.

13. During the period of long service leave District Allowance will not be paid except where the family or dependants of the employee remain in the district.

14. An employee whose service is broken owing to the exigencies of his particular work for a period not exceeding two weeks shall in respect of such period be deemed on leave without pay.

15. So far as practicable an employee shall not be booked off for long service leave without receiving one month's notice of the date of the commencement of such leave.

16. This Agreement shall have effect in regard to the employees engaged in the Government Motor Garage under the control of the Premier's Department covered by Industrial Agreement No. 26/1925.

17. This Agreement is for the term of three years from the date thereof.
