WHEREAS by Section 9 of "The Land Act, 1898," the Governor may resume, for any of the purposes specified in Section 39 of the said Act, any portion of land held as a Conditional Purchase Lease: And whereas it is deemed expedient that the portion of Conditional Purchase Lease 20(55)/1227 (Victoria Location 5340), as described hereunder, should be re-sumed for one of the purposes specified in paragraph 6 of Section 39 of the said Act, that is to say, for a School site: Now, therefore I, Colonel Sir William Robert Campion, Governor as aforesaid, with the ad-vice of the Executive Council, do by this my Proclama-tion resume portion of the aforesaid Conditional Pur-chase Lease for the purpose aforesaid.

of Section 20, 21, 22 and 23 of the said Act.

Description and Location of Reticulation Works approved and exempted.-Metropolitan Reticulation Main Improvements.-South Perth Road District:-Proposed six-inch diameter cast-iron water main commencing at the existing four-inch main at the intersection of King Edward street and Angelo street and proceeding thence in a Southerly direction along King Edward street to Karoo street, thence in a Westerly direction along Karoo street to connect with the existing four-inch main in Labouchere road (length about twenty-six and a-half chains).

The above main to be complete with valves, hydrants, and all necessary apparatus, and existing three-inch mains to be lifted as shown in red on plan M.W.S.,S., & D.D., W.A. No. 4741.

The Metropolitan Water Supply, Sewerage and Drainage Act, 1909.

ORDER IN COUNCIL.

Description and Location of Reticulation Works approved and exempted,-Metropolitan Reticulation Main Improvements.-Cottesloe Municipality:-(1) Proposed three-inch diameter cast-iron water main commencing at the existing three-inch main at the intersection of Broome street and Eric street and proceeding thence in a Southerly direction along Broome street to a point opposite Geraldine street; thence Westerly across Broome street and along Geraldine street to connect with the existing one-and-a-half inch tube main opposite Lot 33 (length about fourteen and a-half chains), and (2) proposed three-inch diameter cast-iron water main commencing at the above-mentioned proposed three-inch main at the junction of Geraldine street and Broome street and proceeding thence in a Southerly direction along Broome street to a point opposite Lot 41 (length about two and a-half chains).

The Traffic Act, 1919-26. Bridgetown Road Board. ORDER IN COUNCIL.

P.W. 1196/26.

WHEREAS under the provisions of "The Traffic Act, 1919-26," the Governor may by Order in Council empower a Local Authority to exercise within its District any power of making regulations which the Governor can exercise under Division 4 of Part IV. of the said Act: And whereas it is desirable to empower the Bridgetown Road Board to prohibit the passage of heavy traffic over specified roads within its District nearly traine over specified roads within its District and to define what shall be deemed heavy traffic for such purpose: Now, therefore, His Excellency the Gov-ernor, by and with the advice and consent of the Execu-tive Council, under the provisions of the said Act, and of every other authority enabling him in this behalf, doth hereby empower the Bridgetown Road Board, by the By-law in the Schedule hereto, to prohibit the passage of heavy traffic over specified roads within its District and to define what shall be deened heavy traffic for such purpose, and to impose a peualty not exceeding $\pounds 20$ for the breach thereof.

CHILD WELFARE ACT, 1907-27.

294/20. HIS Excellency the Governor in Council has been pleased to approve of the following amended Regulations con-cerning Wards of the Child Welfare Department placed at service by Institutions, in accordance with Section 150 of "The Child Welfare Act, 1907-27."

Regulations concerning Wards of the Child Welfare Department placed at Service by Institutions.

These Regulations shall take effect as from the 1st January, 1928.

2. All Institutions from which Wards are placed at service shall keep a Register of Wages Accounts, as approved by the Secretary of the Child Welfare Depart-

ment, which shall be posted up quarterly. 3. All agreements shall be numbered consecutively and filed. Such numbering shall harmonise with the accounts in the Register. 4. Claims for wages due shall be rendered to em-

ployers at least quarterly, i.e., March, June, September, and December.

Receipts for moneys received shall be acknowledged on the official receipt form and moneys brought to account in the State Savings Bank as soon as pos-sible. Receipt books will be issued by the Child Welfare Department.

6. Money due to the child by the employer must not remain outstanding "beyond one month after each quarter. Failing recovery after that period each individual case shall be reported in writing to the Secretary of the Child Welfare Department. 7. Accounts will be subject to audit by the Auditor

General at least once in each year. 8. In the months of February and July of each year a return shall be furnished to the Secretary of the Child Welfare Department disclosing on each individual account the balance due by the employer to the child.

9. Official receipts of acknowledgment on the approved form shall be obtained from any child who has received moneys from the Management of the Institution.

10. Within a period of three months after a Ward who has been placed out at service by an Institution has reached the expiration of the term of supervision or detention, the Savings Bank Account shall be trans-ferred to the Secretary, Child Welfare Department, as Trustee for the said Ward, and the Savings Bank Pass Book handed to the said Secretary. The governing authority during the before-mentioned period of three months shall collect and pay to the child's Bank Ac-count any wages due to the date the Ward last ceased to be employed under the supervision of the Institution.

The hours for which any building or furniture may be hired shall be—(a) day, 9 o'clock a.m. to 7 o'clock p.m.; (b) evening, 7 o'clock p.m. to 12 o'clock p.m.; (c) extension of time may be granted upon payment of prescribed fees.

6. The Board may at any time cancel any agree-ment made for the hiring of any building or furniture. 7. The Board may at any time demand that the

hirer shall, prior to the term of engagement, deposit an amount estimated to cover any damage that might occur during the term of such engagement.

The Board reserves the right to refuse to let any building or furniture to any applicant for the hiring of same, without assigning any reason for such refusal.

12. No spirituous liquors, wine, ale, beer, porter, cider or perry shall be brought into or consumed in any building during the term of engagement, except when permitted by the Board in writing 13. No person shall smoke any tobacco, cigar,

cigarette, or objectionable substance, nor strike or otherwise ignite any light in any building during any ball or public entertainment, or at any gathering of persons, in the said building, whether such persons have been admitted by the payment of money or otherwise, except at a banquet or smoke social where those present comprise men only.

14. No person shall, in any part of a building-

- (a) use profane or improper language; (b) enter or be allowed to enter whilst intoxi-
- cated:
- (c) be guilty of any misbehaviour whatsoever; (d) damage, mark, or deface any wall or any other part of the building. Any person who does, permits, or suffers such damage shall be liable to pay the cost, in addition to any penalty imposed by these By-laws; (e) stand, loiter, or cause any obstruction what-

Interpretation.

1. In the construction of this By-law, unless the context otherwise requires, the following terms shall have the meanings set out against them respectively, that is to say:

- (a) "Reserve" shall mean and include any portion
- of the Endowment Lands and Reserve 16921. (b) "The Town Clerk" shall mean the Town Clerk
- (b) "The Town Clerk" shall mean the Town Clerk or Acting Town Clerk of the City of Perth.
 (c) "Council" shall mean the Municipal Corpora-tion known as the City of Perth.
 (d) "Inspector" shall mean and include any person appointed by the City of Perth as an Inspector in regard to the Reserve and any acting or consistent Townetter. assistant Inspector.

2. No person shall misconduct himself, or indulge in any riotous or indecent conduct, or use any indecent or improper language, or offend against decency as re-

gards dress on the Reserve.3. No person shall enter upon or remain on the Reserve when visibly under the influence of liquor.

4. No person shall post, stick, stamp, stencil, paint, or otherwise affix, distribute, or give out any placard, handbill, notice, advertisement, or any document what path, or any place whatever on the Reserve, and no person shall cause to be done any of the acts herein prohibited.

5. No person shall spit or expectorate in or upon any building, structure, or erection in the Reserve. 6. No person shall engage in public worship, preach-

ing, or public speaking of any kind, or any meeting of character on the Reserve without the consent of like the Town Clerk.

7. No person shall bet or offer to bet publicly on any part of the Reserve.

No person shall injure, cut, break, deface, pull 8. up, pick, remove, or destroy any tree, shrub, or grass growing on the Reserve.

9. No person or persons shall carry or discharge any firearms, or throw or discharge any stone or other missile, or set off any fire balloon, or throw or set fire to any fireworks, or kindle or make any fire on any portion of the Reserve without the consent of the Town Clerk.

10. No person shall deposit or leave any rubbish, refuse, paper, broken glass, china, or litter of any kind whatsoever within the Reserve except in the receptacles provided for the purpose.

11. No person shall place, or break, or permit or suffer to be placed or broken any glass, metal, or earthenware, bottles, or utensils in the Reserve without having first obtained the consent of the Town Clerk so to do.

12. No person shall gallop or swim a horse or drive any motor cycle or motor car or other vehicle on the beach within three hundred yards of the terminus of the Beach Road.

13. No person shall cut up, damage, disfigure, or interfere with the roads on the Reserve, or with any part of the fences, buildings, electrical equipment, water pipes, or fittings.

14. No person shall, without the consent of the Town Clerk, sell or expose for sale any goods, wares, refresh-ments, fruit, nuts, confectionery, fish, or other merchandise or things, or solicit or offer to purchase bottles on any portion of the Reserve.

15. No person shall, upon the said Reserve, without the consent of the Town Clerk, exercise horses, dogs, or other animals for racing.

16. No person shall cause, allow, or suffer any horse, cattle, sheep, dog, goat, camel, donkey, mule, pig or other animal, or fowl or other bird to enter, stray, or feed upon the said Reserve without permission, nor cause, allow, or suffer any dog to enter any swimming area, nor throw sticks or other missiles therein. 17. Every person on the beach, or bathing in any

portion of the sea exposed to public view, shall at all times, when not dressed in ordinary apparel, wear either a two-piece neck-to-knee costume, or a one-piece costume

In any case where an Inspector is of opinion that any person's bathing costume is indecent or inadequate, or that the material is too thin, or is not in a proper state of repair, or is for any reason unsuitable, he may direct such person to resume at once his ordinary dress.

If any person shall fail to resume immediately 19. his ordinary dress when directed so to do by an In-spector, he shall be guilty of an offence against this By-law, and may with any necessary force be removed to the dressing shed by the Inspector.

20. A person shall not dress or undress or remove or disarrange any part of his bathing costume in any place open to the public view; provided that this shall not prevent any person already clad in proper bathing costume from doffing or donning on the beach any dressinggown or outer robe.

21. A person shall not bathe at any place after being 21. A person shall not be at any reasons warned by an Inspector that such place is dangerous, or if such place be indicated as dangerous by a ger" signal or notice.

22. No person bathing in any open public water shall molest or in any way interfere with any other person bathing, or approach any bather in such a manner as may reasonably cause annoyance to such bather.

23. (a) A dressing shed shall be used for dressing and undressing only. A person shall not play games

or, without reasonable excuse, loiter in or in the vicinity of any such shed; (b) A person shall not bring or deposit any filth or

rubbish in any such shed;

(c) No person shall, under any pretext whatsoever, enter any dressing shed set apart for the use of the

opposite sex. 24. No person shall damage, deface, disfigure, or write in or upon or paste or affix any advertisement on or to any dressing shed or public convenience, or to or on any notice board or other erection, except with the written consent of the Town Clerk first had and obtained.

25. No person shall camp, lodge, or tarry overnight, or frequent the Reserve for the purpose of camping,

lodging, or tarrying overnight. 26. Notwithstanding the provisions of Clause 25, camping may be permitted in areas set apart for the purpose by the Council, but not elsewhere, upon the issue of a permit from the Inspector, and subject to the following conditions :-

Fees are payable prior to the issue of permits, on the following scale:

For permits to camp for a period not exceeding For permits to camp for a period not exceeding 24 hours, including supply of firewood—3s. 6d. For permits to camp for a period not exceeding three days, including supply of firewood—7s. 6d. For permits to camp for a period not exceeding

seven days, including supply of firewood-15s. Extensions of the permit may be secured upon the payment of a further fee upon the above scale.

(a) No person shall sublet any camp, or sell, give,

or otherwise dispose of any permit to any person; (b) Except by the permission of the Inspector, no

person shall bring into or keep within the Camping Area any animals or birds whatever;

(c) No person shall misconduct himself or indulge in any riotous or indecent conduct, or use any indecent or improper language, or offend against decency as regards dress in the Camping Area;

(d) No person shall bring into or keep or consume in the Camping Area any intoxicating liquor, nor enter nor remain thereon when visibly under the influence of

liquor; (e) Campers must keep the area covered by their per mit in a clean and sanitary condition at all times. All rubbish capable of destruction by fire shall be burned by the occupier in the approved fire-place;

(f) All campers must use the sanitary conveniences provided, and in no circumstances will improvised conveniences or individual camping sites be permitted;

(g) No person shall cause or permit any damage to trees, shrubs, or grass, whether naturally or artificially

trees, surfuls, or grass, whether naturally or artificially planted, within or surrounding the Camping Area; (h) Camping permits may at any time be withdrawn by the Inspector, if in his opinion a breach of these By-laws has been committed, or if, in his opinion, it is desirable that the permit shall be terminated. In the event of termination hereunder, the rental paid shall be forfeited to the Council, and no compensation shall be claimed or paid for loss, damage or inconvenience suf-

(i) Subject to the right of the Board, or any person act-ing under their instructions, or any Police Constable, to enter any Camping site at any time, no person shall enter into or remain within such Camping site except

(i) No fires shall be lighted on any Camping Area, oxcept in places approved by the Inspector;
(k) Except so far as they may be inconsistent with

this By-law, the whole of the By-laws now or hereafter made by the Council to apply to the Endowment lands, shall apply to Camping Areas.
