Any person contravening any of the provisions of this By-law shall be liable on summary conviction to a penalty not exceeding £2.

Rule 23.—Every articled clerk, save as hereafter provided shall, before he has served cne-half of the term of service provided under his articles, pass an intermediate examination in Stephen's Commentaries, Williams' Real and Personal Property (modified by local laws) and Constitutional Law (including the Federal and State Constitutions), or such subjects as the Board may from time to time direct.

Rule 26.—Every articled clerk, save as hereafter provided, shall pass a final examination in law in the following subjects:—(1.) Real and Personal Property and Conveyancing; (2.) Contracts; (3.) Torts; (4.) Criminal Law; (5) Equity; (6) Private International Law: (7. and 8.) Practice and Procedure in the Supreme Court of Western Australia in all its jurisdictions (including Pleading); Practice and Procedure in the Inferior Courts, Evidence (two papers).

26a. No articled clerk shall present himself for final examination until after service under articles of not

less than four years and six months, or, in the case of a Bachelor of Laws serving under articles for a term of two years until after a like service of not less than one year and six months; provided, however, that the Board may in its discretion permit an articled clerk applying under Rule 26 who has declared his intention to take the final examination in two sections to present himself at any time, not being less than twelve months after the passing of the Intermediate Examination for examination in either section after the expiration of a term of service under articles of three years, or, in the case of an articled clerk serving under a two years' term of articles at any time after the expiration of six months after the passing of the Intermediate Examination.

26b. ## THE ROAD DISTRICTS ACT, 1919. Quairading Road Board.

By-laws of the Quairading Road Board.

P.W. 1489/27.

WHERERAS by "The Road Districts Act, 1919," "The Cattle Trespass, Fencing, and Impounding Act, 1882," and other Statutes, the Road Board of any district is empowered to make By-laws for all or any purposes in the said Acts mentioned, the Quairading Road Board, in pursuance of the powers vested in the said Board, under and by virtue of the said Acts, and of every other authority enabling it in that behalf, doth hereby make and publish the following By-laws.-

#### Interpretations.

1. In these By-laws the interpretations set out in "The Road Districts Act, 1919," shall apply, in addition to which the following terms shall, unless the context otherwise indicates, bear the meaning set against them in the Road Districts Act, or respectively, that is

to say:-"The Act"-"The Road Districts Act, 1919," and all amendments thereto which may hereafter come into

"Board"—The Quairading Road Board.
"Board Room" shall be the office, hall, or building

to time. "District"—The district under the jurisdiction of

the Quairading Road Board, "Secretary"—The Secretary of the Board.

All other interpretations to be prescribed in the Road Districts Act or other Acts or Regulations thereunder.

#### Offences, Omissions, or Neglects.

- 2. Any person guilty of the following offences shall, on conviction thereof, pay a penalty not exceeding Ten
  - (a) Damaging or destroying any building, dam, well, tank, pump, windmill, windlass, bucket, rope, piping, troughing, fence, gate, or other property under the control of the Board;
  - (b) Placing any placard or other document, writing or printing on or otherwise defacing any house or building abutting or contiguous to a public road, or any wall, fence, gate, or lamp-post without the consent of the occupier or owner thereof:

(c) Blasting any rock, stone or other timber in or near any road without the permission of the Board, and not attending to such directions in regard thereto given by such Board;

(d) Placing, stacking, or storing within the limits of any townsite, in the open air, any cases, paper, shavings, crates packed with straw or dangerous or inflammable substances so as to be or likely to become a source of danger through

## Lighting.

3. Any unauthorised person who shall light, put out when lighted, or in any other way interfere with any imp belonging to the Board, or shall damage or destroy such lamp shall pay, in addition to the value of such damage, if any, on conviction, a sum not exceeding £10.

### Water Supply.

- 4. Any person who shall injure or destroy any well, bore, pipe, tank, or place of storage for water, or any machinery, appliances, or property used in connection therewith, shall be liable to a penalty not exceeding £20, and also shall pay to the Board the sum of such damages.
- 5. Any person who shall waste, or allow to escape, foul, pollute, or tainf water contained in a bore, pipe, tank, or place of storage, shall be guilty of an offence against this By-law and shall be liable to a penalty not exceeding £20.
- 6. No person shall pollute or cause to be polluted any watercourse, pool, tank, reservoir, or other water within the district.
- 7. Any person leaving open the lid of any well, or any gate of an enclosure surrounding any dam or other water supply under the control of the Board shall be guilty of an offence against these By-laws, and not-withstanding any remedy for damages so caused shall be liable, on conviction, to a penalty not exceeding £10.

8. Any person may, with the consent of the Board, and upon payment of such reasonable fee as may be demanded, remove any water from any well, bore, tank or other place of storage under the control of the Board. For the purpose of this By-law the consent of the Board shall be deemed to be given and remain in force until notice to the contrary is specially given to any such person or is generally given by publication in a local paper, or posted upon or in the vicinity of the well, bore, tank, or other place of storage to which such notice shall apply. After service or publication of such notice any person removing any water from any well, lore, tank or other place of storage, the subject of such notice, shall be guilty of an offence and be liable to a penalty not exceeding £5.

#### Fencing.

9. The owner of any land abutting on any road in any townsite shall fence all such boundaries so abutting with such description of fence as may be directed by the Board, and shall maintain every such boundary fence erected or to be erected, in good order. In the event of such fence not being erected or repaired after due notice has been given so to do, the Board may fence or repair such fences and recover the cost of so doing from the owner or owners of the land.

#### Depasturing of Cattle.

- 10. Any person who shall turn loose, or suffer any kind of animal belonging to him or under his control to stray or go about, or to be tethered or depastured in or upon any road, recreation ground or reserve shall, on conviction, be liable to a penalty not exceeding £10.
- 11. The owner of any animal suffering from an intectious or contagious disease shall not permit such animal to be ridden or allowed to stray on any road, unfenced land, or reserve within the district. Any animal so suffering may be slaughtered and destroyed without notice and at the owner's expense.
- 12. The owner or driver of any such animal shall be liable if convicted of a breach of this By-law, to a penalty not exceeding £10, and not less than £2.

#### Straying Stock.

- 13. No owner or person having the custody or control of any animal shall cause, permit, or suffer such animal to stray on any road, public reserve, or other public place, or in any unfenced land abutting thereon, within the boundary of the Road Board District.
- 14. (a) Any contravention of By-law 13 shall be an offence punishable under these By-laws, if the animal is a bull, boar, or stallion, by a fine not exceeding £20, and not less than £2.
- (b) In any other case, by a fine not exceeding £10, and not less than 10s.

Provided that this By-law shall not apply in the case of stock whilst in charge of the Town Ranger duly appointed by the Board.

## Copulation of Stock.

15. Any person who, as owner or otherwise, while in charge of an entire horse, bull, or ass shall cause, allow, permit, or suffer any such entire horse, bull, or ass to try to cover any mare or cow within any township within the district, or shall cause, permit, allow, or suffer any such entire horse, bull, or ass to be turned loose in any yard or in any other place with any mare or cow for the purpose of allowing any such mare or cow to be tried or covered, except in some yard, building or other premises as shall be entirely and sufficiently screened from public view, shall forfeit and pay, on conviction, a sum not exceeding £10.

## Goats.

- 16. (a) No person shall keep any goat within the boundaries of the Quairading Road District unless such goat shall have been registered and the registration fee of sixpence paid to the Secretary of the Board.
- (b) Every registration shall be renewed in the month of July in each year.
- (e) The Board may refuse to register any goat if in the opinion of the Board suitable accommodation has not been provided for keeping such goat.
- (d) The penalty for breach of any of the preceding clauses shall be a sum not exceeding £10 for each breach, in addition to such sums as the justices may direct as compensation for damages done by such goats.

## Crossing Places.

17. It shall be lawful for the owner of any land fronting or adjoining any public way requiring access thereto with horse or vehicle from such street to such land across any existing made footpath, kerbing, channel, or gutter, having first had and obtained the consent of the Board, to construct a crossing of such dimensions and materials and in such form and manner as the regulations of the Board for the time being require, or as may be directed by the Secretary, and thereafter keep and maintain the same in good repair. Any person not complying with this By-law shall be liable to a penalty not exceeding £5.

#### Public Pound, etc.

18. The Quairading Road Board under and by virtue of the powers contained in "The Road Districts Act, 1919," and "The Cattle Trespass, Fencing, and Impounding Act, 1882," hereby appoint Quairading Road District Public Pound, situated on Quairading Town Lot 189 and Reserve 18764, to be the public pound for the Quairading Road Board.

19. Any person who shall release or attempt to re-lease any cattle which shall be lawfully seized for the purpose of being impounded, whether such cattle be in the pound or on the way to cr from the pound shall be guilty of an offence against this By-law, and shall

on conviction, be liable to a penalty not exceeding £10.

20. Any person who shall break, damage, or destroy any pound, fence, gate, lock, shed, trough, or other premises the property of the Board, shall be liable to a penalty not exceeding £10. Any person who shall obliterate, deface, or damage any table of fees, placard, cr other notice required by "The Cattle Trespass, Fencing, and Impounding Act, 1382," shall be guilty of an offence against this By-law and shall be liable to a penalty not exceeding £10.

21. Owner of impounded stock for the release of such shall pay:-

## Trespass Fees.

22. Trespass on unenclosed country land:

For every entire horse, ass, or bull, in the day-time—not less than £2 nor more than £4.

For every such horse, ass, or bull, in the night-time—not less than £3 nor more than £5.

For every other head of "great cattle" by day or

night—Three shillings.

For every other head of "small cattle" by day or night—One shilling.

Trespass on enclosed land, whether town or country, or suburban, not being a public street or thoroughfare in a city or town or public cemetery:

For every entire horse, ass, or bull, in the day-time-

Not less than £2 nor more than £4.

For every such horse, ass, or bull, in the night-time-Not less than £3 nor more than £5.

For every other head of cattle, by day or night-A sum not exceeding 20 shillings.

Trespass on a public street, thoroughfare in a town

or in an enclosed public cemetery:

For every entire horse, ass, or bull—Not less than £3 nor more than £5.

For every other head of cattle—A sum of 40 shillings. For every other head of "small cattle" other than sheep, by day or night—The sum of five shillings. For every head of sheep—Threepence per head. Great cattle trespassing, not branded with registered

brand-Double fee.

#### Sustenance Fees.

23. For every horse, mare, gelding, mule, ass, camel, pony, or head of horned cattle over twelve months old -3s. 6d.

For every colt, foal, or head of horned cattle under twelve months old-3s.

For sheep, per head-6d.

For every pig-3s.

For every goat-2s.

Such rates to be charged for each day of 24 hours. No charge to be made for less than three hours.

#### Description and Quantity of Sustenance.

For each head of "great cattle"-28lbs. of 24. chaff.

For each head of "small eattle" other than pigs-6lbs. of chaff.

For each pig-9lbs, pollard or corn.

#### Mileage Fees.

25. "Great cattle" One shilling and sixpence per head per mile, with a minimum of one shilling and sixpence (1s. 6d.)
"Small cattle"—Threepence (3d.)

mile, with a minimum of threepence (3d.)

### Heavy Traffic.

26. The Board may, by notice affixed to any bridge or culvert, declare the maximum weight of any engine, agricultural or other machine or vehicle of any kind, and of any load or material which shall be permitted to cross such bridge or culvert, and also the pace or speed at which such engine, vehicle, or load shall be driven, led, or taken over such bridge or culvert, and any person who shall cross such bridge or culvert in contravention of this By-law shall in addition to any liability for damage he may have caused, be liable to a penalty not exceeding £20.

### Damaging Roads.

27. No person shall either wilfully or negligently damage or destroy by means of horse or any other creans any road under construction or repair; any person found guilty of such damage or destruction shall be liable to a penalty not exceeding £20.

Any person who-

(a) cuts or removes, without the consent of the Board, timber, earth, stone, or other material from a road or reserve; or

(b) erects, without the consent of the Board, upon

a road so as to encroach thereon; or

(e) draws, without the consent aforesaid, across the waterside of a road or across a drain, except over a propertly constructed approach or culvert, a dray or other wheeled vehicle; or

(d) draws upon any road, timber, stone or other material otherwise than on a wheeled vehicle, or suffers such material when carried principally or in part upon a wheeled vehicle to drag or trail upon a road, or draws upon a road a whim or timber carriage any portion of other attachment trails or drags upon a road, shall be guilty of an offence against these By-laws and shall be liable to a penalty not exceeding £5 for every such offence.

28. Any person taking any plough, cultivator, tractor or other implement over or along any road and thereby damaging or marking such road in such a manner which, in the opinion of the Board, may indirectly cause ultimate damage to the road, shall be liable to a

penalty not exceeding £5.

29. Any person who draws upon any road any vehicle the wheel or wheels of which are locked, unless there is placed at the bottom of such wheels some sufficient protection to prevent damage to such road shall be liable to a penalty not exceeding £5.

## To Protect Bridges from Fire.

30. Any person who shall light a fire (except by the order of the Board), or who shall place any rushes or other inflammable substance under, near, or against any bridge in the district, for the purpose of making a camp or sleeping place, or for any other purpose shall be liable to a penalty not less than £1 and not exceeding £20.

Prevention of Trees falling across Road.

31. No person shall make or leave a fire near any load or reserve without taking proper precaution against such fire spreading.

No person shall ringbark or set fire to any standing tree upon or near to any road or track.

Park Lands, Reserves, and Recreation Grounds.

33. All park lands and recreation grounds shall be open to the public daily for recreation purposes, excepting as otherwise provided for in these By-laws. The Board shall have power to grant exclusive right to use and occupy any park lands, recreation grounds, or re-serves placed under its control within the district for holding public sports or amusements to any responsible person or persons or club, and any person or persons obtaining such right shall be responsible for the proper care of all fences, buildings, trees, or other improvements upon or enclosing such park lands, recreation grounds, and reserves, and shall pay the Board a fee to be fixed for admission on such occasion, and comply with the provisions of these By-laws and any Regulations passed by resolution of the Board under which such exclusive rights are granted.

- 34. No horses, cattle or vehicles shall be allowed on any park lands, or recreation grounds without the written permission of the Board.
- 35. All persons using or being upon any park lands, recreation grounds, or reserves shall at all times conduct themselves in a becoming manner, and any person creating any disturbance or annoyance to the public shall be liable to be expelled from such lands by any police officer or officer of the Board.
- 36. The Board may, in its discretion, prohibit any games or gymnastics from being played or carried on by any person or persons upon any park lands, recreation grounds, or reserves on a Sunday, Christmas Day, or Good Friday.
- 37. No person shall offer for sale on any reserve any provisions, refreshments, or other goods of any kind, nor carry on any games or boxing or other similar shows, nor use any firearms, except with the express sanction of the Board and payment of such fee as may be demanded.
- 38. The Board may or any person duly authorised may make charges for admission for adults, and for horses and vehicles or motor cars, to any reserve or defined portion thereof, with free entry for children (accompanied) under five years of age.
- 39. Such person to whom the use of any reserve is given for picnic, sports, races or other use shall be held responsible for the immediate removal of all rubbish brought thereon on the occasion of such use, and a deposit not exceeding £5 shall be paid as a guarantee for the due removal of such rubbish. On the removal of such rubbish, to the satisfaction of the Board, the deposit shall be returned.
- 40. No person shall damage or injure any tree, shrub, or plant in any park lands, recreation grounds, streets, or reserves. Any person offending against this By-law shall forfeit and pay, on conviction, a penalty not exceeding £10 for every such offence.
- 41. The Board may allow to any person who pays the rates for which he is liable, within thirty days of such rates becoming due, a percentage by way of discount of five per centum on the amount of such rates.

## Hawking.

42. No person shall be permitted to hawk fruit, fish, meat, poultry, game, or vegetables, or any article of merchandise without first having obtained a license from the Board and payment of fees as per Schedule "A" hereto annexed:—

# Schedule "A." Fees for Hawker's License.

For a license to hawk fish, meat, poultry, game, fruit, or vegetables . . . . 0 5 0 For a license to hawk merchandise . . . 5 0 0 A hawker's license shall be issued for a term of 12 months from date of issue.

### Penalties.

- 43. Where any person by these By-laws, or any of them is required to do or perform any act, and such act is not done or remains undone or unperformed, it shall be lawful for the Board to perform the same and charge the cost and expenses against such person, and the amount thereof may be recovered summarily.
- 44. Every person who does, permits, or suffers any act, matter or thing contrary to any of these By-laws or commits or permits any breach or neglect thereof, shall be deemed guilty of an offence against these By-laws, and, where not otherwise provided, shall be liable to a penalty not exceeding £20 for every such offence.
- 45. All penalties or other sums recovered under provisions of these By-laws shall, unless otherwise provided be paid to the Board and shall become the property of and form part of the ordinary income of the Board, except so much as may be paid to any informer.

#### Gate Permits.

- 46. All gates erected across roads must be subject to permission from the Board and shall conform to the following By-laws:—
  - (a) All gates, except those across motor roads, shall be 12 feet in width, to be optional whether in one or two sections, hung to substantial posts and swinging freely, and opening to a width of not less than 15 feet. To be previded with suitable stops to prevent swinging in when stock or vehicles are passing through, and a convenient fastening when closed.
  - (b) The gates shall be placed at right angles to the line of road and in the centre of the line of survey, and an approach cleared for a width of 12 feet for a distance of 1½ chains in either direction from the gate.
  - (e) At cross roads, or where one road joins another, the gates shall be placed not less than one chain back from such junction of the roads, and wing fences erected from the gate site to the junction.
  - (d) Gates must not be erected where the grade is steeper than 1 to 20, nor within one chain of where any watercourse crosses the road.
  - (e) The applicant for a permit must lodge the consent in writing of at least two users of the road, and must post a notice of their intention to apply for a permit at the gate site for at least 12 days previous.

## Conformity with By-laws.

- 47. Every person who does, permits, or suffers any act, matter, or thing contrary to any of the foregoing By-laws, or commits or permits any breach or neglect thereof, shall be deemed guilty of an offence against these By-laws, and any person guilty of an offence against these By-laws, shall be liable to a penalty not exceeding £20 for every such breach, where not otherwise provided for.
- 48. Any person who without consent in writing of the Board first had and obtained shall store more than eight hundred gallons in the whole total quantity of kerosene oil, petrol, benzine, naphtha, turpentine, motor or other spirit of any kind or substance, or other substance, liquid fluid or solid, or other inflammable or volatile fluid or substance, as defined in "The Explosives Act, 1895," at one and the same time in any one building or place within the Quairading Road Board District occupied by the same person or persons, firm, or corporation, shall forfeit and pay upon conviction a penalty not exceeding £20, and a further penalty not exceeding £1 for each and every day during which the offence continues.

The foregoing By-laws were passed by resolution of the Quairading Road Board on the 10th March, 1928.

# THE ROAD DISTRICTS ACT, 1919. Quairading Road Board—Building By-laws.

WHEREAS by "The Road Districts Act, 1919," the Road Board of any district is empowered to make Bylaws for all or any purposes under the Act recited, the Quairading Road Board, in pursuance of powers vested under the said Act, and of every other authority enabling it in that behalf, doth hereby make the following, which shall be known and cited as "The Building By-laws." The words "Public building" shall mean and include every building used as a church, chapel, or other place of public worship; also every building used for purposes of public instruction; also every building used as a college, public hall, hospital, theatre, public

concert room, public exhibition room, public cinema, or picture halls, amusements, or for structures closures used for any other public purposes.

- 1. No person shall lay out a block of ground for building unless and until a plan showing clearly the number of houses or buildings proposed to be erected thereon, and the area to be occupied by each house or building, and the position of every drain and privy, and a copy of the specification, have been laid before and approved by the Board, in accordance with Building Regulation No. 2.
- 2. No person shall commence to build, alter, add to, or do any of the other acts or works mentioned in Building Regulation No. 3, unless he-

(a) Shall have made application in the form provided in Schedule "A," and
(b) shall have deposited plans and specifications pre-

(a) shall have deposited plans and specimentions prepared in accordance with By-law No. 4, and
(b) shall have paid the appropriate fees as set out in Schedule "B," and
(c) until there has been issued therefor a Building License in the form set out in Schedule "C'. and the plans and specifications have been duly

endorsed as approved by the Board.

Penalty for breach, not exceeding £20, and £2 per day for such time as the offence continues.

3. No person who shall have obtained the approval of the Board as provided hereinbefore, in respect of any building or addition or alteration, shall, in the construction of such building or addition or alteration curtail or otherwise depart from the plans and specifications which have been approved, without the written consent of the Board first had and obtained, and such alterations or departures from approved plans and specifications shall be drawn, described, and endorsed on and in the plans and specifications.

in the plans and specifications.

Penalty for breach, not exceeding £20, and £2 per day for such time as the offence continues.

4. All plans shall be neatly made in ink (scale 8 feet to 1 inch) on drawing paper, tracing cloth, or sunprint of at least 15in. x 20in. in size. The plans shall show every storey, elevations of external fronts, and one or more sections, showing the heights of storeys, walls, roofs, etc., all clearly figured and dimensioned in feet and inches.

There shall also be deposited in locality plan (scale not less than 16 feet to 1 inch) showing the position of

not less than 16 feet to 1 inch) showing the position of the site, on the block of the proposed building, and other buildings existing thereon, with all showing

drains, privies, and other works.

All specifications shall be compiled so as to clearly and fully set forth the materials, workmanship, and every detail for the due completion of the work it refers

Plans and specifications shall be left with the Board at least seven days before the issue of the Building

5. Whenever requested to do so by the Board, the holder of a Building License shall produce for inspection any plan or specification that has been approved

- by the Board and referred to in such Building License.
  6. The level of the ground floor of any building shall not be less than three inches above the level of the adjacent footway or crown of the road, without the written permission of the Board first had. In cases where the road or footpath has not been constructed, the level of the ground floor shall be at such height as the Board shall determine, and for this purpose a cross-section of the building shall be supplied by the building owner, showing the relative levels of the site and the unmade
- 7. The Board may refuse to approve of any plan or specification which has not by reason of inflammable material proposed to be used, or for other reason, proper regard to the safety of persons or buildings in the
- event of fire.
  8. The Board may refuse to approve of any plans or specifications which, in the opinion of the Board, are by reason of size or design of construction or architecture calculated to have a depreciative effect on adjacent buildings, or on the locality where the proposed building would be erected.
- 9. No license will be granted for the erection of a building of wood, or iron, or with materials other than brick, stone, or artificial stone unless the position and design, or value of such building will not, in the opinion of the Board, be prejudicial to adjacent buildings, or to the locality where the proposed building would be erected.

- 10. No part of a building to be used as a dwelling house shall be placed at a lesser distance than five feet from the side boundaries of the block, nor at a lesser distance than ten feet from the road boundary or any adjacent building, unless the written authority of the Board has been first obtained.
- 11. No person shall open any footpath or road, or place any materials upon the same, nor erect any staging thereon, unless he first give three days' clear notice thereof in writing, and deposits the sum of £5 and have obtained the written consent of the Board, and shall comply with all conditions as to covering, railings, lights and other requirements which may be set out in the consent herein referred to.
  - (a) On the completion of the work, the person to whom the consent has been issued shall, within three days, fill in and repair all disturbances in the road or footpath, and shall remove all materials therefrom. On the work of repair and removal having been done to the satisfaction of the Board, the deposit will be refunded in due course.
  - (b) If the work referred to in (a) has not been done to the satisfaction of the Board or is unduly delayed, the Board may do the necessary work at the cost and charge of the person to whom the aforesaid consent was given.
- 12. No person shall erect any verandah (or other projection) over any public way without first having deposited plans and specifications of the proposed erection, and if approved by the Board, the said plans and specifications shall be endorsed as approved, subject however, to any conditions which may be attached thereto.

No advertising, trade, or other signs shall be displayed on any veraudah (or other projection) over any public way save with the written approval of the Board first had.

- 13. A privy in accordance with the Health By-laws shall be provided before any further work is done (where such is not already on the premises) for the use of all workmen employed on the job.
- 14. Any person who does any act contrary to or neglects or omits to do any act required to be done within the meaning of these By-iaws shall, where no specific penalty is otherwise provided, incur a penalty not exceeding £10, and a further penalty of £1 per day for each day the offence continues.
