WHEREAS by Section 4 of "The Vermin Act, 1918," it is enacted that "Vermin" means and includes any animal or bird mentioned in the Third Schedule to this Act, and such other animals or birds the names of which the Governor may by Proclamation add to the said Schedule, and also that any Proclamation whereby the names of other animals or birds are added to the Third Schedule may be restricted in its operation to any por-

tion of the State, to be defined by the Proclamation: And whereas it is deemed expedient to add the names of animals known as "Euros" and "Kangaroos" respectively to the said Third Schedule, but to restrict this Proclamation in its operation to Roebourne-Tableland Vermin District: Now, therefore I, the said Governor, acting with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act, do hereby add to the said Third Schedule of the said Act the names of animals known as "Euros" and "Kangaroos" respectively for the purposes of the said Act, but this Proclamation shall be restricted in its operation to that portion of the State constituted and known as Roebourne-Tableland Vermin District for the purposes of the said Act.

*Amendment of Yalgoo Common By-laws.*Department of Lands and Surveys,

(7.) Travelling stock arriving by train will be allowed one clear day free of charge. Stock waiting for trucks, to be railed away, will be allowed three clear days free of charge. If the period in either case is exceeded a charge of Two shillings per head of small stock per day or sixpence per head per day for large stock will be made. The maximum time allowed on the Common for such stock is seven days inclusive of time allowed free.

(8.) No stock shall enter on the Common, unless written notice of time of arrival has been given to the Board. Any stock crossing the Common must be off the Common within twelve hours of coming on.

Workers' Compensation Act, 1912-24.

Regulation 11.

Delete the existing regulation, and insert the following in lieu thereof:—

Appeals.

(1) An appeal to a Medical Board under Section 14, paragraph (b), of the First Schedule to the Act shall be brought by the party appellant giving notice to the other party and to the Clerk of the Court within 10 days after the report of the medical referee has been lodged with the Clerk, stating that he is dissatisfied with such report, and desires to appeal therefrom to a Medical Board.

(2) The Clerk shall forthwith send notice to the Registrar that such appeal has been instituted, together with copies of the medical certificates submitted by the parties, and of the medical referee's report.

(3) The persons to constitute such Board shall be such as are approved by the Minister. The Registrar shall, on receiving notice from the Clerk of Court, arrange for the appointment and place and time of meeting of the Board and shall advise the parties thereof.

(4) The parties shall attend before the Board at the time and place appointed, and shall adduce such evidence as they may respectively desire the Board to hear, and the Board may of its own motion call any evidence and require any examination to be made and information to be procured which it may consider necessary.

(5) The Board shall embody its decision in a report which shall be signed by the members of the Board, and shall be forwarded to the Registrar, who shall communicate the contents thereof to the parties.

Regulation 15A.

Insert the following new regulation:—

Any person committing a breach of any of these regulations may be proceeded against summarily before Justices, and upon conviction shall be liable to a penalty not exceeding ten pounds.

THE Court of Arbitration of Western Australia doth hereby make the following Award in connection with the Industrial Dispute between the abovenamed parties:—

1.—Wages.

2.—Engagement and Dismissal.

Notwithstanding that the rate of pay is fixed on a weekly basis, it is hereby agreed that if in the case of any employee for any reason whatever during any portion of the working hours of any week no work is available or performed the employee will only be paid for the time actually worked at the rate of pay as above prescribed (per week of 44 hours) apportioned to the time actually worked during the week: notwithstanding the rate of pay is fixed on a weekly basis there shall be no obligation on the part of the Minister or the employee to give a week's notice to determine the employment, that is to say, the existing practice will continue to be observed.

Twenty-four hours' notice on either side shall be sufficient to terminate an engagement provided that in case of drunkenness on duty, or refusal of duty, the employee may be summarily dismissed.

3.—Preference.

(a) Preference shall be given to members of the Coastal Dock River and Harbour Works Union of Workers over non-members provided there are available at the port where the work is offering, members of the Union bearing good records and qualified to perform the work to be done.

(b) Preference then to be given to members of Union who are available at the port where the work is offering, bearing good records and qualified to perform the work to be done.

(c) Provided that all employees who may be employed on dredges, covered by this Award shall join the Coastal Dock Rivers and Harbour Works' Union of Workers not later than the second full pay after commencing work thereon.

4.—Hours.

(a) The ordinary working hours for employees other than those who may be required to work seven days per week shall not exceed eight (8) hours for the first five days in the week and four (4) hours on Saturdays.

(b) When a dredge is commissioned to work two or more shifts the hours of work in each week may be varied by the Minister to the extent that the hours may be forty, forty-four, or forty-eight per week: Provided that the average hours worked shall not exceed forty-four per week, and further provided, that operations for the week shall cease not later than twenty minutes past noon on Saturday.

(c) In any week in which a holiday occurs the number of working hours shall be reduced by eight hours for such holiday.

Time shall be counted when the men are actually working or when the dredges are under way. It is agreed that stationary dredges shall not be considered under way.

5.—Meal Hours.

The present practice whereby a dredge operates continuously in eight-hour shifts without cessation for a recognised meal hour shall continue: Provided that, during each shift, reasonable time shall be allowed each worker to have his meal, and to enable this to be done, employees shall relieve each other during such meal hours as at present.

6.—Overtime.

(a) All time worked outside of or in excess of the usual working hours shall be paid at the rate of time and a half for the first four hours after the usual stopping time and double time thereafter: Provided that the employee required to commence work within one and a half hours before the usual starting time shall be paid time and a half to the usual starting time.

(b) If the Minister requires an employee to work on Sunday, Good Friday, Easter Monday, Labour Day, Christmas Day, Boxing Day, New Year's Day, or Picnic Day, such employee shall be paid at the rate of double time, except in the case of watchmen, who shall take such days as ordinary shift days.

(c) When an employee is recalled to work after leaving his job he shall be paid at least two hours overtime.

7.—Holidays.

(a) Twelve paid holidays per annum will be granted all employees: Provided always, that the following days: Good Friday, Easter Monday, Labour Day, Christmas Day, Boxing Day, and New Year's Day shall be taken as they come as portion of the holidays; the balance of six days to be granted as annual leave, at the convenience of the Department. Payment for holidays shall be made in accordance with the usual hours of work.

(b) Every worker, after one month's continuous service, shall be entitled to holidays in proportion as the length of service is to the full number of holidays for the 12 months.

(c) (1) Approved periods of absence owing to sickness shall not be considered breaks in continuity of service, but such periods shall not qualify for holidays.

(2) Approved periods of absence from work through accident sustained in the course of the Department's employment, up to a maximum of one month in any one period, shall not break continuity of service for the purpose of computing holidays. For approved periods of absence exceeding one month the provisions of Subclause (c) (1) shall apply.

(d) Holiday pay shall be at the rate the worker is in receipt of at or immediately prior to the holiday being taken.

8.—Casual Workers.

A casual worker is one for whom work over a longer period of twelve consecutive days is not provided by the employer, not including holidays, and such casual worker shall be entitled to an increase of 10 per cent. over the ordinary wage.

9.—Conveyance of Employees.

Employees shall be conveyed by the Minister free of charge from and to the recognised landing stages to and from the dredge.

10.—Detention on Dredge.

When the working conditions are such that the Minister requires an employee to remain on board the dredge from Monday to Friday or Saturday, he shall supply eating and cooking utensils and a cook, but the employees shall find their own food, and, in addition, the monthly allowance of five shillings shall be paid all ratings in lieu of bedding when the latter is not provided.

11.—Sustenance Allowance.

(a) In places where an employee is transferred to another port for a period exceeding six months, he may be required by the Minister to accept free transport for himself, wife, family, and effects, with an allowance of £4 for married employees and 15s. for single men in lieu of allowance set out hereunder. If required to travel by train "free transport" shall in these cases include second-class sleeping berths, if available, for employee, wife, and family.

(b) Employees transferred for a period exceeding three months, but which is not expected to exceed six months, shall be paid a weekly allowance of twenty-five shillings (25s.) in lieu of transfer or lodging allowance to cover the excess cost of living while away from home.

(c) Employees working away from their home port other than those mentioned, shall be paid at the rate of 8s. per day for the first seven days and thereafter 6s. per day until returned thereto, unless victualling and accommodation is paid by the Minister.

(d) Employees absent from their place of abode on duty in their home port for a period exceeding twenty-four hours shall be paid five shillings for the first twenty-four hours and eight shillings for each subsequent twenty-four hours, or be provided with board and lodging.

(e) (i.) Employees working on a dredge when journeying from one port to another shall be paid eight shillings per day unless victualling and accommodation is supplied by the Minister. When victualling and accommodation are supplied by the Minister the following conditions shall be observed:—

(ii) The Minister shall supply for the use of the employee, all necessary utensils, to be of enamel or of a similar nature thereto, but not tin, free of cost to employee and also bedding consisting of mattress, pillow, and two blankets, and a third blanket to be supplied on application in cold latitudes: Provided that, in the event of an employee failing to return in good order any of such utensils or bedding as may have been issued to him, the Minister shall deduct any sum, being not more than seventy-five per cent. of the value of such utensils or bedding not returned, from any money due to such employee on the termination of the journey. The mattress supplied to be of flax or other fibre and not of straw or tow.

(iii) All necessary eating utensils and messing utensils, including washing clothes and drying towels, shall be supplied by the Minister prior to the commencement of the journey.

(iv) The accommodation provided for the employees shall be cleaned in the Minister's time each day during the journey.

(v) One towel and soap shall be provided by Minister for use by each employee each week during the voyage, free of cost, so long as the employee uses the towels reasonably and hands them back each week and subject to the conditions set out in Clause 11 (e) (ii).

(f) The Minister shall not be called upon to bear any expense in returning the employee to the port of engagement if he leaves his employment without permission or is dismissed for misconduct. In the event of a dispute regarding the application of this subclause it shall be settled by a board consisting of representatives of the Minister and Union and a chairman to be mutually agreed upon.

(g) Employees sent from their home port to duties in another port, if required to travel by train, shall be provided with second-class compartments, including second-class sleeping berths, if available. In such cases, travelling time during ordinary working hours up to a minimum of eight hours a day shall be paid, calculated at the ordinary rates of pay operating at the home port.

12.—Travelling Time.

All travelling time in excess of ten minutes each way between places of embarkment and disembarkment and the dredges shall be paid at ordinary time rates.

13.—Working in Water.

Any employee working in water shall be paid an allowance of 1s. per day or part of a day.

14.—Higher Duties.

Any worker carrying out work classified at a higher minimum than his ordinary rate for two hours in any one shift shall be paid the minimum rate for the whole of that shift: Provided that such minimum is not lower than such worker's regular rate of pay. If he be employed for less than two hours at work classified at a higher minimum than his ordinary rate he shall be paid his ordinary rate for the whole of that shift.

15.

Masters and engineers in the dredges shall be responsible for the time being correctly kept.

16.—Inspection of Dredges.

A representative of the Union may inspect the dredges covered by this Award in company with representatives of the Minister from time to time for the purposes of making requests regarding accommodation and the working conditions generally as far as they apply to the members of the Union.

17.—Board of Reference.

The Court appoints for the purposes of the Award a Board of Reference. The Board shall consist of a chairman and two other representatives nominated by the parties. There are assigned to such Board in the event of no agreement being arrived at between the parties to the Award, the functions of—

- (i) classifying and fixing wages, rates and conditions for any machine, occupation or calling not specifically mentioned in the Award;
- (ii) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of the Award or any of them;
- (iii) deciding any other matter that the Court may refer to the Board from time to time.

18.—District Allowance.

In addition to the wages prescribed in Clause 1 of this Award the following district allowance (daily) shall be paid to employees working in the undermentioned places:—

19.—Oilskins.

The Department will supply oilskins free of charge to all men compelled to work in exposed positions.

20.—Area.

This Award shall operate over the coastline of Western Australia, from and including Wyndham on the North to a point 20 miles East of Esperance in the South; and fifteen miles from the coastline.

21.—Definitions.

"Fremantle Harbour" shall mean the Fremantle Harbour, as at present defined under the Act relating thereto.

"Albany Harbour" shall mean the harbour of Princess Royal.

"Bunbury Harbour" shall mean the Bunbury Harbour as at present defined.

"Geraldton Harbour" shall mean Geraldton Harbour as at present defined.

"All other Ports in Western Australia" shall mean a limit of three (3) miles from the entrance.

"Home Port" shall mean the port of engagement.

AGREEMENT—HANDLING WHEAT, ETC., AT GERALDTON, ALBANY, BUNBURY AND ESPER- ANCE.

Registered 21st December, 1928.

No. 27 of 1928.

THIS Agreement, made in pursuance of "The Industrial Arbitration Act, 1912-1925," the 30th day of November, One thousand nine hundred and twenty-eight, between John Darling & Son; Louis Dreyfus and Company; Dalgety and Company, Limited; The Westralian Farmers, Limited; and Bunge Pty., Limited (hereinafter called "the Employers"), of the one part, and the Australian Workers' Union Westralian Branch Pastoral and Agricultural Industrial Union of Workers (hereinafter called "the Union"), of the other part: Witnesseth, that for the consideration hereinafter appearing the parties hereto mutually covenant and agree the one with the other as follows:—

1.—Area.

The Agreement shall apply to workers engaged in handling, lumping, and stacking of wheat, including sewing, re-bagging and laying dunnage inside of the Railway Yards at Geraldton, Albany, Bunbury and Esperance.

2.—Term.

This Agreement shall take effect as from the 30th day of November, 1928, and shall continue in force for a period of three years; provided that, at any time after the expiration of twelve months from this date, either party may make application to the other party to amend or vary this Agreement; provided that thirty days' notice is given by one to the other parties to the Agreement.

3.—Hours.

Forty-four hours shall constitute a week's work, and any time worked in excess of these hours shall be classified as overtime and paid for at overtime rates. The hours of work shall be from 8 a.m. to 12 noon and from 1 p.m. to 5 p.m. on the first five days of the week, and 8 a.m. to noon on Saturdays.

4.—Wages.

- (a) Basic wage of £4 5s. per week.
- (b) The rate of pay for wheat lumping or tally clerks shall be 3s. 3½d. per hour; when engaged handling sleepers to be used as dunnage, or sewing of bags, the rate shall be 2s. 6d. per hour.

5.—Overtime.

From 5 p.m. to 6 p.m., 4s. per hour; from 6 p.m. to 7 p.m., 6s. 9d. per hour; from 7 p.m. to 8 p.m., 4s. per hour; Saturday from 1 p.m., 4s. 9d. per hour.

6.—Holidays, Ordinary.

New Year's Day, Foundation Day, Easter Monday, Boxing Day, and King's Birthday.

7.—Holidays, Extraordinary.

Christmas Day, Good Friday, Labour Day, and Sunday.

8.—Meal Hours.

Breakfast from 7 a.m. to 8 a.m.—6s. 9d. per hour; dinner from 12 noon to 1 p.m.—5s. 11d. per hour; tea from 6 p.m. to 7 p.m.—6s. 9d. per hour. In cases where the work for the day commences at 7 a.m., the rate for the hour until 8 a.m. shall be ordinary overtime, viz., 4s. per hour; only in cases where the worker is employed prior to 7 a.m. in the forenoon shall the breakfast hour rate apply.

9.—Holiday Rates.

The rates of pay for work done on holidays shall be—extraordinary holidays—6s. 6d. per hour; ordinary holidays, 5s. per hour.

10.—Conditions.

When engaged handling wheat five men and a stacker shall constitute a gang; where an elevator is in use six men and a stacker.

When men are ordered to work, a minimum rate of two hours shall be paid for.

All men employed to be members of the A.W.U., if available.

Employees shall not carry wheat more than 12 bags in height.

Richey's corner, opposite the Freemasons' Hotel, shall be considered the place to pick up, in Geraldton, between the hours of 7.30 a.m. and 8.30 a.m. in the forenoon, and between the hours of 1 and 2 p.m. in the afternoon; all men engaged to commence work at the appointed hour.

11.—Rates.

The rates embodied in this Agreement are subject to variation as per the Waterside Workers' Federal Award.

In the event of a dispute arising the Agreement will be subject to the ruling of the Industrial Court.

THE INDUSTRIAL ARBITRATION ACT, 1912-1925.

No. 10 of 1928.

Between the W.A. Municipal Roads Boards, Parks and Racecourse Employees' Union of Workers, Applicant, and Perth City Council and others, Respondents.

Award of Industrial Board.

1.—Interpretations.

- (a) "Casual hand" shall mean a worker employed for less than six (6) consecutive working days.
- (b) "Overtime" shall mean all or any time worked on any one day or night in excess of the ordinary number of working hours.
- (c) "Roadman" shall mean a worker engaged forming or constructing roads or street surfaces, including footpaths.
- (d) "Wood blocker" or "cube layer" shall mean a worker who is setting or laying wood blocks or stone cubes.
- (e) The term "gardener" shall include men who do pruning, hedge cutting, or cutting grass with a scythe.
- (f) "Wet ground" shall mean ground in which, in the opinion of the engineer in charge of the particular work, it is impracticable for workers to work without getting wet feet.

2.—Hours of Labour.

- (a) Forty-four (44) hours shall constitute a week's work for all employees, except night watchmen or night stablemen, and attendants at public latrines. Such hours shall commence at the place of the particular work, and close at the place of the particular work.
- (b) The hours for night watchmen or night stablemen shall be seventy (70) per week of seven days.

(c) The hours for attendants at public latrines shall be fifty-six (56) hours per week of seven days.

(d) The hours of horse drivers shall commence when an employee signs on at the yard or depot in the morning and finish when he signs off on leaving in the evening.

(e) Except where otherwise specified, a week's work shall consist of forty-four (44) hours, and shall be worked in five and a half days.

3.—Overtime.

Overtime shall be paid for at the rate of time and a half, provided that—

(a) Sunday time shall be paid at the rate of double time, except in the case of sanitary employees caretakers, stablemen, watchmen, and attendants at public latrines. Any sanitary work done on Saturday night shall be paid for at the rate of time and a half.

(b) Any employee called upon to work on Christmas Day, Boxing Day, New Year's Day, Anniversary Day, Good Friday, Easter Monday, Anzac Day, Labour Day, and Union Picnic Day shall be paid at the rate of double time.

(c) Any worker whose duty is ordinarily performed between 6 o'clock a.m. and 6 o'clock p.m., who is called upon to work between 6 p.m. and 6 a.m., or any worker whose duty is ordinarily performed between 6 p.m. and 6 a.m., who is called upon to work between 6 a.m. and 6 p.m., shall receive not less than two hours' pay at overtime rates.

4.—Holidays.

(a) The days on which New Year's Day, Anniversary Day, Union Picnic Day, Good Friday, Easter Monday, Anzac Day, Labour Day, Christmas Day, and Boxing Day are observed shall be holidays, and paid for as such.

(b) In addition to the above, six days' annual leave on full pay shall be allowed to all workers under this Award who have been twelve consecutive months in the service of the Council, except night watchmen or night stablemen and attendants at public latrines, who shall be allowed fourteen (14) days' annual leave on full pay. Such leave shall be taken at such time as the Head of the Department may decide, but at least fourteen (14) days' notification of such decision shall be given to the worker.

(c) All employees, after one month's service, shall be entitled to the holidays set out in the preceding paragraph in proportion as the length of service is to the full number of holidays for the twelve months.

(d) Workers who have been in the employment of the Council for twelve months preceding the date of their annual leave shall be allowed a further leave of six days, without pay, if they so request.

5.—Wages.

With the exception of the workers mentioned hereunder in Subclauses (a), (b) and (c), whose contract of service shall be a weekly one, the contract of service of all other workers in the following schedule of wages shall be a daily one:—

6.—Conditions.

Men engaged on tar or bitumen work, 1s. per day extra. This rate shall also apply to the men sweeping the roads prior to tarring.

Men engaged working in wet ground, 1s. per day extra.

Concretors shall be paid 1s. per day extra.

Casual hands shall be paid 1s. per day in addition to the rate provided for the particular class of work on which they are employed.

Men engaged operating the tar spraying pressure machine shall receive 2s. per day extra.

Men cleaning bitumen tank or boiler shall be paid three shillings (3s.) per day extra when so employed.

Stone crusher: Where no appliances are provided for preventing dust, workers employed on stone crushers shall be paid 1s. 6d. per day extra.

Workers using slag in building or repairing roads shall be paid 1s. per day in addition to their ordinary rate.

Tar mixers and tar boilers shall be paid one shilling per day in addition to their ordinary work.

Relief: Any worker temporarily employed relieving another worker shall not be reduced in wages whilst so employed.

Wood block and cube layers shall be paid one shilling (1s.) per day extra in addition to the minimum rate.

Men employed behind the wood block tarring machine shall receive one shilling (1s.) per day in addition to the tar allowance.

Men required to throw with a shovel metal or other material more than six feet into a wagon shall be paid one shilling per day in addition to their ordinary rate.

Men engaged in drying or screening metal shall receive one shilling (1s.) per day extra.

7.—Casual Workers.

If worker be employed at any of the designations in (a), (b), or (c) of the wages schedule for less than six consecutive working days he shall be deemed to be a "casual" and shall be paid one shilling a day in addition to the proportionate rate provided for the class of work he performs.

8.—Drivers.

(a) Drivers who, in addition to the hours of which the working week is composed, are required to feed horses shall be paid the following rates in addition to the weekly wage:—

During the six (6) working days of the week, 3s. per horse;

For Sundays, 2s. for one horse, and 1s. 6d. for every additional horse.

Leading hands in charge of not less than three or not more than ten men shall be paid fifteen shillings (15s.) per week in advance of the workers whose work they direct. Leading hands in charge of more than ten men shall receive £1 per week in advance of the men whose work they direct.

9.—Performing Higher Duties.

Employees called upon to perform a duty for which a higher rate is provided than that which they are ordinarily in receipt of shall be paid for the day such higher rate if so employed for one hour or more in any one day.

10.—Aged and Infirm Workers.

Any worker who through old age or infirmity is unable to earn the prescribed minimum wage may be employed at such lesser rate as may be agreed upon as between the employer and the President and Secretary of the Union.

10.—Travelling Allowance.

Workers required to walk more than a mile and a half from the yard or depot shall be provided with travelling facilities or reimbursed any tram or train fares necessarily incurred.

11.—Record Book.

The employers shall keep a record book of the name of each employee, the time he starts and finishes work each day, total number of hours worked, overtime worked, and wages paid to each employee.

Such record shall be open to the inspection of the secretary of or other person appointed by the workers' Union during working hours.

12.—Leave of Absence to Officers.

For the purpose of this Award leave of absence from duty without prejudice shall be granted to the president or secretary without pay: Provided that they shall first find satisfactory substitutes if so required by the Head of their Department.

13.—Scope of Award.

This Award shall apply to workers eligible to belong to the applicant Union directly or indirectly employed by the Perth City Council and other Local Governing Bodies in the work to which the Award relates.

14.—Interpretation of Award.

Any dispute arising as to the interpretation of this Award shall be referred for settlement to a Board consisting of the Chairman of this Board and one representative of the Union and one representative of the Local Governing Bodies concerned.

15.—Term of Award.

This Award shall commence from 21st December, 1928, and remain in force for a period of three years. Provided that either party may at any time after the expiration of one year from its date apply to the Court or to this Board to alter, amend, or revise the same.

16.—Area.

This Award shall apply to the area contained within a radius of twenty-five miles from the General Post Office at Perth and to the Townsite of Northam.
