WHEREAS by Section 122, Subsection (1) of "The Health Act, 1911-19," it is provided that no building shall be erected within any Municipal district unless and until plans and specifications thereof have been submitted by the owner or occupier to and have been approved in relation to ventilation, lighting, and sanitary construction, and also as to the area of the open space appurtenant to such building by the Local Authority; and whereas under Subsection (2) of Section 122 the Governor may from time to time declare by Proclamation that Subsection 1 of the said section shall apply in any other district or in any portion of any other district, and may at any time revoke any such Proclamation, and while such declaration remains in force Subsection 1 of the said section shall apply in any such district, or portion of such district, as if it were a Municipal District: Now, therefore I, the said Lieut. Governor, acting by and with the advice and consent of the Executive Council, do hereby by this Proclamation declare that Subsection 1 of Section 122 shall apply to South Perth Health District.

WHEREAS by Section 8 of "The Fisheries Act, 1905-21," it is provided that the Governor may by Proclamation prohibit all persons from taking any fish whatsoever by any specified means of capture in any specified portion of Western Australian waters during a specified portion of every year: And whereas it is desirable to revoke the Proclamation under this Act dated the 29th day of August, 1928, and published in the *Government Gazette* of the 31st August, 1928, and to prohibit the taking of fish by means of fishing nets in the waters described in the Schedule hereto during a specified portion of every year: Now, therefore I, the said Lieut.-Governor and Administrator, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid, and of every other power enabling me in this behalf, revoke the said Proclamation, and do hereby prohibit all persons from taking any fish whatsoever by means of fishing nets in the said waters, being the waters described in the Schedule hereto, from the date of the publication of this Proclamation in the *Government Gazette* until the 31st day of December, 1929.

WHEREAS by Section 8 of "The Fisheries Act, 1905-21," it is provided that the Governor may by Proclamation prohibit all persons from (a) taking fish of any specified species by any specified means of capture; (b) taking any fish whatsoever by any specified means of capture; (c) taking any fish whatsoever by any means of capture whatsoever in any specified portion of Western Australian waters during any specified time in any specified year, or during a specified portion of any year: Now, therefore I, the said Lieut.-Governor and Administrator, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid, and of any other powers enabling me in this behalf, proclaim and declare—

That in lieu of paragraph (5) of the Proclamation under the said Act published in the *Gazette* on the 14th day of December, 1928 (which paragraph is hereby repealed), the following paragraph shall have effect:—

(5) That all that portion of Western Australian waters defined in the Fifth Locality Schedule hereunder shall be closed against the use of fishing nets as from the 21st day of March, 1929, until the 31st day of December, 1929, inclusive; provided that, subject to certain provisions (*vide* separate Proclamation), it shall be lawful to fish within the waters of the Leschenault Estuary North of a line drawn from the South-Eastern corner of Leschenault Location 24 to the North-Western corner of Leschenault Location 31 between the hours of twelve o'clock noon on Monday to twelve o'clock noon on Tuesday, and from twelve o'clock noon on Thursday to twelve o'clock noon on Friday in each week.

Fifth Locality Schedule.—The whole of the waters of Leschenault Estuary (Bunbury).

The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 261/29.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works, and stormwater drainage works; and whereas it is further provided that the Governor may exempt reticulation works from certain sections of this Act: Now, therefore, His Excellency the Lieut.-Governor and Administrator, with the advice of the Executive Council, hereby approves of the construction and extension by the Minister for Water Supply, Sewerage, and Drainage of the following works under the said Act, and does hereby exempt such works from the operations of Sections 20, 21, 22 and 23 of the said Act:—

Description and Location of Reticulation Works Approved and Exempted.—Metropolitan Reticulation Main Extension.—Claremont Road District.—Proposed four-inch diameter cast-iron water main commencing at the existing four-inch main in Jutland Parade opposite Lot 16 and proceeding thence in a Westerly direction along Jutland Parade to a point opposite Lot 24 (length about sixteen chains).

The above main to be complete with hydrants and all necessary apparatus, as shown in red on Plan M.W.S., S., & D.D. No. 4912.

This Order in Council shall take effect from the 22nd day of March, 1929.

The Traffic Act, 1919-26.

Dumbleyung Road Board.

ORDER IN COUNCIL.

P.W. 677/27.

WHEREAS under the provisions of "The Traffic Act, 1919-26" the Governor may by Order in Council empower a local authority to exercise within its district any power of making regulations which the Governor can exercise under Division 4 of Part IV. of the said Act: And whereas it is desirable to empower the Dumbleyung Road Board to prohibit the passage of heavy traffic over specified roads within its district and to define what shall be deemed heavy traffic for such purpose; Now therefore, His Excellency the Lieut.-Governor and Administrator, by and with the advice and consent of the Executive Council, under the provisions of the said Act and all other powers enabling him in this behalf, doth hereby empower the Dumbleyung Road Board, by the By-law in the Schedule hereto, to prohibit the passage of heavy traffic over specified roads within its district, and to define what shall be deemed heavy traffic for such purpose, and to impose a penalty of not exceeding £20 for the breach thereof.

THE TRAFFIC ACT, 1919-26.

Dumbleyung Road Board.—By-law.

The Dumbleyung Road Board, pursuant to an Order in Council under Section 43 of "The Traffic Act, 1919-26," and in exercise of the power thereby conferred, doth hereby make the following By-law, to have effect in the Dumbleyung Road District:—

The passage of all vehicles engaged in heavy traffic over roads as set out in the schedule below within the Dumbleyung Road District is hereby prohibited during the period 1st May and the 31st October in every year:—

Schedule.

(1) Katanning-Dumbleyung Road. Commencing at the South-West corner of Reserve 6665; thence in a general Northerly and North-Easterly direction to a point where it enters the Dumbleyung Townsite at the North-West corner of Williams Location 3733.

(2) Wagin-Lake Grace Road: Commencing at the West side of Nippering Townsite; thence generally Easterly through Dumbleyung Townsite; thence East and North-Easterly through the 118-mile Gate, Rabbit Proof Fence, past Kukerin Townsite to Tarin Rock Sid-ing.

For the purpose of this By-law heavy traffic means all motor vehicles fitted with other than pneumatic tyres, the weight of which, including the load, exceeds four tons.

Any person who commits a breach of this By-law shall be liable on conviction to a penalty of not exceeding £20.

THE MUNICIPAL CORPORATIONS ACT, 1906, AND THE CITY OF PERTH ENDOWMENT LANDS ACT, 1920.

The City of Perth.—Amendment of By-law 44.

P.W. 12/28.

IN pursuance of the powers in that behalf contained in Part VII. of "The City of Perth Endowment Lands Act, 1920," and "The Municipal Corporations Act, 1906," the City of Perth doth order that By-law No. 44 be amended by the addition thereto of the following clauses:—

27. No advertising hoarding shall be erected upon the Reserve.

28. The following portion of the Reserve is classified as a residential district, namely, the land bounded on the South-West by Challenger Drive, on the North-West and North by The Boulevard, on the East by Templetonia Crescent, and on the South by a line following Kingsland Avenue from Templetonia Crescent West to Boronia Crescent, thereafter following the Southern boundaries of the building lots fronting Kingsland Avenue to Hesperia Avenue, and thereafter following Hesperia Avenue to Challenger Drive.

29. The following portions of the Reserve are classified as business districts, namely:—

(a) the land bounded by Ocean Drive, Challenger Drive, and a continuation West of Lowanna Way;

(b) the land bounded by Ocean Drive, The Boulevard, and a continuation West of Dampier Avenue.

30. No building shall be erected on the Reserve which in the opinion of the Council would be unsuitable in the place where it is intended to erect the same, or which in the opinion of the Council would tend to destroy local amenities there.

31. No building shall be erected in a classified residential district other than a building intended for the purpose of such district and of which the plans shall have been approved by the Council.

32. No fence, wall or hedge on or near a street alignment shall be of greater height than 4ft. 6in. above the street level.

33. No sub-division of a lot or of an area comprising less than three adjacent lots shall be effected within a classified residential district. An area comprising three or more adjacent lots may with the consent in writing of the Council be sub-divided provided that in no case shall a lot be formed having less than 60 feet frontage and 132 feet depth.

34. No semi-detached residence and no terrace of residences shall be erected within a classified residential district.

35. Not more than one building with the usual offices and out-buildings shall be erected on any one lot within a classified residential district.

36. Every residence within a classified residential district shall front the street adjoining the land on which it is erected provided that if such land shall adjoin two or more streets such residence shall front the street which shall in each particular case be specified by the Council.

37. Every building within a classified residential district shall conform to the building line prescribed for that district by the Council and in no case shall such building line be nearer than 25 feet to the street frontage.

38. No private motor garage shall be erected within a classified residential district except in a position approved by the City Building Surveyor and the front alignment of such garage shall not in any case be nearer to the street frontage than is the front alignment of the residence erected on the same lot.

39. All buildings, outbuildings, fences, and other erections within a classified residential district shall be of modern design and shall before erection be approved as to the position, material, plan and design by the Council.

40. No residence which with offices and outbuildings shall cost less than £800 shall be erected within a classified residential district.

41. All houses shall be constructed of brick, concrete, stone, or similar material within a classified residential district.

42. All buildings, outbuildings, fences, and other erections shall be wholly completed in accordance with the approved plans and specifications within 12 months of the granting of such approval; in default of which the Council may withdraw such approval and it shall be as if such approval had never been granted.

43. The plans and specifications for a residence to be erected within a classified residential district shall not be approved if they are exactly or nearly similar to the plans and specifications of a residence already approved for erection on an adjoining lot.

44. All residences within a classified residential district shall be roofed with slates, tiles, or shingles.

45. No advertisement of any kind shall be painted on or affixed to any land or erection within a classified residential district.

46. No plans and specifications for a residence within a classified residential district shall be approved unless a septic tank is therein provided for such residence.

47. All buildings within a classified business district shall be of brick, stone, or concrete.

48. Not more than two shops and not more than one residence in addition to such shop or shops shall be erected on any one lot within a classified business district.

49. No advertisements or signs shall be exhibited within a classified business district, except in accordance with the By-laws of the City of Perth.

50. No plans and specifications for a shop or residence within a classified business district shall be approved unless a septic tank is therein provided for such shop or residence.

51. Where anything by this By-law is directed to be done or forbidden to be done, or where authority is given to any officer to direct anything to be done or to forbid anything to be done, and such act so directed to be done remains undone, or such act forbidden to be done is done, in every such case the person making such default as to such direction and prohibition respectively shall be deemed guilty of a breach of this part of this By-law. And every person guilty of a breach of this part of this By-law shall be liable for every such offence, besides any costs which may be incurred in the taking of proceedings against such person guilty of such offence, as well as any costs or expenses which may be incurred in the execution of the work directed to be so executed and not so executed, to a penalty not exceeding Twenty pounds for every breach of any such By-law, or to a penalty not exceeding Two pounds for each day during which such breach shall be committed or continued.

ENGINE-DRIVERS (BREWERIES).

(Registered 7th March, 1929.)

No. 6 of 1929.

THIS Agreement, made in pursuance of "The Industrial Arbitration Act, 1912-25," this 4th day of March, One thousand nine hundred and twenty-nine, between the Swan Brewery Company, Limited; the Emu Brewery Company, Limited, and the Redcastle Brewery, Limited, all of Perth and Fremantle Districts (hereinafter in these presents called "the Employers"), of the one part, and The Federated Engine-drivers and Firemen's Association of Australasia (West Australian Branch) Association of Workers, being an Industrial Association of Workers registered under the provisions of "The Industrial Arbitration Act, 1912-25." Whereby it is mutually agreed by and between the parties hereto that the several stipulations, conditions, and provisions set out herein shall in all cases be binding upon and shall be faithfully and promptly carried out, observed, performed, and complied with according to the true intent and meaning thereof, by the parties hereto.

1.—Definitions.

For the purpose of this Agreement "The above-mentioned Companies" shall mean the "Employers," and the "Association" shall mean the Federated Engine-drivers and Firemen's Association (West Australian Branch).

(a) "Engine Driver" shall mean and include any person who operates or drives any engine or engines the motive power of which is either steam, gas, air, oil, water, compressed air, or electricity.

(b) "Fireman" shall mean any person employed in a stoke hole, attending a steam boiler or suction-gas generator.

(c) "Greaser" shall mean an employee who is employed mainly in oiling engines or shafting, and who assists the engine-driver as required.

2.—Schedule.

The parties to this Agreement mutually agree that the minimum rate of wages that shall be paid by the employers respectively to the persons employed by such employers in the capacities undermentioned is as follows:—

Engine-drivers, firemen, or greasers who shall be employed on boiler cleaning work shall receive an additional 1s. per hour in addition to his ordinary or overtime rate of pay.

3.—Hours.

Forty-four hours, consisting of eight hours per day from Mondays to Fridays inclusive and four hours on Saturdays, shall constitute a week's work for engine-drivers, firemen, and greasers, who shall commence work not before 5 a.m. on any day, and the employer may require any engine-driver, fireman, or greaser to start work at any time after that time, but such work shall not be less than eight hours per day from Mondays to Fridays inclusive and four hours on Saturdays, so that each engine-driver, fireman, and greaser shall work forty-four hours from Monday to Saturday in every week. Where one shift only is worked such shift shall begin not later than eight a.m.

4.

In all cases, in reckoning the time of duty, any time necessarily occupied in raising steam, in starting up, or closing down engines, or in banking fires, shall be included.

5.—Overtime.

If any employee works earlier than his starting time, or later than his quitting time, he shall be paid overtime at the rate of time and a half. Each day to stand alone.

6.—Record Book.

Each Company shall keep a record of the name of each employee, the time he starts and finishes each day, total number of hours worked, overtime worked, wages paid to each employee, and such record book shall be open to the inspection of the Secretary of or any other person appointed by the employees' Union during working hours. Each employee shall sign the record book kept for all moneys received by him.

7.—Sundays.

All work performed on Sundays shall be paid for at the rate of double time.

8.—Holidays.

All holiday shifts to rotate. If no work be done, the ordinary rates shall be paid for holidays. If work is performed on a holiday, ordinary rates shall be paid in addition. The days to be observed as holidays, according to the provisions of this Agreement are:—Christmas Day, Good Friday, New Year's Day, Eight Hours' Day, Show Day, Easter Monday, Sovereign's Birthday, Annual Picnic Day, Boxing Day, the 26th January, and Anzac Day.

9.—Annual Leave.

Two weeks' annual leave on full pay shall become due to workers with twelve months' service, such leave to be taken at times to be mutually agreed on between the employees and employer, between the 30th April and 30th September in each year, in addition to the holidays enumerated above. Temporary hands with less than twelve months' service on retirement shall receive proportion of two weeks' holiday equivalent to eight hours' pay per month of service.

Relieving engine-drivers and firemen shall be paid for annual holidays *pro rata* to the length of time they have been employed on the higher rates.

10.

The engagement between the employer and employees, except casual hands, shall be weekly, a week's notice from either party to terminate same, except in case of the employee absenting himself without leave, not obeying lawful commands, or being guilty of misconduct, or of the works of the employer being stopped through fire or tempest, when such agreement may be terminated immediately.

11.

Any employee, being unable through sickness or accident to attend to his duties, shall notify the employer not later than 10 a.m. on the day he first absents himself from duty, and he shall also satisfy the employer that he is unable to attend to his duties, and if called upon shall provide a medical certificate that he is unfit to perform his work through sickness.

12.

All employees on day shift, engaged in or about a Brewery or Bottling Works, shall, if required to work more than one (1) hour's overtime after 5 p.m., knock off between 5 p.m. and 6 p.m. for refreshments.

13.—Area.

This Agreement shall apply to all workers engaged in the Brewing Industry as engine-drivers, firemen, and greasers in the South-West Land Division in the State of West Australia, exclusive of a radius of five miles from the Post Office, Merredin.

14.—Term of Agreement.

This Agreement shall operate from the twentieth day of November, One thousand nine hundred and twenty-eight, and shall remain in force for three (3) years from that day: Provided that either party shall have a right to apply for amendment after the expiration of twelve months, and provided that the rates of pay will be subject to amendment in accordance with "The Industrial Arbitration Act Amendment Act, 1912-25."

Between Coastal Dock, Rivers, and Harbour Works' Union of Workers, Applicant, and the Hon. the Minister for Works, Respondent.

THE Court of Arbitration of Western Australia doth hereby make the following Award in connection with the Industrial Dispute between the abovenamed parties:—

Award.

1.—Wages.

2.—Engagement and Dismissal.

Notwithstanding that the rate of pay is fixed on a weekly basis, it is hereby agreed that if in the case of any employee for any reason whatever during any portion of the working hours of any week no work is available or performed the employee will only be paid for the time actually worked at the rate of pay as above prescribed (per week of 44 hours) apportioned to the time actually worked during the week: notwithstanding the rate of pay is fixed on a weekly basis there shall be no obligation on the part of the Minister or the employee to give a week's notice to determine the employment, that is to say, the existing practice will continue to be observed.

Twenty-four hours' notice on either side shall be sufficient to terminate an engagement provided that in case of drunkenness on duty, or refusal of duty, the employee may be summarily dismissed.

3.—Preference.

(a) Preference shall be given to members of the Coastal Dock River and Harbour Works Union of Workers over non-members provided there are available at the port where the work is offering, members of the Union bearing good records and qualified to perform the work to be done.

(b) Preference then to be given to members of Union who are available at the port where the work is offering, bearing good records and qualified to perform the work to be done.

(c) Provided that all employees who may be employed on dredges, covered by this Award shall join the Coastal Dock Rivers and Harbour Works' Union of Workers not later than the second full pay after commencing work thereon.

4.—Hours.

(a) The ordinary working hours for employees other than those who may be required to work seven days per week shall not exceed eight (8) hours for the first five days in the week and four (4) hours on Saturdays.

(b) When a dredge is commissioned to work two or more shifts the hours of work in each week may be varied by the Minister to the extent that the hours may be forty, forty-four, or forty-eight per week: Provided that the average hours worked shall not exceed forty-four per week, and further provided, that operations for the week shall cease not later than twenty minutes past noon on Saturday.

(c) In any week in which a holiday occurs the number of working hours shall be reduced by eight hours for such holiday.

Time shall be counted when the men are actually working or when the dredges are under way. It is agreed that stationary dredges shall not be considered under way.

5.—Meal Hours.

The present practice whereby a dredge operates continuously in eight-hour shifts without cessation for a recognised meal hour shall continue: Provided that, during each shift, reasonable time shall be allowed each worker to have his meal, and to enable this to be done, employees shall relieve each other during such meal hours as at present.

6.—Overtime.

(a) All time worked outside of or in excess of the usual working hours shall be paid at the rate of time and a half for the first four hours after the usual stopping time and double time thereafter: Provided that the employee required to commence work within one and a half hours before the usual starting time shall be paid time and a half to the usual starting time.

(b) If the Minister requires an employee to work on Sunday, Good Friday, Easter Monday, Labour Day, Christmas Day, Boxing Day, New Year's Day, or Picnic Day, such employee shall be paid at the rate of double time, except in the case of watchmen, who shall take such days as ordinary shift days.

(c) When an employee is recalled to work after leaving his job he shall be paid at least two hours overtime.

7.—Holidays.

(a) Twelve paid holidays per annum will be granted all employees: Provided always, that the following days: Good Friday, Easter Monday, Labour Day, Christmas Day, Boxing Day, and New Year's Day shall be taken as they come as portion of the holidays; the balance of six days to be granted as annual leave, at the convenience of the Department. Payment for holidays shall be made in accordance with the usual hours of work.

(b) Every worker, after one month's continuous service, shall be entitled to holidays in proportion as the length of service is to the full number of holidays for the 12 months.

(c) (1) Approved periods of absence owing to sickness shall not be considered breaks in continuity of service, but such periods shall not qualify for holidays.

(2) Approved periods of absence from work through accident sustained in the course of the Department's employment, up to a maximum of one month in any one period, shall not break continuity of service for the purpose of computing holidays. For approved periods of absence exceeding one month the provisions of Subclause (c) (1) shall apply.

(d) Holiday pay shall be at the rate the worker is in receipt of at or immediately prior to the holiday being taken.

8.—Casual Workers.

A casual worker is one for whom work over a longer period of twelve consecutive days is not provided by the employer, not including holidays, and such casual worker shall be entitled to an increase of 10 per cent. over the ordinary wage.

9.—Conveyance of Employees.

Employees shall be conveyed by the Minister free of charge from and to the recognised landing stages to and from the dredge.

10.—Detention on Dredge.

When the working conditions are such that the Minister requires an employee to remain on board the dredge from Monday to Friday or Saturday, he shall supply eating and cooking utensils and a cook, but the employees shall find their own food, and, in addition, the monthly allowance of five shillings shall be paid all ratings in lieu of bedding when the latter is not provided.

11.—Sustenance Allowance.

(a) In places where an employee is transferred to another port for a period exceeding six months, he may be required by the Minister to accept free transport for himself, wife, family, and effects, with an allowance of £4 for married employees and 15s. for single men in lieu of allowance set out hereunder. If required to travel

by train "free transport" shall in these cases include second-class sleeping berths, if available, for employee, wife, and family.

(b) Employees transferred for a period exceeding three months, but which is not expected to exceed six months, shall be paid a weekly allowance of twenty-five shillings (25s.) in lieu of transfer or lodging allowance to cover the excess cost of living while away from home.

(c) Employees working away from their home port other than those mentioned, shall be paid at the rate of 8s. per day for the first seven days and thereafter 6s. per day until returned thereto, unless victualling and accommodation is paid by the Minister.

(d) Employees absent from their place of abode on duty in their home port for a period exceeding twenty-four hours shall be paid five shillings for the first twenty-four hours and eight shillings for each subsequent twenty-four hours, or be provided with board and lodging.

(e) (i.) Employees working on a dredge when journeying from one port to another shall be paid eight shillings per day unless victualling and accommodation is supplied by the Minister. When victualling and accommodation are supplied by the Minister the following conditions shall be observed:—

(ii) The Minister shall supply for the use of the employee, all necessary utensils, to be of enamel or of a similar nature thereto, but not tin, free of cost to employee and also bedding consisting of mattress, pillow, and two blankets, and a third blanket to be supplied on application in cold latitudes: Provided that, in the event of an employee failing to return in good order any of such utensils or bedding as may have been issued to him, the Minister shall deduct any sum, being not more than seventy-five per cent. of the value of such utensils or bedding not returned, from any money due to such employee on the termination of the journey. The mattress supplied to be of flax or other fibre and not of straw or tow.

(iii) All necessary eating utensils and messing utensils, including washing clothes and drying towels, shall be supplied by the Minister prior to the commencement of the journey.

(iv) The accommodation provided for the employees shall be cleaned in the Minister's time each day during the journey.

(v) One towel and soap shall be provided by Minister for use by each employee each week during the voyage, free of cost, so long as the employee uses the towels reasonably and hands them back each week and subject to the conditions set out in Clause 11 (e) (ii).

(f) The Minister shall not be called upon to bear any expense in returning the employee to the port of engagement if he leaves his employment without permission or is dismissed for misconduct. In the event of a dispute regarding the application of this subclause it shall be settled by a board consisting of representatives of the Minister and Union and a chairman to be mutually agreed upon.

(g) Employees sent from their home port to duties in another port, if required to travel by train, shall be provided with second-class compartments, including second-class sleeping berths, if available. In such cases, travelling time during ordinary working hours up to a minimum of eight hours a day shall be paid, calculated at the ordinary rates of pay operating at the home port.

12.—Travelling Time.

All travelling time in excess of ten minutes each way between places of embarkment and disembarkment and the dredges shall be paid at ordinary time rates.

13.—Working in Water.

Any employee working in water shall be paid an allowance of 1s. per day or part of a day.

14.—Higher Duties.

Any worker carrying out work classified at a higher minimum than his ordinary rate for two hours in any one shift shall be paid the minimum rate for the whole of that shift: Provided that such minimum is not lower than such worker's regular rate of pay. If he be employed for less than two hours at work classified at a higher minimum than his ordinary rate he shall be paid his ordinary rate for the whole of that shift.

15.

Masters and engineers in the dredges shall be responsible for the time being correctly kept.

16.—Inspection of Dredges.

A representative of the Union may inspect the dredges covered by this Award in company with representatives of the Minister from time to time for the purposes of making requests regarding accommodation and the working conditions generally as far as they apply to the members of the Union.

17.—Board of Reference.

The Court appoints for the purposes of the Award a Board of Reference. The Board shall consist of a chairman and two other representatives nominated by the parties. There are assigned to such Board in the event of no agreement being arrived at between the parties to the Award, the functions of—

- (i) classifying and fixing wages, rates and conditions for any machine, occupation or calling not specifically mentioned in the Award;
- (ii) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of the Award or any of them;
- (iii) deciding any other matter that the Court may refer to the Board from time to time.

18.—District Allowance.

In addition to the wages prescribed in Clause 1 of this Award the following district allowance (daily) shall be paid to employees working in the undermentioned places:—

19.—Oilskins.

The Department will supply oilskins free of charge to all men compelled to work in exposed positions.

20.—Area.

This Award shall operate over the coastline of Western Australia, from and including Wyndham on the North to a point 20 miles East of Esperance in the South; and fifteen miles from the coastline.

21.—Period.

The currency of this Award shall be for three years from date hereof: Provided that, after the expiration of twelve months from the date hereof, the Court may amend or revise the Award on the application of any party or persons affected by its provisions.

22.—Definitions.

"Fremantle Harbour" shall mean the Fremantle Harbour, as at present defined under the Act relating thereto.

"Albany Harbour" shall mean the harbour of Princess Royal.

"Bunbury Harbour" shall mean the Bunbury Harbour as at present defined.

"Geraldton Harbour" shall mean Geraldton Harbour as at present defined.

"All other Ports in Western Australia" shall mean a limit of three (3) miles from the entrance.

"Home Port" shall mean the port of engagement.

Regulations.

1. (a) Free instruction will be given to male and female students, between the ages of 14 and 18 years, who are not attending day schools. They must attend not less than two classes a week, provided that students under 18 who require only one subject to complete the Pass Out Certificate may be permitted to attend for one night a week.

(b) Day school scholars over 14 years of age in the VII. or VIII. class may attend, provided that no facilities for the teaching of the subjects required are afforded in the State School during the day time.

(c) Children under 14 who have obtained exemption from attendances at day schools may be admitted.

(d) In centres where there are no Technical Classes students between the ages of 18 and 21 at the date of entry may be granted free tuition for the remainder of the year under the conditions laid down in (a).

(e) Students over 21 may be admitted on payment of a fee of 10s. per class per term. A student joining a class after the commencement of a term may be charged a proportionate fee for the remainder of the term provided that he pays at the same time a full fee for the next term. For advanced instruction in certain subjects higher fees may be charged.

All fees must be paid in advance.

2. (a) Each class term will consist of eleven lessons of two hours each.

(b) English will, as a rule, be a compulsory subject for students under the age of 18.

(c) If a student is absent for more than three consecutive meetings of any class, his name must be crossed off the roll. If subsequently he gives a satisfactory reason for his absence, he may be re-admitted. The reasons must be given in writing, and must be filed and retained.

(d) Students whose attendance is irregular or whose conduct is unsatisfactory may be required to leave at any time.

(e) Each student will be expected to confine his subjects to one of the following groups:—Preliminary, Commercial, Industrial, Domestic, Science; provided that the Director of Education shall have power to allow a relaxation of this rule where special circumstances have to be considered.

(f) Students will be classified by the Headmaster as Preliminary, 1st year or 2nd year, according to their attainments or other information available.

3. No class may be commenced without the permission of the Department.

4. Evening Continuation Schools will be classified as follows:—

A Headmaster of a Class IV. or Class Vb. School, to receive the above salary, will teach one class. Headmasters of Schools of Class Va. or Class VI. will teach

two classes. If a Headmaster does not desire to teach, his salary will be reduced accordingly. Headmasters will not be allowed to teach a greater number of classes than those mentioned above. Headmasters of Schools of Classes I.-III. will not be eligible for posts as class teachers.

Note.—In places where a district allowance is paid, the Headmaster's remuneration, as shown in the scale above, shall be increased by an amount of 1s. 8d. for each class taught.

Payment will be made for 36 weeks in the year. Head Teachers must give at least two months' notice of intended resignation. When full notice is not given, pay may be forfeited at the discretion of the Minister.

6. The remuneration of instructors will be, as a rule, 13s. 4d. per lesson of 2 hours, except that in places where a district allowance is paid, the remuneration will be 15s. per lesson of 2 hours. For advanced instruction in certain subjects higher rates may be paid.

7. The remuneration of cleaners shall be in accordance with the following scale:—

Up to 5 classes—	5s. per week for 36 weeks.
6 to 10 classes—	6s. per week for 36 weeks.
11 to 15 classes—	7s. 6d. per week for 36 weeks.
16 to 20 classes—	10s. per week for 36 weeks.
21 to 25 classes—	12s. 6d. per week for 36 weeks.
Over 25 classes—	15s. per week for 36 weeks.

8. Students who complete any full course and pass the examination set by the Department will receive a Pass Out Certificate. Students who gain a Pass Out Certificate will be granted free admission to the Perth Technical College, or to the Technical Schools at Fremantle, Midland Junction, or Boulder.

9. Returned soldiers, widows and children of fallen soldiers, wives and children of incapacitated soldiers, winners of Government scholarships and bursaries, and students specially exempted by the Hon. the Minister, will be exempt from the payment of fees.
