## Morawa Road Board.

## ORDER IN COUNCIL.

## Central Ward.

The Vermin Act, 1918.

#### ORDER IN COUNCIL.

WHEREAS it is enacted by Section 14 of "The Vermin Act, 1918," that the Governor may by Order in Council constitute any defined portion of the State a Vermin District for the purposes of the said Act, and specify the boundaries of any such district, and also by Section 45 of the said Act that the Governor may appoint the Board of any Road District to be the Board of any Vermin District the boundaries whereof are the same as those of the Road District: And whereas it is deemed expedient to constitute that portion of the State now constituted and known as Three Springs Road District and comprised within the boundaries of such District a Vermin District, for the purposes of "The Vermin Act, 1918," to be known as "Three Springs Vermin District"; and also to appoint the Board of the said Three Springs Road District the Board of the said Three Springs Vermin District: Now, therefore, His Excellency the Lieut.-Governor and Administrator, acting with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act, doth hereby constitute all that portion of the State now constituted and known as Three Springs Road District, and comprised within the boundaries thereof, a Vermin District for the purposes of "The Vermin Act, 1918," to be known as "Three Springs Vermin District," and doth hereby appoint the Board of the said Three Springs Road District to be the Board of Three Springs Vermin District, hereby constituted as aforesaid, for the purposes of the said Act.

CHANNEL ACROSS SUCCESS BANK BETWEEN  
GAGE ROADS AND OWEN ANCHORAGE.*Channel Re-surveyed and Re-marked.**Notice to Mariners.*

THE Fremantle Harbour Trust Commissioners notify, for the information of those navigating vessels through the channel (known as The Naval Base Channel) dredged through the Success Bank between Gage Roads and Owen Anchorage, in the Outer Harbour of Fremantle, that this channel has recently been completely re-surveyed, sounded and re-marked.

This channel is approximately one mile and eight cables in length by an approximate width of 300 feet, except at one spot which is marked by piles, where the banks of the channel approach to a width of approximately 200 feet.

The channel has in it a sufficient depth of water to enable it to be navigated by vessels of a maximum draft not exceeding 17 ft. 6 in., in a smooth sea.

The course through the channel is South 9 degrees 3 minutes East true.

The navigation marks are as follows, viz.:—

1. At the North-Western extremity a red painted conical buoy carrying a flashing white gas light showing one (1) second flash and four (4) seconds eclipse; position, latitude 32 degrees 4 minutes 12 seconds South, and longitude 115 degrees 41 minutes 10 seconds East.

2. At the North-Eastern extremity a black cask buoy placed 350 feet distant on a bearing of 81 degrees from the red conical light buoy at the North-Western extremity mentioned in No. 1 above.

3. The Western and Eastern edges of the channel are marked as follows, viz.:—

At distances five (5) cables, nine (9) cables, and one (1) mile two cables from the buoys mentioned in

Nos. 1 and 2 above and bearing South 9 degrees 3 minutes East true, single pile beacons surmounted by red discs on the Western, and black discs on the Eastern side, have been driven 350 feet apart, the height of the discs being 14 feet above low water.

In addition, at a distance of ten (10) cables from the buoys mentioned in Nos. 1 and 2 above, two piles without discs have been driven 200 feet apart, indicating the approach of the edges of the Channel at that spot.

At the Southern end of the Channel are two (2) leading beacons marking the centre line of the Channel and placed 840 feet apart.

The Northernmost of these two beacons consists of a single pile surmounted by a triangle showing a four (4) feet side 14½ feet above low water.

The Southernmost of these two beacons stands on three (3) piles and is surmounted by an inverted triangle showing an eight (8) feet side 36½ feet above low water. The position of this Southernmost beacon is latitude 32 degrees 5 minutes 56 seconds South and longitude 115 degrees 41 minutes 33 seconds East.

These two beacons are to be used as transit leads for the centre line of the Channel and must both be passed close to on their Eastern side.
