*In the matter of "The Licensing Act, 1911" (Consolidated), and in the matter of a Petition for authority to grant a New License.*

To His Excellency the Governor of Western Australia.

The humble Petition of the undersigned sheweth as follows:—

1. That your Petitioners are a majority in number of the Electors of the Yilgarn Electoral Division of the State of Western Australia, living in an area comprised within a circle having a radius of six miles (6) from the local Post Office, situate in the Townsite of Hollerton (late Glenelg Hills), Yilgarn District, and being the area approved by the Licensing Reduction Board for the purpose of this Petition.

2. That there has been an increase in population in such area and that such increase is likely to be permanent.

3. That a Gallon License is required at Hollerton to meet the requirements both of the residents in that Townsite and of the miners and other residents in the surrounding District. It is probable that agricultural settlement will extend around Hollerton.

Your Petitioners therefore humbly pray that the Licensing Court may, pursuant to the powers in that behalf contained in "The Licensing Act, 1911" (Consolidated), have the authority to grant a new Gallon License for the premises within the above-mentioned area.

No. 6. Every hawker whilst employed in hawking shall produce his License, upon being required by any constable or officer of the Board, and shall at all times have affixed to some conspicuous part of his coat, barrow, basket, vehicle, or dray a board or plate bearing his name, and the words "Licensed Hawker" legibly printed thereon in letters not less than one inch in length.

No. 7. No licensed stall shall be placed or allowed to stand in any street or position other than that mentioned in the License, or between the hours of 9 p.m. or 4 a.m.

No. 8. The following fees shall be paid for Licenses to hawkers or stalls, and shall be paid in advance, and if any payment be not paid when due, the License shall be void.

## Hawkers' Licenses.

For every hawker with hand basket or tray—20s. per annum.

For every hawker with wheelbarrow or handcart—30s. per annum.

For every other hawker with motor or vehicle drawn by horse or other animal—40s. per annum.

## Stall Licenses.

For every stall—10s. per month.

No. 9. Every licensed hawker and stall-holder shall at all times obey the lawful directions of the secretary or other authorised officer of the Board.

No. 10. No person to whom a Hawker's or Stall-holder's License is granted shall lend, transfer, or assign his License granted, and no person shall borrow or make use of any such License granted to a person other than himself, unless by written consent of the secretary.
