NYABING PUBLIC CEMETERY (RESERVE 14218)  
BY-LAWS.

Department of Lands and Surveys,  
Corres. 1749/12. Perth, 25th September, 1929.

HIS Excellency the Governor in Executive Council has been pleased to approve of the following By-laws under the provisions of "The Cemeteries Act, 1897."

## Public Cemetery, Nyabing—By-laws.

By virtue of all powers on that behalf vested in the Trustees of the Public Cemetery, Nyabing, the said Trustees make the following By-laws:—

1. All fees and charges payable to the Trustees, as set forth in Schedule "A" are to be paid at the time when the applications are made or orders given.

2. Any person desiring ground in the cemetery for any grave, private grave, vault, or tombstone, monument or enclosure, or for any other purpose, shall make application therefor on prescribed form. Upon such application being approved of the Trustees shall cause to be issued to such person so applying a Certificate of Right of Burial in the form specified in the Act (see Schedule "B").

3. All applications for interment shall be made at the office of the Trustees in time to allow of at least five (5) working hours, notice being given to the Secretary at the Cemetery prior to the time fixed for burial, otherwise an extra charge shall be made.

No free interment shall be allowed unless the application and order therefor be handed in at the office in time to allow at least six (6) working hours' notice being given as above.

4. The name, age, late place of residence, probable cause of death of deceased, and other particulars mentioned in Schedule "F," shall be furnished at the time of giving the order.

5. The Trustees shall cause all ordinary graves to be dug, but any person requiring a brick grave or vault shall be permitted to construct the same under the supervision of the Secretary, after submitting a plan of same and obtaining a written approval of the Trustees thereon and on payment of the necessary fees; and

every coffin placed therein shall be bricked in, cemented, and covered by a slab of stone, or iron, unless special exemption be obtained from the Trustees in writing.

6. Every coffin shall have upon the lid an approved metal plate, bearing the name of the deceased stamped or otherwise indelibly inscribed in legible characters thereon.

7. Every grave shall be at least 6ft. deep, and no interment shall be allowed in any grave with less depth than 4ft. 6in. from the top of coffin to the original surface of the surrounding ground after such interment.

8. No interment shall be allowed in any private grave or vault without the production of the Certificate of Right of Burial, as in Schedule "B," or other satisfactory evidence that the person desiring to bury therein is entitled to do so, except in such cases as are provided for in the following By-law.

9. In the case of an application for interment in any private grave or vault to which the deceased had no claim during life, the written consent of the owner shall be handed in with the application.

10. No burial shall be allowed to take place in the Cemetery without a certificate from the District Registrar of Deaths that the death has been registered, or a Coroner's order for burial. Such certificate or order shall be at the latest handed to the Secretary upon the funeral entering the Cemetery.

11. The hours for burial shall be as follows:—1st September to 30th April—week days, from 8 a.m. to 6 p.m.; Sundays, from 2 p.m. to 6 p.m.; 1st May to the 31st August—week days, from 8 a.m. to 5 p.m.; Sundays, from 2 p.m. to 5 p.m.; and no burial shall be allowed to take place, nor any coffin allowed to enter the Cemetery at any other hour except by written permission of the Trustees.

12. The time fixed for any burial shall be the time at which the funeral is to arrive at the Cemetery.

13. At funerals no vehicles other than hearses shall be allowed to enter the Cemetery gates.

14. All hearses shall proceed by such roads as directed, and the drivers shall at all times observe such directions as may be issued to the Secretary by the Trustees from time to time for the regulation of the traffic.

15. No headstones, footstone, kerbing, monument or any other erection of any kind shall be permitted, nor shall any inscription be allowed until the plans and particulars of the same have been approved by the Trustees.

16. Every erection shall be placed on proper and substantial foundations, and if required by the Trustees or their officers, such foundations shall extend to the bottom of the grave.

17. The materials used in every erection shall be subject to the approval of the Secretary or other officer appointed by the Trustees, and any material rejected shall be immediately removed from the Cemetery by the contractor or person responsible for the erection.

18. All material, refuse, and other rubbish remaining after any work is completed shall be immediately removed from the Cemetery by the person responsible therefor.

19. In the event of the refuse, rubbish, or material referred to in previous By-law not being so removed, the Trustees shall have power to cause the same to be removed, and to recover the costs of such removal from the person or persons responsible therefor.

20. All materials required in the erection and completion of any stone or other work shall, as far as possible, be prepared before taking to the Cemetery, and all materials required by tradesmen shall be admitted at such entrance to the Cemetery and conveyed along such roads or tracks as the Secretary shall direct, and no vehicle conveying any such material with wheels less than 4in. broad shall be permitted to enter the Cemetery.

21. Monumental masons and other tradesmen shall, before commencing any work within the Cemetery, deposit with the Secretary to the Trustees the sum of ten shillings, which shall be forfeited if either of the two last preceding By-laws is not complied with to the satisfaction of the Trustees.

22. The Trustees will not (unless in very exceptional cases) permit the removal of any corpse from any grave for re-interment in this or any other Cemetery.

23. Before any such exceptional case, as referred to in the last By-law, be dealt with by the Trustees, a written application, setting forth the reason for the proposed removal, and verified by a statutory declaration, shall be produced by the nearest available representative of the deceased, and in the event of such ap-

plication being granted, the permission of the Chief Secretary, in addition to the permission of the Trustees shall be obtained. If in the opinion of the Trustees it is necessary, the coffin shall be enclosed in a second and air-tight coffin prior to removal.

24. Any person requiring an "Exclusive Right of Burial" in any part of the Cemetery shall apply to the Trustees, in writing, specifying the location of the grave and whether it is proposed to erect a brick grave or vault and in such case submitting plans and specifications of the proposed work. Such application shall also state the names of any already deceased person whose remains it is proposed to inter therein.

25. Upon being satisfied of the matters aforesaid, and of the suitability of the said work, plans and specifications, the Trustees may authorise the construction and erection thereof; or, if no work is to be done, may issue a "Grant" in the Form "E" in the Schedule.

26. Upon the completion of the work aforesaid, the Trustees may, if and when such work is done to their complete satisfaction, issue a "Grant" in the Form "E" in Schedule.

27. The shape and height of all graves, etc., shall be subject to the approval and supervision of the Secretary.

28. No catacomb shall be allowed.

29. No trees or shrubs shall be planted in any enclosure, except such as are approved by the Secretary.

30. All workmen, whether employed by the Trustees or by any other person, shall at all times, whilst within the boundaries of the Cemetery, be subject to the supervision of the Secretary, and shall obey such directions as that officer may find necessary to give, and any workman committing any breach of these regulations and By-laws, or refusing or neglecting to comply with any directions of the said Secretary, shall be removed from the Cemetery.

31. Any person taking part in dressing or attending to any grave shall comply with the following rules:—

(a) No rubbish, soil, sand, or any other materials removed in dressing a grave shall be placed on any other graves, and if placed on any other adjoining ground shall be removed immediately the work is completed.

(b) No sand, soil, or loam shall be taken from any portion of the Cemetery for the purpose of dressing graves, except with the permission of the Secretary.

(c) The dressing of all graves, and the wheeling and carting of any material shall be subject to the supervision of the Secretary.

(d) Work in all classes to be carried on with due despatch, and only during regulation hours.

32. Any person who dresses or attends a grave, for which dressing or attention a charge is made, shall pay the prescribed annual license fee for grave dressing.

33. Children under the age of ten years shall not be admitted to the Cemetery unless in charge of some responsible person.

34. It shall be unlawful for any person to smoke within the Cemetery or to discharge any fireworks therein.

35. No dogs shall be admitted into the Cemetery, and any found there shall be liable to be destroyed.

36. Any person violating the rules of propriety and decorum, or committing any nuisance or trespass, or injuring any trees, shrubs, flower, border, or any erection, or in any way infringing "The Cemeteries Act, 1897," or any rule, regulation, or by-law made for protecting the Cemetery, shall be prosecuted as the law directs.

37. Any person who commits a breach of or an offence against any By-law may be expelled from the Cemetery.

38. No person shall promote or advertise, or carry on within the Cemetery or its approaches, any trade, business, or calling, either by solicitation, distribution of circulars or cards, or otherwise, or by any other system of advertisement whatever.

39. No person employed by or under the Trustees shall be permitted to accept any gratuity whatever whilst in discharge of his duty, nor shall he be pecuniarily interested in any work in the Cemetery other than that for which he receives payment from the Trustees, and any person so employed accepting any gratuity, or being pecuniarily interested in any such work shall be liable to summary dismissal.

40. Licenses for grave dressing or decorating may be issued by the Trustees in the form set out in Schedule "G"; such licenses to be renewed annually.

41. Subject to the directions of the Trustees, the Secretary shall exercise a general supervision and control over all matters pertaining to the Cemetery, including the conduct of all funerals within the Cemetery.

42. The Trustees shall have power to cancel the annual license of an undertaker for a breach of any By-law, and prohibit any unlicensed undertaker from undertaking or conducting any funeral in the Cemetery.

The foregoing By-laws, with the accompanying schedules, were duly framed and presented to a meeting of the Board of Trustees held at their office at Nyabing on the 6th August, 1929.

STOCK DISEASES ACT, 1895.

Regulation.

1. (1) Whenever a mob of cattle is travelling in the West Kimberley portion of the State or therefrom to any other part of the State, no person shall leave or permit to be left any of such live cattle upon the stock route, or any station property or other land between the station of origin and the point of destination.

(2) It shall be the duty of the owner of such travelling cattle, and of the person in charge thereof, to forthwith destroy any animal that for any reason does not or is unable to proceed with the mob, and to forthwith notify the District Inspector of Stock thereof; and if such destruction takes place within the boundaries of the station property of any other owner of cattle, to forthwith give notice thereof to such owner.

(3) Any person who commits a breach of this regulation, or any provision thereof, shall be liable to a penalty not exceeding one hundred pounds.
