WHEREAS by Section 9 of "The Fisheries Act, 1905-21," it is provided that the Governor may by Proclamation prohibit all persons from taking any fish whatsoever in every or any specified portion of Western Australian waters by means of fishing nets and fishing lines, or either of such means of capture, or by any other specified means of capture, for any specified term: Now, therefore I, the said Lieut.-Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid, and of every other power enabling me in this behalf, prohibit all persons from taking any fish whatsoever by means of fishing nets in any of the portions of Western Australian waters

specified in the Schedule hereto, for a period of twelve months as from the date of the publication of this Proclamation in the *Government Gazette*.

## Schedule.

(a) All that area of Western Australian waters (Cockburn Sound) Eastward of the Fremantle Fish Market Jetty and extending to the Western extremity of South Street, and to a width of half a mile from high-water mark.

(b) That area of Western Australian waters (Cockburn Sound) commencing at the Western extremity of Sydney Street and extending Southward to a point a quarter of a mile South of the Jetty fronting Douro Road, and to a width of half a mile from high-water mark.

(c) That area of Western Australian waters (Cockburn Sound) commencing at a point on the foreshore a quarter of a mile North of Robb's Jetty, and extending to a point on the foreshore a quarter of a mile South of Robb's Jetty, and extending into the waters aforesaid to a distance of a quarter of a mile from high-water mark.

WHEREAS it is provided by "The Game Act, 1912-13," that the Governor may by Proclamation declare from time to time that any bird or animal indigenous

to Western Australia shall be at all times strictly preserved, either generally throughout the State or in any one or more portions thereof, and that the Governor may in like manner exempt from the operations of any such declaration under the said Act any defined locality: And whereas by a Proclamation dated the 30th day of July, 1924, it is provided that the portions of the State and localities defined in the Schedule thereto shall be a Reserve for Grey Kangaroos, known scientifically as *Macropus giganteus*: And whereas it is desirable to exempt from the operations of the said Proclamation defined localities: Now, therefore I, the said Lieut.-Governor, in exercise of the power aforesaid, do hereby, by and with the advice and consent of the Executive Council, exempt from the operations of the aforesaid Proclamation, and the declaration contained therein, all those localities mentioned and defined in the Schedule hereto for a period of six months as from the date of the publication of this Proclamation in the *Government Gazette*.

(a) All that area comprised in the Kent Road Board District;

(b) All that area comprised in the Dumbleyung Road Board District; and

(c) All that area comprised in the Lake Grace Road Board District.

Perth Road Board.

#### ORDER IN COUNCIL.

P.W. 259/25.

WHEREAS under the provisions of "The Traffic Act, 1919-26," the Governor may by Order in Council empower a Local Authority to exercise within its District any power of making Regulations which the Governor can exercise under Division 4 of Part IV. of the said Act: And whereas it is desired to empower the Perth Road Board to—

- (a) prohibit the use of a specified road within its district by traffic, except when proceeding in a specified direction;
- (b) regulate the speed of vehicles when crossing bridges and culverts within district;
- (c) specify the maximum weight of vehicles crossing such bridges and culverts:

Now, therefore, His Excellency the Lieut.-Governor, by and with the advice and consent of the Executive Council, under the provisions of the said Act, and all other powers enabling him in this behalf, doth hereby empower the Perth Road Board by the By-law in the Schedule hereto to—

- (a) prohibit the use of that portion of the Esplanade, North Beach, between Malcolm Street and Mary Street, within its District, by any vehicle, or by any person riding or driving any animal, except when proceeding in a specified direction;
- (b) regulate the speed of vehicles when crossing bridges and culverts within its District;
- (c) specify the maximum weight of vehicles crossing such bridges and culverts,

and to impose a penalty of not exceeding £20 or imprisonment for not exceeding one month for the breach thereof.

#### THE TRAFFIC ACT 1919-26.

#### Perth Road District.

The Perth Road Board, pursuant to an Order in Council made under Section 43 of "The Traffic Act, 1919-26," doth hereby make and publish the following By-laws, to have effect within the Perth Road District:—

1. No person shall ride or drive any animal, or drive any vehicle on, over, or along the Esplanade, North Beach, between Malcolm Street and Mary Street, except only in a Northerly direction.
2. No person shall drive, or cause or permit to be driven, a vehicle on a road when crossing a bridge or culvert outside the Metropolitan Area as defined by the Regulations made under "The Traffic Act, 1919-26," (a) at a speed exceeding 15 miles per hour or (b) whose maximum weight including loading exceeds 25 hundredweight to each wheel.
3. Any person committing a breach of any of the foregoing By-laws shall on conviction be liable to a penalty not exceeding £20 or to imprisonment for not exceeding one month.

Cranbrook Road Board.

#### ORDER IN COUNCIL.

P.W. 1920/26.

WHEREAS under the provisions of "The Traffic Act, 1919-26," the Governor may by Order in Council empower a Local Authority to exercise within its District any power of making Regulations which the Governor can exercise under Division 4 of Part IV. of the said Act: And whereas it is desirable to empower the Cranbrook Road Board to regulate the standing of vehicles in the streets of Cranbrook Townsite: Now, therefore, His Excellency the Lieut.-Governor, by and with the advice and consent of the Executive Council, under the provisions of the said Act, and all other powers enabling him in this behalf, doth hereby empower the Cranbrook Road Board by the By-law in the Schedule hereto, to regulate the standing of vehicles in the streets of Cranbrook Townsite, and to impose a penalty not exceeding £20 for the breach thereof.

#### THE TRAFFIC ACT, 1919-26.

#### Cranbrook Road Board.

The Cranbrook Road Board, pursuant to an Order in Council under Section 43 of "The Traffic Act, 1919-26," and in exercise of the power thereby conferred, doth hereby make the following By-law, to have effect within the Cranbrook Road District:—

No vehicle is allowed to remain at a standstill for any period exceeding fifteen minutes in any street or roadway, within the Townsite of Cranbrook, excepting those streets and reserves herein named, viz.:— (1) That portion of Gathorne Street, on the East side, from the Railway Yard gates to opposite the intersection of Dunn Street; (2) the whole of Mason Street; (3) that

portion of the South-West corner of Frederick Square (Reserve 8712) between the boundary of the reserve and the boundary of the football playing ground.

Any person who commits a breach of the By-law shall be liable on conviction to a penalty not exceeding £20.

The Prisons Act, 1903-1918.

ORDER IN COUNCIL.

1205/27.

WHEREAS it is enacted by Section 64M of "The Prisons Act, 1903-1918," that the Governor may make Regulations, not inconsistent with this Act, for any of the purposes in the said section mentioned: And whereas the Governor in exercise of the said power made Regulations relating to the discipline and management of the Pardelup Penal Outstation, which were published in the *Government Gazette* on the 21st day of October, 1927: And whereas it is deemed expedient to amend Regulation 15 of the said regulations in the manner hereinafter mentioned: Now, therefore, His Excellency the Lieut.-Governor, acting with the advice and consent of the Executive Council, and in exercise of the power conferred by the said Act, doth hereby amend Regulation 15 of the said regulations as follows:—

1. Paragraph (f) is amended by deleting the words "2s. in each week" and inserting in lieu thereof the words "1s. in each week, except by permission of the Superintendent."

2. After paragraph (g) a new paragraph is added as follows:

"(g1) Lights out and silence shall be observed after 9 p.m."

3. Paragraph (h) is amended by inserting after the word "earnings" in the eighth line the words "then standing"; and by adding at the end of the paragraph the words "or which may thereafter accrue to him."

4. Paragraph (i) is amended by inserting after the word "earnings" in the fifth line the words "then standing"; and by adding at the end of the paragraph the words "or which may thereafter accrue to him."

5. Paragraph (1) is amended by inserting at the beginning of the paragraph the words "Subject to any variation or alteration from time to time recommended by the Officer in Charge or Superintendent and approved by the Comptroller General."

The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 1073/29.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works, and stormwater drainage works: And whereas it is further provided that the Governor may exempt reticulation works from certain sections of this Act: Now, therefore, His Excellency the Lieut.-Governor, with the advice of the Executive Council, hereby approves of the construction and extension by the Minister for Water Supply, Sewerage, and Drainage of the following works under the said Act, and does hereby exempt such works from the operations of Sections 20, 21, 22, and 23 of the said Act.

Description and Location of Reticulation Works approved and exempted—Metropolitan Reticulation Main Extension—Perth Road District.—Proposed six-inch diameter cast-iron water main commencing at the end of the existing six-inch diameter main in Fitzgerald Street, opposite Lot 35, and proceeding thence in a North-Easterly direction along Fitzgerald Street to a point opposite Lot 95 (length about twelve and a half chains).

The above main to be complete with valves, hydrants, and all necessary apparatus, as shown in red on Plan M.W.S., S., & D.D., W.A., No. 5012.

This Order in Council shall take effect from the 15th day of November, 1929.

## Rock-Boring Machines.

46. A District Inspector of Mines may by notice in the Record Book prohibit the use of any rock-boring machine which in his opinion causes dust which seriously and materially endangers the health of workmen. Dry percussion machine drills shall not be used in mines, except in shafts and winzes.

## Ventilation of Dead-ends.

47. In all mines where compressed air is used underground, it shall be compulsory for the manager to install venturi blowers or other appliances or means which in the opinion of the District Inspector of Mines are equally efficient in all dead-ends.
