WHEREAS by "The Factories and Shops Act, 1920," it is enacted that the Governor may by Proclamation temporarily suspend the operations of the said Act, in so far as it applies to the closing time fixed or appointed for any shop or shops: And whereas it is expedient to exercise such power in manner hereinafter appearing: Now, therefore I, the said Administrator, by and with the advice and consent of the Executive Council, do hereby by this Proclamation suspend the operations of the said Act between the hour of ten o'clock and eleven o'clock in the morning of the 28th March, 1932, in so far at it applies to the closing time of Hairdressers' shops situate within a radius of 15 miles from the Gen-eral Post Office, Perth.

# The Rights in Water and Irrigation Act, 1914. Waroona Irrigation District.

### ORDER IN COUNCIL.

P.W.W.S. 504/31. WHEREAS by "The Rights in Water and Irrigation Act, 1914," it is provided that the Governor may, on the recommendation of the Minister, acting with the advice of the Commissioners appointed under the said Act, by Order in Council extend any Irrigation District:

[MARCH 11, 1932.

Now, therefore, His Excellency the Administrator, by and with the advice of the Executive Council on the recommendation of the Minister acting with the advice of the said Commissioners, doth hereby extend the Waroona Irrigation District by adding thereto the land described in the Schedule hereto.

### Schedule.
