AT a meeting of the Executive Council held in the Executive Council Chambers at Perth, the fourth day of May, 1932, the following order in Council was authorised to be issued:—

Forests Act, 1918.

## ORDER IN COUNCIL.

F.D. 1821/30.

WHEREAS by "The Forests Act, 1918," it is provided that a dedication under the said Act of Crown land as a State Forest may be revoked in whole or in part in the following manner:—

- (a) the Governor shall cause to be laid on the Table of each House of Parliament a proposal for such revocation;
- (b) after such proposal has been laid before Parliament, the Governor, on a resolution being passed by both Houses that such proposal be carried out, shall by Order in Council revoke such dedication:

And whereas His Excellency the Governor did cause to be laid on the Table of each House of Parliament his proposal dated the Ninth day of December, 1930, for the revocation in part of the dedication of Crown lands as State Forest: And whereas after such proposal had been laid before Parliament a resolution was passed by both Houses that such proposal should be carried out: Now, therefore, His Excellency the Administrator, with the advice and consent of the Executive Council, doth hereby revoke in part the dedication of Crown lands as State Forest No. 20, by excising that portion of such State Forest as is described in the Schedule hereto:—

## HOSPITALS ACT, 1927.

By-laws.

M.H.D. 389/32; Ex. Co. No. 758.

WHEREAS under the provisions of "The Hospitals Act, 1927," the Minister of Public Health controls certain public hospitals; and whereas under the provisions of the said Act the Minister may make By-laws in respect of the public hospitals under his control: Now, therefore, the Minister hereby makes the following By-law:—

## 43A.—Notice to be given to Employees.

A matron or any member of the nursing staff shall be entitled to one month's notice of the intended termination of her services, and any other employee shall be entitled to fourteen days' notice thereof.

## THE HOSPITALS ACT, 1927.

Rules and Regulations for the Management of the  
Morawa District Hospital.

Ex. Co. No. 759; M.P.H. No. 869/31.

1. The name of the Hospital shall be Morawa District Hospital.

2. The Board of Management shall consist of nine members appointed by the Governor. They shall be selected in the month of July in each year at the annual general meeting of subscribers. Retiring members shall be eligible for re-selection. Nominations for appointment shall be received as follows:—Two to be nominated by the Morawa Road Board; two to be nominated by the Board of Management; five to be nominated by the subscribers.

3. Subscribers.—Every person subscribing 10s. 6d. shall be entitled to vote. Annual subscribers shall be, viz., any person who subscribes 10s. 6d. per annum. Any married person who subscribes three guineas per annum shall be entitled to hospital accommodation and treatment for self, wife, and family under the age of 16 years at half the existing rates for the ensuing 12 months. Any unmarried person who subscribes one guinea per annum shall be entitled to hospital accommodation and treatment at half the existing rates for the ensuing 12 months. Benefits become operative 28 days after payment.

4. The Annual General Meeting of the Board and subscribers shall be held during the month of July in each year, on a day to be fixed by the Board, and of which 14 clear days' notice has been given.

5. Nominations from financial subscribers for membership of the Board shall close with the Secretary on the seventh day next preceding the day of selection. Where there are more candidates than are required to be selected, voting shall be by ballot conducted similar to ordinary Parliamentary elections.

6. The order of business at the annual meeting shall be:—

The Report of the Board for the previous year.

The Secretary's Report and Balance-sheet.

Business of which notice has been given.

7. The Board shall, at its first meeting after appointment, elect one of its number to be Chairman.

8. The Chairman shall, when present, preside at all meetings of the Board, and in the absence of the Chairman from any meeting, or if after being present he retires, the members present may elect one of their number to be Chairman for that meeting, or the remainder thereof. In the absence of the Chairman from the State, or in case of illness of the Chairman, the mem-

bers present at any meeting may elect one of their number Acting Chairman during such absence or illness.

9. The Secretary shall be elected by the Board and shall retain office at its discretion.

10. An Auditor, who shall not be a member of the Board, shall be elected annually by the subscribers. The books and accounts shall be audited as on 30th June.

11. Board of Management.—The Board of Management shall meet at a time and place to be fixed by resolution, and altered at any time by notice of the Board.

12. Quorum.—A quorum of the Board shall be five.

13. Order of Business.—

Minutes.

Correspondence.

Secretary's Report and Financial Statement.

General.

14. Seats declared Vacant.—In the case of any member of the Board of Management being absent for three consecutive meetings without leave of absence, the Board may recommend to the Governor that his seat shall be declared vacant.

15. A nomination to fill the vacancy thus created shall be made by the body which selected such representative.

16. Special Meetings.—Special meetings of the Board may be called at any time or place by the Chairman, or by the Secretary upon requisition by any three members of the Board, in writing.

17. Notice of Meeting.—Every member of the Board of Management shall receive at least 24 hours' notice, in writing, of an ordinary or special meeting.

18. House Committee.—The Board of Management shall appoint from amongst themselves a House Committee of three, who shall attend to the internal management of the hospital and such other matters as may be delegated to them. They shall furnish monthly reports to the Board of Management. The Board shall also appoint such other Committees as they may deem fit.

19. Duties of Secretary.—The Secretary shall conduct the correspondence and have charge of all documents relating to the hospital; attend all meetings of the Board and House Committee and keep the minutes thereof, and see that as far as practicable all resolutions or orders passed at such meetings are forthwith carried into effect under the direction of the Board; keep the books, forms and accounts of the hospital; attend at the hospital when required; receive all moneys paid to the hospital; give receipts for and pay same into hospital bank account; and shall report to the House Committee any matter which, in his opinion, requires attention.

20. Matron.—The Matron shall have full control of the hospital and all things appertaining thereto. She shall be responsible for the good order and cleanliness of the institution and the clothing of the patients, the preparation and service of meals, and the proper and efficient nursing of the patients. She shall see that the report books are entered up daily, and shall be responsible for the stores, take charge of all valuables and money belonging to the patients, and in the case of death or insanity, hold same to the order of the Board. She shall be entitled to 14 days' vacation each year on full pay.

21. Nurses.—Each nurse shall be responsible to the Matron for the efficient nursing of the patients, the charge of all the linen, furniture, and other articles, and the cleanliness and management of her ward. She shall strictly obey the orders of the Matron, and take such day or night duties as the Matron shall direct. The Matron may grant leave to any nurse not to exceed one half-day in any one week and one alternate Sunday. All nurses shall reside on the premises and shall be entitled to the same vacation as the Matron.

22. Servants.—The cook, laundress, and other servants shall be ready to carry out orders at any time. They shall faithfully execute all orders of the Matron, and be respectful and orderly in conduct. They shall not be absent without leave from the Matron, and shall be entitled to seven days' vacation each year on full pay.

23. In-Patients.—No distinction shall be made between those who pay and those who are unable to pay, nor shall any intimation to either effect be made upon any bed, card, or otherwise, nor shall any separate ward be set apart for either.

24. Exclusions.—No person suffering from V.D., D.T., or ultra contagious diseases shall be admitted to the hospital, except in cases of emergency.

25. Maintenance Fees.—The fee for paying patients shall be fixed by the Board of Management from time to time, on a basis of the actual cost per day as disclosed by the annual audit, but at a minimum of £3 3s. per week or 9s. per day. All drugs and dressings ordered by a medical officer shall be an extra charge to the patient. Maternity cases, £4 4s. per week. Children under 14, £2 2s. per week. Waiting fees, 35s. per week. Theatre fees: major operations, £1 1s. and dressings; minor operations, 10s. 6d. and dressings.

26. Complaints.—Complaints from subscribers or patients shall be made in writing and lodged with the Chairman of the Board or made direct to the House Committee within seven days of the occurrence, and such complaints shall be dealt with by the Board, and its decision shall be final and binding on all parties. The Board may refuse to inquire into any complaint which is not lodged within the time specified.

27. Notification to Patient's Friends, etc.—Should a patient be dangerously ill, the Matron shall at once notify some of the relatives or friends of such patient, and should the patient desire that a clergyman be sent for, his or her wishes are to be immediately complied with.

28. Residential Rules.—No person other than patients or those employed by the hospital shall reside on the premises or have any meals there, nor shall any visitor to employees under any circumstances be permitted to remain after ten (10) p.m.

29. Ministers of Religion.—Ministers of religion shall have free access to patients of their respective denominations, but, prior to entering the ward, must obtain the Matron's consent.

30. Payment of Fees.—Before the patient leaves the hospital all fees must be handed to the Matron or Secretary, or a satisfactory guarantee of payment left in the hands of the Matron or Secretary, except in bona fide or indigent cases.

31. These Rules and Regulations shall not be altered, amended, varied, or added to except upon notice, in writing, given to the Secretary, stating the proposed alterations, additions, or cancellations, and the Secretary shall give each member of the Board seven days' notice in writing thereof prior to the matter being discussed.

32. Register of Subscribers.—A Register of Subscribers shall be kept and be open for inspection at the office of the Secretary.

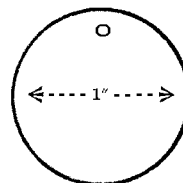
## THE DOG ACT, 1903-28.

## Regulations.

1. These Regulations shall come into operation and have the force of law in every district throughout the State on and from the 1st day of July, 1932.

2. All regulations previously made under the Act shall be and are hereby repealed as from the 30th day of June, 1932.

3. The registration label for the financial year ending 30th June, 1933, required by Section 9 of "The Dog Act, 1903-28," is hereby prescribed to be a flat piece of nickel-plated brass, of the size and shape depicted hereunder, inscribed on the one side with the name of the District, the year of registration, and the registration number, and on the other side with the emblem of the State flag.



4. Such registration label shall be securely fixed to a collar which shall be continually worn round the dog's neck.

5. Registration shall be effected on or within 21 days from the first day of July, 1932.

6. (a) The registration fees for dogs other than those used for tending cattle and sheep, shall be—

(c) In respect of any registration made after the 31st day of December in any year, only one-half of the registration fee shall be payable.

7. The definition of cattle, referred to in these Regulations, shall be as set out in the Second Schedule of "The Cattle Trespass, Fencing and Impounding Act, 1882," namely:—

"Great Cattle"—horse, mare, gelding, colt, filly, ass, mule, bull, ox, cow, heifer, calf, camel, deer and foal.

"Small Cattle"—ram, ewe, sheep, wether and lamb, goat, kid and pig.

8. Application for the issue of a license for a dog shall be made on the prescribed form, namely, Form "A" in the Second Schedule to "The Dog Act, 1903-28" (as printed and issued by the Department of Works and Labour).

9. Where a license is required under the proviso to Section 11 of the said Act, the number of cattle or sheep for which the dog is used for tending must be stated in the last column of the prescribed form.

10. Any person contravening any of these Regulations, whether by act or omission, shall, on conviction, be liable to a penalty not exceeding £5 for every such offence.

## WOOL SCOURING AND FELLMONGERY (METROPOLITAN).

(Registered 28th April, 1932.)

No. 2 of 1932.

THIS Agreement made in pursuance of "The Industrial Arbitration Act, 1912-1930," this 26th day of April, 1932, between The Metropolitan Wool Scouring and Fellmongery Employees' Industrial Union of Workers (hereinafter called "the Union"), of the one part, and The Swan Wool Scouring Company of W.A., Limited; The Westralian Wool Scouring Company, Limited; and The West Australian Meat Exports Company, Limited (hereinafter called "the Employers"), of the other part, witnesseth that for the considerations hereinafter appearing the parties hereto mutually covenant and agree the one with the other as follows:—

## 1.—Area.

This Agreement shall apply to the Wool Scouring Industry carried on within a radius of thirty (30) miles from the General Post Office in the City of Perth.

## 2.—Term.

The term of this Agreement shall be one year from the date hereof.

## 3.—Definitions.

In this Agreement, if not inconsistent with the context—

"Casual Hand" shall mean an employee engaged by the hour, and who may be put off or leave the employer's service at any moment without notice.

"Weekly Hand" shall mean an employee engaged by the week and whose employment shall be terminated by not less than one week's notice on either side: Provided that in the case of a breakdown in the employer's

machinery, or through the failure of electric power operating same, or no wool being available for scouring, the employer shall be entitled to deduct payment of wages for any day or portion of a day that the worker cannot be employed. Provided further that a worker who is stood down on account of the foregoing shall be paid at casual rates for the time worked in any week when he is so stood down.

## 4.—Hours.

(a) Day Work: Forty-eight hours shall constitute a week's work, to be worked as follows:—

Hands employed on the wool breaker, scouring machine, and/or drier, shall work  $9\frac{3}{4}$  (nine and three-fifth) hours per day from Monday to Friday inclusive.

All other hands shall work 8 hours 48 minutes from Monday to Friday inclusive and 4 hours on Saturday.

(b) Shift Work: Ordinary time, 11 p.m. Sunday to 11 p.m. the following Saturday, each day to be divided into three shifts of eight hours, and forty-eight hours to constitute a week's work, inclusive of crib time.

## 5.—Holidays.

Two weeks' annual leave on full pay shall be granted to each worker on completion of each year of service, or should the period of continuous service be less than one year the worker shall be paid holidays in proportion as his length of service is to the full year's employment.

The following days shall be days upon which, if the employer's establishment be closed, payment may be deducted:—Anniversary Day, Easter Monday, Anzac Day, and Foundation Day, New Year's Day, Good Friday, Easter Saturday, Christmas Day, Boxing Day, and Labour Day.

## 7.—Overtime.

All time worked prior to the usual starting time or after the usual finishing time shall be regarded as overtime and paid for at the rate of time and a half.

## 8.—Sundays and Holidays.

(a) Except as provided hereunder all work performed on Sundays or Christmas Day, New Year's Day, and Labour Day shall be paid for at double time rates.

(b) In the case of shift workers all time worked beyond eight (8) hours on Sundays or Christmas Day, New Year's Day, and Labour Day, shall be deemed overtime and shall be paid for at the prescribed overtime rates, calculated on the special rate prescribed for ordinary work on the particular day on which such overtime is worked.

## 9.—Proportion of Juniors.

Employers shall be entitled to employ one junior, and thereafter additional juniors may be employed in the proportion of one junior to every four or fraction of four adults.

## 10.—Higher Duties.

A worker required to do work which is entitled to a higher rate under this Agreement than that which he usually performs shall be entitled to payment at the higher rate whilst so employed.

## 11.—Time and Wages Record.

The employer shall keep and enter up or cause to be kept and entered up a record containing the names of each of his workers to whom the Agreement applies, the class of work performed by and the wages paid to each such worker, and the time during which he has been employed. Such record shall be open to inspection by a representative of the Union at least one day in each week between the hours of 10 a.m. and 4 p.m.

## 12.—Under-rate Workers.

Any worker who by reason of old age or infirmity is unable to earn the minimum adult wage prescribed by this Agreement may be employed at such lesser wage (if any) as may be agreed upon in writing between the worker and the Secretary of the Union. If within twenty-four hours after the worker has notified the Secretary of his desire to work at a lesser wage than the said minimum, the Secretary and the worker do not agree as aforesaid, then the worker may apply to the most convenient Resident or Police Magistrate for a permit to work at such lesser wage. The worker shall give to the Secretary at least twenty-four hours' notice in writing of his intention to make such application to the Magistrate and the Secretary or his agent shall be entitled to attend before the Magistrate, and, pending the decision thereon in either case, the worker shall be entitled to work and be employed by an employer at the proposed lesser rate. The Magistrate may grant to such worker a permit to work for such wage and for such period not exceeding six calendar months as he thinks fit and his decision in the matter shall be final. The permit shall entitle the worker to work at the wage therein mentioned for such period as may be therein stated until the wage shall have again been settled by the Magistrate on the application of the said Secretary.
