By-law No. 1.-Management of Recreation Reserves. P.W. 60/33.

IN pursuance of the powers in that behalf contained in "The Road Districts Act, 1919," and "The Road Districts Act Amendment Act, 1932," Section 196 (44), the chairman and members of the Narrogin Road Board hereby make the following By-law:-

Interpretation Clause.

- 1. In the construction of this By-law, unless the context otherwise requires:
 - (a) The word "Board" shall mean the Narrogin Road Board;
 - (b) The word "Reserve" shall mean any Reserve vested in the Board for the purposes of recreation:
 - (c) The word "Caretaker" shall mean the person appointed by the Board to take care of such Reserve or Reserves, and shall include the plural.
- 2. The management of the Reserve or Reserves shall be vested in the Board.
- 3. No person shall damage or interfere with any property belonging to the Reserve, commit any nuisance, or leave thereon any bottles, paper, or cast-off clothing, or any litter, rubbish, or waste-matter of any kind.

 4. No boat shall be used on the Reserve without hav-
- ing first obtained a permit from the Board and on payment of such fee, and on such terms and conditions as the Board shall determine and which shall be stated on such permit.
- 5. No person shall sell or expose for sale any goods, wares, merchandise, or things upon any portion of such Reserve or Reserves, or on any public road adjoining such Reserve or Reserves, without having first obtained a permit from the Board, and on such terms and conditions as the Board shall determine.
- 6. Permits other than above may also be issued at the discretion of the Board and upon such terms and conditions as may from time to time be determined.
- 7. No holder of a permit shall transfer or lend his permit to any person, and any person committing a breach of this clause shall be liable to have his permit revoked by the Board.
- 8. Whenever a permit is revoked by the Board no compensation shall be payable in respect to such revocation.
- Any person found in a state of intoxication on the Reserve, or behaving in a disorderly manner, or creating any disturbance, or using obscene language, or committing any breach of these By-laws, may be forthwith removed from the Reserve by any member of the Board, or caretaker, or any member of the Police Force without affecting such person's liability to prosecution for an offence against this By-law.
- 10. All rubbish appurtenant to any camp shall be placed in the receptacle provided by the Board.
- 11. Each camp and its surroundings shall be maintained in a clean and tidy manner and free from any nuisance, to the satisfaction of the Board.
- 12. No person shall light a fire except in the area provided for that purpose.
- 13. No person shall use any firearm within the boundary of the Reserve.
- 14. A charge may be made for every adult person using the Reserve not exceeding sixpence.
- 15. Any person committing a breach of any of these By-laws shall on conviction be liable to a penalty not exceeding £10.
