WHEREAS by Section 9 of "The Fisheries Act, 1905-21," it is provided that the Governor may by Proclamation prohibit all persons from taking any fish whatsoever, in every or any specified portion of Western Australian waters, by means of fishing nets and fishing lines or either of such means of capture, or by any other speci-fied means of capture, for any specified term: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of every other power enabling me in this behalf, proclaim and declare as follows:—That all that portion of Western Australian waters defined in the Schedule hereto shall be closed against the use of fishing nets for a term of three years as from the 1st day of April, 1934.

Taylor's (Nannarup) Inlet:-The whole.

BEGULATIONS GOVERNING THE CONSIDERATION OF PETITIONS PRESENTED TO THE GOVERNOR UNDER SUBSECTION (2) OF SECTION 47 OF THE LICENSING ACT, 1911-1922.

1. On the receipt of any petition presented to the Governor in Executive Council, praying for the grant of a new license under Subsection (2) of Section 47 of "The Licensing Act, 1911-1922," the Minister for Justin tice shall cause inquiries to be made, in manner hereinafter appearing, with a view to ascertaining whether such petition is signed by a majority in number of the electors living in the area specified in Subsection (3) of that section (hereinafter called "the statutory area").

- 2. (a) A lithograph or plan shall be supplied by the Court to the Chief Electoral Officer marked with a circle showing the statutory area, and certified to by a qualified officer of the Lands Department.
- (b) The Minister may obtain from the Chief Electoral Officer a roll containing the names of those persons who were qualified as electors under the provisions of "The Electoral Act, 1907-1921," in the statutory area at the date of the presentation of the petition.
- (e) The Minister may require the applicant to prepay the cost of—
  - (i) compiling the roll and of obtaining the report of the Chief Electoral Officer, and the Chief Electoral Officer shall fix a sum which in his opinion will be sufficient to pay such cost; and
  - (ii) the advertisements hereinafter mentioned.
- (d) The Chief Electoral Officer shall report as to whether the signatures on the petition are those of electors in the District who were qualified to vote at an election for the return of a member of the Legislative Assembly at the date of the presentation of the petition.
- (e) Where the place of living of an elector falls partly within and partly without the area comprised in the circle, the Chief Electoral Officer shall, in preparing the roll, include or exclude the name of any person who, in his opinion, resides respectively inside or outside the statutory area.
- 3. The persons whose names appear on the roll as prepared by the Chief Electoral Officer shall be prima facie taken to be persons who at the date of the presentation of the petition were electors qualified to vote in the District at an election for the return of a member of the Legislative Assembly.

Such roll shall be exhibited at the office of the State Licensing Court for a period of 14 days from the date of its preparation, or for such period and in such locality as the Court shall decide, and notice thereof shall be given by the Court in the form Numbered 1 in the Schedule in the Government Gazette and a newspaper circulating in the statutory area.

4. No new names may be added to the roll after the date of the presentation of the petition, but the name of any elector may be objected to by an elector whose name appears on the roll as prepared by the Chief Electoral Officer.

The objection shall be in writing and shall be signed by the objector and lodged in duplicate with the Clerk of the Licensing Court, or with the Clerk of the Court of Petty Sessions, at such place as the Licensing Court may determine, and within such time as the Licensing Court may fix, and shall clearly set forth the grounds thereof. The objection shall be in the form Numbered 2 in the Schedule.

- 5. The sum of 2s. 6d. for each objection shall be deposited with the Clerk of the Licensing Court or the Clerk of Petty Sessions as aforesaid on the lodgment of the objection, and such sum shall be forfeited if the objection is held not to be reasonable
- 6. (a) The Clerk of the Licensing Court or the Clerk of the Petty Sessions as aforesaid shall set down the objection for hearing before the members of the Court, who shall appoint the date and place for the hearing
- (b) The Clerk of the Licensing Court or the Clerk of Petty Sessions as aforesaid, shall give at least four clear days' notice of the objection to the person objected to at his address as shown on the roll prepared by the Chief Electoral Officer, and of the date and place appointed for the hearing. A copy of the objection, setting forth the grounds thereof, shall accompany the notice.
- (c) The Clerk shall give a similar notice to the objector at his address as shown on the said roll.
- 7. The name of every elector whose enrolment is objected to shall be publicly exhibited outside such place or places as the Court may direct, and maintained there until the objection is heard and determined.
- 8. The person objected to may, on the hearing of the objection, either—  $\,$ 
  - (a) appear in person;
  - (b) appear by an agent appointed in writing under his hand; or

- (e) forward by post, addressed to the Clerk of the Licensing Court or the Clerk of Petty Sessions as aforesaid, a statement made by the person objected to and signed before another person whose name appears on the roll as prepared by the Chief Electoral Officer, setting forth the reasons for his remaining on the roll.
- 9. The Court shall hear and determine the objection, and may direct the Clerk to retain the name ou the roll or to strike the name off the roll, or to make such amendment as may be necessary, according to such determination

No grounds of objection shall be entertained, except such as are specifically set forth in the objection lodged as aforesaid.

10. After consideration of any objection the Court shall make a report to the Governor, through the Minister, and on the basis of that report the Governor will decide whether or not the petition is signed by a majority in number of the electors living within the statutory area at the date of the presentation of the petition.

- Section 3 of Statute No. 20 is amended to read:—
   The Research Studentships shall be given under the following conditions:-
  - (a) Post Graduate Studentships of a value not exceeding £150 per annum are open to graduates of the University. An additional sum, not exceeding £100 per annum, may be spent under the direction of the Supervisor of the research for the provision of books, apparatus, and other expenses incidental to the student's work, and for expenses of travelling, to be approved by the Vice-Chancellor. These books and other materials shall remain the property of the Universtiy.
  - (b) The Chancellor shall have received satisfactory assurance that the applicant's means are such as to make it difficult for him to continue as a full-time research student without the assist ance of a Studentship.
  - (c) A Studentship shall be given in the first instance for a period of one year, and that year normally is to be spent in Western Australia. The Academic Board may then renew the Studentship for a period of one or two years, if it is satisfied that the student in the meantime has shown such special ability as warrants the renewal.
  - (d) The student shall not engage in any work other than that for which his Studentship has been granted, without the permission of his Super-
  - (e) Applications should reach the Vice-Chancellor at a date to be fixed by the Vice-Chancellor.
  - (f) Applicants must submit a scheme of work, to be reported on by the Faculties concerned and submitted for the approval of the Senate. A schedule must also be submitted of the estimated amounts which will be required for books, apparatus, travelling, and other ex-
  - (g) The awards will be made by the Academic Board, after reports have been received from The Faculty concerned shall the Faculties. in each case appoint a Supervisor of the student's research. No awards shall be made in any year unless applicants of sufficient merit present themselves.
  - (h) Payment of the grant under the Studentship may be made in instalments, at such times as may be decided, each instalment, with the exception of the first, which will be paid in advance, being payable only on receipt by the University of sufficient evidence that the Molder of the Studentship is satisfactorily pursuing his studies.
  - (i) At the close of the Studentship the research student shall be required to supply a full report to the University on the progress he has made with the work originally undertaken, including copies of any thesis or publications resulting from his work.
  - (j) Whenever publication is made of any work carried out under a Hackett Research Studentship, this fact shall be acknowledged in the publication. If the Academic Board considers a thesis to be of sufficient merit, it may recommend to the Senate the expenditure of an additional sum, not exceeding £75, for the publication of the thesis, on condition that the University receive, without further cost, as many copies as it may require, which it may use in whatever way it may decide.

- (k) A student who is allowed to hold his Studentship wholly or in part outside Western Australia, shall, before leaving the State, sign an agreement with the University. Under this agreement he shall undertake that if, within three years of the completion of his Studentship, he does not either return to Australia and become or remain domiciled therein, or satisfy the Senate that he has made bona fide endeavour to obtain suitable employment in Australia, he shall owe to the University a sum not exceeding one-half the total amount paid by the University in connection with his study outside Australia; such sum to be determined in each case by the Senate. this total amount any sums expended on books and apparatus which have been returned to the University shall be excluded. This debt shall then be repaid to the University on the following conditions:-
  - (i) The student shall, on the termination of the period of three years abovementioned, commence to repay to the University the amount of his debt by halfyearly instalments, unless otherwise then agreed, but so that payment of the debt shall be made within a period not exceeding ten years.
  - (ii) The Studentship shall be deemed to be completed on the 31st December in the year in which the student receives his last payment.

#### STATUTE No. 29-PROFESSORIAL BOARD.

- 1. There shall be constituted a Board to be called the "Professorial Board," which shall consist of the following members:—

  (a) The Dean of each Faculty;
  (b) The Professors of the University;

  - (c) Such Lecturers as the Senate may appoint, on the recommendaton of the Professorial Board, but the number of such Lecturers in the Professorial Board at the same time shall not exceed two.
- The Board, at its first meeting each year, shall appoint one of its members to be Chairman for the year. Should be be absent at any meeting, the members present shall appoint another member as Chairman for the meet-The Chairman shall preside at all meetings of the ing. Board.
- 3. The Board, after report from the Faculty concerned, shall submit to the Senate recommendations regarding the various courses of study.
- 4. The Board, after report from the Faculty or Faculties concerned, shall make arrangements for giving effect to the Statutes and Regulations relating to courses of study in the University.
- The Board, after report from any Faculty or Board concerned, shall nominate for appointment by the Senate, examiners for all examinations conducted by the
- 6. The Board may, on the recommendation of the Faculty or Board of Examiners concerned, require any student to withdraw from any course or from the Uni-
- versity, if his work is found to be unsatisfactory.

  7. The Board shall report to the Senate upon all proposals for the creation or suppression of Professorships, Lectureships, or Faculties; all proposals for the foundation or abolition of Fellowships, Studentships, Scholarships, Exhibitions or Prizes; all proposals for new buildings or equipment and all applications from departments for grants for study or research.

  8. The Board may make recommendations to the
- Senate as to Regulatious governing academic ceremonials.
- The Board may make representations to the Senate
- as to the removal of any Professor, Lecturer, or other member of the Teaching Staff.

  10. The Board shall fix, subject to any conditions made by the Founders and accepted by the Senate, the time and mode of awarding Fellowships, Studentships, Scholarships, Exhibitions or Prizes, and award the same.
- The Board shall receive and consider communications from the Guild of Undergraduates and forward, with or without comment, such as are intended for communication to the Senate.

12. All questions which shall come before the Board shall be decided by the majority of the members present, but the Chairman, in the case of an equality of votes, may give a easting vote. No question shall be decided at any meeting of the Board unless at least two-fifths of the members thereof be present.

13. Subject to the provisions of the Statutes and to the Regulations made by the Senate, the Board shall have power to regulate its own procedure, to fix the times and places of its meeting, and to do such other acts and things as the Senate shall authorise or prescribe, and to make such recommendations to the Senate as the Board may think fit.

14. The Board, after each meeting, shall forward a report to the Senate for its consideration, and the Senate shall have power, of its own motion, to review any decision of the said Board.

15. The words "Professor" and "Professorship" shall respectively include "Associate Professor" and "Associate Professorship."

16. (a) Statute No. 21 (Academic Board) is hereby repealed.

(b) Where in any Statute or Regulations reference is made to the Academic Board constituted by Statute No. 21 hereby repealed, such Statute or Regulation shall be construed and have effect as if the reference made therein were to the Professorial Board hereby constituted.

(e) In every reprint of such Statute or Regulation, the words "Professorial Board" shall be substituted for the words "Academic Board."

### STATUTE No. 30—AMENDMENTS TO STATUTE No. 26—GUILD OF UNDERGRADUATES.

Subject to the provisions of this Statute the Guild of Undergraduates may make regulations—

(a) to provide for the election of officers, for the alteration and interpretation of its regulations, for the registration and affiliation with the Guild of University clubs and societies, and for all other matters requiring regulation;

(b) to authorise the Guild Council-

(i) to make by-laws for the internal management and administration of the Guild;

(ii) to impose fines on members, associates, or affiliated clubs, and societies infringing any regulation or by-law; provided that the limits of such fines shall be clearly stated in the regulations or bylaws;

(iii) to delegate to affiliated councils, clubs, and societies and subsidiary organs of the Guild, a power to make by-laws for their proper management and administration, including a power to impose fines and penalties for breaches of such bylaws. 8. All such regulations shall be subject to the approval of the Senate, and shall be enrolled on a statute book to be kept by the Secretary of the Guild.

### STATUTE No. 31—AMENDMENT OF STATUTE No. 10—CONVOCATION.

Section 7 of Statute No. 10 is hereby amended as follows:—Delete the following words in Section 7:—

And, in addition, a printed notice of meeting shall be sent by post to each member of Convocation, at least ten days before the meeting, stating the business to be considered at such meeting, and the nominations (if any) for the office of Warden which have been received as prescribed by Section 1, of Part III. hereof,

At least ten days before the meeting, a printed notice of the meeting shall be sent by post to each member of Convocation who has requested in writing to be placed on the list of those entitled to receive such notices. The last notice at the end of a two-year period shall contain a form of renewal of the request for notices.

#### UNIFORM GENERAL BY-LAWS.

P.W. 1460/28.

- 1. On notice being published by a Board of a proposition for borrowing money under the provisions of Part VII. of "The Road Districts Act, 1919-1933," and on a demand being made under Section 298, and adhered to, that the question whether or not the loan be raised be submitted to the vote of resident owners of rateable land within the District, or (where the loan is proposed to be raised for works or services which in the opinion of the Board would be of special benefit to a portion only of the District, and notification thereoff was included in the published notice) within a portion of the District, the special Roll of resident owners of rateable land within the District or portion of the District (as the case may be) to be prepared pursuant to Subsection (2) of Section 299 of the said Act, shall be in the Form No. 1 in the Schedule to these By-laws.
- 2. A copy of such special Roll shall be exhibited on the outer door of the office of the Board for not less than fourteen days next preceding the day fixed for taking the vote.
- 3. Any resident owner of rateable land within the District, or the portion of the District if the proviso to Subsection (2) of Section 299 applies, may, by notice in writing given to the secretary not later than ten days before the day fixed for taking the vote—
  - (a) apply to have his name inserted in the Roll, if omitted therefrom; or
  - (b) object to the name of any other person being retained on the Roll, on the ground that such person is not entitled to vote as a resident owner of rateable land.

A notice of objection under paragraph (b) must be in duplicate, and it shall be the duty of the secretary to send one of them to the person objected to.

4. The Board shall hold an open Court to deal with any applications and objections, at a time and place to be fixed, of which seven days' notice shall be given, by exhibiting such notice on the outer door of the office of the Board, and, if practicable, by publishing such notice in a newspaper usually circulating in the District:

Provided that, if no application or notice of objection is received by the secretary within the prescribed time, it shall not be necessary for the Board to hold such Court.

- 5. A certificate that the special Roll has been completed and authenticated shall be written at the foot or end thereof, and such certificate shall be dated and shall be signed by the Chairman and two other members of the Board.
- 6. The polling-place, or, the chief polling place and other polling places if more than one, shall be stated in the notification published pursuant to Section 299 of the said Act of the day on which the vote is to be taken.
- 7. Voting papers to be used at the taking of the vote shall be in the Form No. 2 in the Schedule to these By-laws, and a voter shall indicate his vote in the manuer stated in such form.
- 8. An application for leave to vote in absence shall be in the Form No. 3 in the Schedule to these By-laws, and the voter's declaration, the voting paper and the counterfoils, shall be in the Form No. 4 in the said Schedule. The provisions of Section 87 of the said Act shall, mutatis mutandis, apply as in the case of an election to fill an extraordinary vacancy.
- 9. The Returning Officer shall be the Chairman or Vice-Chairman of the Board, or some other person appointed by the Board.
- 10. As soon as practicable after the votes have been taken, the Returning Officer shall at the polling-place, or at the chief polling-place if more than one, in the presence of such resident owners of rateable land as are in attendance, open the ballot boxes and examine the voting papers, and thereby ascertain and declare the result of the poll, that is to say, whether a majority of those resident owners who voted on the question submitted, namely, "Are you in favour of the loan being raised?" voted "yes" or "no."
- 11. The result of the vote shall be notified in writing by the Chairman of the Board to the Minister, and published in the Gazette.
- 12. Subject to these By-laws, the provisions of the said Act relating to the taking of a poll at the Election of members of the Board, so far as applicable, shall apply as nearly as may be.

- 13. These uniform general By-laws shall have the force of law in all Road Districts throughout the State.
- 14. Part 2, paragraphs (1) to (8) inclusive, of Regulation 17, and Forms 40, 41, and 42, in the Regulations made under "The Road Districts Act, 1919," and published in the *Gazette* on the 4th day of July, 1924, are hereby repealed.
