THE SECESSION REFERENDUM ACT, 1932, AND
THE SECESSION ACT, 1934.

Premier's Department,
Perth, 20th September, 1934.

NOTICE is hereby given that I, the undersigned, Philip Collier, Treasurer and Premier in the Government of Western Australia, in the exercise of the power conferred upon me by Section 6 of "The Secession Act, 1934," have appointed under and for the purposes of the said Act the following persons, that is to say:—the Honourable Sir Hal Pateshall Colebatch, C.M.G., Agent General for Western Australia, of London, England; the Honourable Matthew Lewis Moss, K.C., of London, England; Mr. James McCallum Smith, M.L.A., of Perth, Western Australia, Newspaper Proprietor, and Mr. Henry Keith Watson, of Perth, Western Australia, Accountant, as the delegation of four persons authorised by Section 6 of "The Secession Act, 1934," to be appointed by me as Treasurer aforesaid on behalf of the people of Western Australia to present or cause to be presented the humble application by the people of Western Australia to the Right Honourable the Lords Spiritual and Temporal in the Parliament of the United Kingdom of Great Britain and Northern Ireland assembled, and also of the humble application by the people of Western Australia to the Honourable the Commons of the United Kingdom of Great Britain and Northern Ireland in Parliament assembled, as men-

tioned and provided for in Section 3 and Section 6 of the said Act; and that the said four persons appointed by me as the delegation aforesaid have and may exercise, subject to the said Act, by virtue of the said appointment, all the rights, powers, and authorities prescribed and conferred upon them by Section 7 of the said Act; and notice is also hereby given that I, the said Philip Collier, have also authorised the said four persons appointed by me as aforesaid, and each and every one of them for me and on my behalf, to publish and distribute in the United Kingdom of Great Britain and Northern Ireland and elsewhere as to them may seem meet "The Case of the People of Western Australia in support of their desire to withdraw from the Commonwealth of Australia established under the Commonwealth of Australia Constitution Act (Imperial), and that Western Australia be restored to its former status as a separate self-governing colony in the British Empire," as authorised by Section 2 of "The Secession Act, 1934," for submission to His Majesty the King and to both Houses of the Imperial Parliament, and as printed by or with the authority of the Government Printer of Western Australia, under the supervision of the Clerk of the Parliament of Western Australia, as authorised and provided for in Section 2 of the said Act.
