Establishment of a Local Court at Coolgardie.

PROCLAMATION

WESTERN AUSTRALIA, By His Excellency Sir James Mitchell, K.C.M.G., Lientenant-Governor in and over the State of Western Australia lis. Dependencies in the Commonwealth of Australia.

WHEREAS by Section 5 of "The Local Courts Act, 1904-1921," the Governor may by Proclamation order that Courts, to be called Local Courts, shall be held at such places as he thinks fit: And whereas it is deemed expedient to establish a sitting of a Local Court at Coolgardie once in every month: Now, therefore I, the Lieutenant-Governor, with the advice of the Executive Council, do hereby order that a Local Court, under the said Act, shall be holden at Coolgardie once in every month, commencing in October, 1934.

AT a meeting of the Executive Council held in the Executive Council Chambers, at Perth, this 26th day of September, 1934, the following Orders in Council were authorised to be issued:—

The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 775/34.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works, and stormwater drainage works; And whereas it is further provided that the Governor may exempt reticulation works from certain sections of this Act: Now, therefore, His Excellency the Lieutenant-Governor with the advice of the Executive Council hereby approves of the construction and extension by the Minister for Water Supply Sewerage, and Drainage of the following works under the said Act, and does hereby exempt such works from the operations of Sections 20, 21, 22 and 23 of the said Act:—

Description and Location of Reticulation Works Approved and Exempted:—The construction as a reticulation work, of a six-inch diameter stoneware pipe sewer, with manholes and all other apparatus connected therewith:—Commencing at Manhole No. 203, situated in the North-East corner of Lot 25, Brassey Street; thence proceeding South for a distance of 296 feet, through said Lot 25, Brassey Street, across Brassey Street, through Lot 24, Brassey Street, to Manhole No. 214, situated in the North-East corner of Lot 1, Wood Street; thence again proceeding South for a distance of 225 feet, through the said Lot 1, Wood Street, across Wood Street to Manhole No. 217, situated on the South side of Wood Street, in lieu of the six-inch diameter sewer between Manhole No. 203, situated in the North-West corner of Lot 67, Devon Road; thence proceeding South for a distance of 296 feet through Lots 67, 65, 63, 61, 59, 57, 55, 53, and 51, Devon Road, to Manhole No. 214 situated in the North-West corner of Lot 49, Devon Road; thence again proceeding in a Southerly direction for a distance of 225 feet, through Lots 49, 47, 45, and 43, Devon Road; and Lot 1, Wood Street, to and across Wood Street to Manhole No. 217, situated in the North-East corner of Lot 25, Wood Street, which were portions of the works as advertised in the Government Gazette of Western Australia on the 6th day of July, 1934, and as detailed in the plans and specifications therein referred to.

This Order in Council shall take effect from the 5th day of October, 1934.

Perth Road District-Peninsula Ward.

Proposed six-inch diameter water main commencing at the existing eight-inch diameter main in Guildford Road, at the intersection of Guildford Road and Ferguson Street, and proceeding thence in a South-Easterly direction along Ferguson Street to Mephan Street; thence South-Westerly along Mephan Street to connect with the existing three-inch diameter main at the intersection of Mephan Street and Caledonian Avenue (length about thirty-one and a half chains).

Canning Road District.

(b) Proposed four-inch diameter water main commencing at the existing twelve-inch diameter main in North Beach Road at the intersection of North Beach Road and Egina Street, and proceeding thence in a Southerly direction along Egina Street to a point opposite Lot 252 (length about fifteen and a half chains).

Proposed four-inch diameter water main commencing at the existing four-inch diameter main in Angelo Street, at the junction of Angelo Street and Strickland Street, and proceeding thence in a Southerly direction along Strickland Street to connect with the existing three-inch diameter main opposite Lot 112 (length about eighteen chains).

- (b) Proposed four-inch diameter water main commencing at the existing six-inch diameter main at the junction of Barrett Street and Gregory Street, and proceeding thence in an Easterly direction along Barrett Street to connect with the above-mentioned proposed four-inch diameter main at the junction of Barrett Street and Connolly Street (length about twenty chains).

- (c) Proposed four-inch diameter water main commencing at the existing four-inch diameter main at the junction of Lime Street and Royal Street, and proceeding thence in a Northerly direction along Lime Street to connect with the existing four-inch diameter main at the junction of Lime Street and Brown Street (length about six chains).

The above mains to be complete, with valves, hydrants, and all necessary apparatus, and the existing one-inch and one and a quarter-inch mains to be lifted, as shown in red on Plan M.W.S.S. & D.D., W.A., No. 5408.

Claremont Municipality.

Proposed four-inch diameter water main commencing at the existing four-inch diameter main at the junction of St. Quentin Avenue and Stirling Road, and proceeding thence in a North-Easterly direction along St. Quentin Avenue to connect with the existing three-inch diameter main opposite Lot 2, Bay View Terrace (length about seventeen chains).

HIS Excellency the Lieutenant-Governor in Executive Council has been pleased to approve of the following Bylaws for the Control and Management of the Kalgoorlie Public Cemetery in lieu of those previously gazetted, which are hereby cancelled.

KALGOORLIE GENERAL CEMETERY (Town Lots 768-769-1367).

By-laws.

In pursuance of the powers vested in them, the Trustees of the Kalgoorlie General Cemetery make the following By-laws (that is to say):-

- 1. That all applications for interment shall be made to the Secretary of the Trustees, and six working hours notice shall be given to the officiating Minister of Religion and the sexton prior to the time fixed for the burial, otherwise an extra charge shall be made.
- 2. The name of the deceased, age, and other particulars mentioned in Schedule "C' shall be furnished when giving the order, and no burial shall be permitted without such order.
- 3. Prior to conducting any interment within the Cemetery or making use of the Cemetery for any purpose connected with interments, every undertaker shall pay to the Trustees an annual fee of 10s. 6d., and shall at the time of making such payment, give, if required, his assent in writing to such conditions as the Trustees assent in writing to shen conditions as the Trustees may deem fit to impose. Upon such assent being given and payment of the fee made, he shall receive a "Permit," to hold good during good behaviour and until the first day of July following, and unless in the possession of such a "Permit" no undertaker shall be allowed to engage in or carry out any duty or work within the Cemetery.

- 4. The Trustees shall cause all ordinary graves to be dug, but any person desiring to construct a brick grave or vault shall be permitted to construct the same, under the direction of the Secretary or Surveyor, on payment of the required fees, and every coffin placed therein shall be bricked-in, cemented, and made and kept
- Every coffin shall have upon the lid an approved metal plate, bearing the name of the deceased stamped or otherwise indelibly inscribed in legible characters thereon. No coffin not complying with this By-law shall be admitted to or be interred in the Cemetery, except where so ordered by the Coroner or other authority.

6. That every grave shall be at least six feet deep, except those used for the burial of infants, which the Trustees may allow to be of lesser depth; but no interment shall be allowed in any grave with a less depth than three feet from the top of the coffin to the original surface of the ground.

7. That, in the case of application for interment in any private grave or vault to which during life the deceased person had no claim, the written consent of the owner shall be given with application or other satisfactory evidence that the person desiring to bury therein

is entitled to do so.

The hours for burials shall be as follows:-Week days:-September to April inclusive, 9 a.m.

to 6 p.m.; May to August inclusive, 9 a.m. to 5 p.m.

Sundays: -Throughout the year from 9 to 10 a.m.

and from 12 noon to 5 p.m.

- That no burial shall be allowed to take place before or after the hours above-mentioned except by special permission and upon payment of the fee for burials "not in the usual hours."
- 10. That the time stated in the order for burial (Schedule C) shall be the time when the funeral is to be at the Cemetery and the same shall be punctually ob-
- 11. That every funeral shall enter by the principal entrance and thence follow the sexton to the grave. No bicycle, velocipede, carriage or vehicle except hearses and mourning-coaches, shall be permitted to pass the said entrance. Horses shall not be driven faster than at a walking pace, and no horse or other animal shall be ridden in the Cemetery.
- 12. That the Trustees shall not (except in very exceptional cases) permit the removal of any corpse from any grave for re-interment in this or any other Cemetery, and before such exceptional case be dealt with by the Trustees, a written application, setting forth the reasons for the proposed removal of such corpse, and verified by a statutory declaration, shall be produced by the nearest available representative of the deceased; and, in the event of such application being granted, the permission of the Governor (except where the re-interment takes place in this Cemetery), in addition to the permission of the Trustees, shall be obtained. If found necessary, the coffin shall be enclosed in a second and air-tight wooden or leaden coffin prior to removal.
- That any person desiring ground in the Cemetery for a private grave, vault, tomb, monument, cenotaph, tombstone, railing, wall, or for any other purpose, shall apply to the Trustees therefor. If approved, the Trustees, on payment of the required fee, shall issue to such person so applying, a Certificate of Right of Burial in the form specified in Schedule B.
- 14. Any person desiring to place or erect any monument, tombstone, or enclosure in any part of the Cemetery shall, before obtaining permission to do so, submit a plan of such monument, tombstone or enclosure, and specify the materials of which it is to be composed, to the Trustees, and shall obtain such permission in writing before proceeding with the work in the form of Schedule
 - 15. That no catacomb shall be allowed.
- And every person who shall place or erect any monument, tombstone, or enclosure upon any grave, the exclusive right of which has not been obtained, shall keep the same in repair; and if, after receiving one month's notice in writing from the Trustees, such repairs are not executed, then the Trustees may order such monument, etc., to be removed.
- 17. Every person who has the exclusive right of burial in any grave shall keep such grave, and any erection or construction thereon, in proper repair; and, if after re-

ceiving notice in writing from the Trustees requiring such repairs to be executed, shall fail so to do, then, after the expiration of twenty-eight days, the Trustees may cause such repairs to be executed, and may recover the cost thereof from such person in a summary way before two Justices in Petty Sessions.

That no erection of an estimated value of ten pounds (£10) or over will be permitted until a certificate of right of burial shall have first been had and ob-

tained.

19. That every erection shall be placed upon proper and substantial foundations, and, if required by the Trustees, shall extend to the bottom of the grave. All refuse, rubbish, or material remaining after any work, is completed shall be removed from the Cometery at once. by and at the expense of the person causing the same.

20. All materials required in the making, repairing or completion of any work shall, as far as possible, be prepared before being taken into the Cemetery, and shall be subject to the approval of the Secretary or Surveyor. Any material rejected shall be immediately removed from the Cemetery by the Contractor concerned.
21. Monumental masons and other tradesmen shall,

before commencing any work within the Cemetery, deposit with the Secretary to the Trustees the sum of ten shillings, which shall be forfeited if the provisions of either of the two preceding By-laws be not complied with to the satisfaction of the Secretary or Surveyor.

22. Any person taking part in dressing or attending to any grave shall comply with the following rules,

namely:-

(1) That no rubbish or any other material removed in dressing a grave shall be placed on any other grave or pathway, and, if placed on any adjoining ground, shall be removed immediately after the completion of the work.

(2) That no loam shall be taken from any portion

of the Cemetery for the purpose of dressing any

grave.

- (3) That no grave shall be dressed in wet weather, except by special permission of the surveyor, nor shall any materials be wheeled or carted along any path or road while the surface is soft with rain or otherwise. Work in all cases must be carried on with due despatch, and only dur-
- ing regulation hours.
 (4) That monumental masons, grave-dressers or gravedecorators shall not be permitted to carry on work in the Cemetery during other than the hours of from 8 a.m. to 5 p.m. week days, Saturdays and Sundays excepted, when no work is to be done from noon Saturday till 8 a.m. on the Monday morning, without the written permission of the Secretary or Surveyor.
- Licenses for grave dressing or decorating may be issued by the Trustees in the form contained in Schedule E; such license to be renewed annually in the month of July.
- 24. That any workman or other employee, whether employed by the Trustees or by any other person, shall at all times, while in the Cemetery, he subject to the supervision, direction, and control of the Surveyor, and shall obey all such directions, and shall be removable from the Cemetery upon any breach of the By-laws, or any refusal or neglect to comply with or obey any such directions.
- That no child under the age of fourteen years shall be admitted into the Cemetery, except in charge of a responsible person.
- 26. That no smoking shall be allowed within the Cemetery, nor shall any explosives be discharged therein, except by special permission.
- That every driver of a hearse, mourning-coach, or other vehicle, and every pedestrian shall keep strictly to the roads and pathways as laid out for vehicles and pedestrians respectively, and vehicles shall only be turned at points where provision for so doing is made.

28. That no animals other than horses drawing hearses or mourning-coaches shall be permitted to enter

the Cemetery, except by permission.
29. That no person in the Cemetery or its approaches shall commit any nuisance or trespass, or be guilty of any breach of decorum, or cut, pluck, gather or take out of the Cemetery any flower, plant, shrub or tree, or any part thereof, or do any injury whatsoever thereto or to any plot, border railing, fence or any erection or road, or remove or interfere in any way with anything laid,

built or placed on or in any grave or burying place; and any person or persons so offending may be proceeded against in accordance with the Act.

30. That no person shall promote or advertise or carry on within the Cemetery or its approaches any trade, business, or calling, either by solicitation, distribution of circulars or carries and the solicitation of circulars or carries and carri circulars or cards or otherwise, or by any other system of advertisement whatever.

31. That any person committing any breach of any of these By-laws shall thereupon be forthwith removable from the Cemetery by the Trustees or Secretary or Surveyor, and shall be treated as a trespasser, and may be proceeded against accordingly, in addition to any other proceedings or penalties to which such person may be subject.

32. That licenses to undertakers, monumental masons, 32. That heenses to undertakers, monumental masons, grave-dressers, or grave-decorators, and licenses for various purposes not otherwise provided for, may be issued by the Trustees in the form set out in Schedule E.

33. That a plan of the Cemetery, showing the distribution of the land, sections, blocks and graves numbered, a Register of Burials, and a Register of Certification.

cates of Right of Burial shall be kept at the Office of the Trustees

34. The "Secretary" or "Surveyor" as referred to in these By-laws means the person for the time being employed by the Trustees as the Secretary or Surveyor of the Cemetery, and such person or persons shall, subject to the Trustees, exercise a general supervision and control over all matters pertaining to the Cemetery and to the carrying out and enforcement of these By-laws, and the discretary of the and the direction of such person or persons shall in all cases and for all purposes be presumed to be and to have been the direction of the Trustees.

35. All fees and charges payable to the Trustees shall be in accordance with Schedule A.

That all fees may be recovered and all proceedings under these By-laws taken before two Justices in Petty Sessions, except where otherwise provided for.

Williams Common By-laws.

Department of Lands and Surveys, 04. Perth, 26th September, 1934. Corr. 10337/04. HIS Excellency the Lieutenant-Governor in Executive Council has been pleased to approve of the following Bylaws for the Control and Management of Reserve 8708, for Common, Williams Townsite, and to repeal all By-laws previously gazetted relating to this Reserve and Reserve 9576.

Interpretation.

In these By-laws the following terms shall have the meanings as stated:-

- "District"—The locality or area for the time being under the control of the Williams District Road Board.
- "Chairman"—The member acting for the time being as Chairman of the Board.
- "Board"—The Williams District Road Board.
- "Member"—A member of the Williams District Road Board.
- "Road"—Any road as defined by "The Road Districts Act, 1919-33."
- "Reserve" -- Any reserve or common under control of the Board.
- "Person" shall include the plural, also a body corporate.
 - "Officer" shall mean any officer of the Board.
- "Ranger" shall mean the ranger appointed by the Board.
- "Secretary" shall mean the secretary of the Board.
- 1. All stock running on the common otherwise than in accordance with these By-laws shall be treated as trespassing stock.
- 2. That with the exception of stock owned by bona fide travellers, travelling teamsters, or as packers as hereinafter provided for, no person shall run or depasture stock of any description on the common unless the owner of such stock is the holder of a license under these Bylaws and prescribed fees are paid, except as hereinafter provided, and the following fees shall be payable in advance in respect of all stock so running or depasturing thereon. Persons residing within the boundaries of the Williams Townsite and the Williams Road District only to have the right to a license to run stock upon the common.
- 3. The scale of fees shall be as follows:—Heifers over six months—£2 per head per annum or portion of year; dairy cows—£1 per head per aunum or portion of year.
- 4. Bona fide travellers, teamsters, and packers shall be allowed to run their horses and cattle on the common for the space of three clear days free of charge. Should that period, however, be exceeded, they shall be charged at the rate of 3s. per head per week or part of a week for all horses and cattle.
- 5. Travelling cattle and sheep waiting for railway trucks shall be allowed to run on the common for one clear day free of charge, and travelling cattle and sheep being unloaded from railway trucks shall be allowed to run on the common one (1) day free of charge. If these times are exceeded, a charge of five shillings per 100 for sheep and 6d. per head for cattle per day or part of a day will be made.
- 6. No license shall be granted to any person to depasture on the said Reserve No. 8708 at any one time a greater number of cows than one head with calf up to six months old and one heifer.
- 7. Any person or persons running stock on the common may change such stock from time to time; provided that he or they do not at any time exceed the number for which he or they shall pay commonage fees.
- 8. That it shall be compulsory upon all persons making use of the common as heretofore provided to furnish the Secretary of the Board or Rauger of the Board with a list, giving a correct description of all stock placed by them on the common, within twelve hours of placing such stock thereon, and to obtain from such officer a certificate showing the number and description of such stock.
- 9. That all annual license fees shall be due and payable on the first day of July in each year, or on the date of issue of license, if applied for and issued during a current year, and the Secretary or Ranger shall at any time, with the approvel of the Chairman or any two members, have authority to take legal proceedings for the recovery of any fees unpaid.
- 10. That no bull over the age of four months (except by permission of the Board) shall be allowed on the common, and, in addition to the penalty hereinafter prescribed and recoverable under these By-laws against the owner thereof, if known, any such bull found thereon shall be liable to be dealt with in the manner prescribed by "The Cattle Trespass, Fencing, and Impounding Act, 1882" (46 Vict., No. 7).
- 11. The Secretary of the Board shall decide upon which portion of the common any licensed or travelling stock shall at any time depasture, and shall have power to travel such stock at any time from any portion of the common to another portion of the same.

- 12. The Board shall not be responsible for damage or injury sustained from any cause whatever by any cattle depasturing on the said common under the provisions of these By-laws.
- 13. The Board shall be the sole judge of what con stitutes a bona fide butcher, dairyman, traveller, teamster, drover, or packer within the meaning of these Bylaws
- 14. The Board prohibits the doing by unlicensed persons of any act or thing for which a license may be granted under the provisions of these By-laws; and any unlicensed person doing such act or thing shall be guilty of an offence against these By-laws.
- 15. Every licensee under these By-laws shall produce his license upon being required to do so by any constable or officer of the Board.
- 16. Every person who does, permits, or suffers any act, matter, or thing contrary to any of these By-laws, or commits or permits any breach or neglect thereof, shall be deemed guilty of an offence against these By-laws, and be liable to a fine or penalty not exceeding Five pounds and Two pounds per day for each succeeding breach, but not more than Twenty pounds in the aggregate.
