MUNICIPALITY OF NORTHAM.

By-law No. 29. P.W. 1272/30.

A By-law of the Municipality of Northam, made under Section 179 of "The Municipal Corporations Act, 1906," and Numbered 29, for Regulating the Sale of Food and other Articles of Merchandise by Hawkers, and for Regulating the Sale of Food and other Merchandise at movable or temporarily fixed Stalls.

IN pursuance of the powers conferred by the said Act, the Mayor and Councillors of the Municipality of Northem order as follows:---

1. By-law No. 29 of the Municipality of Northam is hereby repealed, and By-law No. 51 of Part VIII. of the Model By-laws under "The Health Act, 1912," is hereby repealed, so far as such By-law applies to the Municipality of Northam, but such repeal shall not affect any license granted under either of such By-laws until the expiration of the term of any such license. 2. In the interpretation of this By-law, the word "Municipality" shall mean the Municipality of Northam, and the word "Council" shall mean the Council of the Municipality of Northam.

3. No person shall hawk food or any article of merchandise in any part of the Municipality without first having obtained a license from the Council, and then only during the currency of such license.

4. Any person (other than a person mentioned in Clause 14 hereof) who, within the Municipality, travels and trades on foot, or with any vehicle or animal or otherwise, carrying to sell, or exposing or offering for sale, within the said Municipality any food or other article of merchandise, or who (not being a person described in the provise hereto) goes from house to house there soliciting orders for the sale of food or other article of merchandise, shall be deemed to hawk the same: provided, however, that nothing in this Bylaw shall be deemed to prevent the soliciting of orders by any person who is registered under "The Factories and Shops Act, 1920," or any amendment thereof as a shopkeeper in respect of any shop within the Municipality which is not a stall, tent, vehicle, or boat, nor the soliciting of orders by an employee of any such persons.

5. No person shall keep, manage, or conduct any movable or temporarily fixed stall in or near any street in the Municipality for the sale of food or any other article of merchandise, unless such person is licensed by the Council, and such stall shall be erected only at such place or places as mentioned in the license issued to such person.

6. Any license to be obtained under this By-law shall be either an annual license or a quarterly license.

An annual license shall remain in force during the whole of the financial year of the Local Authority in which it shall be issued.

A quarterly license shall remain in force until the last day of the month of January, April, July, or October next after the date of the issue of such license.

The financial year of the Local Authority shall be from the first day of November in any year to the thirty-first day of October in the following year.

7. The fee to be paid for any license under this By-law shall be as set out in Schedule B hereto.

8. No licensed hawker shall, without the special permission of the Council, expose any goods for sale within the area bounded by Gairdner Street on the West, Peel Terrace on the East, the Avon River on the North, and the Eastern Railway on the South.

9. No licensed hawker shall, without the special permission of the Council, hawk any goods after the following hours:—(a) The hour of six o'elock p.m. on any week day, except Wednesday; (b) the hour of twelve o'elock noon on any Wednesday.

10. No hawking shall, without the special permission of the Council, be done on Sunday.

11. Every hawker, whilst employed in hawking, shall produce his license, upon being required so to do by any officer of the Council.

12. Every person engaged in the trade of a hawker of food shall comply with the following conditions:-

- (a) He shall cause all food usually consumed in the condition in which it is sold to be protected from contamination by flies and dust by means of screens composed of glass or fine-meshed wire gauze, or other material approved by an inspector or officer of the Council;
- (b) He shall not permit any person, except an officer of the Council, to handle or touch any food in his vehicle;
- (c) He shall maintain his clothing and person at all times in a clean condition.

13. The forms of application for license and of license are set forth in Schedule A hereto.

14. The provisions of this By-law shall not apply to:---

(a) commercial travellers or other persons selling or seeking orders for the sale of food or other articles of merchandise to or from any person in the Municipality who is a dealer therein: provided that such sale is made or such orders sought at the shop of such dealer;

- (b) persons selling newspapers;(c) sellers of goods (other than any article of food) of their own manufacture: provided such goods be manufactured within the Municipality;
- (d) persons selling food or other article of mer-chandise, or keeping or managing a movable or temporarily fixed stall, to raise funds for any charitable purpose;
 (e) persons selling or exposing for sale food or other
- articles of merchandise in any public market or fair legally established, or upon any race-course, agricultural show grounds, or public recreation ground.
