WHEREAS by "The Factories and Shops Act, 1920," it is enacted that the Governor may by Proclamation temporarily suspend the operations of the said Act, insofar as it applies to the closing time fixed or appointed for any shop or shops: And whereas it is expedient to exercise such power in manner hereinafter appearing: Now therefore I the said Lieutenant-Governor by and Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do hereby, by this Proclamation, suspend the operations of the said Act between the hours of six o'clock and nine o'clock in the evening of Monday, Tuesday, Wednesday, Thursday and Friday in every week during the

period commencing on the First day of January, 1935, and ending on the Thirty-first day of December, 1935, insofar as it applies to the closing time of shops conducted in Open Markets which are kept open for the conduct of business therein between the times aforesaid and duct of business therein between the times aforesaid and on the days aforesaid, and in which shops home-made jams and preserves, honey, butter (other than factory butter) and eggs, hams and bacon, not being factory hams or bacon, are sold or offered for sale; provided that only the said goods shall be sold or offered for sale between the said times by virtue of this Proclamation, and the said shops shall not be kept open for the sale or offering for sale of any other goods which cannot otherwise be lawfully sold or offered for sale between the times aforesaid. times aforesaid.

Description and Location of Reticulation Works Approved and Exempted.—Metropolitan Reticulation Main Improvements.—Bayswater Road District:—Proposed four-inch diameter water main commencing at the existsing eight-inch diameter main at the intersection of Slade Street and Guildford Road and proceeding thence in a North-Westerly direction along Slade Street to connect with the existing three-inch diameter main at the junction of Slade Street and Aughton Street (length about twenty-five chains).

The above main to be complete with valves, hydrants, and all necessary apparatus, and the existing one and a half inch main to be lifted, as shown in red on Plan M.W.S.S. & D.D., W.A., No. 5425.

This Order in Council shall take effect from the 23rd day of November, 1934.

By-laws for the Management and Control of Halls.

WHEREAS by "The Road Districts Act, 1919-33," the Road Board of any District is empowered to make By-laws for all or any of the purposes mentioned in the said Act; and whereas the Wyalkatchem Road Board, under and by virtue of the said Act and of every authority enabling it in that behalf, doth hereby make and publish the following By-laws attached herewith:—

1. "Board" shall mean the Wyalkatchem Road

Board.

"Secretary" shall mean the secretary for the time being of the Wyalkatchem Road Board.

Hall' means the Town Hall and Lesser Hall.

"Caretaker" means the caretaker of the Hall duly

appointed by the Board.

- 2. Application for the hire of the hall, or any room or furniture, shall be made to the secretary not less than 24 hours before the time that such hall, room, or furniture is required, and shall state the time and the purpose for which the hall, room, or furniture is required.
- 3. The name and place of abode of the actual and responsible person or persons hiring the hall, or any room or furniture, shall be given in the application for the hire of the hall, room, or furniture.
- 4. The application for the hire of any furniture or crockeryware shall state the precise locality to which the said furniture is to be removed and the Board, when granting the use of any crockeryware or furniture, may fix the date and hour when such crockeryware and/or furniture shall be returned to the hall.
- 5. When any furniture or crockeryware has not been returned to the hall at the stated date and hour, then the Board may forthwith have the furniture and/or crockeryware returned at the hirer's expense.

6. The rent of the hall or any room or furniture or crockeryware shall be paid with each application.

- 7. The Board at any time may demand that the hirer shall, prior to the term of engagement, deposit an amount estimated to cover any damage that might occur during the term of engagement.
- 8. Any person or persons having hired the hall, or any room or furniture, shall give up possession promptly at the time agreed upon, and shall leave the hall or any room or crockeryware clean and fit for other occupation, and the furniture in good condition and in its normal position.
- 9. The Board reserves the right to refuse to hire the hall, or any room or furniture, to any applicant for the hire of same without assigning any reason for such refusal.
- 10. The Board may, at any time, cancel any agreement made for the hiring of the hall or any room or furniture.
- 11. In the event of two or more applications being made for the hire of the hall, or any room or furniture, for the same date and hour the Board may, without considering priority of application, determine to which applicant the hire of the hall, or any room or furniture,
- shall be granted.

 12. The hirer of the hall or any room shall comply with the provisions of the Health Act, Entertainments Tax Act, and any other Act in force for the time being applicable to such hiring and use of hall, or any room. If in the opinion of the Board all the necessary actions have not been taken to comply with the provisions of the aforementioned Acts, the Board may at any time prior to or during the term of an engagement, forbid and prevent the use of the hall or any room.
- In the event of the use of the hall or any room being forbidden or prevented under the last preceding By-law, the hirer shall forfeit the full amount payable for the hire of the hall or any room, as if the hire had been duly fulfilled, and the Board shall not be responsible for any loss or damage incurred by the hirer.

14. No fermented or spirituous liquors shall be brought into or consumed in the hall or any room, ex-

cept when permitted by the Board in writing.

15. No person shall smoke any tobacco, cigar, cigarette or objectionable substance nor strike or otherwise ignite any light in the hall or any room during any ball or public entertainment, or at any gathering of persons in the said hall or room, whether such persons have been admitted by the payment of money or otherwise, except at any banquet or smoke social.

- 16. No person shall, in any part of the hall or any 1:00m:-

 - (a) use profane or improper language;
 (b) enter or be allowed to enter whilst intoxicated;
 (c) be guilty of any misbehaviour whatsoever;
 - (d) damage, mark, or deface any wall or any part of the hall or any room. Any person who does, permits, or suffers such damage shall be liable to pay the cost of all such damage in addition
 - to any penalty imposed by these By-laws;
 (e) stand, loiter, or cause any obstruction whatsoever; any person so doing shall immediately disperse on being requested to do so by the hirer, the secretary, the caretaker, or any other duly authorised officer of the Board, or police constable, whether in uniform or otherwise.
- No offensive impersonations or representations of living persons or anything calculated to produce a disturbance, riot, or breach of the peace shall be permitted in the ball or or in the hall or any room.

18. No encouragement shall be given to improper characters to assemble in the hall or any room.

19. Skating will not be permitted under any consideration

20. Children under ten years of age must be under responsible supervision when in the hall or any room.

IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

(No. 8 of 1934.)

Between Western Australian Government Electric Tramways, Trackless Trams, and River Ferries Employees' Union of Workers, Perth, Applicant, and The Commissioner of Railways of Western Australia, Respondent.

THE Industrial Board for Government Ferry Employees, in pursuance of the powers and duties conferred upon it by Section 107 of "The Industrial Arbitration Act, 1912-1925," and in accordance with a remission to it by the Court of Arbitration, doth hereby make the following Award in connection with the industrial dispute between the abovenamed parties.

AWARD OF INDUSTRIAL BOARD.

1.—Term.

The currency of this Award shall be three (3) years from the date thereof.

2.—Definitions.

(a) "Casual hand" means a worker employed for less than one (1) week continuously, but does not include a worker who, when work is available, leaves his employment before the expiration of one (1) week.

(b) "Deck hand" shall mean a worker who ties up, splices ropes, coals, and cleans ship, issues tickets for cash and/or collects same, and performs other duties, as required

required.

3.—Hours of Duty.

(a) A week's work shall consist of forty-four (44) hours, to be completed in six (6) days, spread over seven (7) days, commencing Sunday, to the finishing time of the last boat on the following Saturday.

(b) The minimum time to be paid for each day (except Sunday) shall be seven (7) hours, and on Sunday

eight (8) hours.
(c) Three (3) hours shall be the minimum time paid for any portion of a shift.

4.—Day Off.

Each worker shall be rostered to have one (1) day off in each week.

In the event of the cancellation of his day off, twenty-four (24) hours' notice of such cancellation shall be given to him.

If, after receiving notice of cancellation of his day off a worker is called upon to work, he shall be paid for a minimum of seven (7) hours at the rate applicable to the day.

If, after receiving notice of cancellation of his day off, a worker is not called upon to work, the worker shall be given an allowance of four (4) hours at ordinary rate.

5.—Sunday Time and Overtime.

(a) The time worked on Sunday up to a maximum of nine (9) hours shall be included in the week's work of forty-four (44) hours, but the extra rate prescribed for Sunday time shall stand alone and be paid for in addition to the week's earnings.

(b) All time worked in excess of nine (9) hours per day shall be paid at the rate of time and a half: Provided that where the overtime is necessitated owing to

day shall be paid at the rate of time and a half: Provided that, where the overtime is necessitated owing to a relieving man not coming on at the appointed time, overtime shall be at the rate of time and a quarter for the first hour and time and a half thereafter.

(c) Workers employed on Sundays shall be paid at the rate of time and a half: Provided that this rate

shall not apply to workers finishing duty on last boat

immediately following midnight on preceding Saturday.

(d) No shift shall be rostered to exceed a spread of twelve (12) hours: Provided that, if during actual operation it is necessary to extend the shift to fourteen (14) hours, double ordinary rates for all time worked in excess of twelve (12) hours shall be paid, with a minimum of one (1) hour. In case of accident or breakdown of the Ferry Service, this overtime rate shall not apply.

(e) All time worked in excess of forty-four (44) hours in any one week shall be paid for at the rate of time and a quarter: Provided that time on which over-time rates as per Subclauses (c) and (d) is payable will not be subject to the extra rate provided for in this

subclause.

6.—Meal Relief.

Workers shall not work longer than five (5) hours fifteen (15) minutes between meal relief, and the minimum period shall be forty-five (45) minutes.

7.—Duty Rosters.

(a) Rosters shall be posted at jetty on Fridays showing the shifts of workers for the following week: Proing the shifts of workers for the following week: Fro-vided that always such roster may be suspended or varied in case of sickness, or on holidays. Alterations to rostered shifts for the following day shall be posted not later than noon each day. In the case of worker being off duty when alteration posted, he shall be personally notified.

(b) Rostered shifts shall be made to rotate as far as

practicable.

(c) Workers shall not be booked up for duty until (c) Workers shall not be booked up for duty until they have had ten (10) hours off duty, except in cases of emergency, or, where necessary, to facilitate the rotation of shifts, or on a day following a public holiday: Provided that in all cases there shall be a minimum of eight (8) hours off duty.

(d) Workers required for Sunday duty shall be rostated in rotation.

tered in rotation.

(e) Workers may, on obtaining approval from the Officer in charge, exchange shifts or days off: Provided there is no loss or gain to the Commissioner.

8.-Uniforms.

Workers shall be supplied with the following uniforms after three (3) months' service:—Two pairs of trousers, one cap, annually; one serge coat, one woollen jersey, one oilskin coat, every alternate year.

9.—Guaranteed Work.

The Commissioner shall guarantee to each worker, other than a casual, a full week's work, except during other than a casual, a full week's work, except during such period as by reason of any action on the part of any section of his employees, or for any cause beyond his control, he is unable to wholly or partially carry on the running of the ferries.

The guaranteed period may be reduced, as follows:—

(1) In respect to any worker under suspension: Provided that any worker suspended on a charge which is not sustained shall be entitled to the benefit of the guarantee during the period of

benefit of the guarantee during the period of his suspension.

(2) In respect of any day when, as the result of a vote of the workers concerned, takes with the consent of the Commissioner, or by agreement between the Union and the Commissioner, a holiday is taken.

10.-Maximum Overtime Payment.

Double time shall be the maximum for overtime payable under any of the provisions of this Award.

11.—Promotion.

Promotion shall be made on capability, suitability, seniority and record.

12.-Holidays.

The following days shall be regarded as holidays, and all workers, other than casuals, shall be paid for such days:-

(a) Time and a half on Good Friday, Anzae Day,
Labour Day, Christmas Day, Easter Monday.
Boxing Day, and New Year's Day;
(b) Should any of the holidays mentioned occur dur-

ing the time a worker is on annual leave a day shall be added to his leave, at ordinary rate;

(c) If a worker is off duty through sickness, and any of the holidays mentioned occur within the first two (2) months of such absence from duty, he shall be paid for such day.

13.—Annual Leave.

(a) After twelve (12) months' continuous service in the employ of the Commissioner, all workers shall be allowed two (2) weeks' leave, of which twelve (12) days shall be paid for at the ordinary rate of eightyeight (88) hours.

(b) All workers, after six (6) months' continuous service, shall be entitled to the holidays set out in the preceding subclause in proportion as the length of service is to the full number of holidays for the twelve

(12) months.

(c) Annual leave shall be paid for at the rate of pay the worker has been in receipt of for the greatest por-tion of the period of service, in respect of which the leave is given.

(d) Holidays may, subject to the approval of the Commissioner, be allowed to accumulate for two (2)

14.—Absence through Sickness.

No deduction shall be made from annual holidays for the period any worker is off duty through sickness, unless the absence exceeds three (3) calcudar months. Any worker losing time through sickness shall be reduced in wages only to the extent of the time actually lost through such sickness.

15.—Transit on Trams.

Workers shall be entitled to employees' tickets when travelling on the W.A. Government Tramways on ser-

16.—Charges against Workers.

(a) Any charge brought against a worker by an officer of the Commissioner shall be made within fourteen (14) days of the officer's first knowledge of the occurrence.

(b) Each worker shall himself provide, when called upon with the least possible delay, any report or statement which may be required by the Officer in charge.

(c) When a worker has made a statement to an

Officer in charge, and which statement such officer has taken down in writing, the worker shall be either furnished with a copy of such statement or allowed to take

a copy of it.

(d) Where a charge involving dismissal is made against a worker who has not the right to approach the Appeal Board constituted under Railway Act, 1904, an inquiry shall, if the worker so desires, be held by the General Manager or officer appointed by him.

The worker concerned shall be supplied with a copy of the charge at least twenty-four (24) hours prior to

of the charge at least twenty-four (24) hours prior to

holding of inquiry.

An officer of the Union may attend the inquiry and represent the worker, and shall be entitled to call evidence on his behalf.

(e) Any worker against whom a charge is made shall be supplied with a copy of same and the name of person making the said charge.

(f) If a final decision in any case in which a charge

has been made against a worker be not given within three (3) calendar months of the occurrence first coming to the knowledge of the head of the branch, the charge in question shall lapse.

17.-Records.

The secretary of the Union shall be entitled at all reasonable times to inspect the Commissioner's records of the hours worked by, and of the amounts paid to, the various workers covered by this Award.

18.—Under-rate Workers.

A worker who is unable to earn the minimum rate hereby prescribed may be employed at a lower rate, which shall be agreed upon in writing between the worker and the secretary for the worker's Union. If within seven (7) days after being notified of the worker's desire to work at a lower rate of wage than that prescribed the said secretary and the worker are unable to agree upon a lower rate, then the worker may apply in writing to the nearest Resident or Police Magistrate to fix such lower rate of wage. The worker shall give such secretary two (2) days' notice in writing of his intention to apply to the Magistrate and the ing of his intention to apply to the Magistrate, and the said secretary or his agent may attend and oppose the application. The Magistrate may fix the rate of wage, and his decision shall be final. Any worker whose wage shall have been so fixed may work for the period of six (6) calendar months thereafter, and, after the expiration of the said period, until fourteen (14) days' notice in writing shall have been given him by the secretary of the Union requiring his wage to again be fixed in the manner prescribed by this clause.

19.—Area and Scope.

This Award shall apply to workers described herein employed by the Commissioner of Railways on the Western Australian Government Ferries plying on the Swan River.

20.—Contract of Service.

- (a) Except in the case of casual workers, the contract of hiring shall be deemed to be by the day and, when the service of such workers are terminated, wages shall be paid accordingly.
- (b) No worker, after six (6) months' continuous service, shall leave the department until the expiration of seven (7) days' written notice of his intention so to do, without the approval of the Commissioner. Seven (7) days' written notice shall be given by the Commissioner to any such worker whose services are no longer required, and the reason for dismissal shall be given.

21.—Ratio of Juniors.

The proportion of junior workers shall not exceed one junior worker to every four (4) (or fraction of four (4), not being less than one (1)) of the total adult workers employed in the Ferry Service.

22.—Wages.

Basic wage-£3 11s. 0d. per week.

(a) The minimum rate of wages shall be:-

- (c) Workers working in water shall be supplied with sea boots; or, if not supplied with sea boots, be paid one shilling (1s.) per day in addition to their ordinary rate of wages per day or part of a day.
 - (d) All wages shall be paid weekly.

23.—Board of Reference.

A Board of Reference shall be appointed for the purposes of this Award. The Board shall consist of a Chairman and two (2) representatives, one to be nominated by each of the parties.

The functions of such Board shall be:-

- (i) Adjusting any matters of difference which may arise at any time between the parties, except such as involve interpretations of the provisions of the Award or any of them;
- (ii) Deciding any other matter that the Court may refer to such Board from time to time;
- (iii) An appeal shall lie from the decision of such Board in the manner and subject to the conditions prescribed in the Regulations to "The Industrial Arbitration Act, 1912-1925," which for that purpose are embodied in this Award.
