Reserve near Katanning.
PROCLAMATION

WHEREAS by "The Aborigines Act, 1905," it is provided that the Governor is empowered by Proclamation to declare any Crown lands to be Reserves for Aborigines: And whereas it is deemed desirable that a Reserve for Aborigines should be declared near Katanning: Now, therefore I, the said Lieutenant-Governor, with the advice of the Executive Council, do hereby declare a Reserve of thirty acres, being the whole of Reserve No. 18426 (Katanning A.A. Lot 442), more particularly described in the Schedule hereto, to be a Reserve for Aborigines.

Schedule.

All that piece of land, containing 30 acres, situate in the Katanning Agricultural Area near the Townsite of Katanning, being the whole of Reserve No. 18426 (Katanning A.A. Lot 442) bounded by lines commencing at the intersection of the North side of Randford Road with the East side of Vanzuilecum Road and extending North along the latter for a distance of 16 chains 61 links; thence 89deg. 68min. 19 chains 61 links; thence 190deg. 35min. 16 chains 90 links to the North side of Randford Road; thence West 16 chains 50 links along the North side of Randford Road to the starting point.

ORDER IN COUNCIL.

C.S.D. 98/35.

HIS Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby, under Section 19 of "The Registration of Births, Deaths, and Marriages Act, 1894," as amended by Section 7 of Act No. 19 of 1907, authorise the Registrar General to remit the whole or any part of any fee payable under the said Act or the Marriage Act, 1894, as prescribed by the Order in Council published in the *Government Gazette* on the 20th day of November, 1931, in any case where, in the special circumstances, the Registrar General may think fit to do so; and, with respect to the prescribed fee of £10 for a special marriage license, the Governor, the Resident Magistrate, or the Registrar General may, on the grant of such license, in any case where in the special circumstances he may think fit to do so, remit the whole or any part of such fee.

ORDER IN COUNCIL.

M.W.S. 882/34.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works, and stormwater drainage works; and whereas it is further provided that the Governor may exempt reticulation works from certain sections of this Act: Now, therefore, His Excellency the Lieutenant-Governor, with the advice of the Executive Council, hereby approves of the construction and extension by the Minister for Water Supply, Sewerage, and Drainage of the following works under the said Act, and does hereby exempt such works from the operations of Sections 20, 21, 22 and 23 of the said Act:—

Description and Location of Reticulation Works Approved and Exempted:—Claremont-Cottesloe Sewerage—Claremont District, Reticulation Area 2:—Commencing at Manhole 336 on Section 25 in Cliff Road and proceeding in a South-Westerly direction for a distance of 180 feet across Cliff Road and through Lot 2, Stirling Highway, to Manhole 367, situated in the South-West corner of Lot 1, Stirling Highway; thence in a South-Easterly direction for a distance of 210 feet through Lot 1, Stirling Highway, and Lots 3 and 4, Cliff Road, to Manhole 368, situated in the North-West corner of Lot 5, Cliff Road, in lieu of six-inch diameter sewer between Manhole 336 on Section 25, in Cliff Road, and proceeding in a South-Westerly direction for a distance of 180 feet across Cliff Road and through Lot 3, Cliff Road, to Manhole 367, situated in the North-West corner of Lot 3, Cliff Road; thence in a South-Easterly direction for a distance of 204 feet through Lots 3 and 4, Cliff Road, to Manhole 368, situated in the North-West corner of Lot 5, Cliff Road, which were the portions of the works as advertised in the *Government Gazette* of Western Australia on the third day of August, 1934, and first day of February, 1935, and as detailed in the plans and specifications therein referred to.

Description and Location of Reticulation Works Approved and Exempted:—Metropolitan Reticulation Main Improvement:—Guildford Municipality:—Proposed three-inch diameter water main commencing at the existing four-inch diameter main at the junction of Meares Street and Market Street and proceeding thence in a North-Easterly direction across Meares Street to Victoria Street; thence in an Easterly direction along Victoria Street to Johnson Street; thence in a Southerly direction along Johnson Street to connect with the existing four-inch diameter main near the intersection of Johnson Street and James Street (length about thirty chains).

The above main to be complete with valves, hydrants and all necessary apparatus, and the existing one-inch and two-inch mains to be lifted, as indicated in red on Plan M.W.S.S. & D.D., W.A., No. 5475.

NOTICE is hereby given that the following Stay Order has been issued in accordance with Section 7, Subsection 1, of "The Farmers' Debts Adjustment Act, 1930-1934," which reads as follows:—

A Stay Order shall direct that no action, execution, distress for rent, proceedings on default for breach of covenant under any mortgage or other security for money, or under an agreement for sale and purchase of land, or other process or proceeding, shall be commenced or proceeded with or put in force against the farmer or any of the farmer's assets, whether utilised in connection with or forming portion of the assets comprised in his farming business or not during the operation of such Stay Order. IT is hereby notified, for general information, that a Petition, the substance and prayer whereof are as follows:—1, That the Municipality of Busselton be dissolved; 2, That the District now controlled by such municipality be annexed to the District controlled by the Sussex Road Board, has been presented to His Excellency the Lieutenant-Governor, in accordance with the provisions of "The Municipal Corporations Act, 1906," and "The Road Districts Act, 1919-1934."

The reasons stated by the petitioners are as follow:—

1. The area of the Municipality (one square mile) is too small and much of this area is unrateable or exempt from rates; that its actual rateable value and the income from rates is too small for a Municipality, and that, as a consequence of the small rateable area, the financial burden of the ratepayers of the Municipality is far greater than it should be;

2. As disclosed by the last annual statement the Council has a large overdraft from the Bank of New South Wales, and this is often the position, whereas the Sussex Road Board, it is alleged by the petitioners, has or had a large credit balance at the date of the Petition;

3. Most of the building during the last ten years has taken place outside the Municipality, in an area known as "West Busselton," which is separated only from the Municipality by the width of a road called West Street. This area is served with electric light and power and, in some cases, water, by the Municipal Power House, which is situated in East Busselton;

4. Owing to the swampy nature of much of the land surrounding most of the other parts of Busselton, the Town has naturally grown towards the West, and is still growing in that direction. It is stated that instances can be quoted of persons removing their places of business and residence altogether from the Municipality and re-erecting them in West Busselton;

5. In West Busselton there are about 188 houses which, being in the Sussex Road Board, pay nothing towards the maintenance of the public utilities of the Municipality, which they enjoy equally with the Municipal ratepayers, nor do they pay any Municipal Loan Rates;

6. Owing to the small size of the Municipality and the small population, the Council only consists of six members (five of whom are at present general storekeepers) and the Mayor (who is a contractor). The remaining Councillor is a carpenter. This is too small, and renders such a Council liable to domination by one or two individuals;

7. The rates in West Busselton are pounds less than they are in the Municipality; notwithstanding this, far more developmental work can apparently be done there than seems possible within the Municipality;

8. Owing to the disparity in rating land values are falling in the residential portion of the Municipality, but the high rating continues, and in some cases has been increased. If this drop in values in the Municipality continues it may eventually affect the Loan position;

9. In the event of the Road Board at any time deciding to have their own officials (which has recently been suggested), it would be very difficult for this Council to maintain its position financially;

10. A Health Board now exists, consisting of representatives of the Road Board and Council, which has jurisdiction over the Municipality and West Busselton, and there is also a meat area over a still larger district. This fact alone shows that the affairs of the Municipality and West Busselton can be administered by one local governing body, and that the retention of the Municipality is not warranted;

11. That the Municipality has spent the public money on works which have proved to be useless for example, the seawall, now partly washed away; removal of sand hills, which formed a natural break-water against the ocean on a low lying shore;

12. The Road Districts Act would make for better government, so far as your petitioners are concerned, as the Road Districts Act is much more up to date than the Municipal Corporations Act, and stricter supervision is kept over the local governing bodies under that Act;

13. That the Council has not kept ratepayers properly posted with information dealing with its expenditure and general business. It is suggested that breaches of Sections 39 and 161 have taken place during the past five years.

The Petition, and the reasons advanced in support of the Petition, have been referred to the Council of the Municipality of Busselton, and the Council has advanced the following reasons against granting the prayer of the Petition:—

1. Neither the area nor the rateable value of the Municipality has been proved to be too small and the Council instances the progress of the Municipality since 1897. As regards property exempt from rating, the position could not be altered if the area were controlled by a Road Board; the unrateable land as such would retain its significance. The burden of rates compares fairly with that imposed by other Municipalities;

2. The statement regarding the overdraft is untrue and calculated to mislead. It is stated that, as evidenced by the latest audit report, there was a net debit of only £49 13s. 7d., whilst as at the 4th February, 1935, there was a credit balance;

3. The value of new buildings in the Municipality and alterations and extensions to existing buildings during the past ten years has increased considerably, and it is alleged that the annual increase in the value of property will bear out this contention;

4. Isolated instances of buildings being removed from the Municipal area to West Busselton are admitted. It must also be conceded that buildings have been removed from the Sussex Road Board District to the Municipal area. Swamp land is not confined to the Municipal area, but it is anticipated

that drainage and filling completed, and further works authorised by the Municipality, will alleviate much flooding;

5. The Council agrees with the statement advanced in reason No. 5 in support of the Petition, but at the same time states that this is not a good ground for the dissolution of the Municipality and annexing of the district to the Sussex Road Board;

6. The Council is constituted by "The Municipal Corporations Act, 1906," and if there is any grievance as to the constitution of the Council this can be rectified under that Act;

7. The Council denies that its development works are less than those which have been carried out in West Busselton;

8. A thorough revaluation of all rateable property was made in 1933, and many anomalies rectified. Individual ratepayers have adequate remedy under the Act, if valuations are considered too high. Any abnormal drop in values will have to be met when the occasion demands. Reference to the Loan position is obscure, but repayment of all current loans is well provided for; and all present loans, with the exception of the new Electric Light Loan, should be paid off by 1937. The objective is the elimination of Loan Rates on loans raised for the Electric Lighting Undertaking;

9. The present arrangement regarding the office staff is the subject of an agreement between the two bodies and their officers, at the acquiescence of the Department, and the Council has no knowledge of any proposal to alter this arrangement. In any event, it is not agreed that the Municipality would have financial difficulty in maintaining its own separate staff;

10. The Council agrees that the combined area could be best administered by one Local Authority, but considers that if an alteration is made the Local Authority should be a Municipality;

11. It is denied that money has been wasted on works;

12. It is contended that efficient control can be exercised under "The Municipal Corporations Act, 1906";

13. The Council denies that any breaches of Sections 31 and 161 have taken place, or that there has been any unwillingness on the part of the Council to publish anything relating to the affairs of the Municipality;

Furthermore, that the financial position of the Sussex Road Board cannot be compared with that of the Municipality, and the condition of the roads in the Municipality is much better than in the Road Board.

Any ratepayer of either the Municipality or the Road District desiring to advance reasons why the prayer of the Petition should or should not be granted should forward same to the undersigned not later than the Fifteenth day of April, 1935.

IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

Nos. 420, 421, and 422 of 1934.

In the matter of Award dated the 1st day of September, 1933, and in the matter of an Application by the Fremantle Tramway Employees' Industrial Union of Workers (hereinafter referred to as "the Union") for an Interpretation of the said Award.

UPON hearing Mr. L. L. Carter, for the Fremantle Municipal Tramways and Electric Lighting Board, and Mr. L. H. Cole, for the Union, the Court doth hereby declare that:—

- (1) the Court's Order, No. 424 of 1933, relating to "call backs," applies to trotting specials only;
- (2) under Clause 8 (a) the employer has the right to substitute one day off for another during the currency of any week's work;
- (3) under Clause 8 (c) the employer has the right to book workers up on two Sundays in succession and class such work as part of the week's ordinary duty, where such Sunday duty is occasioned by ordinary traffic.

No. 5 of 1935.

THIS Agreement, made in pursuance of "The Industrial Arbitration Act, 1912-1925," this seventh day of February, One thousand nine hundred and thirty-five, between Swan Portland Cement, Limited, whose registered office is situate at Portland House, Rivervale, in the State of Western Australia, of the one part, and The Federated Engine-drivers and Firmen's Associa-

tion of Australasia, West Australian Branch Association of Workers, whose registered office is situate at Trades Hall, Perth, of the other part, whereby it is mutually agreed as follows:—

1.—Area.

This Agreement shall have effect over the area comprised within a radius of fifteen (15) miles from the General Post Office, Perth.

2.—Scope.

This Agreement shall apply to all workers covered in the Schedule of Rates and engaged by the abovenamed Company.

3.—Term.

This Agreement shall take effect from the seventh day of February, One thousand nine hundred and thirty-five, and shall continue in force for a period of three years.

4.—Hours of Work.

(a) Employees working three (3) shifts shall work eight (8) hours per day for the first five (5) days of the week including crib time and four (4) hours on Saturday. Provided that the foregoing hours may be altered at any time by agreement in writing between the parties.

(b) Day shift workers shall work eight hours per day, exclusive of crib time, on the first five days of the week and four hours on Saturday.

(c) In all cases in reckoning the time of duty, any time necessarily occupied in raising steam, in banking fires, and attending to boilers, or engines during meal hours shall be included.

(d) Drivers shall fire the boilers and maintain steam on both the shore and floating cranes.

5.—Crib Time.

Crib time for shift workers shall be taken in relays at such time as not to cause a stoppage of work, and no deduction shall be made therefor from the employees' wages.

6.—Overtime and Holiday Rates.

(a) Overtime shall be paid for at the rate of time and a half for the first four (4) hours and double time thereafter.

(b) Time and a half shall mean one half day's wages in addition to the prescribed minimum rate, or pro rata, if there is more or less than a day.

(c) All work done on Sundays by day workers shall be paid for at the rate of double time and by shift workers at the rate of time and a half. All work performed on Christmas Day, Boxing Day, New Year's Day, Good Friday, Easter Monday, or Labour Day, being the holidays specially mentioned in Clause 7 hereof, shall be paid for at double time.

(d) Work done in the meal hour, or any portion thereof, shall be paid for at the rate of double time, but this shall not apply to cases involving completion of work commenced before the lunch hour and not occupying more than fifteen (15) minutes from the commencement of the lunch hour, in which case the lunch hour shall be extended by fifteen minutes beyond the ordinary time. This subclause shall not apply to shift workers who are provided for under Clause 5.

(e) Double time shall mean one (1) day's wages in addition to the prescribed minimum rate or pro rata if there is more or less than a day.

(f) Nothing in this Agreement shall entitle a worker working any overtime either on week days Sundays or holidays, to more than twice the ordinary rate of pay.

7.—Holidays.

(a) Twelve (12) paid holidays per annum shall be granted each worker after twelve (12) months' continuous service: Provided always, that New Year's Day, Good Friday, Easter Monday, Labour Day, Christmas Day, and Boxing Day, or the days observed as such, shall be taken as they come as portion of the holidays. The balance of the six (6) days shall be granted as annual leave at the convenience of the employer, but shall not be allowed to accumulate.

(b) In the event of a worker being employed for portion only of a year, he shall only be entitled to such holidays on full pay as are proportionate to his length of service during that period, and if such holidays are not equal to the holidays given to the other workers, he shall not be entitled to work or pay whilst the other workers of such employer are on holidays on full pay.

(c) Except when employed subject to the conditions of Clause 6 (e) (Overtime) no worker shall be required to present himself for duty on any of the specially named holidays in Subclause (a) hereof. On any other public holiday the employer's establishment or place of business may be closed, in which case a worker need not present himself for duty, but, if kept open or work done, ordinary rates shall apply.

(d) Where a worker is dismissed for wilful misconduct he will not be entitled to the benefit of the provisions of this clause.

8.—Men Recalled.

When a worker is recalled to work after leaving the job, he shall be paid at least two (2) hours at overtime rates.

9.—Payment of Wages.

Wages shall be paid weekly unless otherwise mutually agreed.

10.—Mixed Functions.

Workers called upon to temporarily work at a higher grade shall be paid the prescribed rates for such higher grade for the actual time so employed.

11.—Notice to Cease Work.

In the event of a breakdown of machinery, or an industrial dispute, the Company shall only be called upon to give employees one day's notice to cease work. In other instances the ordinary week's notice shall apply.

12.—Payment for Sickness.
