### PROCLAMATION

WESTERN AUSTRALIA, ( By His Excellency Sir James Mitchell,  
TO WIT. ) K.C.M.G., Lieutenant-Governor in and  
JAMES MITCHELL, over the State of Western Australia  
Lieutenant-Governor. and its Dependencies in the Common-  
[L.S.] wealth of Australia.

IN pursuance of the provisions contained in the fifth section of "The Bank Holidays Act, 1884," I, the Lieutenant-Governor of the said State, do by this my Proclamation appoint Thursday, 21st March, 1935, a special day to be observed as a Bank Holiday in the Town of Bunbury.

AT a meeting of the Executive Council held in the Executive Council Chambers, at Perth, this fifth day of March, 1935, the following Orders in Council were authorised to be issued:—

### ORDER IN COUNCIL.

M.W.S. 869/25.

WHEREAS the enactment contained in Section 74 of "The Constitution Act, 1889," whereby the appointment of all public officers under the Government of the State is vested in the Governor in Council does not apply to minor appointments which by Order in Council are vested in the Heads of Departments or other officers or persons within the State: And whereas it is desirable that the appointment of foremen and all other persons employed at a daily wage on water supply, sewerage, and drainage works under the control of the Metropolitan Water Supply, Sewerage and Drainage Department should be vested in various officers: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice of the Executive Council, hereby further amends schedule appended to the Order in Council gazetted on the 28th

May, 1920, by the addition of the names of E. W. Stoddart, W. M. Herbert, T. R. Allison, V. C. Munt, and A. G. Sloane, and of any person or persons appointed to temporarily act in the place of such officers.

The Water Boards Act, 1904, and Amendments—  
Manjimup Water Area.

### ORDER IN COUNCIL.

P.W.W.S. 2256/18.

WHEREAS by "The Water Boards Act, 1904," the Governor is empowered by Order in Council to constitute the District of a Local Authority, or two or more Local Authorities, or any part or parts of such District or Districts, a Water Area, under such name as may be directed: And whereas the Governor is empowered to appoint a Local Authority whose District, or a part of whose District is within the Water Area to be the Water Board: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby constitute a Water Area, having the boundaries described in the Schedule hereto, for the purposes of the said Act, under the name of the Manjimup Water Area, and doth hereby appoint the Manjimup Road Board to be the Water Board under the name of Manjimup Water Board.

This Order in Council shall take effect on the 15th day of March, 1935.

### Schedule.

(a) Commencing at a point on the South-Westerly corner of Manjimup Townsite Location 2 and proceeding in a Northerly direction along the Western boundary of the said location for a distance of 920 links; thence proceeding in an Easterly direction to the North-Eastern corner of Sub-lot 2, Arnott Street; thence proceeding in a Northerly direction along the Western boundary of Arnott Street, across Rutherford Street and Graphite road to the Northern boundary of Johnson Street; thence proceeding in an Easterly direction along the Northern boundary of Johnson Street to a point on the Eastern boundary of Ward Street; thence proceeding Southerly along the Eastern boundary of

Ward Street, across Graphite Road to a point on the Northern boundary of Edwards Street; thence proceeding in a South-Easterly direction along the Northern boundary of Edwards Street to a point on the Western boundary of Rose Street; thence proceeding in a Northerly direction along the Western boundary of Rose Street to a point opposite the prolongation of the Northern boundary of the street North of Police Reserve 14809 (Lot 156); thence crossing Rose Street and following the Northern boundary of the above-mentioned street to the Railway Reserve; thence in a general Southerly direction for a distance of 5 chains to a point opposite the Railway crossing; then proceeding Easterly across the Railway Reserve and along the North boundary of the road North of Lots 318 and 202 to a point opposite the prolongation of the Western boundary of Mottram Street; thence proceeding in a South-Westerly direction across the said road and along the Eastern boundary of Lot 318 to a point opposite the Southern boundary of Mount Street; thence proceeding Easterly across Mottram Street and along the Southern boundary of Mount Street to the Western boundary of O'Connor Street; thence proceeding in a South-Westerly direction along the Western boundary of O'Connor Street to and across Young Street and along the Eastern boundaries of Lots 58 and 59 to and across Wheatley Street, and along the Eastern boundaries of Lots 50 and 51; thence proceeding Westerly along the Southern boundaries of Lots 51 and 48 to and across Reeve Street and along the Southern boundary of Lot 45 to and across Mottram Street, following the Northern boundary of Brain Street and its prolongation across the Railway Reserve to Chopping Street; thence following the same direction and crossing the said Chopping Street to the South corner of Lot 231 and following its Southern boundary to the Western corner of the said lot; thence proceeding in a general Northerly direction along the West boundary of Lot 231 to the South corner of Lot 230; thence proceeding in a North-Westerly direction along the South-Western boundaries of Lots 230, 229, and 228 to the Western corner of Lot 228; thence Westerly along the South boundary of Lot 227 to and across Somerville Street to the South-Eastern corner of Lot 226; thence proceeding Northerly along the Eastern boundary of Lot 226 and its prolongation to and across Plunkett Street to the centre of the timber tramway; thence following the centre of the tramway line in a general Westerly direction to a point opposite the Western boundary of Cronin Street; thence Northerly along the prolongation of the West boundary of Cronin Street to the South boundary of the road South of Lot 2; thence Westerly along the said Southern boundary to a point opposite the prolongation of the Western boundary of Lot 2; thence Northerly across the said road to the point of commencement, as shown in blue on Sheet No. 1 of P.W.D., W.A. 27784.

(b) Commencing at the North-Westerly corner of Nelson Location No. 7293 (Sanitary Site), and proceeding in a North-Westerly direction through Locations Nos. 5842 and 15977 to a point on the Easterly boundary of Location 9777 and 15 chains South of the North-Eastern corner of the said location; thence proceeding in a Northerly direction along the Eastern boundaries of Locations 9777 and 9776 to the North-Eastern corner of Location 9776; thence proceeding in a Westerly direction along the Northern boundary of Location 9776 for a distance of 20 chains; thence proceeding in a Northerly direction through Location 9775, and across the timber tramway track, through Location 9760, to a point on the Southern boundary of Location 9774 five chains West of the South-Eastern corner of the said location; thence proceeding in a North-Westerly direction across Location 9774 to the North-Western corner of the said location; thence proceeding due East for a distance of 40 chains through Timber Reserve 15974; thence proceeding in a South-Easterly direction through the said Reserve to the North-West corner of Location 5841; thence proceeding in a South-Easterly direction to the South-Eastern corner of Location 5841; thence along the Eastern boundary of Location 5842 to the Northern boundary of Road No. 5555; thence proceeding in a South-Westerly direction along the Northern boundary of the said road to the North-Eastern corner of Location 7293; thence along the Northern boundary of Location 7293 to the point of commencement, as shown in red on Sheet No. 2 of Plan P.W.D., W.A. 27784.

(c) Commencing at a point on the boundary described above at the South-East corner of Location 5841 and proceeding in a general North-Easterly direction through Location 7367 to a point on the timber railway line at which the railway line deviates to a North-Easterly direction; thence following the tramway track through Locations Numbered 7367, 9665, 5836, 6798, and 9239 to the South-Western corner of Location 2109, and proceeding in an Easterly direction along the Southern boundary of the said Location 2109 to its South-Easterly corner; thence continuing in a general Easterly direction through Manjimup Townsite to a point at the South-Western corner of Manjimup Townsite Location 2, on the boundary of the Manjimup Water Area, as defined in (a) above, as shown in red on Sheet 5 of Plan P.W.D., W.A. 27784.

The Sandalwood Act, 1929.

ORDER IN COUNCIL.

F.D. 1478/29.

WHEREAS under the provisions of Section 2 of "The Sandalwood Act, 1929," the Governor may from time to time by Order in Council limit and restrict the quantity of sandalwood that may be pulled or removed from Crown land and alienated land during the period therein stated: And whereas it is desirable to limit and restrict the quantity of sandalwood that may be pulled or removed from Crown land and alienated land during the period from the First day of January, 1935, to the Thirtieth day of June, 1935, to 800 tons: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act, doth hereby limit and restrict the quantity of sandalwood that may be pulled or removed from Crown land and alienated land during the period from the First day of January, 1935, to the Thirtieth day of June, 1935, to 800 tons, exclusive of sandalwood required for oil distillation purposes within the State.

NOTICE is hereby given that the following Stay Orders have been issued in accordance with Section 7, Subsection 1, of "The Farmers' Debts Adjustment Act, 1930-1934," which reads as follows:—

Regulation 49.—Delete all the words after paragraph (b) commencing with the words "In computing service" and ending with the words "long service leave," and insert in lieu thereof a proviso as follows:—

Provided that, in computing service for the purposes of this regulation, the following provisions shall apply and be observed:—

- (i) If a teacher has been transferred to the Education Department after serving in another Department in a permanent position carrying rights to long service leave, such last-mentioned service shall be added to his service as a teacher and count towards his long service leave as a teacher;
- (ii) service as a teacher, other than a probationer or monitor, prior to the making of this regulation shall be included in the service to qualify for benefits under this regulation;
- (iii) time spent as a student in the Teachers' College shall not be or be counted as service;
- (iv) in the case of a probationer or monitor who has completed 15 years' continuous service (as required by paragraph (a) of this regulation) or ten years' continuous service (as required by paragraph (b) of this regulation) as a probationer or monitor, and is still continuing in the service of the Department, he may be granted long service leave under this regulation in respect of such service, but on only half the appropriate rates of pay respectively prescribed in paragraphs (a) and (b) aforesaid, as the case may require;
- (v) a teacher who is granted long service leave under paragraph (b) of this regulation shall not be eligible for further long service until after the expiration of ten years from the end of the former period of long service leave;
- (vi) a probationer or monitor who voluntarily retires from the Department before taking the long service leave for which he may be eligible under this regulation shall not thereafter be eligible for any long service leave or other equivalent allowance;
- (vii) where a person has served continuously in the Department for part of the time as a probationer or monitor and for part of the time

as a teacher (as distinct from a probationer or monitor), the service as a probationer or monitor shall be counted only to the extent of half the number of completed years thereof when ascertaining the period of service of such person for the purpose of this regulation; but when such person has served the necessary period computed as provided in this present subparagraph, he may be granted long service leave in respect of such period at the appropriate rates of pay prescribed in paragraphs (a) or (b) of this regulation, as the case may require.

THE Quairading Road Board, pursuant to an Order in Council made under Section 43 of "The Traffic Act, 1919-31," and in exercise of the power thereby conferred, doth hereby make the following By-law to regulate the standing of vehicles in the Townsite of Quairading:—

1. No person in charge of any motor wagon, cart, or sulky shall cause or permit such vehicle to stand in Heal Street or Jennaberring Road, within the Townsite of Quairading, for a longer period than 20 minutes.

2. All such vehicles when parked on a prescribed parking area shall face South.

3. The areas defined hereunder shall be prescribed Parking Area:—

Commencing at a point on the Southern boundary of Heal Street in line with the Eastern side of Cubbine Road, as indicated by a sign post, and extending East to a distance of 350 feet, as indicated by a sign post, and from the first-mentioned point in a line 84 feet 6 inches South to the present railway fence; thence in a line East for a distance of 275 feet to a point indicated by a sign post; thence in a line North-East for a distance of 125 feet to the sign post mentioned secondly.

4. The person in charge of any vehicle shall at all times when leaving such vehicle stationary on the North side of Heal Street, within the Townsite of Quairading, stop as close as practicable to the kerbing or footpath, at an angle of 90 degrees, with the kerbing or footpath alignment.

5. No vehicle shall be permitted to be parked on the South side of road in Heal Street.

6. The person in charge of any vehicle shall not leave same stationary within 10 feet of any bowser or petrol pump in Heal Street, in the Townsite of Quairading, for a longer period than is necessary to fill such vehicle with petrol.

7. The person in charge of any vehicle shall not at any time park such vehicle in front of any entrance or right-of-way to private property.

Any person committing a breach of these By-laws shall on conviction be liable to a penalty not exceeding £20.

### MUNICIPAL CORPORATIONS ACT, 1906, AND THE ROAD DISTRICTS ACT, 1919-1934.

Petition bearing date the 6th day of November, 1934, to dissolve the Municipality of Busselton and merge same into the Sussex Road District.

Department of Works,

Perth, 20th February, 1935.

IT is hereby notified, for general information, that a Petition, the substance and prayer whereof are as follows:—1, That the Municipality of Busselton be dissolved; 2, That the District now controlled by such municipality be annexed to the District controlled by the Sussex Road Board, has been presented to His Excellency the Lieutenant-Governor, in accordance with the provisions of "The Municipal Corporations Act, 1906," and "The Road Districts Act, 1919-1934."

The reasons stated by the petitioners are as follow:—

1. The area of the Municipality (one square mile) is too small and much of this area is unrateable or exempt from rates; that its actual rateable value and the income from rates is too small for a Municipality, and that, as a consequence of the small rateable area, the financial burden of the ratepayers of the Municipality is far greater than it should be;

2. As disclosed by the last annual statement the Council has a large overdraft from the Bank of New South Wales, and this is often the position, whereas the Sussex Road Board, it is alleged by the petitioners, has or had a large credit balance at the date of the Petition;

3. Most of the building during the last ten years has taken place outside the Municipality, in an area known as "West Busselton," which is separated only from the Municipality by the width of a road called West Street. This area is served with electric light and power and, in some cases, water, by the Municipal Power House, which is situated in East Busselton;

4. Owing to the swampy nature of much of the land surrounding most of the other parts of Busselton, the Town has naturally grown towards the West, and is still growing in that direction. It is stated that instances can be quoted of persons removing their places of business and residence altogether from the Municipality and re-erecting them in West Busselton;

5. In West Busselton there are about 188 houses which, being in the Sussex Road Board, pay nothing towards the maintenance of the public utilities of the Municipality, which they enjoy equally with the Municipal ratepayers, nor do they pay any Municipal Loan Rates;

6. Owing to the small size of the Municipality and the small population, the Council only consists of six members (five of whom are at present general storekeepers) and the Mayor (who is a contractor). The remaining Councillor is a carpenter. This is too small, and renders such a Council liable to domination by one or two individuals;

7. The rates in West Busselton are pounds less than they are in the Municipality; notwithstanding this, far more developmental work can apparently be done there than seems possible within the Municipality;

8. Owing to the disparity in rating land values are falling in the residential portion of the Municipality, but the high rating continues, and in some cases has been increased. If this drop in values in the Municipality continues it may eventually affect the Loan position;

9. In the event of the Road Board at any time deciding to have their own officials (which has recently been suggested), it would be very difficult for this Council to maintain its position financially;

10. A Health Board now exists, consisting of representatives of the Road Board and Council, which has jurisdiction over the Municipality and West Busselton, and there is also a meat area over a still larger district. This fact alone shows that the affairs of the Municipality and West Busselton can be administered by one local governing body, and that the retention of the Municipality is not warranted;

11. That the Municipality has spent the public money on works which have proved to be useless for example, the seawall, now partly washed away; removal of sand hills, which formed a natural break-water against the ocean on a low lying shore;

12. The Road Districts Act would make for better government, so far as your petitioners are concerned, as the Road Districts Act is much more up to date than the Municipal Corporations Act, and stricter supervision is kept over the local governing bodies under that Act;

13. That the Council has not kept ratepayers properly posted with information dealing with its expenditure and general business. It is suggested that breaches of Sections 39 and 161 have taken place during the past five years.

The Petition, and the reasons advanced in support of the Petition, have been referred to the Council of the Municipality of Busselton, and the Council has advanced the following reasons against granting the prayer of the Petition:—

1. Neither the area nor the rateable value of the Municipality has been proved to be too small and the Council instances the progress of the Municipality since 1897. As regards property exempt from rating, the position could not be altered if the area were controlled by a Road Board; the unrateable land as such would retain its significance. The burden of rates compares fairly with that imposed by other Municipalities;

2. The statement regarding the overdraft is untrue and calculated to mislead. It is stated that, as evidenced by the latest audit report, there was a net debt of only £49 13s. 7d., whilst as at the 4th February, 1935, there was a credit balance;

3. The value of new buildings in the Municipality and alterations and extensions to existing buildings during the past ten years has increased considerably, and it is alleged that the annual increase in the value of property will bear out this contention;

4. Isolated instances of buildings being removed from the Municipal area to West Busselton are admitted. It must also be conceded that buildings have been removed from the Sussex Road Board District to the Municipal area. Swamp land is not confined to the Municipal area, but it is anticipated that drainage and filling completed, and further works authorised by the Municipality, will alleviate much flooding;

5. The Council agrees with the statement advanced in reason No. 5 in support of the Petition, but at the same time states that this is not a good ground for the dissolution of the Municipality and annexing of the district to the Sussex Road Board;

6. The Council is constituted by "The Municipal Corporations Act, 1906," and if there is any grievance as to the constitution of the Council this can be rectified under that Act;

7. The Council denies that its development works are less than those which have been carried out in West Busselton;

8. A thorough revaluation of all rateable property was made in 1933, and many anomalies rectified. Individual ratepayers have adequate remedy under the Act, if valuations are considered too high. Any abnormal drop in values will have to be met when the occasion demands. Reference to the Loan position is obscure, but repayment of all current loans is well provided for; and all present loans, with the exception of the new Electric Light Loan,

should be paid off by 1937. The objective is the elimination of Loan Rates on loans raised for the Electric Lighting Undertaking;

9. The present arrangement regarding the office staff is the subject of an agreement between the two bodies and their officers, at the acquiescence of the Department, and the Council has no knowledge of any proposal to alter this arrangement. In any event, it is not agreed that the Municipality would have financial difficulty in maintaining its own separate staff;

10. The Council agrees that the combined area could be best administered by one Local Authority, but considers that if an alteration is made the Local Authority should be a Municipality;

11. It is denied that money has been wasted on works;

12. It is contended that efficient control can be exercised under "The Municipal Corporations Act, 1906";

13. The Council denies that any breaches of Sections 31 and 161 have taken place, or that there has been any unwillingness on the part of the Council to publish anything relating to the affairs of the Municipality;

Furthermore, that the financial position of the Sussex Road Board cannot be compared with that of the Municipality, and the condition of the roads in the Municipality is much better than in the Road Board.

Any ratepayer of either the Municipality or the Road District desiring to advance reasons why the prayer of the Petition should or should not be granted should forward same to the undersigned not later than the Fifteenth day of April, 1935.
