WHEREAS it is provided by Subsection (2) of Section 102 of "The Factories and Shops Act, 1920," that, subject to the said Act, the day on which all shops affected by the said section shall close at one o'clock p.m. shall be Saturday, but that the Governor may by Proclamation at any time, and from time to time, on the petition (according to the form in the Sixth Schedule to the said Act) of the majority of the keepers of such shops in any District, substitute in that District for Saturday any other week day, and may at any time on the like petition revoke any such substitution: And whereas a Petition in due form has been presented to the Governor by a majority of the keepers of such shops

in the Cue-Day Dawn Shop District, praying that Wednesday may be substituted in that locality for Thursday as the day on which such shops shall close at one o'clock p.m., and it is desirable to accede to the prayer of such Petition: Now, therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council, do hereby substitute Wednesday for Thursday in the Cue-Day Dawn Shop District, and do declare that, subject to the said Act, the day on which all shops as aforesaid shall close at one o'clock in the afternoon in the Cue-Day Dawn Shop District shall be Wednesday.

The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.

## ORDER IN COUNCIL.

M.W.S. 358/34.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works, and stormwater drainage works: And whereas the preliminary requirements of the said Act have been complied with, and plans, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Lieutenant-Governor, with the advice and consent of the Executive Council, does hereby en-

power the Minister for Water Supply, Sewerage, and Drainage to undertake the construction of the following works under the said Act, namely:—

Nedlands-Claremont Stormwater Drainage:—Drain in Stirling Highway between Walter Street and Bay Road.—30-inch diameter cast-iron pipes, including manholes and all apparatus (length about 798 feet), as indicated in red on Plan M.W.S.S. & D.D., W.A. 5437.

This Order in Council shall take effect from the 22nd day of March, 1935.

#### ORDER IN COUNCIL.

P.W. 1331/29.  
HIS Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council, hereby makes the following Order under the authority of "The Road Districts Act, 1919-1934," namely:—In pursuance of Section 8 of the said Act, that the portion of the Nullagine Road District described in Schedule hereto be severed therefrom and such portion be annexed to the Marble Bar Road District:—

#### Schedule.

All that piece of land bounded on the North by part of the Northern boundary of the Nullagine Road District, from the South-West corner of Pastoral Lease 394/667 to its intersection with the Rabbit-Proof Fence Reserve; on the Eastward by part of the Rabbit-Proof Fence Reserve from said intersection to the production

East of the Southernmost boundary of Pastoral Lease 394/422; on the Southward by a line extending along said production and Southernmost boundary of Pastoral Lease 394/422 and along a West and a South boundary of the said Lease, part of the East, the South, and part of the West boundary of Lease 394/817, and a South boundary of Lease 394/422 to the South-East corner of Lease 394/816; thence along South and West boundaries of the last-mentioned Lease to the South-East corner of Lease 3205/96 and along the South and part of the latter's West boundary to the production East of the Southernmost boundary of Lease 394/668; thence along said production and Southernmost boundary and along a West and South boundary of said Lease 394/668 to the Northern boundary of the District; on the Westward by part of the District boundary from the last-mentioned point to the starting point. (Plans 109, 108, 99 and 98/300.)

The Water Boards Act, 1904, and Amendments.

Collie Water Area.

#### ORDER IN COUNCIL.

P.W.W.S. 1718/18.

WHEREAS by "The Water Boards Act, 1904," the Governor is empowered by Order in Council to alter or extend the boundaries of a Water Area: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby extend the boundaries of the Collie Water Area in accordance with the Schedule hereto.

This Order in Council shall take effect on the 22nd day of March, 1935.

#### Schedule.

Commencing at a point on the existing Collie Water Area boundary at the intersection of the Eastern boundary of Wilson Street and the Southern boundary of Christie Street, and proceeding in an Easterly direction along the said Southern boundary to a point opposite the South-East corner of Collie Town Lot 996; thence Northerly across Christie Street and along the Eastern boundary of the said Lot 996 and its prolongation to the South boundary of Lot 1063; thence Easterly along the said boundary to the South-East corner of Lot 1063; thence in a general Northerly direction following the Eastern boundaries of Lots 1063 and 1059 to the North-East corner of Lot 1059; thence South-Westerly along the South-Eastern boundary of Palmer Road to a point opposite the Eastern boundary of Lot 988; thence Northward across Palmer Road and along the said Eastern boundary of Lot 988 to its North-East corner; thence Westerly along the Northern boundary of Lot 988, North-Westerly along the Eastern boundary of Lot 989, and South-Westerly along the Northern boundaries of Lots 989, 990, 991, and 1028, and continuing in a straight line across the Collie River to the Eastern boundary of the existing Collie Water Area on the Eastern boundary of Lot 339, thereby including in the Collie Water Area all the land adjacent to such area as is coloured blue on Plan P.W.D., W.A. 27758.

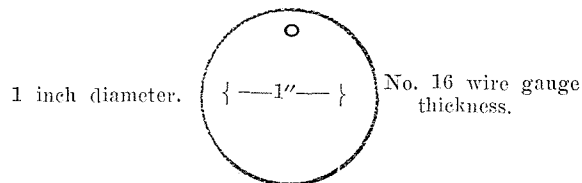
THE DOG ACT, 1903-28.

Regulations.

1. These Regulations shall come into operation and have the force of law in every District throughout the State on and from the 1st day of July, 1935.

2. All Regulations previously made under the Act shall be and are hereby repealed as from the 30th day of June, 1935.

3. The registration label for the financial year ending 30th June, 1936, required by Section 9 of "The Dog Act, 1903-28," is hereby prescribed to be a flat piece of nickel-plated brass, of the size and shape depicted hereunder, inscribed on the one side with the name of the District, the year of registration and the registration number, and on the other side with the emblem of the State flag.



4. Such registration label shall be securely fixed to a collar, which shall be continually worn round the dog's neck.

5. Registration shall be effected on or within 21 days from the 1st day of July, 1935.

6. (a) The registration fees for dogs other than those used for tending cattle and sheep shall be:—

(c) In respect of any registration made after the 31st day of December in any year, only one-half of the registration fee shall be payable.

7. The definition of "Cattle," referred to in these Regulations, shall be as set out in the Second Schedule of "The Cattle Trespass, Fencing, and Impounding Act, 1882," namely:—

"Great cattle"—Horse, mare, gelding, colt, filly, ass, mule, bull, ox, cow, heifer, calf, camel, deer, and foal.

"Small cattle"—Ram, ewe, sheep, wether and lamb, goat, kid, and pig.

8. Application for the issue of a license for a dog shall be made on the prescribed form, namely, Form "A" in the Second Schedule to "The Dog Act, 1903-28" (as printed and issued by the Department of Works and Labour).

9. Where a license is required under the proviso to Section 11 of the said Act, the number of cattle or sheep for which the dog is used for tending must be stated in the last column of the prescribed form.

10. Any person contravening any of these Regulations, whether by act or omission, shall on conviction be liable to a penalty not exceeding £5 for every such offence.

IN pursuance of the powers and duties conferred upon the Industrial Board for the calling or industry of Marine Diving, by Section 107 of "The Industrial Arbitration Act, 1912-1925," and in pursuance of a remission to the said Industrial Board by the Court of Arbitration, the Board doth hereby make the following Award in connection with the industrial dispute between the abovenamed parties:—

## AWARD.

## 1.—Interpretation.

For the purpose of this Award "Union" shall mean the Coastal Dock, Rivers, and Harbour Works Union of Workers.

## 2.—Rates of Pay.

Basic wage—Metropolitan Area—£3 11s. per week.

(a) Marine divers shall be paid, when diving, at the following rate per shift:—

Margin over Basic Wage.	Total Wage.
18s. 2d.	£1 10s. 0d.

(b) When not actually engaged in diving, a diver shall be entitled to be paid the margin over the basic wage provided in the appropriate Industrial Award or Agreement for the particular work he may be employed upon: provided always, that such work entitles him to a margin of at least eighteen shillings (18s.) per week over the basic wage. If the work upon which he is employed does not provide a margin of eighteen shillings (18s.), he shall be paid such a retaining allowance as will bring his margin over the basic wage up to an amount of eighteen shillings (18s.) per week over the basic wage.

(c) Tenders shall be paid at the following rate per shift, when attending on a diver:—

Margin over Basic Wage.	Total Wage per Shift
6s. 0d.	17s. 10d.

(d) When not actually engaged in attending on a diver, a tender shall be entitled to be paid the margin over the basic wage provided in the appropriate Industrial Award or Agreement for the particular work he may be employed upon: provided always, that such work entitles him to a margin of at least nine shillings (9s.) per week over the basic wage. If the work upon which he is employed does not provide a margin of nine shillings (9s.), he shall be paid such a retaining allowance as will bring his margin over the basic wage up to an amount of nine shillings (9s.) per week over the basic wage.

(e) Divers and tenders shall be entitled to the amounts provided respectively for a shift, even though the diver only takes one dip during the course of the shift.

## 3.—Hours of Duty.

Forty-four (44) hours shall constitute a week's work. A shift on Monday to Friday inclusive shall consist of six (6) hours diving, half an hour each forenoon and afternoon for smoke-oh, and the balance of the usual working hours for dressing and undressing, preparing

and returning gear, and Saturday shall consist of three (3) hours' diving, half an hour for smoke-oh, and the balance of the usual working hours for dressing and undressing and attending to gear, etc. Saturday's work shall finish not later than noon.

## 4.—Meal Hour.

For all work performed during meal hours, time and a half shall be paid; time and a half to be continuous until men are knocked off for meals.

Meal hours shall be:—Breakfast, the hour preceding the ordinary starting time; dinner, between the hours of 12 noon and 1 p.m.; tea hour, between 5 p.m. and 6.30 p.m.

## 5.—Overtime.

(a) If a diver or tender be called out to work between 5 p.m. and midnight, they shall be paid at the rate of time and a half for a shift or part thereof, and, if a diver or tender be called out to work between midnight and 8 o'clock a.m., they shall be paid at the rate of double time for a shift or part thereof: provided that, in case of an accident or an emergency, a diver who has not done six (6) hours diving in the preceding shift may be called upon to continue work up to six (6) hours at the appropriate overtime rate.

(b) The maximum amount of actual diving in any one shift shall be six (6) hours.

(c) Double time shall be paid for work done on Sundays.

(d) Work other than day shift shall not be recognised as night shift unless five (5) consecutive shifts are worked, but shall be deemed to be overtime: provided that, where a shift is not worked on account of a holiday, such shift shall for the purpose of this clause be counted as if it had been worked.

## 6.—Holidays.

(a) The holiday provisions of Award No. 10 of 1926, and any amendments thereto, or any Award made in substitution therefor, shall apply to workers employed by the Commissioner of Railways, and those of Award No. 26 of 1922 and any amendments thereto, to workers employed by other respondents.

(b) In the event of a diver and tender working for three (3) days immediately prior to a holiday prescribed in Awards referred to in Subclause (a) hereof, and the work is to continue after the holiday, they shall receive a diver and tender's pay for the holidays, but if the diving job is finished before the holiday, they will not receive the diver and tender's rate of pay for the holiday.

## 7.—Travelling Time.

(a) The ordinary day's rate shall be paid to workers whilst travelling on duty, but no worker shall be entitled to more than one day's pay of eight (8) hours in each twenty-four (24) for the time spent in travelling. The ordinary day's work in this connection shall mean the rate payable when not diving or when not tending.

(b) The employer shall pay all fares, including sleeper, if available. Fares shall be first class; when travelling by coastal boat saloon fares shall be paid.

## 8.—Payment of Wages.

(a) Workers inside the Metropolitan Area shall be paid weekly and those outside the area fortnightly.

(b) All men dismissed from employment shall be paid within four (4) office hours from the time of dismissal. If this period is exceeded they shall be paid at the ordinary rate from the time of dismissal till payment.

## 9.—Away from Home Allowance.

Divers and tenders sent to work at a place other than the place at which they are usually employed shall be paid the away-from-home allowance prescribed in the particular Award or Industrial Agreement under which they are usually employed.

## 10.—Absence from Duty.

Should any worker be unable to report for duty owing to illness, he shall notify the officer in charge without delay. If the absence extends over twenty-four (24) hours he shall produce a doctor's certificate, which shall retain him the right to be taken on again when recovered.

11.—Oilskins.

Tenders shall be supplied with oilskins and knee boots while tending.

12.—General Conditions.

- (a) All air pumps shall be manned with two (2) pumpers, and the diver shall have the right to select one of the two men thus employed.
- (b) The diver shall select his own tender.
- (c) The diving gear, whether in or out of use, shall not be interfered with, except by the diver or his tender.

13.—Preference.

Preference of employment shall be given to Unionists, provided they are available at the port when work is offering.

14.—Board of Reference.

The Court appoints for the purpose of the Award a Board of Reference. The Board shall consist of a Chairman and two (2) representatives nominated by both parties. There are assigned to such Board, in the event of an agreement not being arrived at between the parties to the Award:

Functions:—

- (1) Adjusting any matter of difference that may arise between the parties from time to time;
- (2) Deciding any other matter that the Court may refer to the Board from time to time.

15.—Area and Scope.

This Award shall apply to workers employed by the Minister for Works, the Fremantle Harbour Trust Commissioners, the Bunbury Harbour Board, the Commissioner of Railways, and the Chief Secretary as Minister Controlling the State Shipping Service, and shall operate over the coastline of the State from a point twenty (20) miles North of Geraldton to a point twenty (20) miles East of Esperance and for a distance of fifteen (15) miles inland therefrom.

16.—Term.

The currency of this Award shall be three (3) years: provided that, at any time after the expiration of twelve (12) months from its date, the Court may alter or amend the Award on application of any party or persons affected by its provisions.

17.—Application of other Awards.

When employed other than on the work of diving and tending:—The provisions of Award No. 26 of 1922 as amended by Order No. 236 of 1929, or by any future amendment; or of Award No. 10 of 1926 and any amendments thereto, as the case may be, shall operate, or any Awards made in substitution therefor.
