WHEREAS by Section 13 of "The Main Roads Act, 1930-1932," the Governor may, on the recommendation of the Commissioner, declare by Proclamation that any road shall be a main road: And whereas the Commissioner has recommended that the road specified in the Schedule hereto be so declared: Now therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, hereby declare that the road specified in the Schedule hereto shall be a main road within the meaning of "The Main Roads Act, 1930-1932," and that the footpaths, if any, of such road be excluded from the main road.

Coolgardie-Kalgoorlie Road.

(Coolgardie Road District.)

That portion of a public road commencing at the junction of Roads Nos. 987 and 1610 near the Western boundary of the Coolgardie Townsite Reserve; thence North-Easterly along said Road No. 987 for a distance of one mile approximately, to the Eastern side of the Coolgardie-Kalgoorlie Railway Reserve at the 353-mile mark; thence North-Easterly along the Eastern boundary of the said Railway Reserve to a crossing at the 353½-mile mark, crossing the aforesaid Railway Reserve to its Western side at this point; thence North-Easterly along Road No. 921 for a distance of 70 chains, approximately, to again join the Western side of the Coolgardie-Kalgoorlie Railway Reserve; thence North-Easterly along the Western boundary of the said Railway Reserve for a distance of four miles to again junction with said Road No. 921; thence North-Easterly along said Road No. 921 for a distance of 9½ miles to the boundary between the Coolgardie and Kalgoorlie Road Districts, as shown on Plan M.R.D., W.A., 1087.

ORDER IN COUNCIL.

M.W.S. 114/35.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works and stormwater drainage works: And whereas the preliminary requirements of the said Act have been complied with, and plans, sections and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Lieutenant-Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage, and Drainage to undertake the construction of the following works under the said Act, namely:—

Metropolitan Sewerage.—Claremont District—Reticalation Area No. 6, Claremont:—6-inch and 4-inch diameter reticalation sewers with all manholes and other apparatus connected therewith, between Stirling Highway and Alice Road, and Stanley Street and Bulimba Road, as shown in pink on Plan M.W.S.S. & D.D., W.A., No. 5532.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that the Governor may by Order in Council alter or extend the boundaries of the Metropolitan Water Supply, Sewerage and Drainage Area, or of any District: And whereas it is desirable that the boundaries of Metropolitan Stormwater Districts Nos. 2 and 1 as at present defined should be altered: Now, therefore I, the said Lieutenant-Governor, acting by and with the advice of the Executive Council, do hereby alter the boundaries of Metropolitan Stormwater Districts, Nos. 2 and 1, and declare that the said boundaries, as shown on Plans M.W.S.S. & D.D., W.A., Nos. 3449 and 2545, and as described in Order in Council of 18th June, 1919, and subsequent amendments, shall be altered in the following manner, by deleting the area described hereunder from Metropolitan Stormwater District No. 1 and including it in Metropolitan Stormwater District No. 2.

Schedule.

Commencing at a point on Daglish Townsite boundary opposite the North-East side of Munsie Avenue and proceeding South-Easterly across Troy Terrace; along Munsie Avenue to and across Stubbs Terrace and Railway Reserve to the North-West side of Railway Road; thence South-Westerly along Railway Road to a point opposite the South-West boundary of Lot 66, Stubbs Terrace; thence North-Westerly across Railway Reserve, Stubbs Terrace, and along the South-West boundary of the said Lot 66 and its prolongation along the right-of-way between Munsie Avenue and Hickey Avenue, to and across

Troy Terrace to Daglish Townsite boundary; thence North-Easterly along the said boundary to the point of commencement, as shown in brown on Plan M.W.S.S. & D.D., W.A., No. 3449.

WHEREAS under the provisions of Section 2 of "The Sandalwood Act, 1929," the Governor may from time to time by Order in Council, limit and restrict the quantity of sandalwood that may be pulled or removed from Crown land and alienated land during the period therein stated: And whereas it is desirable to limit and restrict the quantity of sandalwood that may be pulled or removed from Crown land and alienated land during the period from the first day of July, 1935, to the thirty-first day of December, 1935, to 700 tons: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act, doth hereby limit and restrict the quantity of sandalwood that may be pulled or removed from Crown land and alienated land during the period from the first day of July, 1935, to the thirty-first day of December, 1935, to 700 tons, exclusive of sandalwood required for oil distillation purposes within the State.

FARMERS' DEBTS ADJUSTMENT ACT, 1930-1934.

NOTICE is hereby given that the following Stay Order has been issued in accordance with Section 7, Subsection 1, of "The Farmers' Debts Adjustment Act, 1930-1934," which reads as follows:—

A Stay Order shall direct that no action, execution, distress for rent, proceedings on default for breach of covenant under any mortgage or other security for money, or under an agreement for sale and purchase of land, or other process or proceeding, shall be commenced or proceeded with or put in force against the farmer or any of the farmer's assets, whether utilised in connection with or forming portion of the assets comprised in his farming business or not during the operation of such Stay Order: Provided that, by leave of a Judge, any action may, notwithstanding the Stay Order, be instituted and/or carried on against the farmer, but not beyond judgment.

THE ROAD DISTRICTS ACT, 1919-34.

By-laws.

Quairading Road Board.

P.W. 1489/27.

WHEREAS by "The Road Districts Act, 1919-34," the Road Board of any District is empowered to make By-laws for all or any purposes in the said Acts mentioned, the Quairading Road Board, in pursuance of the powers vested in the said Board, under and by virtue of the said Acts, and of every other authority enabling it in that behalf, doth hereby make and publish the following By-laws:—

Interpretations.

1. In these By-laws the interpretations set out in "The Road Districts Act, 1919-34," shall apply, in addition to which the following terms shall, unless the con-

text otherwise indicates, bear the meaning set against them in the Road Districts Act, or respectively, that is to say:—

- “The Act”—“The Road Districts Act, 1919-34,” and all amendments thereto which may hereafter come into force.
- “Board”—The Quairading Road Board.
- “Board Room” shall be the office, hall, or building in which the meeting of the Board is held from time to time.
- “District”—The district under the jurisdiction of the Quairading Road Board.
- “Secretary”—The Secretary of the Board.

All other interpretations to be prescribed in the Road Districts Act or other Acts or Regulations thereunder.

Duties of Secretary.

2. The duties of the Secretary shall be:—

- (a) To attend all Board meetings.
- (b) To attend all Committee meetings.
- (c) To take notes of minutes and prepare reports of Committees.
- (d) To conduct all correspondence, and to give the other officials instructions, as directed by the minutes, and carry out the resolutions of the Board as contained in such minutes.
- (e) To answer all questions on the Board's business.
- (f) To prepare and place before the Board the monthly financial statement at the end of each month.
- (g) To supervise the preparation of the rate books, and the Board's Electoral Lists, to examine proof of the latter, and to arrange for the distribution of copies prior to the elections; also to attend all courts of revision or appeal, to make the necessary arrangements for the elections, to issue instructions to the Supervisor in accordance with the Board's resolutions.
- (h) To keep all books up to date, in accordance with instructions issued by the Minister and additional instructions of the Board.
- (i) To check all accounts sent in to the Board, and see that all accounts for works have stated in them the authority under which such works have been done, and to check all returns made by the Collector or other of the Board's officers, and see that the counterfoils of the receipt book accompany all returns; to supervise, and attend to due payment of all moneys coming through the hands of the Board's officers and payable to the credit of the Board.
- (j) To report to the Board at its next meeting any officer neglecting to make his returns as provided, with the necessary vouchers attached thereto.
- (k) To see that all moneys received, with the exception of Treasury credits, are lodged to the credit of the Board in the Bank, not less frequently than every second day, and more frequently if the total amount held exceeds £50.
- (l) To see that no payments to the credit of the Board shall be made by any officer except through the Secretary, or such other officer as may be acting temporarily in that capacity.
- (m) To readily and cheerfully obey all lawful commands or orders of the Board, and to attend to all matters affecting the finances and welfare of the Board and not herein specified.
- (n) To see that all bonds and other forms of security to be taken from the contractors are prepared, and that the security required of servants is taken within due time, and report as to such matters to the Board.
- (o) To report to the Chairman any servant of the Board who has been guilty of any neglect of duty, or who is incapable of performing the duties allotted.
- (p) To exercise, subject to any directions given by the Board, or Chairman, control over all servants of the Board.
- (q) To see that no receipt is on any form other than the forms prescribed by the Acts and Regulations under which authority is given for the issue of such receipts.
- (r) To be responsible for the issue of receipts on the proper prescribed forms, and that all receipts issued are in proper sequence.

Duties of Supervisor.

3. The duties of the Supervisor shall be:—

- (a) The Supervisor shall have the control of works, plant, and all property of the Board, and shall issue instructions to the foreman, and shall see that same are faithfully carried out. Should the foreman be guilty of insubordination or disobedience, or be found incapable of performing the duties allotted to him, the Supervisor shall report the matter to the Chairman, who shall inquire into the matter, and if necessary, shall suspend the foreman, and report the matter to the next meeting of the Board.
- (b) To prepare proper plans and specifications for all works and improvements as regards roads and culverts under the control of the Board; examine all materials to be employed in such works, and to see the same faithfully and properly executed and performed, and watch the progress and formation thereof; submit all specifications and plans to the Board before tenders are called.
- (c) To see that the work of cleaning, and repairing all public roads and footways is properly carried out.
- (d) To see that no labourers are engaged but those that are able-bodied.
- (e) To see that all drains, sewers, culverts, and bridges are maintained in a state of efficiency.
- (f) To see that all servants under his control carry out their duties efficiently, and to report any departure therefrom.
- (g) To attend all Board or Committee meetings if required.
- (h) To specially examine all roads throughout the District at least once each six months, or as required by the Board.
- (i) To supply monthly, or as required, to the Board returns of all work completed or in progress, with remarks thereon.

Duties of Collector.

4. (a) The Collector shall collect moneys that may be due to the Board, issuing receipts in the Board's printed forms for payment and entering particulars of all payments in the book provided by the Board for that purpose.

(b) The Collector shall make his financial report and payments to the Secretary every fourteen days, or as otherwise required by the Board from time to time.

Appointment of Officers.

5. No permanent appointment shall be made to any office under the Board until after an advertisement has been published in one or more local newspapers calling for applications from persons competent to fill such an appointment. All appointments shall be made by resolution passed by the Board.

6. The salary or allowance attached to the office under consideration of the Board shall be fixed in all cases preceding the appointment, and the salary of any officer when fixed shall not at any time be considered with a view to its increase or reduction unless specially authorised by a meeting of the Board, at which at least a quorum is present.

7. All complaints against servants of the Board must be in writing and must in every case be signed by the person or persons complaining, and no notice whatever shall be taken of any complaint not made in accordance with this By-law. All such complaints as are receivable shall be addressed to the Chairman, who, upon the receipt of such complaints, shall have power to investigate the same, and he shall report thereon to the Board at their next meeting.

Meetings and Proceedings.

8. Meetings of the Board shall be of two kinds—“Ordinary” and “Special.” Ordinary meetings are the regular meetings held in pursuance of these By-laws for the transaction of the general business of the Board, including meetings adjourned for the purpose of any incomplete business, but an adjourned meeting would not exclude any business which was considered necessary to transact. Special meetings are those called under Section 131 of the Act, and shall include those called by the Chairman in response to a requisition signed by three members, and the notices for such meetings shall have

such special business notified thereon for which the meeting was called, and for which each member shall receive seven days' notice. No business shall be transacted at a special meeting other than that for which the special meeting was called: Provided that any matter of urgency can be discussed, with the ruling of the Chairman, and the consent of those present. The ratepayers' meeting shall consist of one called under Section 144 of the Act, and the Standing Orders shall, so far as the Act allows, apply to the proceedings, but the provisions of the Act shall be first complied with.

9. Ordinary meetings shall be held at the office of the Board once in each month, on the day and the hour appointed from time to time by resolution of the Board.

10. No business will be transacted at any ordinary or special meeting of the Board unless a quorum is present.

11. At any meeting of the Board it shall rest with the majority of the members of the Board present to exclude the public from such meeting, when, in their opinion, it is expedient to do so.

12. The first business of all ordinary meetings of the Board shall be the reading of the minutes of the preceding meeting aloud, with a view to their confirmation.

Minutes of Meetings.

13. The Minute Book prescribed by the Act shall be kept, in which any item of business transacted by the Board at a meeting shall be entered by the Secretary. Minutes of special meetings or ordinary meetings shall be confirmed at the next ordinary meeting. No discussion shall take place upon the minutes of proceedings, except as to their accuracy or for the rectification of a clerical error.

Standing Orders.

14. The order of business of all ordinary meetings of the Board shall be as follows, that is to say:—

- (a) Reading and confirmation of minutes of last ordinary meeting, also special meetings (if any).
- (b) Consideration of business arising out of such minutes.
- (c) Questions of which due notice has been given by members or officers of the Board.
- (d) The Chairman shall have the right of directing attention at any meeting to any matter or subject within the jurisdiction or official cognisance of the Board, by a minute signed by himself, and such minute shall, when introduced, take precedence of all business before or to come before the Board, and the adoption thereof may be put by him from the chair as a motion without being seconded, but he shall confine himself to the questions contained therein.
- (e) Reports of sub-committees and officers.
- (f) Presentation of monthly statement and passing of accounts for payment.
- (g) Reading of correspondence received, and, at the option of the Board, despatched, and taking action as may be deemed expedient in regard thereto.
- (h) Consideration of tenders and ratification of contracts.
- (i) Deputations and presentation of petitions or memorials, and consideration thereof.
- (j) Motions of which previous notice has been given.
- (k) Motions without notice (by leave of the Board, under By-law 19).
- (l) General business.
- (m) Notice of motions.

15. In the event of any member having urgent business to place before the meeting, he may move the suspension of the Standing Orders, and, if agreed to by the Board, such business shall take precedence of all other.

Petitions.

16. Every petition or memorial shall be respectful and temperate in its language, and shall be presented to the Board by a member only, and any member presenting a petition or memorial to the Board shall affix his name to the beginning thereof, with the number of signatures, and any member presenting a petition or memorial shall acquaint himself with the contents thereof and ascertain that it does not contain language disre-

spectful to the Board. The nature or prayer of every petition or memorial shall be stated to the Board by the member presenting the same.

Deputations.

17. Due notice of at least three days shall be given to the Secretary of all deputations intended to wait on the Board, and no deputation shall be received unless such notice has been given and the nature of the business proposed to be discussed.

Tenders.

18. Tenders for works shall be opened and dealt with when the subject matter of the tenders comes on to be considered at the meeting of the Board, or by a committee appointed for the purpose. The Board may require a deposit of 5 per cent. of the amount of the tender to accompany such tender, or two satisfactory sureties.

Orders of Debate—Speakers must not digress.

19. A member, when speaking, shall not digress from the subject of debate.

Correspondence.

20. All correspondence with the Board shall be addressed to the Secretary, and submitted to the Board. No letter addressed to the Board shall be presented or read by a member.

Consideration of Reports.

21. (a) If in a report of a committee distinct recommendations are made, the decision of the Board may be taken separately on each recommendation.

(b) Any report of a committee or any portion thereof may be amended by the Board in any matter if it may think fit, or may be referred back to the committee for further consideration.

(c) The recommendations of any committee, when adopted by the Board shall be the resolutions of the Board.

Precedence of Chairman.

22. When the Chairman rises in his place during the progress of a debate, any member when speaking, or offering to speak, shall immediately resume his seat, and every member shall preserve strict silence, so that the Chairman may be heard without interruption, but the member who was speaking may resume when the Chairman takes his seat.

Notice of Motion—Absence of Mover.

23. In the absence of a member who has placed a notice of motion on the business paper for any meeting, any other member may at such meeting move the same, or such motion may be deferred until next ordinary meeting of the Board.

Withdrawals of Motions.

24. Except as elsewhere provided, no motion, after being placed on the business paper, shall be withdrawn without the consent of the Board.

Motions to be Seconded.

25. No motion shall be debated unless or until it has been seconded.

Motions not to be withdrawn without consent.

26. When a motion has been proposed and seconded it shall become subject to the control of the Board, and shall not be withdrawn without the consent of the Board.

Amendment may be Moved.

27. When a motion has been proposed and seconded any member shall be at liberty to move an amendment thereon, but no such amendment shall be debated unless or until it has been seconded.

Motions and Amendments to be in writing.

28. A motion or amendment not seconded cannot be discussed by any member except the mover, nor put by the Chairman.

29. No motion or amendment shall be debated, unless or until it has been reduced to writing, if the Chairman so directs.

30. In submitting a motion or amendment, the Chairman shall put the question first in the affirmative and then in the negative.

Further Amendment may be moved on amended Questions.

31. If an amendment has been carried, the question as amended thereby shall become itself the question before the Board, whereupon any further amendment upon such question may be moved.

How subsequent Amendments may be Moved.

32. If an amendment, whether upon an original question or amendment as aforesaid has been negatived, then a further amendment may be moved to the question to which such first mentioned amendment was moved, and so on until there are no further amendments and the question is decided by the final vote in the affirmative or negative: Provided that not more than one question and one proposed amendment thereof shall be before the Board at any one time.

Motions for Adjournment.

33. No discussion shall be permitted upon any motion for adjournment of the Board. If upon the question being put on any such motion the same is negatived, the subject then under consideration or next on the business paper shall be discussed, and it shall not be competent for any member to again move a motion for adjournment until half an hour has elapsed from the time of moving the one that has been negatived.

Mover of Adjournment—When entitled to Priority.

34. On resuming any discussion which has been adjourned, the mover of such adjournment shall be entitled if he has not already spoken on the subject under discussion, to speak first.

Notice of Questions to be given.

35. Sufficient notice of every question shall be given to the Chairman or member expected to reply, and, if necessary, reference to other persons or documents.

Questions to be put without argument.

36. Every question shall be put categorically and without argument.

Replies and Objections.

37. No discussion shall ensue upon any reply or refusal to reply to any questions, except by permission of the Board.

Mode of addressing the Board.

38. Members shall, on all occasions when at a meeting, address the Chairman and speak to each other by their official designation, as Chairman or Secretary, etc., as the case may be, and, with the exception of the Chairman, shall rise in their place and stand while speaking (except when prevented from doing so by bodily infirmity).

Speaker not to be interrupted if in order.

39. No member shall be interrupted while speaking, except for the purpose of calling him to order, as hereinafter provided for in pursuance of By-law.

Limitation as to number of Speeches.

40. The mover of an original motion shall have the right of general reply to all observations which have been made in reference to such motion, and to any amendment thereon, as well as the right to speak upon every such amendment. Every member, other than the mover of an original motion, shall have the right to speak once upon such motion, and once upon every amendment moved thereon. No member shall, without the consent of the Board, speak more than once upon any question, or for longer than ten minutes at any one time, unless when misrepresented or misunderstood, in which case he may be permitted to explain without adding further observations that may be necessary for the purpose of such explanation.

Determination of Questions.

41. (a) All questions shall, if not otherwise decided by law, be determined thus: upon a question being put the Chairman shall call for a show of hands for and against the question, and shall declare whether the question has been affirmed by the majority of members pre-

sent or otherwise. The decision of the Chairman shall be final, unless such decision be immediately challenged and any member rise and demand a division.

(b) Where any member dissents he may request that his name be recorded in the minutes as opposed to the motion, and it shall be so recorded.

Divisions.

42. Upon a division being so called for, the question shall first be put in the affirmative and then in the negative, and the Chairman and all members present shall vote by show of hands, and the names and votes of the Chairman and members present shall be recorded in the minutes by the Secretary.

Chairman may repeat Question.

43. The Chairman shall be at liberty to put any question as often as may be necessary, to enable him to form his opinion as to the result of the voting and declare same.

Acts of Disorder.

44. Any member who at any meeting of the Board or any committee commits a breach of any By-law, or who moves or attempts to move any motion or amendment embodying any matter beyond the legal jurisdiction of the Board or committee, or who in any other way raises or attempts to raise any question, or addresses or attempts to address the Board or committee upon any subject which the Board or committee shall have no legal right to entertain or discuss, or uses any language which, according to the common usage of gentlemen, would be disorderly, or makes use of any expression inconsistent with good order and decorum, or who says or does anything calculated to bring the Board or committee into contempt, shall be guilty of an act of disorder.

Ruling of Chairman.

45. (a) The Chairman, when called upon to decide a point of order or practice, shall state the rule or precedent applicable to the case, without further argument or comment, and his decision shall be final in that particular case.

(b) If the ruling of the Chairman be disagreed with, then the usual Parliamentary procedure may be adopted.

Members called to Order more than once.

46. Any member who, having been called to order by the Chairman for any infringement of any of the provisions of this By-law, or for any breach of decorum, shall, upon the request of the Chairman, withdraw from the Board Room for the remainder of the meeting.

Removal from Board Room—Penalty for continued Breach of Order, etc.

47. In the event of a member declining to withdraw from the Board Room on being requested to do so by the Chairman, the Chairman may order his retirement until the termination of the sitting, and should such member disobey such order he shall be deemed guilty of an offence and shall be liable to a penalty not exceeding one pound (£1).

Disorder.

48. If disorder arises at any meeting, the Chairman may adjourn the meeting for a period of fifteen minutes and quit the chair. The Board, on resuming shall, on question put from the chair, decide without debate whether the business be proceeded with or not.

Appointment of Committee.

49. The Board may at any time appoint three or more members as a committee to inquire into any matter and make a report and recommendation thereon, but no committee shall incur any financial liability or in any way commit the Board to any responsibility whatever without express and specific authority conferred by the By-laws or a resolution of the Board.

Finance and Accounts.

50. All accounts, bills, and vouchers shall be submitted to the finance committee and the ordinary general meeting, and, after being certified as correct, shall be paid by cheque. An account shall be opened with such bank as the Board may from time to time direct, and all moneys received from whatever sources, with the exception of moneys paid to the credit of the Board at

the Treasury, shall be paid to the credit of the Board's account at such bank. All cheques and orders drawn against the Board's bank or Treasury accounts must be signed by the Chairman and any one member of the Board, and in all cases countersigned by the Secretary of the Board.

51. All moneys belonging to the Board shall, within 24 hours after they come into the hands of any officer, servant, or clerk, be paid to the Secretary or responsible officer directed by the Board to receive same.

Urgent Work.

52. The Chairman, or, in the absence of the Chairman any three members may in the case of urgent necessity authorise the expenditure of a sum not exceeding ten pounds on statutory works or undertakings; provided that in such case they shall report the matter at the next ordinary or special meeting of the Board.

53. Any member may in a case of very urgent necessity authorise the expenditure of a sum not exceeding two pounds on statutory works or undertakings within the ward he represents; provided that he must report the matter at the next ordinary or special meeting of the Board.

Unauthorised Expenditure.

54. Every item of expenditure and every liability incurred by any Committee or member of the Board, otherwise than under the authority of the Act or of these By-laws, shall be deemed unlawful expenditure and a breach of this By-law by such person.

Common Seal.

55. The common seal of the Board shall be kept in the Board's safe. The common seal shall not be affixed to any deed or other instrument except by order of the Board.

Preservation of Trees.

56. Any person who shall carelessly, wilfully, or wantonly injure, destroy, carry away, or remove from its place any tree or shrub, or plant standing in any of the roads, enclosures, public places, or reserves, or who shall carelessly, wilfully, or wantonly injure, destroy, carry away, or remove out of its place, or ride or drive against any of the tree guards, fences, or other protection to such trees, shrubs, or plants aforesaid, shall be liable to a penalty of not more than £10, and in addition thereto shall also pay the Board a sum equal to the damage so done; provided, however, that the Board may give written permission to any person to grub out and remove any tree or shrub or plant standing in any of the roads, enclosures, public places, or reserves.

Amendment to By-laws.

M.H.D. 697/28; Ex. Co. 1545.

WHEREAS Model By-laws have been prepared in accordance with the provisions of Section 295 of "The Health Act, 1911-1933," and published in the *Government Gazette* on the 8th day of April, 1927; and whereas the Geraldton Municipal Council, being a Local Health Authority under the provisions of the said Act did, by resolution published in the *Government Gazette* on the 28th day of September, 1928, adopt either wholly or in part such Model By-laws to be its By-laws; and whereas by the provisions of the said Act a Local Authority may alter or amend By-laws so made: Now, therefore, the Geraldton Municipal Council, being the Local Health Authority, doth hereby amend the By-laws in the following manner:—

By-law 21. By inserting the following clauses:—

(1) Whenever it is intended to carry out any work in connection with the construction or laying of any drains or any plumbing work in connection with the disposal of liquid refuse on any premises, the owner of such premises shall make application in writing to the Local Authority for permission to do so. Such application shall be in the form set out in Schedule "B" hereto and shall be accompanied by a block plan and a specification in triplicate drawn to a scale of not less than one-eighth of an inch to one foot. Such plan shall show:—

- (a) The position of the drains in relation to adjacent buildings.
- (b) The situation and designation of the various fittings, disconnecting traps, and vents.
- (c) The ultimate disposal of the liquid refuse, whether by soak well, impervious receptacle, or to the ocean outfall drain.

(2) When the work in connection with such drain and plumbing is complete and ready for inspection the owner of the premises shall forthwith notify the Local Authority in writing. Upon receipt of such notice the Local Authority shall, as soon as practicable, arrange for the inspection of such drains and plumbing work. Until such inspection has been made all drains, connections, etc., shall remain exposed. If the work has been carried out in accordance with these By-laws and with the plans and specifications approved of, the Local Authority shall issue to the owner a "Certificate of Completion" to utilise such drainage and plumbing. No drainage, plumbing work or fittings in connection therewith shall be used until such certificate has been issued.

By-law 23. By deleting the whole of paragraph (a) in Clause (1), and by adding to Clauses (1) and (2) the following words:—

"The work to be carried out in accordance with and as provided for in paragraphs (c) and (d) of By-law 23."

 WHEREAS by Section 295 of "The Health Act, 1911-33," it is provided that the Governor may cause to be prepared Model By-laws for all or any of the purposes for which By-laws may be made by a Local Authority under any of the provisions of the said Act, and that a Local Authority may, of its own motion, by resolution, adopt the whole or any portion of such By-laws; and whereas Model By-laws have been prepared in accordance with the provisions of the said section and published in the *Government Gazette* on the 8th day of April, 1927: Now, therefore, it is resolved and determined by the Municipal Council of the City of Fremantle, being a Local Health Authority within the meaning of the said Act, that the whole of such Model By-laws and subsequent amendments thereto be adopted for the district of Fremantle: And whereas a Local Health Authority may make By-laws and may amend, repeal, or alter any By-laws so made: Now, therefore, the Municipal Council of the City of Fremantle, being a Local Health Authority within the meaning of the said Act, doth hereby amend its By-laws as follows:—

Substituting the following to stand in lieu of Section 26, Part I.:—
 Part I., Section 26:

Stables.

The occupier of any premises whereon a horse is kept shall provide a stable which shall comply with the following conditions:—

- (a) It shall not be at any less distance than 50 feet of any house, nor nearer than 3 feet to any boundary fence unless built of brick or stone, nor less than 50 feet from the milking shed or milk room of any dairy.
- (b) The walls shall be constructed of concrete, brick, stone, wood, or galvanised iron.
- (c) The roof shall be constructed of some impervious material.
- (d) There shall be on all sides of the building between the wall and the roof a continuous clear space of at least 6 inches in height.
- (e) The upper surface of the floor shall be raised and maintained at least 3 inches above the surface of the surrounding ground.
- (f) There shall be provided outside each such stable a receptacle for manure; such receptacle shall be constructed of brick faced with cement, or with other approved material, it shall be provided with a tight-fitting cover, and shall be emptied at least once weekly.
- (g) All manure produced on the premises shall be collected daily and placed in the receptacle for manure.
- (h) The stables shall be maintained in a cleanly condition and shall be cleansed and disinfected when so ordered by an inspector.

Keeping of horses, cows, sheep and goats.

By deleting from the eighth line of Section 28 of Part I. the words "twenty feet," and inserting in lieu thereof the words "fifty feet," in respect of the above.

By substituting the following to stand in lieu of Section 29, Part I.:—

Part I., Section 29:

Keeping of Poultry or Pigeons.

(a) The occupier of any premises shall not keep any poultry or pigeons except for the purpose of immediate sale within that portion of the district embraced within the following boundaries:—

Bounded by lines starting from the left bank of the Swan River and extending South-East along Edward Street to the intersection of Parry Street; thence South along Parry Street to Holdsworth Street; thence West along Holdsworth Street to the intersection of Queen Street; thence North-West along Queen Street to the intersection of Henderson Street; thence West along Henderson Street to the intersection of South Terrace; thence across South Terrace to the centre of Essex Street; thence West along Essex Street to the intersection of Marine Terrace; thence along the sea coast Northwards and East along the said bank of the Swan River to the starting point.

(b) The occupier of any premises shall not keep any pigeons or fowls or turkeys within 25 feet of any dwelling house, and where pigeons are kept they shall be continually confined.

(c) The occupier of any premises shall not keep any ducks or geese within 40 feet of any dwelling house.

(d) All enclosures or cages within which birds of any description are kept shall be maintained at all times in a clean condition, and shall at any time be cleaned, disinfected, or otherwise dealt with as an inspector may direct.

Bakehouses.

By adding the following to Section 56 of Part VII. in respect of the above:—

(f) Every person engaged in selling or carrying bread shall cause all bread in course of transport to be carried in weatherproof-covered vehicles or containers constructed in such a manner as to thoroughly protect such bread from flies and dust.
