### ORDER IN COUNCIL.

WHEREAS by "The Water Boards Act, 1904," it is provided that, before undertaking the construction of waterworks, the Minister shall submit plans, descriptions, books of reference, and estimates of the proposed works to the Governor for approval; and that if they are approved the Governor may forthwith by Order in Council empower the Minister to undertake the construction of the proposed works: Now, therefore, His Excellency the Lieutenant-Governor, with the advice of the Executive Council, hereby approves of the plans, descriptions, books of reference, and estimates marked P.W.D., W.A. 27933, for the construction of waterworks within the Wiluna Water Area, which were duly submitted for approval, and hereby empowers the Wiluna Water Board to undertake the construction of the said works.

ORDER IN COUNCIL.

P.W. 1504/34.

HIS Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council, hereby makes the following Order under the authority of "The Municipal Corporations Act, 1906," namely:—In pursuance of Subsection 6 of Section 12 of the said Act, that the outlying land described in Schedule hereto be annexed to the Municipality of Albany.

Schedule.

All that portion of Hanover Bay and Princess Royal Harbour bounded by lines starting from a point in prolongation southerly of the western boundary of Albany Lot B.14 and situate 4 chains southerly from its southern corner, and extending westerly to a point in prolongation southerly of the western boundary of Lot B.28 and situate 4 chains southerly from its south-western corner; thence west-south-westerly to a point in prolongation southerly of the western boundary of Lot B.41 and situate 2 chains 80 links southerly from its south-western corner; thence northerly along the latter prolongation to the high-water mark of said Princess Royal Harbour; thence generally easterly along said H.W.M. to a point in prolongation southerly of the western boundary of said Lot B.14, and thence southerly to the starting point. The Public Works Act, 1902-1933.

Maylands Home for Mentally Deficient Girls—Sale of Land no longer required for the above.

ORDER IN COUNCIL.

P.W. 500/28; Ex. Co. No. 2058.

The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.

Victoria Quay, Fremantle:—Lifting 14 chains of 4-inch main and replacing with 6-inch main.

FARMERS' DEBTS ADJUSTMENT ACT, 1930-1934.

NOTICE is hereby given that the following Stay Orders have been issued in accordance with Section 7, Subsection 1, of "The Farmers' Debts Adjustment Act, 1930-1934," which reads as follows:—

A Stay Order shall direct that no action, execution, distress for rent, proceedings on default for breach of covenant under any mortgage or other security for money, or under an agreement for sale and purchase of land, or other process or proceeding, shall be commenced or proceeded with or put in force against the farmer or any of the farmer's assets, whether utilised in connection with or forming portion of the assets comprised in his farming business or not during the operation of such Stay Order: Provided that, by leave of a Judge, any action may, notwithstanding the Stay Order, be instituted and/or carried on against the farmer, but not beyond judgment.

Confetti:—An extra 5s. will be made if confetti is used in or about the Hall.

Crockery:—A charge of 3d. per dozen, with a minimum of 2s. 6d. All crockery must be returned to the kitchen, and all breakages paid for.

Copper:—1s. 6d.

General:—The Board reserves the right to levy an additional charge to cover the cost of any extra cleaning, repairs, etc., rendered necessary by virtue of any use of the Hall and surroundings.

If any person makes default in duly complying with any such notice served upon him under this By-law, the Council, or any person acting under its authority, may enter into and upon any such private property as aforesaid, and remove any such hoarding, or any such bill, placard, or advertisement, as the case may be, and may recover the expenses incurred in so doing from the person or persons making default as aforesaid as a debt owing by him or them to the Council by action in any court of competent jurisdiction.

4. No person shall obstruct or interfere with any person acting under the authority of the Council in the course of the removal by such person of any such hoarding, or any such bill, placard, or advertisement under the power given in Clause 3 hereof preceding.

5. If any person shall contravene any of these By-laws he shall be guilty of an offence hereunder, and on conviction for such offence shall be liable to a penalty not exceeding £10, and also for each successive similar offence to a penalty not exceeding Two pounds.
