WHEREAS by Section 17 of "The Fisheries Act, 1905-21," it is provided that the Governor may by Proclamation in the *Government Gazette* declare (*inter alia*) what length of net and size of mesh for the whole or any part of a fishing net shall, when used or intended to be used in any specified water or waters, or for catching any specified kind or kinds of fish, be a lawful net: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of every other power enabling me in this behalf, proclaim and declare as follows—That nets, known as meshing nets, with meshes not less than the size of two and one-half inches in any part thereof, measured from knot to knot on the inside of the mesh when wetted and ready for use and stretched so that the opposite knots on the alternate corners are in contact shall, when used or intended to be used for lawful fishing in the waters defined in the Schedule hereto be lawful nets, and that it shall not be lawful to use in such waters any meshing net not in conformity with these conditions.

That portion of the waters of Koombana Bay (Bunbury) exclusive of that portion of the said bay which is closed to the use of fishing nets, *vide* paragraph 8 of the Schedule in a Proclamation under the provisions of "The Fisheries Act, 1905-21," dated the 17th day of December, 1934, and published in the *Government Gazette* on the 21st December, 1934.

ORDER IN COUNCIL.

P.W.W.S. 733/35.

IN pursuance of the powers reserved to him under Section 36 of "The Water Boards Act, 1904," His Excellency the Lieutenant-Governor, acting by and with the advice and consent of the Executive Council, does hereby vest in the Dangin-Quairading Water Board the following waterworks, constructed out of moneys appropriated by Parliament for the supply of water respectively to the Dangin and Quairading Water Areas, namely:—(a) Storage reservoir on Toapin Rock, Reserve 17433, capacity 2,542,000 gallons, together with all valves, pipes, outlet works, and inlet drains connected therewith; (b) fencing to the said Reserve 17433; (c) service reservoir, 140,000 gallons capacity galvanised iron tank on Reserve 17434; (d) rising main, 145 chains of 2.7/8-inch diameter g.w.i. pipes from the storage reservoir to the service reservoir; (e) gravitation main, 230 chains of 2-inch diameter g.w.i. pipes from the service reservoir to Dangin Townsite; (f) reticulation mains within the Dangin Townsite together with all services, meters, and fittings; (g) an easement of 15 links on each side of the pipe lines through Avon Locations 21605, 21606, 21607, and 21613.

This Order in Council shall take effect from the 1st day of July, 1935.

Yilgarn Road Board—Building By-laws.

P.W. 9/26.

IN pursuance of the powers conferred on it by the Second Schedule to "The Road Districts Act, 1919-34," Building Regulations 36 and 37, the Yilgarn District Road Board doth make and publish the following By-laws, and doth order that such By-laws shall apply to the Townsite of Southern Cross, Bullfinch, Marvel Loch, Yellowdine, Palmer's Find, Moorine Rock, Noon-gaar and Boddalin.

1. No person shall erect any building, or alter or add to an existing building or shall permit any person to erect any building, or alter or add to an existing building, on land of which he is the owner or which he has the control, except such building, alteration, or addition is erected in conformity with these By-laws.

2. No person shall build any structure intended for human habitation or occupation, or capable of being used as such, or shall alter or add to any such existing structure, without having obtained a Building License from the Board and paying the fees prescribed herein, namely:—

- (a) The fee for Building License;
- (b) The fee for the use of the portion of the street abutting on the building during building operations, and deposit as a security for the reinstatement and repair of such portion of such street;
- (c) The charge of the Local Health Authority for providing the necessary pans and lids for the privy.

3. Before such Building License is issued, plans and specifications in the form prescribed herein, showing size and type of all material to be used, which must be to the satisfaction of the surveyor, together with the number of ventilators in each room, shall be submitted to the surveyor, and a license will not be granted before seven days after the submission of such plans and specifications, unless in special circumstances, of which special circumstances the surveyor shall be the sole judge.

4. Plans shall be in ink, on tracing linen or on paper sufficiently strong to stand the erasure of "H" pencil marks without injury to the paper; and specifications shall be in typewriting or in ink manuscript, clearly written, and on strong paper.

5. Plans shall show clearly such ground plans, elevations, and sections as are sufficient to make plain the construction and dimensions of the proposed structure. The sizes of rooms and thickness of walls shall be written on in figures. Specifications shall show clearly, both as to materials and sizes of same, the construction of the foundations, floors, internal and external walls, ceilings and roof; also the ventilation of the structure, the number of privies and the construction of same, and

shall provide for at least one privy of the prescribed construction provided with the pan supplied by the Local Health Authority.

A block plan, signed by the builder or owner, shall be supplied, showing clearly the position of the intended structure on the block of land on which it is to be erected, and the position of the privy, also position of any other structure on the block, together with any other structure within 20ft. of the boundary of the block. Such plan will be retained by the Board.

6. If the plans and specifications submitted are in accordance with these By-laws, and the prescribed fees paid, the surveyor shall sign them on behalf of the Board and issue a Building License, in the form prescribed herein, and for the period set forth in such license, but if the plans and specifications contain any matter which in the opinion of the surveyor is contrary to sound or sanitary construction, and such matter is not covered by these By-laws, the surveyor shall refer such matter to the Board at its next meeting, and the Board shall have power to decide any matter referred to in Clauses A to K of Section 37 of the Building Regulations, when such matter is not defined by these By-laws, and a Building License will not be granted until the Board decides on such matter, provided that such decision will not be unreasonably delayed.

7. Within that portion of Antares street, Southern Cross, to the south of Canopus street, no wall of any structure facing Antares street shall be erected unless constructed of brick, stone, or concrete.

Within that portion of the Southern Cross Ward bounded on the northern side by the railway line, on the east by Aldebaran street, the south by Circus street and the Townsite boundary, and the west by the Townsite boundary and Taurus street, no building shall be erected having outer walls of "inflammable material" as defined in Regulation 14, Subsection 2, of "The Road Districts Act, 1919-34."

8. On behalf of the Board the surveyor may authorise the internal linings, partitions, and ceilings of any dwelling, if such building is not nearer than ten feet to any boundary of the block of land on which it stands, to be constructed wholly or partly of inflammable material. Such authority shall hold good for not more than twelve months after the date fixed for the expiration of the Building License, but may be extended by the Board from time to time, on the application of the then owner. If no such extension of time is granted, such inflammable material shall then have become erected contrary to the provisions of Section 14 of the Building Regulations, within the meaning of the said section, and the Board may at any time proceed in the manner set forth in the said Section 14.

9. No wall of any building capable of being used as a residence shall be erected nearer than three feet to the boundary of the block of land on which it is to stand, unless it be a parapet wall rising to a height of one foot at least above the roof gutter. The Board will not approve of the erection of any residential building where a wall will conflict with these By-laws, if such block of land became subdivided or in the ownership of more than one person. In no building capable of being used as a residence or business premises shall the top wall-plate or ceiling be nearer to the floor than 10 clear feet; only in a building, the roof of which is of the skillion type, may the lowest side of the ceiling be as low as nine feet from the floor. On no block of land having a frontage of 66 feet or less to any street shall approval be given for the erection of more than one building capable of being used as a residence, except where the adjoining wall of such building is of the parapet type.

10. No street verandah shall be erected except in accordance with the plan submitted to and approved of by the Board, and every such verandah shall be provided with a suitable gutter to carry the water falling on such verandah. If the water from such gutter discharges into the street, it shall be carried into the street gutter by a cast or wrought-iron downpipe, of such size as the Board may direct, and such downpipe shall discharge into the street gutter in such manner as the Board may direct.

Any such street verandah, gutter, and downpipe shall at all times be kept in repair by the owner of the building in front of which it is built, to the satisfaction of the Board, and the owner shall carry out any repairs in such manner as may be ordered by the Board.

11. Where a right-of-way adjoins each block, the privy must abut on such right-of-way.

12. Before the construction of any building is commenced a privy should be provided on the land for the use of the workmen.

Fees Payable.

For a Building License:—Two shillings and sixpence for each 1,000 square feet of floor space or part thereof.

The term "Floor area" shall mean the space occupied by each floor of the building, including basement and verandah.

INDUSTRIAL AGREEMENT.

No. 16 of 1935.

(Registered 3-9-35.)

THIS Agreement, made in pursuance of "The Industrial Arbitration Act, 1912-1925," this twenty-first day of August, One thousand nine hundred and thirty-five, between the Hotel, Club, Caterers, Tearooms and Restaurant Employees' Industrial Union of Workers, Perth (hereinafter called "the Union"), of the one part, and The Hotel-keepers of Collie, whose names and signatures appear in the Schedule hereto (hereinafter called "the Employer"), of the other part, witnesseth that, for the consideration hereinafter appearing, the parties hereto mutually covenant and agree the one with the other as follows:—

1.—Area.

This Agreement shall have effect over the area comprised within the radius of ten (10) miles from the Central Post Office, Collie.

2.—Term.

This Agreement shall come into operation on the twenty-first day of August, One thousand nine hundred and thirty-five, and shall remain in force for a term of twelve (12) months from its date.

3.—Wages.

Except as hereinafter provided, the following shall be the minimum rate of wages per week:—

4.—Hours.

Forty-eight (48) hours shall constitute a week's work.

(b) Any worker, except casual workers, who works a lesser number of hours per week, shall be paid the full week's wages. For the purpose of this Agreement the time during which the employee is on the premises of the employer shall be deemed working time. If the employee has permission to leave the premises for any time not less than one (1) hour but prefers to remain thereon, such time shall not be included in the working time.

5.—Spread of Shift.

Daily spread of shift shall mean the time which elapses from the time when the worker first starts work in the morning and the time when he or she finishes for the day. Weekly spread of shifts shall mean the aggregate number of hours contained in the daily spread for the week. The weekly spread shall not exceed seventy-two (72) hours.

(b) The longest spread of shift in any one (1) day shall not exceed twelve (12) hours.

(c) In addition to one (1) hour break for meals, there shall not be more than one (1) break in any one (1) shift, such break to be not less than two (2) hours.

6.—Overtime.

Work done by workers after the completion of forty-eight (48) hours in any one (1) week, or in excess of the rostered hours in any one (1) day shall be deemed overtime, and shall be paid for at the rate of time and a half for the first four (4) hours, and, thereafter, double time.

7.—Holidays.

All workers shall be entitled to and shall receive one (1) full day off per week.

(b) Christmas Day, Good Friday, Labour Day, and Anzac Day shall be holidays in all establishments, otherwise an extra day's pay shall be paid to each employee who is required to work on any of those days.

(c) After the completion of twelve (12) months' service, annual holidays shall be granted as follows:— Two (2) weeks on full pay shall be granted to those workers, and such holiday shall be granted within one (1) month of it becoming due, and all such workers shall be required to take such holidays. Provided also, that any worker who shall have served one (1) month or over, and whose service shall have been terminated by either party before the annual holiday has become due under this clause, shall be entitled to and shall receive a proportionate allowance for the time actually served.

8.—Preference of Employment.

Preference of employment shall be given to members of the Union.

9.—Meals.

Meals shall be supplied as per menu.

10.—Restriction of Work.

No female employee shall be permitted or compelled to climb ladders for the purpose of cleaning electric fans, fanlights, walls, or windows.

11.—Roster.

A roster of the working hours of all workers shall be exhibited in each establishment, in such a place as it may be conveniently and readily seen by each worker, such roster to be compiled weekly, and shall denote the hours to be worked by such workers for the week ahead, and shall be open for inspection by Union officials during all working hours. A copy of this Agreement shall be available at all times in a place where all may peruse it.

12.—Weekly Wage.

Wages shall be paid weekly. When no agreement in writing is made determining the period of notice, then a notice of not less than twenty-four (24) hours shall be given by either party of intention to terminate service.

13.—Higher Duties.

Any employee engaged for two (2) hours or more in any week in work carrying a higher prescribed rate of wage shall receive such higher rate for the time so engaged.

14.—Board and Residence.

If full board is provided by the employer, he may deduct fourteen (14) shillings and four (4) pence for males and thirteen (13) shillings and eleven (11) pence for females per week, and, where lodging is provided, the sum of six (6) shillings and four (4) pence for males and six (6) shillings and two (2) pence for females may be deducted each week.

(b) The employer requiring the worker to sleep in shall provide suitable accommodation. If the worker shall consider the accommodation unsuitable, then the Union may request a Health Inspector to inspect and report on the same. Employees sleeping in shall be provided with a common sitting room apart from their bedroom, and they shall have access to the bathrooms.

15.—Uniform Allowance.

Employers shall pay two (2) shillings per week for the laundering of all white cuffs and collars where same are demanded to be worn, and also pay two (2) shillings per week extra to all workers who wear white aprons or coats.

Only a plain black and white uniform will be recognised by the parties to this Agreement. The cost of any alteration in colour or design required by the employer shall be provided by that employer.

The wearing of all head gear by any employee in any establishment is hereby prohibited.

16.—Record.

The employer shall keep or cause to be kept at his business premises a time and wages book, wherein shall be entered the names and occupations of all employees (and, in the case of juniors, their age on last birthday) the time that he or she commences work each day, the hours worked on each day, and the wages paid to each employee each week. Such book shall be initialed daily, if correct, by each worker.

The book shall be open for inspection by a duly authorised representative of the Union during all working hours.
