### ORDER IN COUNCIL.

P.W. 939/34.

WHEREAS under the provisions of "The Traffic Act, 1919-31," the Governor may by Order in Council empower a local authority to exercise within its District any power of making Regulations which the Governor can exercise, under Division 4 of Part IV. of "The Traffic Act, 1919-31": Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council, under the provisions of the said Act and all other powers enabling him in this behalf, doth hereby empower the Perth Road Board to make By-laws to:—1, Regulate the speed of vehicles on roads; 2, regulate or prohibit the parking of vehicles on roads; 3, prohibit the use of any specified road by any vehicle, or by any person riding, driving, or in charge of any animal, except when proceeding in a prescribed direction.

## FARMERS' DEBTS ADJUSTMENT ACT, 1930-1934.

NOTICE is hereby given that the following Stay Orders have been issued in accordance with Section 7, Subsection 1, of "The Farmers' Debts Adjustment Act, 1930-1934," which reads as follows:—

A Stay Order shall direct that no action, execution, distress for rent, proceedings on default for breach of covenant under any mortgage or other security for money, or under an agreement for sale and purchase of land, or other process or proceeding, shall be commenced or proceeded with or put in force against the farmer or any of the farmer's assets, whether utilised in connection with or forming portion of the assets comprised in his farming business or not during the operation of such Stay Order: Provided that, by leave of a Judge, any action may, notwithstanding the Stay Order, be instituted and/or carried on against the farmer, but not beyond judgment.

## SUPREME COURT RULES.

THE following amendment of the Supreme Court Rules is published for general information:—

The Honourable Sir John Alfred Northmore, K.C.M.G., Chief Justice of Western Australia, The Honourable Thomas Percy Draper, and the Honourable John Patrick Dwyer, Puisne Judges of the Supreme Court of Western Australia, do hereby, in pursuance of the powers contained in "The Supreme Court Act, 1880," and of every other power them in this behalf enabling, amend Rule 1 of Order LXIII. of the Supreme Court Rules of 1909 in the manner hereinafter mentioned, and declare that such amendment shall come into operation one month after publication thereof in the *Government Gazette*:—

Order LXIII.

Rule 1 is deleted and a new rule is inserted in lieu thereof, as follows:—

1. The civil sittings of the Supreme Court for the trial of actions and issues of fact shall be ten in every year and shall commence on the first Tuesday in every month, from March to December, both inclusive.

Provided that—

- (i) Whenever the day hereby appointed for the commencement of the civil sittings shall fall on the Tuesday after Easter, such sittings shall not be held until the Wednesday after Easter; and
- (ii) whenever any sittings would commence on a public holiday they shall not be held until the day next following such public holiday.

Wherever the District or part of the District under the control of a Local Authority has been or hereafter shall be zoned or districted or classified under the provisions of the Town Planning and Development Act, the owner of any land shall not use, nor shall he suffer or permit any person to use, any land of which he is the owner, or any building erected thereon, or which may be erected thereon, for any purpose contrary to the provisions of any town planning scheme.

2. The authority or authorities responsible for carrying the Town Planning By-law into effect and enforcing its observance shall be the executive officer of any Local Authority and/or the Town Planning Commissioner.

3. If any person shall, either by act or omission, contravene this By-law, he shall be guilty of an offence under this By-law, and on conviction for such offence shall be liable to a penalty not exceeding £10.

*Melville Road Board Town Planning Scheme and  
Regulations.*

Melville Road Board.

Town Planning Scheme.

IN pursuance of the resolution of the Melville Road Board of the 5th November, 1935, and notices advertised in accordance with the Town Planning Regulations, 1930, the undermentioned works are planned and projected:—

Work No. 1.

Development and Construction, Melville Highway.

1. To construct a highway from Canning Bridge along the waterfront of the Canning and Swan rivers to the Board's western boundary, namely, the junction of the south bank of the Swan river and the western boundary of Swan Location 70.

Work No. 2.

2. Zoning or districting the Road Board District for industrial, business and residential purposes, as shown on plan and described in the Schedule hereunder.

Work No. 3.

3. Make provision for the survey and extension of Foss street, Bicton, from its present terminus to View terrace.

Industrial and Agricultural Areas Regulations.

(a) No portion of the Road Board District shall be used for industrial, and/or agricultural purposes, except those lands coloured purple, and excepting the areas defined in the Schedule. Industrial and/or agricultural purposes shall mean any work, manufactory, or industrial or agricultural enterprise not included in a business area.

The whole of the northern frontages of Preston Point road from Point Walter road to First street.

The whole of the frontages of First street, Bicton.

The whole of the frontages of Matheson road from Dee road to Kintail road, the whole of the frontages of

Kintail road from Matheson road to Ardross street, the whole of the frontages of McLeod road from Kintail road to Dee road, the whole of the frontages of Dee road from Matheson road to McLeod road, the whole of the frontages of McDonald road from McLeod road to Ardross street, the whole of the frontages of Ardross street from Kintail road to McDonald road, the whole of the eastern frontage of Cunningham street from Matheson road to Troy road.

The whole of the frontages of Short street from the Esplanade to Coogee road, and the whole of the frontages of Park road from Hawkins street to Coogee road.

(b) Churches, public buildings, or other institutional buildings may be erected in the Residential Area with the approval of the Board.

(c) No residential lot shall be built on to cover more than one-third of the area of such lot.

(d) No lot shall be built on where such land is below the seven feet contour as defined on the plan, unless:—

1. The land is drained to the satisfaction of the Road Board, and/or
2. The land is built up to the level of the crown of the road (whether existing or to be built) on which the lot fronts.

IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

No 5 of 1935.

Between Western Australian Nurses' Association Industrial Union of Workers, Perth, Applicant, and The Board of Management of the Perth Hospital, The Board of Management of the Fremantle Hospital, Children's Hospital Incorporated, Minister for Public Health for the State of Western Australia, The Board of Management of the Lemnos Hospital, Children's Protection Society Incorporated, The Board of Management of the Warren Hospital, Jardee; Silver Chain District Nurses' Association (Incorporated), Infant Health Association of Western Australia, Respondents.

THE Court of Arbitration of Western Australia doth hereby make the following Award in connection with the industrial dispute between the abovenamed parties:—

AWARD.

1.—Scope.

This Award shall apply to all nurses (including matrons and assistant matrons and midwifery nurses) and pupil nurses or trainees in the employment of the respondents, and to all included by virtue of the provisions of Section 83 of the Act within the area covered by the Award.

2.—Area.

This Award shall have effect throughout the State of Western Australia.

3.—Term.

This Award shall be for a period of three (3) years, with the right of any party hereto to apply to the Court for amendment after twelve (12) months.

4.—Definitions.

(a) "Nurse": The term "nurse" shall mean and include one who is registered under or entitled to be registered under "The Nurses' Registration Act, 1921," or "The Health Act, 1911-1933."

(b) "Matron": A "matron" is a nurse in control of the nursing services and performing other duties at a hospital.

(c) "Assistant matron": An "assistant matron" is a nurse appointed to assist the matron in control of the nursing services and to perform other duties at a hospital.

(d) "Sister": A "sister" is a nurse in charge of a ward or a department of a hospital or the training of nurses or of a district.

(e) "Trainee": A "trainee" is a pupil nurse undergoing training in a registered training school, and is an apprentice within the meaning of that term in "The Industrial Arbitration Act, 1912-1925."

(f) "Training School": A registered "training school" is one which is registered as a training school under either "The Nurses' Registration Act, 1921," or "The Health Act, 1911-1933."

(g) "Union": The "Union" shall mean the "Western Australian Nurses' Association Industrial Union of Workers, Perth."

5.—Average Occupied Beds.

For the purpose of ascertaining the daily average of occupied beds, the average shall be taken for the twelve (12) months ending June 30th in each and every year, and such average shall relate to the salary for the succeeding year.

In the event of a hospital not having been open for the required period, the salary to be paid shall be such as may be agreed upon by the employer and the Union and, if no agreement is arrived at, determined by the Board of Reference appointed hereunder.

6.—Classification of Hospitals.

For the purpose of this Award, hospitals are classified as follows:—

Class "A":

Hospitals which are registered training schools.

Class "B":

Hospitals which are not registered training schools but at which the beds occupied average more than twenty (20).

Class "C":

All other hospitals.

7.—Hours.

The ordinary hours for sisters, nurses, and trainees covered by this Award shall be:—

(a) At hospitals within a radius of twenty-five (25) miles from the General Post Office, Perth, and at Kalgoorlie Hospital, forty-eight (48) hours per week exclusive of meal times.

(b) At hospitals, except Wooroloo and Kalgoorlie, outside a radius of twenty-five (25) miles from the General Post Office, Perth, ninety-six (96) hours per fortnight, exclusive of meal times.

(c) At Wooroloo one hundred and ninety-two (192) hours per four (4) weeks, exclusive of meal times.

(d) At hospitals which come under the provisions of paragraph (a), those on day duty shall be allowed one and a half days' continuous time off duty per week, and those on night duty shall be allowed one and a half days' continuous time off duty per week or three (3) days' continuous time off duty per fortnight. Similar provisions shall apply to those covered by paragraph (b), where reasonably practicable.

(e) At Wooroloo, four (4) days' continuous time off duty in every four (4) weeks shall be allowed.

(f) The provisions of this clause shall not apply to hospitals where the daily average of occupied beds does not exceed nine (9), in which case there shall be no fixed hours of duty.

(g) The provisions of this clause shall not apply to matrons or assistant matrons.

(h) Notwithstanding anything to the contrary contained in this section, the ordinary working hours of the sisters in charge of the Diabetic Clinic at Perth Hospital, and the sister on duty in the Medical Superintendent's office at Perth Hospital, sisters on duty in X-ray and Radium Clinics, Social Service Sisters, and nurses engaged in Infant Welfare work, within the area comprised within a radius of twelve (12) miles from the General Post Office, Perth, and at the Kalgoorlie and Wiluna centres, shall not exceed thirty-eight (38) hours per week, to be worked between 9 a.m. and 5 p.m. on week days, with a break of an hour for lunch, which time shall not be included in the said thirty-eight (38) hours, and from 9 a.m. to 12 noon on Saturdays.

(i) In addition to the time off duty hereinbefore provided, nurses and sisters engaged in X-ray work or radium work shall be allowed such other time off duty as in the opinion of the Medical Officer in charge of such work may be necessarily consequent upon such work for the purpose of maintaining or restoring them to normal health and all such time shall be computed as part of the ordinary working time, and there shall be no reduction in salary in respect thereof.

(j) Morning and afternoon tea shall be provided by the employer, to be taken as convenient, without deduction of time involved.

(k) Where an employee is required to travel as part of her duty, such travelling time shall be considered as part of her working time, and there shall be no reduction in respect thereof.

8.—Overtime.

All time worked in excess of the ordinary working time shall be paid for at the rate of time and a half, or, if the employer and employee so agree, time off in lieu thereof shall be granted, at the convenience of the hospital.

Less than thirty (30) minutes' overtime for a week or a fortnight, as the case may be, shall not be paid for.

9.—Holidays.

(a) Every employee covered by this Award, where not otherwise provided for, shall be entitled to four (4) weeks' leave on full pay for each twelve (12) months' service.

(b) Leave shall be paid for at the rate of salary the employee is receiving at the time of taking such leave: Provided that any leave accrued for the final year of training shall be paid for at the rate payable for such year of service.

(c) An employee with more than one month's service (and, in the case of a trainee, three (3) months' service) who may resign or be dismissed, except the dismissal is due to misconduct, shall be entitled to pay for holidays *pro rata* up to the time of her leaving the service.

(d) In addition to her salary, the employee on leave shall, where board and lodging allowance is not included in the salary, be entitled to receive such allowance for the period of her leave.

(e) Every employee shall receive at least seven (7) days' previous notice of the commencement of her leave. For the purpose of ascertaining the approximate time of the annual leave, a roster shall be kept in all hospitals of Class "A" and Class "B," giving the necessary information.

(f) Leave shall be given as soon as practicable after falling due. The leave of a trainee shall not accumulate, but shall be given each year. The leave of a nurse shall not accumulate except with the consent of the nurse and in no case shall it accumulate for more than two (2) years.

(g) Notwithstanding anything to the contrary herebefore contained, the nurses whose hours are fixed at thirty-eight (38) per week under Clause 7 (h) shall be entitled only to all public holidays and one fortnight's leave per annum: Provided that in the case of sisters in charge of X-ray and radium clinics, their holidays shall be four (4) weeks per annum in addition to the public holidays.

#### 10.—Long Service Leave.

(i) An employee who has completed ten (10) years' continuous service, reckoned from the date of the coming into operation of this Award, in one hospital or under one employer, shall be entitled to long service leave for three (3) months on full pay, including board and lodging allowance as above, or six (6) months on half pay, plus half the said allowance. Time spent in long service leave or in absence for more than two (2) weeks without pay shall not be considered as part of such seven (7) years' service.

(ii) Any employee who resigns or is retired or dismissed (except for misconduct) and has long service leave due to her, shall receive three (3) months' full pay, plus board and lodging allowance as aforesaid.

(iii) After the completion of the next term of ten (10) years' service, the employee shall be entitled to another long service leave of three (3) months and, similarly, after the next term of seven (7) years, on the same conditions as apply to the first term of long service leave.

(iv) This clause shall not apply when there is in existence a special Agreement for long service leave.

#### 11.—Sick Leave.

(a) Sick leave, with pay, may be granted on the following scale:—

Under three (3) years' service:—One month on full pay and one month on half pay.

Over three (3) years' service:—Two (2) months on full pay.

Provided that all sick leave within the period named herein granted to trainees shall be on full pay.

(b) Sick leave may be granted in one or more periods, but the aggregate amount of leave on pay shall not in any one triennial period exceed the time provided for in the foregoing scale.

(c) A "triennial period" shall be three (3) years preceding the date of application.

#### 12.—Dismissals.

(a) No employee shall be dismissed (except for misconduct), unless she has received fourteen (14) days' previous notice of her dismissal or pay for such period in lieu thereof.

(b) No employee shall, without the consent of her employer, resign without first having given fourteen (14) days' previous notice of her intention so to do.

(c) An employee dismissed for misconduct shall have the right of appeal against such dismissal to an Industrial Magistrate or Police or Resident Magistrate, or such other person as may be agreed upon by her with her employer, and such employee shall be entitled to a written statement as to the reason for her dismissal from her employer, within fourteen (14) days of the said employer's having received a written request for such statement.

(d) This clause shall not apply to casual employees.

#### 13.—Transfer.

(a) An employee who is transferred from one place to another shall be entitled to first-class travelling accommodation between the places of transfer and to full payment of salary during the time of leaving duty and taking up her new duties.

(b) In addition, she shall be entitled to a travelling allowance of five shillings (5s.) per half day. No such allowance as mentioned shall be made for journeys completed between the ordinary meal times. Where practicable, at least fourteen (14) days' previous written notice shall be given to an employee required to transfer from one hospital or place to another.

#### 14.—Engagement.

(a) When a nurse or a trainee is engaged for service in a hospital or place outside the area within a radius of twenty-five (25) miles of the General Post Office, Perth, she shall be entitled to first-class accommodation and travelling allowance as above from the place of engagement to the place of employment.

(b) If an employee is dismissed before the period for which she was engaged has expired, or if none is stipulated, then before the period of six (6) months from the date of her appointment, except in case of dismissal for misconduct, she shall be entitled to first-class accommodation and travelling allowance as above to her place of engagement, should she desire to return there.

(c) Any employee whose duties require her to travel shall be entitled to first-class travelling accommodation, at the expense of her employer.

#### 15.—Trainees.

(a) Every trainee shall be given the opportunity of securing by experience a knowledge of all hospital duties essential to her calling performed in the hospital or hospitals where she is in training.

(b) A trainee shall not be required to undertake ward duty, except under the immediate supervision of a nurse during the first six (6) weeks' service.

(c) Where trainees are given preliminary training before taking up ward duty, the time spent in such preliminary training shall be counted as part of the period of training.

(d) The period of training shall be such as is prescribed in the Regulations issued by the Nurses' Registration Board, or, in the cases of midwifery training, in the Regulations issued under the Health Act.

(e) Any employer taking a trainee on probation shall within fourteen (14) days thereafter register such probationer by giving notice thereof to the Registrar in writing.

(f) Within one month from the end of the period of probation an agreement in writing as required by the Act, shall be executed and signed by the employer, the trainee, and, where the trainee is under twenty-one (21) years of age, the parent or legal guardian of the probationer. There shall be three (3) executed copies of such agreement, of which one copy shall be held by the employer, one by the trainee or her parent or guardian, and one shall be lodged with the Registrar.

(g) Trainees shall be employed for a period of three (3) months on probation; such period shall count as part of the term of service. The period of probation may be extended, with the approval of the Court, but shall not exceed six (6) months in all.

(h) A trainee may be transferred from one employer to another, but notification thereof must be sent to the Registrar within fourteen (14) days of such transfer.

(i) The agreement may be cancelled by mutual consent of the parties, but notification of such cancellation must be forwarded to the Registrar within fourteen (14) days from the date thereof.

(j) The employer, with the consent of the Court, may discharge a trainee from service and cancel the agreement for misconduct or wilful disobedience or any other cause which the Court may deem sufficient.

(k) Lecture times:—Any lectures which occur normally during duty hours shall be computed as part of the working time of the trainees whose duty it is to attend such lectures, and there shall be no reduction in salary in respect thereof.

(l) Trainees who do not pass their final examinations may be retained until such examinations are passed, and during such period they shall be paid at the rate provided for trainees in their final year. But such extended period shall in no case exceed twelve (12) months.

#### 16.—Laundry.

(a) Each employee shall be entitled to all reasonable laundry work, at the expense of the employer.

(b) Each employee shall, on entering upon any employment, supply herself with sufficient uniforms to last her six (6) months. The employer, if she continue in the service, shall supply her with all future uniforms required.

#### 17.—Rosters.

A roster of the working hours shall be exhibited in such place as it may conveniently and readily be seen by each employee concerned. The roster shall be posted not less than forty-eight (48) hours preceding the day on which the roster commences. The roster shall be available to the Union secretary for inspection at all reasonable times. Rosters may be altered at any time if the hospital exigencies render any alteration necessary.

#### 18.—Time and Wages Book.

(a) A Time Book shall be open for inspection at all reasonable times by the Union secretary, or her nominee appointed in writing under the seal of the Union. Each employee must record in such book the exact time on which she starts and finishes duty on each day and also time booked off for meals.

(b) The salary sheets shall, upon reasonable notice being given, be open for inspection at the office of the employer concerned by the Union secretary or her nominee appointed as aforesaid.

(c) Any system of automatic recording by means of a machine shall be deemed a compliance with the provisions of Subclause (a), so far as the particulars actually recorded are concerned.

#### 19.—Interviews.

The Union secretary shall be entitled to interview members of the Union on the employer's premises at reasonable times.

#### 20.—Notices.

If the Union so requests, a copy of this Award shall be posted on a board of reasonable size in a place where it may be conveniently and readily seen by every employee concerned. The Union secretary may also post thereon such other notices relating to Union matters as are reasonable.

#### 21.—Preference.

All other qualifications being equal, preference in matters of employment and promotion shall be given to unionists. This provision shall not apply to the engagement of trainees.

#### 22.—Present Salaries and Privileges.

Subject to method of regulating salaries on the average of occupied beds, nothing herein contained shall entitle an employer to reduce the salary of any employee who at the date of this Award is being paid a higher rate of salary than the minimum prescribed for her class of work.

An employee shall not be deprived of any privileges relating to her employment enjoyed by her at the date hereof, except such as are dealt with in the Award, in which case the Award provisions shall apply.

#### 23.—Relieving.

Any nurse who performs the duties of an employee on a higher classification of salary than herself for a period of more than twenty-eight (28) days continuously shall receive as from the beginning of such period the minimum salary of the higher classification while performing such duties.

#### 24.—Accommodation.

(a) In addition to the salaries (cash) provided herein, all employees shall receive suitable accommodation, board and lodging, or, alternatively, shall be paid per week fifty-two per cent. (52%) of the basic wage for females: Provided, however, that in the case of matrons the value of board and lodging shall be as specified in the Wages Schedule.

(b) The Union secretary or her nominee duly appointed in writing under the seal of the Union shall be entitled to inspect such food and accommodation at reasonable times.

#### 25.—Special Allowances.

In addition to the salaries prescribed herein, special allowances as set out in this paragraph shall be paid:—

#### 27.—King Edward Memorial Hospital.

Notwithstanding anything to the contrary herein contained, the salary of the matron of the King Edward Memorial Hospital shall be the same as the matron in charge of a hospital with two hundred (200) beds or over.

#### 28.—Postponement of Hours.

The clause relating to the hours shall not come into effect until three (3) months after the date of the delivery of this Award, so as to permit the employer to complete the necessary arrangements for the accommodation of the additional staff required.

#### 29.—Emergencies.

In the event of any emergency arising, the Commissioner of Public Health may, with the consent of the Court, or, if the Court is not sitting, with the consent of the President, take such measures as may in his opinion be necessary for the safety and protection or welfare of patients, notwithstanding anything contained in this Award.

#### 30.—Casuals.

A nurse employed for a period of less than two (2) weeks shall be deemed a casual employee, and be paid ten per cent. (10%) over the rates specified in this Award.

#### 31.—Board of Reference.

The Court appoints for the purposes of the Award a Board or Boards of Reference. Each Board shall consist of a Chairman and two (2) other representatives, one to be nominated by each of the parties. There are assigned to each such Board, in the event of no agreement being arrived at between the parties to the Award, the functions of:—

- (i) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of the Award, or any of them;
- (ii) classifying and fixing salaries, rates, and conditions for any occupation or calling not specifically mentioned in the Award;
- (iii) deciding any other matters that the Court may refer to such Board from time to time.
- (iv) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the Regulations to "The Industrial Arbitration Act, 1912-1925," which for this purpose are embodied in this Award.

SILVER CHAIN DISTRICT NURSES' ASSOCIATION (INCORPORATED).

The provisions of this Award, including Clause 48 (Salary Schedule), shall apply to this respondent, subject to the modifications hereunder:—

32.—Hours.

The ordinary working hours of employees of the Association shall not exceed eighty-eight (88) hours per fortnight, to be worked during eleven (11) days in each fortnightly period.

All time worked in excess of the ordinary working time shall be paid for at the following rate, that is to say:—

For the first two (2) hours—Time and a half.  
Thereafter—Double time.

33.—Holidays.

(a) Employees shall be entitled to three (3) weeks' leave of absence on full pay for each twelve (12) months' service, and, in addition thereto, to all public holidays.

(b) Leave shall be paid for at the rate of salary (cash) the employee is receiving at the time of taking such leave.

(c) An employee with more than one month's service, who may resign or be dismissed, except for misconduct, shall be entitled to payment for holidays *pro rata* up to the time of her leaving the service.

(d) An employee called upon to work on a public holiday shall receive a day's holiday in lieu thereof.

34.—Long Service Leave.

(a) An employee who has completed seven (7) years' continuous service, reckoned from the date of the coming into operation of this Award, shall be entitled to long service leave for three (3) months on full pay: Provided, however, that payment for such leave shall not include an allowance for board and lodging.

(b) Time spent in long service leave, or in absence for more than two (2) weeks without pay shall not be considered as part of such seven (7) years of service.

(c) An employee who resigns or is retired or dismissed, except for misconduct, and has long service leave due to her, shall receive three (3) months' full pay without provision for payment in respect of board and lodging as aforesaid: Provided, however, that nothing herein contained shall deprive an employee from long service leave (or payment in lieu thereof) which has actually accrued and is due and owing at the time of dismissal from any cause.

35.—Sick Leave.

An employee shall be entitled to a maximum of two (2) weeks' sick leave in any year of service.

36.—Engagement.

(a) When a nurse is engaged for service in a hospital or place outside the area within a radius of twenty (20) miles of the General Post Office, Perth, she shall be entitled to first-class accommodation and travelling allowance as above from her home to the place of employment.

(b) If such employee remains in such service for the period for which she was engaged, and, if none is stipulated, then for the six (6) months, she shall receive first-class accommodation and allowance as above to return to her home.

(c) If she is dismissed before such time as aforesaid (except for proved misconduct), she shall be entitled to first-class accommodation and travelling allowance as above to return to her home.

(d) Any employee whose duties require her to travel shall be entitled to first-class travelling accommodation at the expense of her employer.

37.—Award not to Affect Present Salaries or Privileges.

Nothing herein contained shall entitle an employer to reduce the salary of any employee who at the date of this Award is being paid a higher rate of salary than the minimum prescribed for her class of work, or to deprive her of any privileges relating to her employment which are enjoyed by her at the date hereof.

38.

INFANT HEALTH ASSOCIATION OF WESTERN AUSTRALIA AND CHILDREN'S PROTECTION SOCIETY (INCORPORATED).

The provisions of this Award shall apply to these respondents, subject to the modifications hereunder:—

39.—Hours.

The ordinary working hours shall not exceed thirty-eight (38) per week, to be worked in not more than five and a half (5½) days per week. In the area comprised within a radius of twenty-five (25) miles from the General Post Office, Perth, and in the Kalgoorlie, Boulder, and Wiluna centres, the hours shall be worked between 9 a.m. and 5 p.m. on Mondays to Fridays, inclusive, and from 9 a.m. to 12 noon on Saturdays.

40.—Holidays.

Employees shall be entitled to two (2) weeks' leave (in addition to the public holidays) on full pay for each twelve (12) months' completed service. In the event of an employee's services being dispensed with, *pro rata* payment for holidays up to the time of leaving shall be made. Provided, however, that an employee who is dismissed for neglect of duty shall not be entitled to such *pro rata* payment. Leave shall not be allowed to accumulate, except with the consent of the nurse, and in no case shall it accumulate for more than two (2) years.

41.—Sick Leave.

After twelve (12) months' service an employee shall be entitled, upon production of a medical certificate, to sick leave at the rate of fourteen (14) days for each twelve (12) months of service, but such leave shall not accumulate from year to year.

42.—Transfers.

Where a registered nurse is engaged for service in a place other than the place where she is living at the time of such engagement, she shall be entitled to first-class travelling accommodation from her home to the place of employment, in order to enter upon such employment. In addition, she shall be entitled to a travelling allowance of five shillings (5s.) per half day of such travelling time. No such allowance as last-mentioned shall be made for journeys completed between ordinary meal times. If the employee remains in the service of the employer for the period for which she was engaged, or if none is stipulated, then for six (6) months she shall receive first-class accommodation and allowance as above to return to her home. If she is dismissed before such time as aforesaid (except for neglect of duty), she shall be entitled to first-class accommodation and travelling allowance as above to return to her home.

Any employee whose duties require her to travel shall be entitled to first-class travelling accommodation, at the expense of her employer.

Notwithstanding the above, any places outside the boundaries of Western Australia will not be taken, for the purpose of this Award, as the home of the employee.

43.—Preference.

All other qualifications being equal, preference in matters of employment shall be given to members of the Union.

44.—Award not to Affect Present Salaries or Privileges.

The provisions of the general Award shall apply, but the wages at present being paid shall be deemed to include a special district allowance.

45.—Salaries.

Nurses engaged shall be paid at the rate of four pounds four shillings (£4 4s.) per week. For the purpose of this Award any amount included in the said sum of four guineas (£4 4s.) per week as and by way of the margin over and above the basic wage shall increase or diminish inversely by the same amount as the basic wage is increased or diminished from time to time.

46.—District Allowances.

In addition to any other allowance due hereunder, and in addition to the salary prescribed, employees employed in the following places shall be paid the following allowances in view of the unpleasant weather, social, or living conditions, and the distance from Perth of the said places:—

## IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

No. 7 of 1935.

Between Western Australian Nurses' Association Industrial Union of Workers, Perth, Applicant, and The Matrons of Avro Private Hospital, Faversham Hospital, and Sister Levitzki, St. Omer and Tressilliau, and others as per Schedule attached, Respondents.

THE Court of Arbitration of Western Australia doth hereby make the following Award in connection with the industrial dispute between the abovenamed parties:—

## AWARD.

## 1.—Scope.

This Award shall apply to all registered nurses, or nurses entitled to be registered, employed in the industry carried on by the respondents to this Award, or who are included in the Award by virtue of Section 83 of "The Industrial Arbitration Act, 1912-1925."

## 2.—Area.

This Award shall have effect throughout the area comprised within a radius of twenty (20) miles from the General Post Office, Perth, excluding that area occupied by the Alexandra Home for Women.

## 3.—Term.

This Award shall be for a period of three (3) years, with the right of any party hereto to apply to the Court for amendment each twelve (12) months.

## 4.—Definitions.

(a) A "registered nurse" is one who is registered under "The Nurses Registration Act, 1921," or "The Health Act, 1911-1933," or entitled to be so registered.

(b) The "Union" shall mean the "Western Australian Nurses' Association Industrial Union of Workers, Perth."

## 5.—Hours.

(a) Fifty-six (56) hours shall constitute a week's work.

(b) Any employee who is not on duty and elects to remain on the employer's premises shall not be paid for such time.

## 6.—Overtime.

Work done by employees in excess of fifty-six (56) hours in any one week shall be paid for at the rate of time and a quarter.

## 7.—Annual Holidays.

Each employee shall be entitled to two (2) weeks' holiday on full pay on completion of each year of service, without any deduction being made for board and/or lodging.

The annual holiday shall be granted within three (3) months of its becoming due.

Provided that any employee who shall have served one month or over, and whose contract shall have been terminated by either party for any cause other than misconduct before the annual holiday became due, shall be entitled to receive a proportionate allowance of holiday pay under this clause.

Holiday pay shall not accrue during the employee's absence from her employment for any cause whatsoever.

## 8.—Payment for Sickness.

An employee shall be entitled to payment for non-attendance, on the ground of personal ill-health, for one half day for each completed month of service: Provided that payment for absence through such ill-health shall be limited to six (6) days in each calendar year. Payment hereunder may be adjusted at the end of each calendar year, or at the time the employee leaves the service of the employer, in the event of the employee being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. This clause shall not apply where the employee is entitled to compensation under the Workers' Compensation Act.

## 9.—Dismissal.

(a) A week's notice of intention to terminate the employment shall be given on either side, except in the case of casual employees.

(b) The employer shall be under no obligation to pay for any day not worked upon which the employee is required to present herself for duty, except such absence from work is due to illness and comes within the provisions of Clause 8, or such absence is on account of holidays to which the employee is entitled under the provisions of this Award.

(c) This clause does not affect the right to dismiss for misconduct, and in such case wages shall be paid up to the time of dismissal only.

## 10.—Laundry.

(a) All employees sleeping in shall have, free of cost, the reasonable use of all laundering facilities, including soap, blue, and other equipments necessary to washing and ironing their clothes.

(b) The practice hitherto existing shall, where it obtains at present, be retained of laundering free of cost of uniforms.

## 11.—Record.

(a) The employer shall keep at her business premises a time and wages record, wherein shall be entered the employee's name, the time she commences and finishes work each day, the total hours worked each day and the wages paid each week.

(b) The employer and the employee shall be jointly responsible for the proper posting of the record.

(c) The salary sheets shall, upon reasonable notice being given, be open for inspection by the Union secretary or her nominee, at the office of the employer concerned.

## 12.—No Reduction—Award not to Affect present Salaries or Privileges.

Nothing herein contained shall entitle an employer to reduce the salary of any employee who at the date of this Award is being paid a higher rate of salary than the minimum prescribed for her class of work, or to deprive her of any privileges relating to her employment which are enjoyed by her at the date hereof.

## 13.—Accommodation.

(a) For all employees where board is provided the employer shall be entitled to deduct thirteen shillings and ninepence (13s. 9d.) per week, and, where lodging is provided, six shillings and one penny (6s. 1d.) per week.

(b) When employees who are paid on a living-out basis are provided with meals by the employer, a deduction shall be made from the wages at the rate of eightpence (8d.) for each meal provided.

(c) Where lodging accommodation is not provided by the employer, she shall provide a suitable change and rest room.

(d) Employees sleeping in shall have access to a properly equipped bathroom.

(e) The Union secretary, or her nominee, shall be entitled to inspect such accommodation at all reasonable times.

(f) In the event of a dispute between the Union and the employer as to the suitability of the accommodation provided for the staff, the matter shall be referred to the Board of Reference for decision.

#### 14.—Special Allowances.

(a) Where the employee is required by the employer to use more than one certificate, she shall be entitled to receive extra payment, at the rate of three shillings and tenpence (3s. 10d.) per week, during the time she is so required. Minimum payment, three shillings and tenpence (3s. 10d.)

(b) Where an employee is required to work night duty for a longer period than three (3) continuous months, she shall be entitled to receive an extra payment of three shillings and tenpence (3s. 10d.) per week during the whole of the period she is so employed.

#### 15.—Payment of Salaries.

Salaries shall be paid at least twice per calendar month.

#### 16.—Salaries.

The minimum salary per week payable to employees shall be as follows:—

#### 17.—Weekly Holiday.

All employees shall be entitled to and shall receive a full day or two half days off a week, to suit the convenience of the employer. When the half days are taken, each half day shall be considered as commencing from or ending at the mid-day meal hour.

#### 18.—Board of Reference.

The Court appoints, for the purposes of the Award, a Board or Boards of Reference. Each Board shall consist of a Chairman and two (2) other representatives, one to be nominated by each of the parties. There are assigned to each such Board, in the event of no agreement being arrived at between the parties to the Award, the functions of:—

- (i) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of the Award, or any of them;
- (ii) classifying and fixing salaries, rates, and conditions for any occupation or calling not specifically mentioned in the Award;
- (iii) deciding any other matters that the Court may refer to such Board from time to time;
- (iv) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the Regulations to "The Industrial Arbitration Act, 1912-1925," which for this purpose are embodied in this Award.

#### IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

No. 18 of 1934.

Between Hospital Employees' Industrial Union of Workers, W.A. Coastal Branch, Applicant, and St. John of God's Hospital, Waverley Hospital, Grosvenor Hospital, Sister Levitzki, M.C.L. Convalescent Home, and others whose names are appended in the Schedule attached hereto, Respondents.

THE Court of Arbitration of Western Australia doth hereby make the following Award in connection with the industrial dispute between the abovenamed parties:—

#### AWARD.

##### 1.—Scope.

This Award shall apply to all hospitals and workers employed therein (other than hospitals and employees already covered by industrial Awards or Agreements) performing work for the public and where patients are received for medical, surgical observation, rest, or other treatment or care.

##### 2.—Area.

This Award shall have effect over the area comprised within a radius of twenty (20) miles from the General Post Office, Perth.

##### 3.—Term.

The term of this Award shall be for a period of three (3) years from the date hereof.

##### 4.—Definition.

"Adult," for the purpose of this Award, shall mean a worker of either sex over the age of twenty-one (21) years.

##### 5.—Hours of Duty.

(a) Forty-eight (48) hours per week, exclusive of meal times, shall constitute a week's work.

(b) All workers, except casual workers, shall be entitled to and shall receive a full day or two half days off in each week, to suit the convenience of the employer's business. When two half days are taken, each half day shall commence or end at 1 p.m., which shall include the worker's interval for mid-day meal.

(c) Any worker who is not on duty and elects to remain on the employer's premises shall not be paid for such time.

##### 6.—Overtime.

Work done in excess of forty-eight (48) hours in any one week shall be paid for at the rate of time and a quarter for the first four (4) hours and time and a half thereafter.

##### 7.—Roster.

(a) A roster of the working hours shall be exhibited in each hospital, in such a place or places as it may be conveniently and readily seen by each worker concerned.

(b) Such roster shall denote the hours to be worked by each worker, and shall be open for inspection by a duly accredited representative of the Union, at such time as the record is so open for inspection.

(c) Such roster shall be drawn up in such a manner as to show the hours of each worker for at least one week in advance of the date of the roster. It may be altered in the case of sickness or absence from work, or of any contingency that the employer cannot reasonably foresee.

##### 8.—Record.

(a) The employer shall keep or cause to be kept on the premises a Time and Wages Book, where there shall be entered the name, occupation, and, in the case of junior workers, the age on his or her last birthday; the time the worker commences and finishes work each day; the total hours worked each day and the wages paid to each worker.

(b) The record shall be entered up at least once a week.



(c) The employer and the worker shall be jointly and severally responsible for the proper entering of the record, which shall be initialed, if correct, by the worker.

(d) The record shall be open to inspection by the secretary of the Union, on the premises of the employer, upon reasonable notice being given by the said secretary.

9.—Holidays.

(a) Each worker shall be entitled to two (2) weeks' holiday on full pay on completion of each year of service, without any deduction being made for board and/or lodging.

(b) The annual holiday shall be granted within three (3) months of its becoming due.

(c) Provided, however, that any worker who shall have served one month or over, and whose contract of service shall have been terminated by either party for any cause other than misconduct before the annual holiday became due, shall be entitled to receive a proportionate allowance of holiday pay under this clause.

(d) Holiday pay shall not accrue during the worker's absence from his or her employment for any cause whatever.

(e) This clause does not apply to casual workers.

10.—Sick Leave.

(a) A worker shall be entitled to leave of absence with pay, on the ground of personal ill-health, for one day for each completed month of service, if the employer is not obliged to and does not employ and pay a substitute to perform the duties of such worker or other duties, owing to a re-arrangement of the worker's duties on account of such absence, but in any event the employer shall be liable to pay the worker absent as aforesaid for one half day for each completed month of service, such payment to be limited to six (6) days in each calendar year.

(b) Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(c) The foregoing paragraphs of this clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(d) If the absence exceeds one week, the employment shall be deemed to have terminated after the expiration of the first week's absence.

(h) When adult workers and junior male workers who are paid on a living-out basis are provided with meals by the employer, a deduction may be made from the wage at the rate of eightpence (8d.) for each meal provided.

(i) If, as a result of a mutual agreement between an employer and a junior female worker, such worker does not lodge with the employer, then such worker shall be entitled to receive the amount provided in Subclause (g) of this clause as a deduction for lodging adult females, namely, six shillings and one penny (6s. 1d.), in addition to the junior rates as prescribed by Subclause (d) of this clause.

12.—Payment of Wages.

Wages shall be paid at least weekly.

13.—Dressing Room.

Where lodging accommodation is not provided by the employer a suitable change-room shall be provided for each sex.

14.—Casual Workers.

All persons engaged for a period of less than six (6) days in any one week shall be paid at the rate of ten per cent. (10%), in addition to payment at the rates hereinbefore prescribed, with a minimum engagement of one half day: Provided that this shall not apply in the case of a worker summarily dismissed for misconduct.

15.—No Reduction.

Nothing contained in this Award shall operate to reduce the wage of any worker who at the time of the Award is being paid a higher rate of wage than the minimum prescribed for his or her class of work.

16.—General Clauses.

(a) All washing of clothing forming part of a uniform shall be provided free of cost to the worker.

(b) A worker who is required to do work which carries a higher rate in this Award than that which such worker usually performs shall be entitled to the higher rate whilst so employed.

(c) When a worker is entitled to annual leave under this Award, such worker shall be given at least seven (7) days' notice of the date when such leave is to commence.

(d) A copy of this Award shall be kept in a convenient place at the employer's premises.

(e) Overtime rates shall be calculated and based on the aggregate wage, that is, the amount paid in cash, plus the deduction for board and/or lodging.

17.—Contract of Service.

(a) The contract of service shall be by the week and shall be terminable by one week's notice on either side, except in the case of a casual worker.

(b) The employer shall be under no obligation to pay for any day not worked upon which the worker is required to present himself for duty, except such absence from work is due to illness and comes within the provisions of Clause 10 (Sick Leave), or such absence is on account of holidays to which the worker is entitled under the provisions of this Award.

(c) This clause does not affect the right to dismiss for misconduct, and in such case wages shall be paid up to the time of dismissal only.

#### 18.—Under-rate Workers.

Any worker who by reason of old age or infirmity is unable to earn the minimum rate prescribed by this Award, may be paid such lesser rate as may from time to time be agreed upon in writing between the employer and the secretary of the Union, or failing such agreement within twenty-four (24) hours after such worker shall have applied in writing to the secretary of the Union, stating his desire that such wage should be agreed upon, such wage as shall be fixed by the most convenient Resident or Police Magistrate upon the application of such worker after twenty-four (24) hours' notice in writing shall have been given by him to the said secretary who shall, if he so desires, be heard by the Magistrate upon such application. After having given notice to the secretary, and after lodging the application mentioned, and pending the Magistrate's decision thereon, the worker shall be entitled to work for and be employed at the proposed lesser rate. The determination of the Magistrate shall have effect for the period of six (6) calendar months from the date thereof and after the expiration of the said period until the wage shall have again been fixed at the instance of the said secretary in the manner prescribed. The secretary of the Union may by writing under his hand appoint an agent or substitute to represent the Union at the hearing of the application before the Magistrate.

#### 19.—Junior Worker's Certificate.

Junior workers, upon being engaged, shall, if required, furnish the employer with a certificate or statement containing the following particulars:—

- (i) Name in full.
- (ii) Age and date of birth.
- (iii) Length of service with each previous employer.

No worker shall have any claim upon an employer for additional pay in the event of the age or length of service or class of work of the worker being wrongly stated on the certificate, nor shall the employer in such case be deemed guilty of a breach of any of the provisions of the Award founded upon the particulars specified therein, except in case of collusion.

#### 20.—Board of Reference.

The Court appoints for the purposes of the Award a Board or Boards of Reference. Each Board shall consist of a Chairman and two (2) other representatives, one to be nominated by each of the parties. There are assigned to each such Board, in the event of no agreement being arrived at between the parties to the Award, the functions of:—

- (i) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of the Award, or any of them;
- (ii) classifying and fixing wages, rates, and conditions for any occupation or calling not specifically mentioned in the Award;
- (iii) deciding any other matter that the Court may refer to such Board from time to time;
- (iv) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the Regulations to "The Industrial Arbitration Act, 1912-1925," which for this purpose are embodied in this Award.

hours per fortnight, to be worked in five (5) consecutive shifts of eight (8) hours each in one week and six (6) consecutive shifts of eight (8) hours each in the following week, and so on from week to week: Provided that, until otherwise ordered, locomotive drivers and locomotive driver's firemen shall be allowed and paid for thirty (30) minutes for preparing the engine, and thirty (30) minutes for stabling same; and the guard shall be allowed a similar time for duties connected with his train at the beginning and end of his shift.

- (ii) The time allowed herein for preparing and stabling, and the guard's time for duties at the beginning and end of his shift, are open to revision at any time, but may be agreed upon by the parties and, if no agreement is arrived at, will be determined by the Court upon the hearing of further evidence, at a date to be subsequently fixed.

(b) Overtime:

For all work performed beyond the hours of duty on any shift, the worker shall be paid at the rate of time and a quarter for the first four (4) hours and at the rate of time and a half thereafter.

Clause 13—Guarantee of employment:

Omit the words "forty-eight" and insert the words "forty-four" in lieu thereof.
