PROCLAMATION

WHEREAS by Section 9 of "The Fisheries Act, 1905-21," it is provided that the Governor may by Proclamation prohibit all persons from taking any fish whatsoever, in every or any specified portion of Western Australian waters, by means of fishing nets and fishing lines, or either of such means of capture, or by any other specified means of capture, for any specified term: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do, in exercise of the powers aforesaid and of every other power enabling me in this behalf, by this Proclamation prohibit all persons from taking any fish whatsoever by means of sunk nets, namely, any nets the ground line of which are moved along the bottom and the cork lines of which are submerged during the process of hauling, in any portion of the Western Australian waters defined in the Schedule hereto as from the date of the publication of this Proclamation in the *Government Gazette*.

Schedule.

(a) The Swan River: The whole; and (b) The Canning River: The whole.

WHEREAS by "The Factories and Shops Act, 1920," it is enacted that the Governor may by Proclamation temporarily suspend the operations of the said Act, in so far as it applies to the closing time fixed or appointed for any shop or shops: And whereas it is expedient to exercise such power in manner hereinafter appearing: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do hereby by this Proclamation suspend the operations of the said Act between the hours of six o'clock and nine o'clock in the evening of Mon-

day, Tuesday, Wednesday, Thursday, and Friday in every week during the period commencing on the first day of January, 1936, and ending on the Thirty-first day of December, 1936, in so far as it applies to the closing time of shops conducted in open markets which are kept open for the conduct of business therein between the times aforesaid and on the days aforesaid, and in which shops home-made jams and preserves, honey, butter (other than factory butter), and eggs, hams and bacon, not being factory hams or bacon, are sold or offered for sale; provided that only the said goods shall be sold or offered for sale between the said times by virtue of this Proclamation, and the said shops shall not be kept open for the sale or offering for sale of any other goods which cannot otherwise be lawfully sold or offered for sale between the times aforesaid.

ZOOLOGICAL AND ACCLIMATISATION GARDENS,
SOUTH PERTH.

By-laws.

Premier's Department,
Perth.

IT is hereby notified, for public information, that His Excellency the Lieutenant-Governor has been pleased to approve of the following By-laws for the control of the Zoological and Acclimatisation Gardens, South Perth, and that part of Reserve No. A1022 comprised in Perth Lot 699, at South Perth.

Definitions.

1. "Animal," unless context otherwise requires, shall include animal, bird, reptile and/or fish.
2. "Cage" shall mean and include any and every building, cage, enclosure, pound, yard or other means whatever by which animals, birds, reptiles or fish are enclosed or housed.
3. "Committee" means the Committee of the Zoological and Acclimatisation Gardens, or the President thereof.
4. "Gardens" mean the Zoological and Acclimatisation Gardens situated at South Perth.
5. "Permission" shall mean the permission of the Committee first obtained and expressed in writing.

Entry.

1. No person shall enter the Gardens by any manner other than through the entrance gates rightfully opened by an authorised person, and after the payment of the prescribed fee, nor remain in the Gardens after the gates have been closed, nor be, nor remain in any portion of the Gardens which may be closed to the public for the time being.

Vehicles.

2. No person shall, without permission, bring any vehicle into the Gardens.

Domestic Animals.

3. No person shall bring into, nor permit to enter the Gardens, any dog, cat, or other animal. Any such animal found within the Gardens may be destroyed by any servant of the Committee, without compensation to the owner.

Cages and Enclosures.

4. No person shall enter any space set apart for the use of keepers or workmen, or railed off around or about any cage, nor interfere with any lock attached to any part of any cage; nor open, move or otherwise interfere with any gate, slide, or grating attached to or associated with any cage.

No person, except workmen employed in the Gardens, shall enter any place enclosed for trees, shrubs, plants, or flowers, nor step or walk upon, or jump across any plot or bed which may be set apart for trees, shrubs, plants, or flowers.

Disturbing Animals.

5. No person shall tease or disturb any animal, nor throw, or attempt to throw stones, sticks, or other injurious substances into any cage, nor give to animals food of an unsuitable kind.

Damaging Growth.

6. No person shall injure cut, break, deface, pull, pick, remove, or destroy any tree, shrub, plant, flower, or grass, or remove or damage stakes or labels therein, nor hang, nor attach clothing or any articles thereto.

Soil, Fences, and Grass.

7. No person shall cut up, damage, disfigure, or interfere with the soil, turf, or surface of any part of the Gardens, or the roads or footways across, around, or over the same, or any part of the fences, cages, buildings, electrical equipment, rockwork, watercocks, or seats around or upon the same, nor pollute or interfere with any ornamental water therein, nor climb on or over any external or internal fence.

Rubbish.

8. No person shall deposit or leave any rubbish, refuse, paper, broken glass, china, or litter of any kind whatsoever within the Gardens, except in the receptacles provided, nor break bottles, china, or other similar substances therein.

Behaviour.

9. No person shall misconduct himself, or indulge in any disorderly, riotous, or indecent conduct, or use any indecent or improper language, or offend against decency as regards dress.

Intoxicating Liquor.

10. No person shall bring into, or consume within the Gardens any intoxicating liquor, nor enter thereon when visibly under the influence of liquor.

Expectoration.

11. No person shall spit or expectorate upon any path, grass, structure, or erection.

Bill Sticking.

12. No person shall post, stick, stamp, stencil, paint, or otherwise affix, distribute or give out any placard, handbill notice, advertisement, or any document whatsoever upon any tree, fence, post, gate, wall, flagging, road, path, or any place whatever in or about the Gardens, and no person shall cause to be done any of the acts herein prohibited.

Fires and Shooting.

13. No person or persons shall carry or discharge any firearms, or throw or discharge any stone or other missile, or set off any fire balloon, or throw or set fire to any fireworks, or kindle or make any fire on any portion of the Gardens.

Trading.

14. No person shall, without permission, sell or expose for sale any goods, wares, refreshments, fruits, nuts, confectionery, fish or other merchandise or things.

Sports and Performances.

15. No person shall, without permission, play, practise, or indulge in any game, sport or gymnastic exercise, or take part in any instrumental or vocal performance, or engage in public speaking of any kind.

Children.

16. No child under ten years of age shall be allowed in the Gardens unless in charge of an adult person.

Smoking.

17. Smoking may be prohibited within the Gardens, or any portion thereof, at such times as it may seem to the Committee necessary for the safety of the Gardens and the property therein. At such times a notice to this effect will be displayed at the entrances.

Obstructing Visitors or Employees.

18. No person shall in any part of the Gardens wilfully obstruct, disturb, interrupt, or annoy any other person in the proper use or enjoyment of the Gardens, nor wilfully obstruct in the execution of his duty or insult or neglect to obey the lawful directions of, or refuse or neglect to give his correct name and address to any member of the Committee or any of its employees.

Charges.

19. The charge for admission to the Gardens on all ordinary occasions shall be as follows:—

Adults	6d.
Children under 12 years of age	3d.
Children under 3 years of age	free.

Provided that the Committee shall have power to arrange lower rates for large parties and on such special occasions as in their opinion are warranted a higher charge may be made.

Train and Animal Rides.

20. No person shall attempt to ride on an animal not then under the care of an employee of the Committee for the purpose of public riding nor take a seat or attempt to ride on an animal, conveyance, or miniature railway without having first purchased and being in possession of a proper ticket and yielding up that ticket to the employee when demanded.

Lost Property.

21. All property of every description apparently lost or abandoned must be handed by the finder to the Superintendent or gatekeeper or person in charge of the Gardens for the time being, to be returned by him to the owner on satisfactory proof of ownership, or disposed of as directed by the Committee, if unclaimed.

Penalties.

Any person offending against the provisions of these By-laws shall be liable on conviction to a penalty not exceeding £20, in addition to being immediately removed from the Gardens.

Timber and Firewood.

3a. No person shall cut or remove any tree or sapling, or any part thereof, either living or dead, for any purpose whatever without permission.

Fires and Matches.

14a. No fires shall be lighted, except in places approved by the Board, and no person shall kindle a fire in any place whatever without first clearing a sufficient surrounding area to afford reasonable protection from the danger of igniting the bush.

No person, having kindled or made use of a fire, shall leave it burning, but shall effectively extinguish it.

No person using a lighted match in any portion of the Reserve shall throw away the same without first making sure it is effectively extinguished.

Boundaries.

25a. In any prosecution under these By-laws it shall not be necessary for the Board or its officers to prove the boundaries of the Reserve, but at the hearing of the complaint the averment contained in the complaint that the offence was committed within the boundaries of this Reserve shall be deemed to be proved in the absence of proof to the contrary.

PARKS AND RESERVES ACT, 1895.

By-laws for the Control of Reserve "A"4813, Point Walter.

The term "Board" in these By-laws shall mean the Board appointed under the provisions of "The Parks and Reserves Act, 1895," to control this Reserve.

"Permission" shall mean the permission of the Board first obtained and expressed in writing.

Control of Vehicles.

1. No person shall drive, ride, convey, or impel any motor car, motor cycle, bicycle, carriage, cart, aeroplane, or other vehicle within this Reserve except upon a declared public highway or road.

Class of Vehicles.

2. No passenger vehicle plying as an omnibus, or which plies for hire, nor any vehicle, team, cart, or wagon used for carrying any goods, bricks, stone, wood, iron, or merchandise of any kind (whether laden or not), nor any hearse, mourning coach, camel, packhorse, or other beast of burden shall enter or pass through this Reserve.

Damaging Growth.

3. No person shall injure, cut, break, deface, pull up, pick, remove, or destroy any tree, shrub, plant, flower, or grass growing on the Reserve, or remove or damage stakes or labels therein, nor hang, nor attach clothing or other articles thereto.

Soil, Fences, and Grass.

4. No person shall cut up, damage, disfigure, or interfere with the soil, turf, or surface of any part of the Reserve, or the roads or footways across, around, or over the same, or with any part of the fences, buildings, electrical equipment, rockwork, watercocks, or seats around or upon the same, or pollute or interfere with

any ornamental water therein, or interfere with or destroy any birds, animals, or fish therein in any manner whatsoever.

Rubbish.

5. No person shall deposit or leave any rubbish, refuse, paper, broken glass, china, or litter of any kind whatsoever within the Reserve except in the receptacles provided, nor break bottles, china, or other similar substances therein.

Behaviour.

6. No person shall misconduct himself or indulge in any riotous or indecent conduct, or use any indecent or improper language, or offend against decency as regards dress on the Reserve.

Intoxicating Liquor.

7. No person shall bring into or consume within the Reserve any intoxicating liquor, nor enter thereon when visibly under the influence of liquor.

Expectoration.

8. No person shall spit or expectorate upon any path, grass, structure, or erection in this Reserve.

Camping.

9. No person shall camp, lodge, or tarry overnight, or frequent the Reserve for the purpose of camping, lodging, or tarrying overnight, nor lie or sleep during the day on the Reserve.

Seats for Ladies.

10. No man shall occupy a seat which is set apart for the use of ladies.

Bill Sticking.

11. No person shall post, stick, stamp, stencil, paint, or otherwise affix, distribute, or give out any placard, handbill, notice, advertisement, or any document whatsoever upon any tree, fence, post, gate, wall, flagging, road, path, or any place whatever on the Reserve, and no person shall cause to be done any of the acts herein prohibited.

Fires and Shooting.

12. No person or persons shall carry or discharge any firearms, or throw or discharge any stone or other missile, or set off any fire balloon, or throw or set fire to any fireworks, or kindle or make any fire on any portion of the Reserve without permission.

Trading.

13. No person shall, without permission, sell or expose for sale any goods, wares, refreshments, fruits, nuts, confectionery, fish or other merchandise or things or solicit or offer to purchase bottles on any portion of the Reserve.

Games and Animals.

14. No person shall, upon the said Reserve without permission, play, practise, or indulge in any game, sport, or gymnastic exercise, or exercise horses, dogs, or other animals for racing.

Straying Stock.

15. No person shall cause, allow, or suffer any horse, cattle, sheep, dog, goat, camel, donkey, mule, pig, or other animal, or fowl or other bird to enter, stray or feed upon the said Reserve without permission, nor cause, allow, or suffer any dog to enter any swimming area, nor throw sticks or other missiles therein.

Meetings.

16. No person shall organise, arrange, advertise, or take part in any fete, picnic, or concert, or engage in public worship, preaching, or public speaking of any kind, or any meeting of like character on the Reserve without permission.

Betting.

17. No person shall bet or offer to bet publicly on any part of the Reserve.

Trespass.

18. No person, except workmen employed in the Reserve, shall enter any place enclosed for trees, flowers, or shrubs, or plantations of young trees, nor step, nor walk upon, or jump across any plot therein which may be set apart for shrubs, plants, or flowers.

Obstructing Employees.

19. No person shall in any part of the Reserve wilfully obstruct, disturb, interrupt, or annoy any other person in the proper use or enjoyment of the gardens, or wilfully obstruct in the execution of his duty, or insult, or neglect to obey the lawful directions of, or refuse or neglect to give his name and address, or give a wrong name or address, to any officer, gardener, keeper, labourer, workman, or other person employed in any connection therewith.

Sails.

20. No person shall spread or dry sails or other similar material upon the Reserve.

Traffic.

21. The traffic requirements in force for the time being under "The Traffic Act, 1919," and its amendments, shall be observed upon the said Reserve, but always with the limitation that no person shall at any time drive, ride, or impel any carriage, motor car, motor cycle, bicycle, tricycle, or other vehicle at a speed exceeding 12 miles an hour.

Mooring Boats.

22. No boat shall be moored or anchored, or kept or left moored or anchored or unattended opposite or near any part of the beach which may be set aside from time to time, unless such boat is and remains at least one chain below low water mark, except as hereinafter provided.

Landing Passengers.

23. If it is necessary to bring any boat nearer to the said beach than is mentioned in the preceding regulation, for the purpose of passengers or any of the crew embarking or disembarking, the purpose shall be effected as speedily as possible, and the boat shall then be immediately removed to and kept at a distance of at least one chain below low water mark.

Beaching Boats.

24. No person shall beach a boat upon the Reserve at any place other than that set apart for the purpose, and no boat thus beached shall be moved, handled, or interfered with in any way by any unauthorised person, but the Board or its employees, at the discretion of the Board, may remove or require the owner to remove at any time any boat wherever placed. The Board shall not accept any responsibility for the care of nor liability for damage to any boat wherever beached.

Destruction of Abandoned Boats.

25. Any boat which may be beached at a place not set apart for the purpose, or which may be drifting, or sunk, or in the opinion of the Board or its employees, has been abandoned, may be taken into the possession of the Board and/or removed to such place as it may think fit, and forthwith sold or otherwise disposed of at the discretion of the Board, without redress to the owner for any loss or inconvenience to which he may be subjected thereby.

Swimming Area.

26. Notwithstanding the provisions of any other By-law, areas may be set apart for bathing and swimming, and no boat of any description shall be permitted to enter or remain in such area. Such areas may be defined from time to time by the placing of posts at intervals along the river side of such area and the posting of a notice indicating the purpose of the area thus set apart.

Permits for Camping.

27. Notwithstanding the provisions of By-law No. 9, camping may be permitted in areas set apart for the purpose, but not elsewhere, at this Reserve, upon the issue of a permit from the Camp Controller, and subject to the following conditions:—

- (a) For the purposes of this By-law the term "Camp Controller" shall mean the person appointed by the Board from time to time to control and supervise the Camping Areas, and shall particularly apply to the Caretaker of this Reserve.

- (b) The permit will indicate the site to be occupied, and the Controller's decision in any dispute shall be final.

Fees are payable prior to the issue of permits, on the scale of 5s. per week or part thereof.

Extensions of the permit may be secured upon the payment of a further fee upon the above scale.

- (c) No person shall sub-let any camp, or sell, give, or otherwise dispose of any permit to any person.
- (d) Except by the permission of the Camp Controller, no person shall bring into or keep within the camping area any animals or birds whatever.
- (e) No person shall misconduct himself or indulge in any riotous or indecent conduct, or use any indecent or improper language, or offend against decency as regards dress in the Camping Area.
- (f) No person shall bring into or keep or consume in the Camping Area any intoxicating liquor, nor enter, nor remain thereon when visibly under the influence of liquor.
- (g) Campers must keep the area, covered by their permit, in a clean and sanitary condition at all times. All rubbish capable of destruction by fire shall be burned by the occupier in the approved fireplace.
- (h) All campers must use the sanitary conveniences provided, and in no circumstances will improvised conveniences or individual camping sites be permitted.
- (i) No person shall cause or permit any damage to trees, shrubs, or grass, whether naturally or artificially planted within or surrounding the Camping Area. The presence of green timber or foliage on the area covered by any camping permit shall be prima facie evidence that the holder of the permit has caused or permitted damage, unless the permit holder has pointed out the damage before taking over the camping site.
- (j) Camping permits may at any time be withdrawn by the Camp Controller, if in his opinion a breach of these By-laws has been committed, or if, in his opinion, it is desirable that the permit shall be terminated. In the event of termination hereunder, the rental paid shall be forfeited to the Board, and no compensation shall be claimed or paid for loss, damage, or inconvenience suffered through the withdrawal of the permit.
- (k) Subject to the right of the Camp Controller, and the officers and employees of the Board, or any person acting under their instructions, or any Police Constable, to enter any camping site at any time, no person shall enter into or remain within such camping site except with the permission of the holder of the permit.
- (l) No fires shall be lighted on any Camping Area, except in places approved by the Camp Controller.
- (m) Except so far as they may be inconsistent with this By-law, the whole of the By-laws now or hereafter made by the Executive Council to apply to areas under control of the Board shall apply to Camping Areas.

Penalty.

28. Any person offending against any of the provisions of these By-laws shall be liable, on conviction, to a penalty not exceeding £20, in addition to being immediately removed from the Reserve.

PARKS AND RESERVES ACT, 1895.

HIS Excellency the Governor in Executive Council has been pleased to approve, under the provisions of "The Parks and Reserves Act, 1895," of the following By-laws for the Control and Management of Reserve No. 17060, Recreation and purposes incidental thereto:—

The term "Board" in these By-laws shall mean the Board appointed under the provisions of "The Parks and Reserves Act, 1895," to control this Reserve.

The term "Reserve" shall mean and include the whole of the area above enumerated, known as Keane's Point. "Permission" shall mean the permission of the Board first obtained and expressed in writing.

Control of Vehicles.

1. No person shall drive, ride, convey, or impel any motor car, motor cycle, bicycle, carriage, cart, boat, aeroplane, or other vehicle within the Reserve except upon a declared public highway or road.

Class of Vehicles.

2. No passenger vehicle plying as an omnibus, or which plies for hire, nor any vehicle, team, cart, or wagon used for carrying any goods, bricks, stone, wood, iron or merchandise of any kind (whether laden or not), nor any hearse, mourning coach, camel, packhorse, or other beast of burden shall enter or pass through the Reserve, except for the service of the lessee and at his request.

Damaging Growth.

3. No person shall injure, cut, break, deface, pull up, pick, remove, or destroy any tree, shrub, plant, flower, or grass growing on the Reserve, or remove or damage stakes or labels therein, nor hang, nor attach clothing or other articles thereto.

Soil, Fences, and Grass.

4. No person shall cut up, damage, disfigure, or interfere with the soil, turf, or surface of any part of the Reserve, or the roads or footways across, around, or over the same, or with any part of the fences, buildings, electrical equipment, rockwork, watercocks, or seats around or upon the same, or pollute or interfere with any ornamental water therein, or interfere with or destroy any birds, animals, or fish therein in any manner whatsoever.

Rubbish.

Meetings.

16. No person shall organise, arrange, advertise, or take part in any fete, picnic, or concert, or engage in public worship, preaching, or public speaking of any kind, or any meeting of like character on the Reserve without permission.

Betting.

17. No person shall bet or offer to bet publicly on any part of the Reserve.

Times of Opening.

18. The Reserve shall be open to the public from 8 a.m. to sunset, free of charge, except during entertainments or on other special occasions, when, permission being first obtained, an admission fee not exceeding 1s. may be charged.

Improper Entry.

19. No person shall be nor remain in the Reserve after the gates have been closed, nor be nor remain in any portion of the Reserve which may be closed to the public for the time being, or enter the Reserve by any manner than through the gates rightfully opened by an authorised person, nor shall climb or jump over or through the gates or fences in or around the Reserve.

Trespass.

20. No person, except workmen employed in the Reserve, shall enter any place enclosed for trees, flowers, or shrubs, or plantations of young trees, nor step, or walk upon, or jump across any plot therein which may be set apart for shrubs, plants or flowers.

Obstructing Employees.

21. No person shall in any part of the Reserve fully obstruct, disturb, interrupt, or annoy any other person in the proper use or enjoyment of the Reserve, or wilfully obstruct in the execution of his duty, or insult, or neglect to obey the lawful directions of, or refuse or neglect to give his name and address to any officer, inspector, gardener, keeper, labourer, workman, or other person employed in connection therewith.

Sails.

22. No person shall spread or dry sails or other similar material upon the Reserve.

Beaching Boats.

23. No person shall beach a boat upon the Reserve at any place other than that set apart for the purpose; and no boat thus beached shall be moved, handled, or interfered with in any way by any unauthorised person, but the Board, or its employees, at the discretion of the Board, may remove or require the owner to remove at

any time any boat wherever placed. The Board shall not accept any responsibility for the care of nor liability for damage to any boat wherever beached.

Destruction of Abandoned Boats.

24. Any boat which may be beached at a place not set apart for the purpose, or which may be drifting, or sunk, or in the opinion of the Board or its employees has been abandoned, may be taken into the possession of the Board and/or removed to such place as it may think fit, and forthwith sold or otherwise disposed of at the discretion of the Board, without redress to the owner for any loss or inconvenience to which he may be subjected thereby.

Penalty.

25. Any person offending against any of the provisions of these By-laws shall be liable on conviction to a penalty not exceeding £20, in addition to being immediately removed from the Reserve.

1. In the construction of these By-laws, subject to the context:—"Board" shall mean the Greenbushes Road Board.

2. No person shall hawk any fish, meat, fruit, vegetables, or any article of merchandise within any part of the Board's District without having first obtained a license from the Board.

3. Any person who trades or travels on foot or with any vehicle or animal, or carries to sell or expose for sale or offer for sale within the Board's District, any of the articles or things above-mentioned, shall be deemed to hawk same:

Provided that nothing contained in this section shall apply to any person or persons paying rates, or liable to pay rates for any shop or store carrying on the usual business, trade, and delivery trade or delivery of goods therefrom, or any ratepayer of the District.

4. A Hawker's License shall be in the Form No. 1 in Schedule A attached hereto.

5. The fee to be paid for licenses issued to hawkers shall be as set forth in Schedule B attached hereto.

6. Every application for a Hawker's License shall be made during the currency of the financial year in which the license is to have effect; and every such license shall have effect for and during that year, or the unexpired portion thereof, and no longer.

7. Every hawker, whilst employed in hawking, must produce his license, upon being required to do so by any police officer or officer of the Board.

8. No person to whom a Hawker's License shall have been granted shall lend, transfer, or assign his license, and no person shall borrow or make use of such license granted to a person other than himself.

9. Every person who does, permits, or suffers any act, matter, or thing contrary to any of these By-laws, or commits or permits any breach or neglect thereof, shall be liable to a penalty not exceeding £10 for every conviction.

Work No. 1.

Development and Construction, Melville Highway.

The whole of the frontages on the northern side of Gibson street from Ardross street to Glenelg street.

(c) The whole of the area described as Industrial Area in this Scheme.

The Shopping Area may include any of the following uses:—

- (a) Any of the uses permitted in a Residential Area.
- (b) The following:—
 1. Theatre, hall, club, or place of amusement.
 2. Office, bank or hotel.
 3. Fire station, police station, post office or public building.
 4. Shops, salesroom or showroom for the conduct of retail or wholesale business.
 5. Workrooms connected with retail business, in which not more than 50 per cent. of the total floor area is devoted to workrooms.
 6. Garage, or petrol-selling or service station.
 7. Such other accessories as the authority might determine, but shall not include any industry, trade, or manufactory.

Residential Areas.

Regulation.

(a) All lots or land within the Road Board District not included in the Industrial or Shopping Areas may be used for residential purposes.

Provided not more than one dwelling is erected on an area of 6,000 square feet or under. Provided also that, where a subdivision or separate title has existed prior

to the gazettal of the Scheme for lots of less than 6,000 square feet, the Road Board may permit the erection of single family dwellings, subject to Health and Building By-laws, and subject to any regulations under the Scheme.

(b) Churches, public buildings, or other institutional buildings may be erected in the Residential Area with the approval of the Board.

(c) No residential lot shall be built on to cover more than one-third of the area of such lot.

(d) No lot shall be built on where such land is below the seven feet contour as defined on the plan, unless:—

1. The land is drained to the satisfaction of the Road Board, and/or
2. The land is built up to the level of the crown of the road (whether existing or to be built) on which the lot fronts.

Objections or recommendations concerning the foregoing will be received at the Office of the Town Planning Board up to the 30th November, 1935, and the plan of the proposed works may be inspected between the hours of 10 a.m. and 3 p.m.

IN accordance with Section 63 of "The Mines Regulation Act, 1906," His Excellency the Lieutenant-Governor in Executive Council has been pleased to make the following Regulation.

17a.—Certificates for Underground Supervisors.

1. Every person employed or acting as an underground supervisor in the capacity of an underground manager, foreman, or shift boss whose duty it is to exercise some control and supervision over twelve or more underground employees in any mine shall—

- (a) have been employed underground for a period of not less than five years; provided that this period shall be reduced to three years, if he is an Associate of the School of Mines of Western Australia in the Mining Course or the holder of a degree, associateship, or certificate which in the opinion of the Board is equivalent thereto; and
- (b) be the holder of a certificate of competency under this regulation.

This clause does not apply to any person who at the time this regulation is gazetted is employed as an underground supervisor at any mine in the State of Western Australia and who obtains from the Board a certificate to the effect that he has been so employed.

2. For the purpose of granting certificates of competency and of service for the purpose of this Act there shall be a Board of Examiners consisting of three members, viz.:—

- The State Mining Engineer, who shall be chairman thereof;
 - The Director of the School of Mines of Western Australia;
 - And an Inspector of Mines from time to time appointed by the Minister;
- who will examine the applicants in writing, or orally, or both, as may seem to the Board most advisable, and issue certificates to the successful applicants.

The subjects for examination shall be:—

- (a) mining, as detailed under Regulation 17, Clause (6), paragraph (a);
- (b) knowledge of the mining laws in force in the State, especially the Mines Regulation Act and Regulations.

The Board may refuse a certificate to any applicant if not satisfied as to his character.

3. (a) The Board will meet at such places and at such times as the Minister may appoint. Notices of intention to hold examination will be advertised in a paper or papers circulating in the mining districts of the State.

(b) Any person desirous of presenting himself for examination shall notify the secretary of the Board of

Examiners for Underground Supervisors, Department of Mines, Perth, of the fact on a prescribed form, which may be obtained from the secretary. The notice shall be accompanied by a fee of £1 1s. This fee shall admit to one examination only.

(c) Each candidate shall forward to the secretary for the Board of Examiners at least 14 days before the date of examination satisfactory evidence as to experience and general good conduct, and as to his having been employed underground for a period of not less than five years. A statutory declaration shall be attached to the effect that all the representations contained in such statement are true.

4. If at any time representation is made to the Minister by an Inspector that any holder of a certificate under this regulation is incompetent or unfit to discharge his duties, or has been convicted of an offence against this regulation, the Minister may, if he thinks fit, cause inquiry to be made by the Board of Examiners into the conduct of the above-mentioned holder of a certificate, and with respect to every such inquiry the following provisions shall have effect:—

- (a) The inquiry will be held at such time or place as the Board may appoint; the aforesaid holder of a certificate to have the right to defend himself at such inquiry. He shall receive twenty-one days' notice of the Board's intention to hold the inquiry.
- (b) The Board shall, at least ten days before the commencement of the inquiry, furnish the aforesaid holder of a certificate with a statement of the case upon which the inquiry is instituted.
- (c) The aforesaid holder of a certificate shall attend such inquiry and may produce such evidence as may be considered necessary.
- (d) The Board shall, upon the conclusion of the inquiry, forward to the Minister a report containing a full statement of the case, and their opinion thereon; and the Governor, on the recommendation of the Minister, may either cancel or suspend such certificate.
- (e) Any person shall, if ordered in writing so to do by the Minister, deliver into the charge of the said Board his certificate of competency or of service, which shall be retained by the said Board during the period of his disqualification, and no such person shall during the period of such disqualification take charge of any mine, and any such person failing or neglecting to comply with this order shall be guilty of an offence against this regulation; and
- (f) Persons attending as witnesses before the Board shall be allowed such expenses as would be allowed to witnesses in a criminal case at the Supreme Court.

5. (1) The Board of Examiners may make such order as it thinks fit respecting the costs and expenses of the inquiry, and such order shall, on the application of any party entitled to the benefit thereof, be enforced by any court of summary jurisdiction as if such costs and expenses were a penalty imposed by that Court.

(2) The party entitled to the benefit of such order shall be entitled to obtain from the Board a certified copy thereof.

6. Where a certificate is suspended or cancelled in pursuance of this regulation, the suspension or cancellation shall be recorded in the register of the holders of certificates, and shall be notified by the Board to the Minister.

7. Whenever any person proves to the satisfaction of the Minister that he has, without fault on his part, lost any certificate granted to him under this regulation, the Minister may, on payment of a fee of ten shillings, cause a copy of the certificate to which the applicant appears by the register to be entitled to be made out and certified by the person who keeps the register, and delivered to the applicant; and any copy which purports to be so made and certified as aforesaid shall have all the effect of the original certificate.

8. Every person who commits any of the following offences (that is to say)—

- (1) forges or counterfeits, or knowingly makes any false statement in any certificate of competency under this regulation, or in any certificate of service granted under this regulation, or any official copy of such certificate; or

- (2) knowingly utters or uses such certificate or copy which has been forged or counterfeited, or contains any false statement or knowingly makes use of, or attempts to make use of, any certificate of competency or service granted to some other person; or
- (3) for the purpose of obtaining for himself or any other person employment as an underground manager, foreman, shift boss, or supervisor, or for the purpose of obtaining the grant, renewal, or restoration of any certificate under this regulation, or a copy thereof, either—
 - (a) makes or gives any declaration, representation, statement or evidence which is false in any particular; or
 - (b) knowingly utters, produces, or makes use of any such declaration, representation, statement, or evidence or any document containing the same,
 shall be guilty of a misdemeanour, and be liable on conviction to imprisonment for a term not exceeding six months.

9. Any person who acts as an underground supervisor in the capacity of an underground manager, foreman, or shift boss without being the holder of the proper certificate, and every person who knowingly employs such uncertificated person in such capacity is liable to a penalty not exceeding ten pounds, and to a further fine not exceeding two pounds for every day or part of a day during which he so acts, after notification by an Inspector of Mines or some other person authorised by the Minister that proceedings are to be taken against him for an offence against this regulation.
