WHEREAS it is provided by subsection (2) of section 102 of the Factories and Shops Act, 1920, that, subject to the said Act, the day on which all shops affected by the said section shall close at one o'clock p.m. shall be Saturday, but that the Governor may by Proclamation at any time and from time to time, on the petition (according to the form in the Sixth Schedule to the said Act) of the majority of the keepers of such shops in any district, substitute in that district for Saturday any other week day: And whereas a Petition in due form has been presented to the Governor by a majority of the keepers of such shops in the Norseman Shop District praying that Wednesday may be substituted in that district for Saturday as the day on which such shops shall close at one o'clock p.m., and it is desirable to accede to the prayer of such Petition: Now, therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council, do hereby substitute Wednesday for Saturday in the Norseman Shop District, and do declare that, subject to the said Act, the day on which all shops as aforesaid shall close at one o'clock in the afternoon in the Norseman Shop District shall be Wednesday.

## Brunswick Water Area.

### ORDER IN COUNCIL.

P.W.W.S. 95/38.

WHEREAS by the Water Boards Act, 1904, the Lieutenant-Governor is empowered by Order in Council to constitute the district of a local authority or two or more local authorities, or part or parts of such district or districts, a Water Area, under such name as may be directed: And whereas the Lieutenant-Governor is empowered to appoint a local authority whose dis-trict or part of whose district is within the Water Area, to be the Water Board: Now, therefore, His Excel-lency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby conin the Schedule hereto, for the purposes of the said Act, under the name of the Brunswick Water Area, and doth hereby appoint the Harvey Road Board to be the Water Board, under the name of the Brunswick Water Board.

This Order in Council shall take effect on the 11th day of February, 1938.

### Schedule.

(a) That portion of land embraced by the flood water level of a weir to be situated about 40 chains north-west of Beela Siding on the Brunswick River.
(b) That portion of land bounded by a width of 12.5 links on each side of a pipe line commencing at the aforesaid Weir and closely following the banks of the Brunswick River for a distance of approximately one mile and thouse following the Collie Railway Ba. one mile, and thence following the Collie Railway Re-serve to the boundary of the portion of Water Area as scheduled in section (e) hereunder. (c) That portion of the Brunswick Townsite bounded by lines commencing at the south-east corner of Lot 84

and proceeding westward along the north boundary of Rose road and its prolongation to the prolongation southward of the east boundary of Sommers road; thence along the said boundary to the north boundary there along the said boundary to the north boundary of Road No. 5339; thence westward along part of the south boundary of part of Lot 25 and along its west boundary to and across Clifton road; thence south-easterly for about 6 chains, north-easterly for about  $1\frac{1}{2}$  chains, south-easterly for about 4 chains, north-easterly for about 2 chains, and south-easterly for about  $1\frac{1}{2}$  chains the north particular bare down for about 21/2 chains to the north-western boundary of Ommany road; thence following the said boundary to the left bank of the Brunswick River and following the said bank of the Brunswick Kiver and following the said bank to the north-east boundary of part Lot 25; thence following in a general south-easterly direction the said boundary of part Lot 25 across the Railway Reserve and parts of Lot 26 and across Clifton road to its southern boundary; thence easterly along the said southern boundary to the north-east corner of Lot 168; thence southerly along the eastern boundaries of Lots 168 and 169 and across Kasten road to the north boun-168 and 169 and across Kasten road to the north boun-dary of Lot 152; thence easterly along the said north boundary of Lot 152 and southerly along its east boun-dary and the east boundaries of Lots 153, 154, 155, 156, and 157; thence westerly and northerly along the south and west boundaries of Lots 157 and 156 to the prolongation eastward of the south boundary of Lot 84; thence across Brunswick road to the point of com-wardement mencement.

Sections (a) and (b) are as shown in red on Plan P.W.D., W.A. 28589, Sheet No. 1, and Section (c) on Sheet No. 2.

### Water Boards Act, 1904-1937. ORDER IN COUNCIL.

WHEREAS by section 40 of the Water Boards Act, 1904-1937, it is enacted that subject to the provisions of 1904-1957, it is enacted that subject to the provisions of the said Act a Water Board shall have power to con-struct waterworks for the purposes of the said Act, and by section 52 the Minister charged with the admin-istration of the said Act may exercise all or any of the powers conferred by the said Act on a Water Board in and for the construction of works in any water

area: And whereas it is enacted by section 161 of the area: And whereas it is enacted by section 101 of the said Act that the Governor may authorise the Minis-ter for Works or the Minister for Mines to exercise within a water area all or any of the powers conferred by the said Act on a Water Board until the constitu-tion of a Board: And whereas it is provided by section 11 of the said Act (as awanded by the Water Board tion of a Board: And whereas it is provided by section 41 of the said Act (as amended by the Water Boards Act Amendment Act, 1937) that the Governor may exempt reticulation works from the operation of certain sections of the said Act: Now, therefore, His Excel-lency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act and of all other powers in this behalf enabling him, doth hereby around from the covertion of coefficient 42 42 44 other powers in this behalf enabling him, doth hereby exempt from the operation of sections 41, 42, 43, 44, and 45 of the Water Boards Act, 1904-1937, all reticu-lation works within the description hereinafter men-tioned which the Minister under section 52 of the said Act, or the Minister for Works or the Minister for Mines under section 161 of the said Act, may from time to time find it necessary to carry out, either alone or in connection with other waterworks in the course of exercising the powers conferred upon him by section 52 or section 161 of the said Act, as the case may be.

#### Description referred to.

Reticulation work, including construction, laying down, extension or alteration of water mains, not exceeding eight inches in diameter and not exceeding a cost of two hundred pounds in relation to such reticulation work.

### INDUSTRIAL AGREEMENT.

No. 35 of 1937.

### (Registered 29/12/37.)

THIS Agreement, made in pursuance of the Industrial Arbitration Act, 1912-1935, this 20th day of December, One thousand nine hundred and thirty-seven, be-tween Collie Industrial Co-operative Society, Limited, and others, whose names appear in the Schedule of Signatures of parties hereto, hereinafter referred to as "the Employers," of the one part, and the Amal-gamated Road Transport Union of Workers, Perth, hereinafter referred to as "the Union" of the other part. The parties hereto mutually covenant and agree as follows:---

#### 1.-Scope.

This Agreement shall apply to all workers employed in the industries carried on by the employers who are parties to this Agreement, following the vocations mentioned herein.

### 2.—Area.

This Agreement shall have effect over an area comised within a radius of 20 miles from the Collie Post fice.

#### 3.—Term

This Agreement shall come into operation from the date hereof and remain in force for three years.

### 4.-Wages.

Basic wage:-£3 15s. 10d. The minimum weekly wage to be paid to and received by all workers, other than casual workers, shall be as follows:-

(e) Casual hands shall be paid two shillings and sixasual hands shall be paid two shiftings and six-pence per day in excess of the rates pre-scribed for weekly hands. If employed only part of the day, the extra two shiftings and sixpence shall be paid. The minimum pay-ment to a casual worker shall be for four hours in any one day.

#### 5.-Hours.

The maximum number of hours any worker may be called upon for duty, without payment of overtime, shall be:-

(a) Forty-four hours per week, or

(b) Eight hours per day.

Provided that in any week where there is a holiday the hours shall be reduced in such week by one sixth, and in any week where there are two holidays, by one third. Provided also, that subject to the meal time deduction set out in clause 14 any hours worked on any day shall be worked in a continuous shift.

### 6.—Overtime.

All workers shall be paid at the rate of time and a-half for all time of duty:-

- (a) in excess of the hours prescribed by Clause 5 hereof; or
- (b) outside the prescribed starting and finishing times; or
- (c) in excess of four hours on Saturdays. (This subclause shall not apply to bread carters.)

All overtime shall stand alone and be paid for in addition to the ordinary wage.

### 7 -Holiday Pay.

All time of duty on holidays (see Definitions) shall stand alone and be paid for in addition to the weekly wage at ordinary rates. Any worker required to work on a holiday shall be deemed to have worked at least four hours on such holiday.

### 8.-Sunday Work.

Sunday work shall consist of attendance on horses only. All time worked on Sundays shall stand alone and be paid for at one and a-half time rates.

#### 9.—Commencing and Finishing Times.

The day's work shall be deemed to commence at the time the worker arrives at his employer's premises and to terminate when he finally leaves them for the day. The starting time for the purpose of calculating overtime shall be 8 a.m. or after (except on double or treble days, when bread carters may commence at 7 a.m.), and the finishing time shall not be later than 6 p.m. on any day: Provided that, except in the case of bread carters, the finishing time on Saturdays shall to vary or change the starting and finishing times of his employees, in accordance with the provisions of this clause, he shall give two weeks' notice of such variation or change to the workers concerned, and post a notice of the intended change at the depot, garage, or vard.

### 10 .--- Boarding and Lodging.

Except in the case of parent and son, a worker shall not board or lodge with his employer or on his premises.

### 11.-Shortages.

A worker shall not be held responsible for shortages in money, goods, or bread, unless notified by the employer or his authorised servant in respect to same within twenty-four hours of such appearing in his delivery book or bread book.

### 12.-Engagement.

One week's notice at any time on either side shall be required before the engagement of any but a casual hand shall be terminated.

### 13.--Meal Time.

Not more than one hour shall be deducted for a meal time in any one day.

#### 14 .- Annual Holidays.

Except as provided herein, one week's holiday on full pay shall be allowed to all workers at the expiration of every twelve months of service, to be given to and taken by the worker within one month of becoming due: Provided that in the case of bread carters the annual holidays shall be two weeks: Provided also, that where the engagement of any worker is terminated before the expiration of twelve months from commencement, or after any period of continuous service from the date on which the previous annual holidays became due, he shall be paid in lieu of holidays in proportion to the length of his service

### 15.-Payment for Highest Function.

Where a worker is called upon to perform on any day duties which carry a higher rate of pay than the duties he usually performs, he shall be deemed to have worked the day at the higher rate class and be paid for such day at the higher rate.

### 16 .- Time and Wages Book.

The employer shall provide a Time and Wages Book, to be kept in a place where it is easily accessible to both the employer and the worker. Such book shall show the name of the worker, the nature of the work he performs, the time he starts and finishes work each day, the number of hours worked by and the wages day, the number of hours worked by and the wages and overtime paid to each worker, and his signature for same. The employer and the worker shall be severally responsible for the proper posting of the book daily. Such book shall during working hours on all days of the week be open for inspection by the secretary of the Union which is a party to this Agreement or any other person authorised in writing by him.

#### 17.—General Conditions.

(a) A copy of this Agreement shall be kept in a place where the industry is being carried on, where it is easily accessible to the workers.

(b) Not more than one casual hand may be employed at any time; provided that this subclause shall not apply owing to the absence through sickness of other workers, or on account of other workers being on holidays, or on account of any cause which the employer cannot reasonably prevent which renders this clause inoperative.

(c) The employer shall, when engaging workers, state definitely whether such worker is engaged as a weekly or casual hand. Failing such notice the worker shall be deemed to be engaged as a weekly worker.

(d) Weekly hands ready and willing to work for the whole week shall be paid a full week's wages.

(e) The employer shall notify his workers on the working day immediately preceding a holiday if their services are required next day. Failing such notice, the worker shall be entitled to take the holiday and to receive a full week's wage.

### 18.-Definitions.

(a) "Casual worker" shall mean any person who is engaged as a casual worker and who is dismissed or refused work without any fault of his own before the expiration of six days from the date of commencing work.

(b) "Bread carter" shall mean and include any person employed delivering or conveying bread, rolls, buns, or pastry anywhere other than at the shop or bakehouse of his employer.

(c) "Grocer's carter" shall mean and include any person employed delivering groceries anywhere other than at the shop of his employer.

(d) "Holidays," for the purpose of this Agreement, (d) "Holidays," for the purpose of this Agreement, shall mean the days on which New Year's Day, Anni-versary Day, Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, Foundation Day, Christmas Day and Boxing Day are observed. Pro-vided that, when Anzac Day is observed on a Sunday, the following Monday shall be deemed to be the holiday in lieu thereof, and when Christmas Day falls on a Sunday the following Tuesday shall be a holiday also, and when Boxing Day falls on a Sunday the following Monday shall be a holiday.

#### INDUSTRIAL AGREEMENT.

### No. 1 of 1938.

### (Reg. 19/1/1938.)

THIS Agreement made in pursuance of the Industrial Arbitration Act, 1912-35, this Twenty-fourth day of December, 1937, between McIlwraith, McEacharn, Ltd., and Alfred Tilley & Co., Limited, on the one part, and the Coastal Dock, Rivers, and Harbour Works Union of Workers, on the other part, witnessed as follows :-

#### 1.—Area.

The following wages and conditions will apply to members of the crews of the excursion steamers "Zephyr" and "Emerald," at the Port of Perth, in the State of Western Australia:-

(b) Providing it is mutually agreed between the parties to this Agreement that one fireman greaser is only required when the boats do not proceed beyond the Inner Harbour.

### 3.---Engagement and Dismissal.

All employment shall be by the week. A week's notice on either side shall be given to terminate the employ-ment or the employer shall pay one week's wages in lieu of such notice subject to the right of the employer to dispense with the services of the employee for mis-conduct or negligence without notice at any time.

#### 4.-Payment of Wages.

(a) All wages other than money for overtime will be paid weekly.

(b) Money for overtime will be payable on the pay day of the week following that on which it was earned.

### 5.-Hours of Labour.

(a) Except as hereinafter provided forty-four (44) hours shall constitute a week's work.
(b) The time worked in any one day to be consecutive, exclusive of meal hours.
(c) The men to be worked at the master's discretion.

### 6.-Overtime.

(a) All time worked in excess of forty-four (44) hours in any one week to be deemed overtime and paid

(b) Broken time will be counted to the nearest quarter hour on a give and take basis.

#### 7.—Meals.

The meal times allowed shall be:-Dinner-any con-secutive sixty (60) minutes between 12 noon and 2 p.m.; tea-any consecutive sixty (60) minutes between 5 p.m. and 7 p.m.

When the exigencies of the trade render it necessary in the opinion of the master or officer in charge of the ressel, a member of the crew may be called upon to give up his dinner or tea hour or a portion of it to the following provisions:—If the time curtailed exceeds half an hour, payment shall be made as for one hour at over-time rates, but where the time is half an hour or less, payment shall be made for half an hour at overtime rates.

### 8.-Time off Duty.

In lieu of Sundays and holidays, the members of the crew to be allowed off duty for five (5) intervals of twenty-four (24) consecutive hours in each calendar month, or else be paid for each interval not given a full day's wages.

### 9.---Annual Leave.

Employees serving the employer for the full period of the excursion season (from December to April, or as the case may be) will be granted in lien of leave of absence one full day's pay for each month served.

#### 10 .- Sickness.

In the case of personal ill-health necessitating absence from work an employee, after one month's continuous service, will be entitled to such sick pay on the produc-tion of a medical certificate on each occasion, but shall not be entitled to such sick pay for more than six days in the excursion season (from December to April, or as the case may be). (In the case of accidents, an em-ployee shall receive only the benefit under the provisions of the Workers' Compensation Act, W.A., 1912-24, or any amendments thereto.)

### 11 .- Time and Wages Record.

The employer shall keep and enter up, or cause to be kept and entered up a record containing the names of each of his workers to whom this Agreement applies, the class of work performed by, the wages paid to each worker, the time during which each such worker has been employed. Such record shall be open for inspection by a representative of the Union of Workers during the workers during the usual office hours.

### 12.-Discrimination.

The employer shall not discriminate without just cause against the members of the Union who bear good conduct records and who agree to and continue to work on the terms now agreed upon and as there are vacancies for, and that the local manager of the Company will consider any representations made to him by the secretary of the Union.

### 13.—Disputes.

There shall be no stoppage of work for any cause or reason whatsoever. Should any dispute arise between any employee and the employers, the matter shall be referred to a Board consisting of one representative of cach party and a chairman to be mutually agreed upon by those representatives; failing their agreement, the Registrar of the Industrial Arbitration Court of West-ern Anstralia, or his deputy shall act as chairman. The decision of the Board shall be final and binding on both narties parties.

#### Term.

The term of this Agreement shall be for two years from December 24th, 1937.

# INDUSTRIAL AGREEMENT-BARMAIDS AND BARMEN, STATE HOTELS.

#### No. 2 of 1938.

### (Registered 26/1/1938.)

THIS Agreement, made in pursuance of the Industrial Arbitration Act, 1912-1935, this 31st day of December, one thousand nine hundred and thirty-seven, between the Western Anstralian Barmaids and Barmen's Union of Workers, Perth, being an Industrial Union of Workers duly registered under the provisions of the Industrial Arbitration Act, 1912-1935, of the one part, and the Hon. the Chief Secretary, of the other part, whereby

(1) This Agreement is based on a basic wage of £3 (1) This Agreement is based on a basic wage of £3 15s. 10d. per week for males and £2 0s. 11d. for females within the South-West Land Division (excluding the Metropolitan Area) and £4 7s. 0d. for males and £2 7s. 0d. for females in all other portions of the State (excluding the Metropolitan Area).

(2) In this Schedule and unless the context otherwise indicates and without limiting the ordinary meaning of the word "barmaid" or "barman" means any per-So over the age of twenty-one (21) years employed in the sale of liquor by retail in any hotel licensed under a publican's general license, hotel license, or wine and beer license.

### Wages.

(3) The wages of a barmaid or barmen shall be £4 19s. 10d. per week in the South West Land Division (excluding the Metropolitan Area) and £5 11s. 0d. in all (exchange the interpolation Area) and  $\pm 5$  115. 0d. In all other portions of the State (excluding the Metropolitian Area), without board and lodging, and shall be paid weekly. Where it is deemed necessary by the Executive or Board of Reference to grant a permit to board and reside on the premises, the amount to be deducted for same shall be  $\pm 1$  28. 3d. in the South-West Land Divi-sion (arealyding the Metropolitica, Area) and  $\pi = 1$ sion (excluding the Metropolitan Area) and £1 6s. 0d. in all other portions of the State (excluding the Metropolitan Area) and subject to any fluctuations in the basic wage.

Provided that, in respect to any basic wage variation which may occur from time to time, the total wage pre-scribed for a barmaid shall be increased or decreased by the same amount that the basic wage for barnen is in-creased or decreased as a result of such variation, in order that the rates for a barmaid and a barman shall remain equal.

(4) Except as hereinafter provided, no barmaid or barman shall board or reside upon the licensed premises of the employer by whom she or he is employed. The above proviso shall not apply to:—

(a) any barmaid or barman who is the daughter or son of the licensee of the hotel in which she or he is employed.

- (b) any employee agreed upon between the General Manager of State Hotels and the secretary of the Union. In the event of a disagreement, the

dispute to be determined by the Industrial Magistrate of the district concerned. A District Allowance of seven shillings (7s.) per week will be paid at Gwalia. When computing overtime the District Allowance shall not be computed as an addition to the day's pay.

### Hours.

(5) (i) All work done in excess of forty-four (44) hours in any one week, or of eight (8) hours in any one (1) day, excepting as provided in (ii) hereof, or outside a daily spread of thirteen (13) hours, to be worked in not more than three (3) periods, shall be paid for at the rate of time and a third  $(1\frac{1}{3})$ ; such overtime rates to stand alone only for generately and spore than three. to stand alone and be paid for separately and apart from the ordinary week's wages.

(ii) On Fridays and Saturdays nine (9) hours may be worked without incurring the payment of overtime.

## Christinas Day, Good Friday, Anzae Day, Sunday, and Labour Day.

(6) All work done on Christmas Day, Good Friday, Anzae Day, Sunday or Labour Day shall be paid for at the hourly rate of double an ordinary day's pay.

#### Uniform.

(7) Where the employers require a barmaid or barman to wear a uniform whilst at work, the employer shall supply same and also maintain same in a reasonable state of cleanliness. Should the washing of the white coats be done by arrangement at the expense of the bar-man, the sum of three shillings shall be provided by the employer per week to defray such cost.

### Meal Time.

(8) A barmaid or barman shall be allowed one hour between the hours of twelve noon and two o'clock, and on every evening, when required to work after six o'clock, one hour between the hours of five and seven o'clock for tea.

#### Weekly Half-holiday and Late Nights.

(9) A barmaid or barman shall not be called upon to work later than six-thirty (6.30) p.m. on more than four nights per week, inclusive of the weekly halfholiday.

Each barmaid or barman shall be allowed one half-holiday per week, the half-holiday to start not later than one (1) o'clock.

### Holidays and Annual Leave.

(10) A barmaid or barman shall be entitled to two (10) A barmaid or barman shall be entitled to two (2) weeks' leave on full pay after the expiration of each twelve (12) months' service. Such leave shall be granted within two (2) months of its becoming due, failing which the employer shall pay double time for all work done after that date, and in no case shall the money be paid instead of the holiday.

A barmaid or barman whose services have been ter-minated before twelve (12) months have expired shall be entitled to payment for one (1) day for each calendar month worked.

For the purpose of calculating holiday pay, the second or any subsequent year's service shall be deemed to commence on the day and the month corresponding to the original commencement of the barmaid's and bar-men's service, irrespective of the time of grant of annual leave.

#### Notice.

(11) One week's notice of termination of employment shall be given by either side.

#### Term.

(12) This Agreement shall operate for a period of three (3) years from its execution. Each party may after twelve (12) months from the execution apply to amend, alter, or revise the same.

### Record Book.

(13) Each employer shall keep or cause to be kept at his business premises record books, in which shall be at his business premises record books, in which shall be entered the name of each worker, the time each worker commences and ceases work each day, the total number of hours and the amount of overtime worked, the time worked on a Christmas Day, Good Friday, Sunday, and Labour Day, and the amount of wages and overtime paid, and the worker's signature for the same. The workers and the employer shall be jointly responsible for the proper posting of the record books weekly. Such record books shall be so kept as to be open to and available for inspection by an accredited representative of the for inspection by an accredited representative of the Union during all reasonable hours, but not at such hours as may unduly interfere with the management of the business.

Schedule of Wages and Working Conditions and Roster. (14) Each employer shall keep on some portion of his business premises a copy of this Agreement, where it shall be open to the inspection of the worker at all reascnable times.

#### Area.

(15) This Agreement shall apply to the hotels under the jurisdiction of the Chief Secretary.
