WHEREAS by the Metropolitan Water Supply, Sewerage, and Drainage Act, 1909, it is provided that the Governor may by Order in Council alter or extend the boundaries of the Metropolitan Water Supply, Sewerage, and Drainage Area, or of any District: And whereas it is desirable that the boundaries of Metropolitan Storm-water Districts Nos. 5 and 1 as at present defined should

be altered: Now, therefore I, the Lieutenant-Governor, acting by and with the advice of the Executive Council, do hereby alter the boundaries of Metropolitan Stormwater Districts Nos. 5 and 1 and declare that the said boundaries as shown on Plans M.W.S., S., & D.D., W.A., Nos. 4105 and 2545, and as described in Order in Council of 18th June, 1919, and subsequent amendments, shall be altered in the following manner, by deleting the area described hereunder from Metropolitan Stormwater District No. 1 and including it in Metropolitan Stormwater District No. 5.

#### Schedule.

Commencing at a point at the intersection of the centres of Stirling highway and Hampden road and proceeding westerly along the centre of Stirling highway to a point opposite the centre of Smyth road; thence north along the centre of Smyth road to a point opposite the south boundary of Lot 258, Smyth road; thence west across Smyth road and along the south boundary of the said Lot 258 to its south-west corner; thence north along the west boundaries of Lots 258 and 257, Smyth road, to the south-east corner of Lot 265, Kinninmont avenue; thence west along the south boundary of the said Lot 265 to the centre of Kinninmont avenue; thence north along the centre of Kinninmont avenue to a point opposite the south boundary of Lot 273, Kinninmont avenue; thence west across Kinninmont avenue and along the south boundary of the said Lot 273 to its south-west corner; thence north along the west boundaries of Lots 273, 272, and 271, Kinninmont avenue, to the south-east corner of Lot 244, Carrington street; thence west along the south boundaries of Lots 244 and 243, Carrington street, to the centre of Boronia avenue; thence north along the centre of Boronia avenue to a point opposite the north boundary of Lot 202, Carrington street; thence east across Boronia avenue and along the north boundaries of Lots 202 and 201, Carrington street, to the south-west corner of Lot 199, Kinninmont avenue; thence north along the west boundaries of Lots 199 to 194 inclusive, Kinninmont avenue, to the north-west corner of Lot 194, Kinninmont avenue; thence east along the north boundary of the said Lot 194, to and across Kinninmont avenue and along the north boundary of Lot 183, Kinninmont avenue, to the south-west corner of Lot 168, Smyth road; thence north along the west boundary of the said Lot 168 to its north-west corner; thence east along the north boundary of the said Lot 168 to the centre of Smyth road; thence south along the centre of Smyth road to the centre of Park road; thence east along the centre of Park road to a point opposite the east boundary of Lot 119, Portland street; thence south across Park road and along the east boundaries of Lots 119 to 121 inclusive, Portland street, to the north-west corner of Lot 152, Williams road; thence east along the north boundary of the said Lot 152, to and across Williams road and along the north boundary of Lot 498, Williams road, to the centre of the right-of-way between Williams road and Merriwa street; thence north along the centre of the said right-of-way to a point opposite the north boundary of Lot 513, Merriwa street; thence east across the said right-of-way and along the north boundary of the said Lot 513 to the centre of Merriwa street; thence north along the centre of Merriwa street to the centre of Park road; thence east along the centre of Park road to a point opposite the east boundary of Lot 557, Leura street; thence south across Park road and along the east boundaries of Lots 557 to 562 inclusive, Leura street, to the north-west corner of Lot 565, Hampden road; thence east along the north boundary of the said Lot 565 to the centre of Hampden road; thence southerly along the centre of Hampden road to a point of commencement as shown in brown on Plan M.W.S.S. & D.D., W.A., No. 4105.

## FARMERS' DEBTS ADJUSTMENT ACT, 1930-1934.

NOTICE is hereby given that the following Stay Orders have been issued in accordance with section 7, subsection (1), of the Farmers' Debts Adjustment Act, 1930-1934, which reads as follows:—

A Stay Order shall direct that no action, execution, distress for rent, proceedings on default for breach of covenant under any mortgage or other security for money, or under an agreement for sale and purchase of land, or other process or proceeding, shall be commenced or proceeded with or put in force against the farmer or any of the farmer's assets, whether utilised in connection with or forming portion of the assets comprised in his farming business or not, during the operation of such Stay Order: Provided that, by leave of a Judge, any action may, notwithstanding the Stay Order, be instituted and/or carried on against the farmer, but not beyond judgment.

Rottneest Island—Additional By-laws.

(Control of Traffic.)

HIS Excellency the Lieutenant-Governor in Executive Council has been pleased to approve, under the provisions of the above Act, of the following additional by-laws relating to the control and management of Reserve A16713, Rottneest Island.

The Rottneest Board of Control, in exercise of the powers conferred on it by the Parks and Reserves Act, 1895, hereby amends the existing by-laws of the Board, published in the *Gazette* of the 8th day of December, 1933, by inserting the following heading, and additional by-laws, to follow by-law No. 29 thereof, and to be read as one with the existing by-laws:—

## Traffic Rules.

29A. No person shall ride or drive any vehicle, or ride or drive any animal on any road on the Island in such a manner as to be likely to endanger the life or lives of any person or persons who are or who might, according to the time, place, or circumstances, be expected to be on the road.

29B. No person shall ride or drive any vehicle or ride or drive any animal at a speed exceeding 20 miles per hour.

29C. Every person riding or driving any vehicle, or riding or driving any animal, shall keep the vehicle or animal as near as practicable to the left hand side of the road in the direction in which the vehicle or animal is proceeding.

29D. (i) Every motor vehicle driven and every motor cycle ridden on any road on the Island shall have attached thereto an approved type of horn capable of giving audible and efficient warning of the approach or position of such vehicle.

(ii) Every cycle other than a motor cycle ridden on any road on the Island shall have attached thereto an efficient bell capable of giving audible and efficient warning of the approach or position of such cycle.

29E. (1) No person shall between sunset and the following sunrise drive, impel, haul, have, or place on any road on the Island any vehicle unless lamps of the kind prescribed in these regulations for use on the vehicle are fixed to the vehicle as prescribed and are kept continually burning and are clearly visible sufficiently to afford an adequate means of signalling the approach or position of the vehicle, whether the vehicle is moving or stationary.

(2) The prescribed lamps are as follows:—

- (a) for carts—two headlamps securely fixed one on each side of the vehicle at least one foot higher than but not higher than four feet from the hub of the front wheel and one rear lamp. The lamps shall be made and placed so as to exhibit bright white lights to the front and a bright red light to the rear of the vehicle between sunset and the following sunrise.
- (b) For motor cars and motor wagons—two headlamps so constructed and placed one on each side of the motor car or motor wagon as to exhibit a bright white light in the direction in which such motor car or motor wagon is proceeding or is intended to proceed, and one lamp so constructed and placed as to exhibit a bright red light from the rear of the motor car or motor wagon.
- (c) For motor cycles—two efficient lamps so constructed and placed that one lamp exhibits a bright white light in the direction in which the motor cycle is proceeding and the other lamp exhibits a red light from the rear.
- (d) For cycles—two efficient lamps so constructed and placed that one exhibits a bright white light in the direction in which the cycle is proceeding and the other exhibits a red light from the rear of the cycle towards the direction from which it has come.

(3) Every light used at the rear of a vehicle under these regulations shall be placed in such a position as to be clearly visible for at least fifty yards.

29F. No person having the care and control of any horse or other animal or of any vehicle shall allow the same to remain on any road on the Island so as to obstruct any portion of the road for a longer period than is absolutely necessary.

29G. The driver of any vehicle on any road on the Island shall, when approaching the intersection or junction of any road, before turning the corner of a road or a bend in any road, and at all other times when necessary, slow down and give audible and sufficient warning of the approach or position of such vehicle by sounding the horn or other instrument.

29H. Every person riding or driving any vehicle or animal shall use the road or track set apart for that purpose and shall not ride or drive the same other than on such road or track.

29I. Nothing in these by-laws shall effect the provisions of by-law number 22 published in the *Gazette* on the 8th day of December, 1933.
