The Metropolitan Water Supply, Sewerage and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 311/37, 933/37, 238/25, 349/38, 293/38, 420/37, 465/38, 470/37, 1802/36.

PURSUANT to sections 19 and 20 of the abovementioned Act, His Excellency the Lieutenant-Governor, with the advice of the Executive Council hereby approves of the construction and extension by the Minister for Water Supply, Sewerage and Drainage of the following works under the said Act, and exempts such works from the operations of sections 20, 21, 22 and 23 of the said Act. This Order in Council shall take effect from the 10th day of June, 1938.

Description of Proposed Works—Metropolitan Sewerage, Area 33, Perth:—Extension to Lots Nos. 152 The Grove, 66 Gregory street and 9 Connolly street, Wembley.

Area 6, Claremont:—Extension to Lot No. 124 Louise street.

Areas 1 and 3, South Perth and 4, Claremont:—Amendments to design.

Metropolitan Water Supply:—Extension along Bunyip and Coogee roads, Melville Road District.

Main in Hay street, Perth, from intersection of Hay and Pier streets to intersection of Hay street and Victoria avenue.

30in. main in Cambridge street, Jersey street, etc., Leederville and Subiaco:—Amendments to design.

ORDER IN COUNCIL.

P.W.W.S. 386/29.

WHEREAS by section 40 of the Water Boards Act, 1904-1937, it is enacted that, subject to the provisions of the said Act, a Water Board shall have power to construct water works for the purposes of the said Act: And whereas it is provided by section 41 of

the said Act (as amended by the Water Boards Act Amendment Act, 1937) that the Governor may exempt reticulation works from the operation of certain sections of the said Act: And whereas it is deemed expedient that the reticulation works hereinafter mentioned to be constructed hereafter by the Water Boards hereinafter mentioned shall be exempted from the operation of the said sections of the said Act: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act, and of all others powers in this behalf enabling him, doth hereby exempt from the operation of sections 41, 42, 43, 44 and 45 of the Water Boards Act, 1904-1937, all reticulation work within the descriptions respectively set forth in the second column of the Schedule hereunder which the Water Boards respectively named in the first column of the Schedule hereunder opposite the said descriptions of reticulation work may hereafter from time to time find it necessary to carry out, either alone or in connection with other water works in the course of exercising the powers conferred upon the said Water Boards by section 40 of the said Act.

BOAT LICENSING ACT, 1878-1936.

HIS Excellency the Lieutenant-Governor in Executive Council has been pleased to approve of the rescission and revocation by the Fremantle Boat Licensing Board duly constituted under the provisions of the Boat Licensing Act, 1878-1936, of all the regulations heretofore made by the said Fremantle Boat Licensing Board and in force under and for the purposes of the said Act and also of the new regulations set forth in the Schedule hereto which have been made by the said Fremantle Boat Licensing Board under and for the purposes of the said Act in place of the previous regulations which have been rescinded and revoked as aforesaid.

The Schedule.

BOAT LICENSING ACT, 1878-1936.

Fremantle Boat Licensing Board Regulations.

1. These regulations may be cited as the Fremantle Boat Licensing Board Regulations.
2. Subject as hereinafter provided, these regulations shall operate and have effect in relation to all steamers, vessels and boats using the navigable waters within the jurisdiction of the Board.

Provided that—

(i) These regulations shall not apply to a boat, ship, vessel or steamer which is subject to the provisions of the Navigation Act, 1904-1926, and its amendments; and

(ii) In so far as the navigable waters under the jurisdiction of the Board include the Fremantle Harbour as constituted under the Fremantle Harbour Trust Act, 1902, these regulations in their application to any boat, ship, vessel or steamer which is subject to these regulations shall, while such boat, ship, vessel or steamer is using the said Fremantle Harbour be read and construed in conjunction with the provisions of the Fremantle Harbour Trust Act, 1902, and the regulations made by the Fremantle Harbour Trust Commissioners under that Act so that where in relation to such boat, ship, vessel or steamer these regulations and the said regulations made by the Fremantle Harbour Trust Commissioners deal with the same matter and can be applied consistently with each other these regulations shall be read and construed as being additional or supplementary to the said regulations made by the said Fremantle Harbour Trust Commissioners and that where in relation to such boat, ship, vessel or steamer these regulations and the said regulations made by the said Fremantle Harbour Trust Commissioners deal with the same matter but cannot be applied consistently with each other the regulations made by the said Fremantle Harbour Trust Commissioners shall prevail, and these regulations shall be read and construed and be applied as being subject and subservient thereto.

3. In these regulations, subject to the context—

“The Act” means the Boat Licensing Act, 1878-1936.

“The Board” means the Fremantle Boat Licensing Board as constituted for the time being and from time to time in accordance with section 5 of the Act.

"Harbour" means the Fremantle Harbour as constituted from time to time under the Fremantle Harbour Trust Act, 1902.

"River" means that portion of the Swan River situate within the jurisdiction of the Board.

"Steamer, vessel or boat" in addition to and without derogating from the meaning appearing in section 3 of the Act, includes all boats, tugs, ballast boats, tank boats, cargo boats and lighters employed in carrying goods or passengers or both for reward or plying for hire either for the carriage of goods or passengers or both, or held or let for hire or reward.

Licenses.

4. (1) No steamer, vessel or boat shall be used for carrying goods or passengers, or goods and passengers for reward, or in plying for hire or be held or let for hire within the jurisdiction of the Board* unless such steamer, vessel or boat is the holder of a license granted by the Board.

(2) An application for a license for any steamer, vessel or boat in respect whereof a license is required by the Act, shall be made by the owner thereof in writing in accordance with Form No. 1 in the First Appendix to these regulations.

(3) Every license granted by the Board to any steamer, vessel or boat shall be in accordance with Form No. 1 in Schedule A to the Act.

Conditions.

5. (1) No steamer, vessel or boat shall be granted a license under the Act until the surveyor or surveyors appointed by the Board has or have surveyed such steamer, vessel or boat and furnished a report of such survey to the Board.

(2) Before the survey mentioned in paragraph (1) of this regulation is made the applicant for the license shall pay to the Board the survey fees prescribed in the Second Appendix to these regulations.

(3) The Board, when granting a license, may grant such license subject to any conditions it may think fit to impose, including a condition limiting the speed at which the steamer, vessel or boat licensed may be propelled when navigating any specified portion of the navigable waters under the jurisdiction of the Board.

(4) Licenses to lighters used to carry explosives shall be granted subject to such special conditions as are required or approved by the Chief Inspector of Explosives of the State.

(5) Where a license is granted subject to conditions, such conditions shall be indorsed upon the license and shall be binding upon the owner of the steamer, vessel, or boat licensed and on every person from time to time having the control or management thereof according to the tenor of such conditions.

(6) Before any license granted by the Board is issued to the steamer, vessel, or boat licensed thereunder, the license fee prescribed in the Second Appendix to these regulations shall be paid to the Board, and all the requirements of section eleven of the Act shall be duly complied with.

Life-Saving Appliances.

6. Subject as hereinafter provided:—

(1) No steamer, vessel, or boat shall ply for hire or reward for the carriage of passengers or of goods and passengers or be held or let for hire or reward for the carriage of passengers or of goods and passengers, unless such steamer, vessel, or boat is properly equipped with life-saving appliances as in this regulation hereinafter mentioned.

(2) Every steamer, vessel, or boat licensed by the Board for the carriage of goods only, shall carry one lifebuoy for each member of the crew, with a minimum at all times of two lifebuoys and all such lifebuoys shall at all times be maintained in an efficient condition, and be so carried as to be available for instant service.

(3) Every steamer, vessel, or boat licensed by the Board for the carriage of passengers or of goods and passengers shall be equipped with sufficient life-saving appliances including a boat of dimensions and type approved by the Board to float all the passengers and the crew, and such appliances and boat shall always be kept on board, and be maintained in an efficient condition and so carried as to be available for instant service.

(4) All life-saving appliances provided on a steamer, vessel, or boat in accordance with this regulation shall be submitted for inspection and survey at any time directed by the Board or by any officer appointed by the Board and should the number, capacity, or efficient condition or method of carrying such appliances be considered by the Board or such officer not to be satisfactory, the Board may cancel or revoke the license held by the steamer, vessel, or boat wherein the said appliances are considered to be unsatisfactory.

(5) Provided that—

(i) Boats under two tons register shall be exempt from carrying or towing a boat, but shall be equipped with sufficient life-saving appliances to float every person on board, as approved by the Board, but so that, where such appliances are fixtures, they must be capable of floating the boat as well as every person on board, or, where such appliances consist of lifebelts or lifebuoys, there shall be one lifebelt for each person on board, and such lifebelts and lifebuoys shall be maintained in an efficient condition and be so carried as to be available for instant service.

* The jurisdiction of the Board comprises all the navigable waters within a radius of twenty miles from the North Mole Lighthouse at Fremantle Harbour. See *Government Gazette*, 27th February, 1931.

- (ii) The Board may, upon special application made to it in writing, exempt any steamer, vessel, or boat from carrying all or any of the life-saving appliances mentioned in this regulation, or may prescribe certain boundaries within the navigable waters under the jurisdiction of the Board, within which all or any of the appliances aforesaid may be omitted by any steamer, vessel, or boat upon special application as aforesaid, but in every case where any exemption is granted by the Board under this paragraph, the Board may impose a condition that there shall be provided a properly approved lifebelt for each person on board which shall be maintained in an efficient condition and be so carried as to be available for instant service.

Fire Appliances.

7. (1) Every steamer licensed to ply for hire for carriage of passengers shall be provided with a hose capable of being connected with the boilers or engines of the steamer, and capable of and adapted for extinguishing fire in any part of the said steamer to the satisfaction of the surveyor, and every steamer, vessel, or boat licensed to ply for hire for the carriage of passengers or goods and passengers shall, except in the case of steam vessels licensed for the carriage of passengers as above, be provided with an efficient power or hand pump and hose adapted for extinguishing fire in any part of the said steamer, vessel, or boat to the satisfaction of the surveyor.

(2) All fire appliances shall at all times be maintained in a thoroughly efficient condition, and be so carried or stowed as to be capable of instant service.

Danger of Fire.

8. No master or other person in charge of any steamer, vessel, or boat licensed to ply for hire for the carriage of passengers, or goods and passengers, shall do or permit to be done any work, act, or thing on board such steamer, vessel, or boat while under way or plying for hire, or while passengers are on board, which may tend to create a danger of fire breaking out on board.

9. No spirits, tar, oils, or other combustible material shall be kept on board of any steamer, vessel, or boat in greater quantity than is necessary for efficient working, and under no circumstances shall any open fire be allowed or any combustible material be treated for any purpose while passengers are on board.

Manning.

10. (1) All steamers over 15 tons net register shall carry on deck, in addition to a licensed master, one look-out man, and at least one other deck hand on watch, and the deck hands shall be distinct from and additional to an efficient engine-room and stokehold staff. All steamers of 15 tons and under shall carry a licensed master and a certificated engine-driver.

(2) All steamers, vessels, or boats being oil or motor vessels under 15 tons net register, shall carry a licensed master, who shall also be a certificated engine-driver, and all steamers, vessels, or boats being oil or motor vessels over 15 tons net register shall carry a certificated engine-driver in addition to a licensed master.

(3) All lighters shall be in charge of a licensed master.

(4) Sailing lighters over ten tons net register must have two men on deck in addition to the master, and all sailing lighters of ten tons and under, one man on deck in addition to the master.

(5) Lighters which are not navigated under their own sails or power, but have to be towed, need not, while working within the river, have any further crew than the master; but similar lighters while working in the harbour must have one man on deck in addition to the master.

Bulwarks.

11. Every decked vessel or steamer carrying passengers shall have a properly constructed and approved bulwark or railing above the deck, for the protection of passengers or persons being thereon.

12. Every ballast lighter, scow, or other similar open vessel which plies within the navigable waters under the jurisdiction of the Board shall have sufficient coamings at least eight (8) inches high above the deck planking.

Number of Passengers—How determined.

13. For the purpose of determining the number of passengers which a steamer, vessel, or boat shall be licensed to carry, the following provisions shall apply, namely:—

(1) As regard steamers, vessels, and boats other than free-board motor boats—

(a) Where the number is determined on the basis of seating accommodation, one adult passenger may be allowed to every eighteen inches of sitting room upon seats provided for the accommodation of passengers.

Provided that—

- (i) such seats are at least three feet apart;
- (ii) there are no such seats on the awning deck; and
- (iii) the sitting room for passengers on such seats is clear of all interference with the proper working of the steamer, vessel, or boat; or

(b) Where the number is determined on the basis of deck space, one adult passenger may be allowed to each six square feet of deck space upon the deck available to passengers when the steamer, vessel, or boat is used for the carriage of passengers within the navigable waters under the jurisdiction of the Board outside the mouth of the Swan River, and one adult passenger may be allowed to each four square feet of such deck space when the steamer, vessel, or boat is used for the carriage of passengers on the river or in that part of Fremantle Harbour inside the mouth of the Swan River.

(2) For the purpose of paragraph (1) hereof two children both under twelve years of age shall count as one adult.

(3) As regards free-board motor boats, the number of adult passengers for which a boat may be licensed shall in the first instance be ascertained in accordance with the provisions of subparagraph (a) or subparagraph (b) of paragraph (1) hereof but thereafter, in so far as may be necessary, the number so determined shall be reduced so that when the boat is loaded with weights representing the full number of adult passengers to be allowed and the crew, each estimated to weigh 140 lbs., the clear height of the side of the boat above water at the lowest point will be as follows:—

plus such further height as is proportionate to the difference between twenty feet and the actual length of the boat. |

(4) Notwithstanding anything to the contrary contained in the foregoing paragraphs of this regulation, the full number of adult passengers which a steamer, vessel or boat may be licensed to carry shall be limited to a number below that determined in accordance with the foregoing provisions, which the surveyor of the Board decides is the greatest number of adult passengers which can be carried with safety having due regard to the stability of the steamer, vessel or boat.

Regulation Lights.

14. The following lights shall be used or carried by steamers, vessels and boats in the navigable waters under the jurisdiction of the Board, that is to say:—

(1) Lights when under way—

(a) Subject as hereinafter provided every steamer, vessel or boat while navigating the said navigable waters between sunset and the next following sunrise, shall carry lights as follow:—on the starboard side, a green light so constructed as to throw a uniform and unbroken light over an arc of the horizon of ten points of the compass so fixed as to throw the light from right ahead to two points abaft the beam on the starboard side, and of such a character as to be visible on a dark night with a clear atmosphere at a distance of at least one mile; also on the port side, a red light, so constructed as to throw a uniform and unbroken light over an arc of the horizon of ten points of the compass, so fixed as to throw the light from right ahead to two points abaft the beam on the port side, and of such a character as to be visible on a dark night with a clear atmosphere at a distance of at least one mile, and so that the said green and red side lights are fitted with inboard screens projecting forward from the light so as to prevent the said side lights from being seen across the bow.

(b) Subject as hereinafter provided every steamer while navigating the said navigable waters between sunset and the next following sunrise shall, in addition to the lights mentioned in subparagraph (a) hereof, carry at a height above the hull of such steamer of not less than ten feet a bright white light so constructed as to show a uniform and unbroken light over an arc of the horizon of twenty points of the compass, so fixed as to throw the light ten points on each side of the vessel, namely from right ahead to two points abaft the beam on each side and of such a character as to be visible on a night with a clear atmosphere at a distance of at least two miles.

Provided that—

- (i) steamers under 15 tons register, while navigating the river only need not carry the red and green sidelights mentioned in subparagraph (a) hereof as permanent fixtures, but, in lieu thereof, may carry an approved form of lantern capable of showing a red and a green light on the port and starboard sides respectively from right ahead to two points abaft the beam but so that such lantern is carried not less than three feet below the white light mentioned in subparagraph (b) hereof;
- (ii) launches to which subparagraph (b) hereof applies may carry the white light therein mentioned at any convenient height above the hull, and need not carry the side lights mentioned in subparagraph (a) hereof, if in lieu thereof they carry a combined lantern showing a red light and a green light from right ahead to two points abaft the beam on the port and starboard sides respectively and such lantern is carried not less than three feet below the said white light;
- (iii) a sailing vessel over 28 tons register, while under way or being towed, need not and shall not carry the white light mentioned in subparagraph (b) of this paragraph;
- (iv) open boats, sailing yachts and lighters of less than 28 tons net registered tonnage need not carry the side lights mentioned in subparagraph (a) of this paragraph if, in lieu thereof, they carry lighted and ready at hand a lantern with a green glass on one side and a red glass on the other side and on approaching or being approached by another steamer, vessel or boat they exhibit such lantern in time sufficient to prevent collision and in such manner that the green light shall not be seen on the port side and the red light shall not be seen on the starboard side;

- (v) a rowing boat or sailing boat of a net tonnage not exceeding two tons which is let or held for hire, need not carry any of the lights mentioned in this paragraph, but shall carry a lantern of approved design from which a white light can be exhibited temporarily in time sufficient to prevent collision with another steamer, vessel or boat.

(2) Towing Lights.—A vessel when towing another vessel between sunset and the next following sunrise shall, in addition to the lights required to be carried by it under subparagraph (a) of paragraph (1) hereof, carry two bright white lights in a vertical line one over the other, not less than three feet apart, so as to distinguish such towing vessel from other vessels: each of such white lights shall be of the same construction and character and shall be carried in the same position as the white light which is required to be carried in accordance with subparagraph (b) of paragraph (1) hereof.

(3) Anchor Lights.—Every steamer, vessel or boat, when at anchor between sunset and the next following sunrise, shall carry, where it can best be seen but at a height not exceeding twenty feet above the hull, a white light in a globular lantern of not less than eight inches diameter and so constructed as to show a clear uniform and unbroken light visible all round the horizon at a distance of at least one mile. Where such steamer, vessel or boat is also required, whilst navigating the said navigable water, to carry the red and green side lights mentioned in subparagraph (a) of paragraph (1) hereof, such steamer, vessel or boat shall also carry the said side lights whilst at anchor.

(4) Stern Light.—Every steamer, vessel or boat which is being overtaken by another steamer, vessel or boat, shall in addition to all other lights required by this regulation to be carried, show from her stern to such last-mentioned steamer, vessel or boat, a white light or a flare-up light.

(5) Lights on vessels lying in tier.—Every steamer, vessel, or boat, which shall between sunset and the next following sunrise lie in tier outside of any other steamer, vessel, or boat moored to the shore or to any wharf, shall exhibit on the side furthest from the steamer, vessel, or boat alongside which it is lying as aforesaid at the widest part of such first-mentioned steamer, vessel, or boat, a bright light so placed as to show a clear and unbroken light completely visible from right ahead to right astern on the side upon which the said light is exhibited.

Steering and Sailing Rules.

15. Every steamer, vessel, or boat licensed or registered by the Board shall at all times while under way within the navigable waters under the jurisdiction of the Board, observe the rules of the Board of Trade for the prevention of collisions or other accident, including the following steering and sailing rules:—

- (1) When two sailing vessels are approaching one another so as to involve risk of collision, one of them shall keep out of the way of the other, as follows:—

(a) A vessel which is running free shall keep out of the way of a vessel which is close-hauled.

(b) A vessel which is close-hauled on the port tack shall keep out of the way of a vessel which is close-hauled on the starboard tack.

(c) When both are running free with the wind on different sides, the vessel which has the wind on the port side shall keep out of the way of the other.

(d) When both are running free with the wind on the same side, the vessel which is to windward shall keep out of the way of the vessel which is to leeward.

(e) A vessel which has the wind aft shall keep out of the way of the other vessel.

- (2) When two vessels under steam are meeting end on, or nearly end on, so as to involve risk of collision, each shall alter her course to starboard, so that each may pass on the port side of the other.

Provided that—

- (i) This paragraph shall apply only to cases where steam vessels are meeting end on, or nearly end on, in such a manner as to involve risk of collision, and shall not apply to two vessels, which must, if both keep on their respective courses, pass clear of each other.
- (ii) The only cases to which this paragraph shall apply are when each of the two vessels is end on, or nearly end on, to the other; in other words, to cases in which by day each vessel sees the masts of the other in line, or nearly in a line with her own, and by night to cases in which each vessel is in such a position as to see both the side-lights of the other.
- (iii) This paragraph shall not apply by day to cases in which a vessel sees another ahead crossing her own course; or, by night, to cases where the red light of one vessel is opposed to the red light of the other, or where the green light of one vessel is opposed to the green light of the other, or where a red light without a green light or a green light without a red light is seen ahead, or where both green and red lights are seen anywhere but ahead.

- (3) When two vessels under steam are crossing, so as to involve risk of collision, the vessel which has the other on her own starboard side shall keep out of the way of the other.

(4) When a steam vessel and a sailing vessel are proceeding in such directions as to involve risk of collision, the steam vessel shall keep out of the way of the sailing vessel.

- (5) Where by any of these rules one of two vessels is to keep out of the way, the other shall keep her course and speed.

(6) When, in consequence of thick weather or other causes, such vessel finds herself so close that collision cannot be avoided by the action of the giving way vessel alone, she also shall take such action as will best aid to avert collision.

(7) Every vessel which is directed by these rules to keep out of the way of another vessel shall, if the circumstances of the case admit, avoid crossing ahead of the other.

(8) Every steam vessel which is directed by these rules to keep out of the way of another vessel shall on approaching her, if necessary, slacken her speed or stop or reverse.

(9) Notwithstanding anything contained in these rules, every vessel overtaking any other shall keep out of the way of the overtaken vessel.

(10) Every vessel coming up with another vessel from any direction more than two points abaft her beam, *i.e.*, in such a position, with reference to the vessel which she is overtaking that at night she would be unable to see either of that vessel's sidelights, shall be deemed to be an overtaking vessel; and no subsequent alteration of the bearing between the two vessels shall make the overtaking vessel a crossing vessel within the meaning of these rules, or relieve her of the duty of keeping clear of the overtaken vessel until she is finally past and clear.

(11) As by day the overtaking vessel cannot always know with certainty whether she is forward of or abaft this direction from the other vessel, she should, if in doubt, assume that she is an overtaking vessel and keep out of the way.

(12) In narrow channels every steam vessel shall, when it is safe and practicable, keep to that side of the fairway or mid channel which lies on the starboard side of such vessel.

(13) Sailing vessels under way shall keep out of the way of sailing vessels or boats fishing with nets, or lines, or trawls. This rule shall not give to any vessel or boat engaged in fishing the right of obstructing a fairway used by vessels other than fishing vessels or boats.

(14) In obeying and construing these rules, due regard shall be had, to all dangers of navigation and collision, and to any special circumstances which may render a departure from the above rules necessary in order to avoid immediate danger.

Sound Signals for Vessels in Sight of One Another.

16. (1) The words "short blast" used in this regulation shall mean a blast of about one second's duration.

(2) When vessels are in sight of one another, a steam vessel under way, in taking any course authorised or required by these regulations shall indicate that course by the following signals on her whistle or siren, *viz.*—

- (a) One short blast to mean, "I am directing my course to starboard."
- (b) Two short blasts to mean, "I am directing my course to port."
- (c) Three short blasts to mean, "My engines are going full speed astern."

Necessary Precautions.

17. Nothing in these regulations shall exonerate any vessel, or the owner, or master, or crew thereof, from the consequences of any neglect to carry lights or signals, or of any neglect to keep a proper look-out, or of the neglect of any precaution which may be required by the ordinary practice of seamen, or by the special circumstances of the case.

Vessels may be Re-measured.

18. The surveyor appointed by the Board may at any time measure or inspect any steamer, vessel or boat, or test the accuracy of such measurement, and appoint the time, place and manner when, where, and in which such measurement or inspection shall be made. For the purpose of such re-measurement or inspection the said steamer, vessel, or boat shall be taken out of the water, if such is considered necessary or desirable by the surveyor, to such an extent as to readily admit of a proper examination of the hull.

Costs of Survey.

19. The expense of measuring, re-measuring and marking any boat or vessel referred to in this section shall be borne and paid by the owner of such boat or vessel, and must be paid at the time of measuring, or before the delivery of the license, and no license is to be issued until such charge is paid.

Water Tank Boats.

20. (1) The owner of every water-tank boat shall paint, and at all times keep legibly painted, on the hatch coamings or other conspicuous place, the number of gallons such boat is licensed to carry; such number of gallons shall also be indorsed upon the license.

(2) No person shall supply water from or ply for hire with any water-tank boat without a license.

Qualifications of Masters and Coxswains.

21. Candidates for Master's or Coxswain's Licenses must be not less than twenty-one years of age, and will be required to produce certificates as to character and service of not less than twelve months on a sea-going or river and harbour vessel, and in addition must possess the requisite knowledge of navigation and seamanship and locality; they must be able to pass the sight and colour tests prescribed by the Board of Trade, and to read and write, and shall be British or duly naturalised British subjects.

Masters' and Coxswains' Licenses.

22. (1) Candidates for a master's license or for a coxswain's license under the provisions of the Act shall make application for the same to the Board in writing in accordance with Form No. 2 in the First Appendix to these regulations.

(2) A master's license and a coxswain's license issued by the Board shall be in accordance with Form No. 2 in Schedule A to the Act.

Vessels held for Hire.

23. (1) The hull and gear of every steamer, vessel, or boat which is held for hire or reward for the carriage of passengers, or goods and passengers, or goods or passengers as distinct from those steamers, vessels, or boat which are licensed by the Board to ply for hire, shall be surveyed annually by the Surveyor appointed by the Board, and such steamers, vessels, or boats may be registered or licensed by the Board as suitable to be held or let for hire or reward, as aforesaid, after the Board is satisfied by the Surveyor that they are in a seaworthy condition both as regards their structural design and construction, rigging, sails and gear and equipment, and their general condition. Such licenses or registration shall be issued annually on the 1st day of March, and shall remain in force till the last day of February thereafter, unless same be cancelled or suspended during that period.

(2) Every steamer, vessel, or boat licensed or registered to be so held or let for hire, shall have her license or registered number painted outside on the bluff of each bow in figures of a conspicuous colour, and not less than four inches in height, and shall also have painted on the inside of the gunwale at the stern sheets the name of the craft in full, and the name and place of abode of her owner, and on the inside of the gunwale, at the foresheets, her license or registration number, and the number of persons and weight or measurement of goods, either or both, she is licensed or registered to carry; and no such steamer, vessel, or boat shall be used for the carriage of any number of persons, or weight or measurement of goods, either or both, other than the number and quantities set out in the license or certificate of registration.

Liability of Persons Letting or Hiring Boats.

24. The person hiring any steamer, vessel, or boat shall declare to the owner, or the owner's representative, when engaging the craft, the number of persons and the quantity of goods, either or both, which he intends to use the craft for the carriage of, and the said owner or owner's representative shall draw the attention of the hirer to the particulars of the license or certificate of registration held for the craft, and shall record the name of the hirer and the number of persons or the quantity of goods which has been so declared, and the hirer shall not permit the said steamer, vessel, or boat while in his possession to carry more than the number of persons and quantity of goods which he has so declared as aforesaid, and the owner or owner's representative shall not let the said steamer, vessel, or boat if the number of persons and quantity of goods so declared or desired to be carried is in excess of the number or quantity respectively provided for in the license or certificate of registration.

Supervision.

25. (1) For the purpose of seeing that all or any of these regulations are properly carried out, it shall be a condition attaching to every license granted by the Board that any officer appointed by the Board or any Harbour Master, Licensed Pilot, or member of the police force, in uniform, shall have access to any steamer, vessel, or boat, at any hour of the day or night, whether under way or not, and shall be allowed and authorised to ask any reasonable question of the master of the vessel, or of any officer thereof, or any other person in temporary charge thereof, and any information required shall in all cases be furnished.

(2) No person shall molest or hinder any officer or person so authorised to supervise the carrying out of these regulations, or refuse to allow him to enter any steamer, vessel, or boat.

Boat Races and Regattas.

26 (1) On the occasion of any boat race or regatta, or on any occasion when large numbers of craft or people assemble, no steamer, vessel, or boat shall pass on the navigable waters under the jurisdiction of the Board so as to obstruct, impede, or interfere with the boat race or regatta, or to endanger the safety of craft or people assembling or assembled on the navigable waters under the jurisdiction of the Board, or to interfere with the maintenance of order thereon.

(2) As it is impossible to foresee every contingency possible to arise in the holding of boat races, regattas, or on other occasions when large numbers of craft or people assemble, the Board may make such additional rules as may be deemed to be necessary or advisable to maintain proper order, and for general safety upon any occasion.

Accidents to be Reported.

27. (1) The owner, and also the master or coxswain, of every steamer, vessel, or boat licensed by the Board for the carriage of passengers or goods (either or both) shall without any delay report in writing to the Board any accident to the said steamer, vessel, or boat, or any occurrence or happening or condition which may have occurred or arisen the effect of which tended to cause such steamer, vessel or boat to become or expected to become unseaworthy, leaky, dangerous, or in any way likely to have or produce any deleterious or harmful effect upon any passenger or cargo (either or both) carried or to be carried.

(2) Any license issued by the Board and still effective shall, concurrently with the occurrence, become automatically null and void and shall remain so until re-issued. It shall be sent to the Board with the reports provided for and the Board will then have an examination made by its Surveyor, and may, on his report, order certain work to be done or repairs or alterations to be carried out by the owner or licensee, and upon their completion to the satisfaction of the Board the license shall be re-issued. All expenses of survey shall be borne by the owner of the said steamer, vessel, or boat.

Refuse Vessels.

28. All steamers, vessels, or boats used to carry manure, offal, or refuse shall have close-fitting hatches, which shall be put on as soon as the material is taken on board, and the said steamer, vessel, or boat shall be at once removed to the ballast grounds prescribed by the Fremantle Harbour Trust Commissioners and be there emptied and thoroughly washed down, the hatches remaining closed till the steamer, vessel, or boat is on the ballast ground. Provided that in the case of light and bulky material, close tarpaulins or sails, completely secured, may be permitted in lieu of fixed hatches.

Load Line.

29. The owner of every steamer, vessel, or boat employed in carrying ballast, coal, or other like material shall have marked, and at all times keep legible and distinct a maximum load line as determined by the Surveyor and approved by the Board, and the master or owner of any such steamer, vessel, or boat who allows her to be so loaded as to put such maximum load line below the surface of the water shall be guilty of an offence.

No Material to go Overboard.

30. No ballast, coal, ashes, refuse, offal, or filth or material of any kind shall be so loaded as will permit of any of it finding its way into the waters of the Harbour or River other than the ballast grounds prescribed by the Fremantle Harbour Trust Commissioners.

Recovery of Dues, Fees and Costs.

31. All dues, fees and costs prescribed by "The Boat Licensing Act, 1878-1936, and any amendment thereof, and by these Regulations, may be recovered by the Board before a Court of Summary Jurisdiction.

Scale of Fees.

32. The various fees payable under these regulations shall be those prescribed in the second appendix to these regulations.

Penalties.

33. Every person who commits a breach of any of these regulations shall be liable to a penalty not exceeding one hundred pounds.

"B" Hospitals in which the following cases are treated:—Scarlet fever, diphtheria, measles, mumps, whooping cough, typhus fever, epidemic poliomyelitis, smallpox, plague and cholera.

"C" Hospitals in which convalescent patients and patients requiring medical supervision, but not requiring constant nursing attention are admitted.

2. Subclause (a) of clause 6 is deleted and a new subclause to be numbered (a) is inserted in lieu thereof as follows:—

(a) Hospitals in Class "A" shall be so situated that the building used as the hospital shall, on all sides, have between it and the boundary of the land used for the purposes of a hospital, a clear space of not less than fifteen feet: Provided that this clause shall not apply to hospitals in Class "A" licensed by the Local Authority at the time of the passing of the Health Act, 1911-15; so long as the situation of the buildings comprising such hospitals remains the same as at the time when the license in each case was obtained.

Hospitals in Class "B" shall be so situated that the building used as the hospital shall, on all sides, have between it and the boundary of the land used for the purposes of a hospital a clear space of not less than 30 feet.

Hospitals in Class "C" shall be so situated that the building used as the hospital shall, on all sides, have between it and the boundary of the land used for the purposes of a hospital, a clear space of not less than 15 feet: Provided that this clause shall not apply to hospitals in Class "C" which were on the 9th day of May, 1938, licensed by the Local Authority as lodging houses and which are proved to the satisfaction of the Local Authority to have on that date been used for the purposes now defined as constituting a private hospital of "C" class.

3. Clause 15 is deleted and a new clause to be numbered 15 is inserted in lieu thereof as follows:—

15. (1) Every person conducting a private hospital shall maintain at all times a sufficient number of nurses and assistants in such hospital.

(2) Without derogating from the provisions of the last preceding subclause every person conducting a Class "A" hospital or a Class "B" hospital shall at all times maintain the nursing staff at not less than the following standard, that is to say:—

(a) Not less than one general trained nurse to every four patients or portion thereof.

(b) Not more than one probationer or nursing assistant to each general trained nurse.

Provided that in respect of midwifery patients in any such hospital registered midwifery nurses may be employed in the proportion specified in subparagraph (a).

(3) Without derogating from the provisions of subclause (1) hereof every person conducting a Class "C" hospital shall maintain on the staff at least one trained nurse.
