Vermín Act, 1918.

PROCLAMATION

WESTERN AUSTRALIA, } By His Excellency Sir James Mitchell,
TO WIT. } K.C.M.G., Lieutenant-Governor in and
JAMES MITCHELL, } over the State of Western Australia
Lieutenant-Governor. and its Dependencies in the Common-
[L.S.] wealth of Australia.

WHEREAS it is enacted by section four of the Vermín Act, 1918, that "vermín" means and includes any animal or bird mentioned in the Third Schedule to the said Act and such other animals or birds the names of which the Governor may by Proclamation add to the said Schedule; And whereas it is deemed desirable and expedient that the animals known as grasshoppers or locusts shall for the purposes of the said Act be vermín throughout the whole of the State of Western Australia: Now, therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act and of all other powers in this behalf enabling, do by this Proclamation add to the Third Schedule to the said Act the names of the following animals, namely, grasshoppers and/or locusts so that the said animals known by such names shall be vermín within the meaning and for the purposes of the Vermín Act, 1918 throughout the whole of the State of Western Australia.

ORDER IN COUNCIL.

M.W.S. 954/38.

WHEREAS by the Metropolitan Water Supply, Sewerage, and Drainage Act, 1909, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works, and stormwater drainage works: And whereas it is further provided that the Governor may exempt reticulation works from certain sections of this Act: Now, therefore, His Excellency the Lieutenant-Governor, with the advice of the Executive Council, hereby approves of the construction and extension by the Minister for Water Supply, Sewerage, and Drainage of the following works under the said Act, and does hereby exempt such works from the operations of sections 20, 21, 22, and 23 of the said Act:—

Description and Location of Reticulation Works approved and exempted—Metropolitan Reticulation Main Improvement—City of Perth:—Proposed 8-inch diameter water main commencing at the existing 30-inch diameter main at the intersection of Milligan street and St. George's terrace, and proceeding thence in a south-

easterly direction along the northern side of St. George's terrace to a point opposite Lot H1 near Mill street (length about 9 chains).

The above main to be complete with valves, hydrants, and all necessary apparatus as shown in red on Plan M.W.S.S. & D.D., W.A., No. 6145.

FARMERS' DEBTS ADJUSTMENT ACT, 1930-1934.

By-laws for the Establishment, Regulation and Control of Camping Areas.

P.W. 1557/30.

IN pursuance of the powers in that behalf contained in the Road Districts Act, 1919-1934, and all other powers thereto them enabling, the Wanneroo Road Board hereby make the following by-laws:—

1. (a) For the purpose of these by-laws the term "Board" shall mean the Wanneroo Road Board.

(b) The term "permission" shall mean the permission of the Board first obtained and expressed in writing.

(c) No camping is permitted on any reserve, or on any land the property of the Board, or on any road in the Board's District save and except within the area set apart for that purpose within the boundaries of Reserve No. 11630 and portion of Location M1405.

(d) No person shall erect, keep or maintain or suffer or allow to be erected, kept or maintained any camp or other building or live or otherwise take up abode or residence within the camping reserves as described above without first obtaining from the Wanneroo Road Board or a duly appointed officer thereof a camping permit and paying the fee prescribed by the said Board therefor.

(e) No person shall erect, keep or maintain or suffer or allow to be erected, kept or maintained any camp or

other building within the boundaries of the Reserve No. 11630 and portion of Location M1405 save and except within that portion of such reserve and location as are marked by special pegs and numbered on the plan open for inspection at the offices of the Board.

2. The camping permit shall indicate the site to be occupied and the secretary's decision in any dispute shall be final.

3. Fees for camping are payable prior to the issue of permits on the following scale:—

For permits to camp for period not exceeding 24 hours	1 0
For permits to camp for period not exceeding 48 hours	2 6
For permits to camp for period not exceeding 7 days	5 0
Extensions of the permits may be secured upon the payment of a further fee upon the above scale.	

4. (a) No person shall sublet any camp or sell, give, or otherwise dispose of any permit to any person.

(b) Except by the permission of the secretary or officer acting on his instructions, no person shall bring into or keep within the camping area any animal or birds.

(c) No person shall bring into or keep or consume in the camping area any intoxicating liquor nor enter nor remain thereon when visibly under the influence of liquor.

(d) No person shall misconduct himself or indulge in any riotous or indecent conduct, or use any indecent or improper language or offend against decency as regards dress or otherwise in the camping area.

(e) Campers shall keep the area covered by their permits in a clean and sanitary condition at all times. All rubbish capable of destruction by fire shall be burned by the occupier in the approved fireplace.

(f) All campers shall use the sanitary convenience provided and in no circumstances will improvised conveniences on individual camping sites be permitted.

(g) No person shall cause or permit any damage to trees, shrubs or grass, whether natural or artificially planted, within or surrounding the camping area. The presence of any green timber or foliage of such trees, shrubs, or grass on the area covered by any camping permit shall be *prima facie* evidence that the holder of the permit has caused or permitted damage, unless the permit holder has pointed out the damage before taking over the camping site. No camping peg shall be damaged or interfered with in any way except by an authorised person.

(h) Camping permits may at any time be withdrawn by the secretary or his deputy, if in his opinion a breach of these by-laws has been committed, or if in his opinion it is desirable that the permit be terminated. In the event of termination hereunder the rental paid shall be forfeited to the Board and no compensation shall be paid or claimed for loss, damage, or any inconvenience suffered through the withdrawal of the permit.

(i) Save and except the secretary and the officers and employees of the Board, or any person working under their instructions or any Police Constable, no person shall enter any camping site or camp except with the permission of the permit holder.

(j) No fires shall be lighted on camping sites, except in places approved by the secretary or his deputy.

(k) Except so far as they may be inconsistent with these by-laws the whole of the by-laws now or hereafter made by the Executive Council or the Board to apply to areas under the control of the Board shall apply to camping areas.

5. The Board will not accept any liability or be held responsible for any accident or mishap which may occur to any person or property while on the camping area.

6. Any person offending against any of the provisions of these by-laws shall be liable, on conviction, to a penalty not exceeding £20 in addition to being immediately removed from the camping area and/or suffering or remaining liable to suffer any other penalty or forfeiture prescribed by these by-laws.
