WHEREAS by section 9 of the Fisheries Act, 1905-21, the Governor may by Proclamation prohibit all persons from taking any fish in every or any specified portion of Western Australian waters by means of fishing nets and fishing lines, or either of such means of capture, for any specified term: And whereas by section 10 of the said Act every such Proclamation may be varied or revoked at any time. Now, therefore I, the said Lie-

tenant-Governor, by and with the advice and consent of the Executive Council, do, in exercise of the powers aforesaid and of every other power thereunto me enabling, by this Proclamation revoke the Proclamation dated the 21st November, 1935 (published in the *Government Gazette* of the 29th November, 1935), prohibiting the taking of fish in the whole of the waters of the Swan River and Canning River by means of sunk nets: And I do further, by and with the like advice and consent, prohibit all persons from taking any fish whatsoever by means of sunk nets, that is to say, nets the ground or lead line of which is moved along the bottom and the cork line of which is submerged during the process of hauling, in any portion of the Western Australian waters described in the Locality Schedule hereto, from the date of publication of this Proclamation in the *Government Gazette* until further notice, provided that it shall be lawful to use a sunk net not exceeding as to the length of the whole or of any of the specified parts the lengths respectively set out in the Descriptive Schedule hereto or having meshes in the specified parts less than those so set out by the processes of hauling and bullringing only during the months of May, June, July, August and September in each year.

### Locality Schedule.

The whole of the waters of that part of the Swan River known as Melville Water, being the waters flowing between straight lines drawn from Point Lewis to Point Belches and from Point Resolution to Point Walter, respectively.

### Descriptive Schedule.

Total length of net not exceeding 100 fathoms.  
Length of bunt not exceeding  $3\frac{3}{4}$  fathoms, or one-third of the total length of net, whichever is the less.  
Mesh of wings not less than 3 inches.  
Mesh of bunt not less than 2 inches.

WHEREAS it is enacted by section 38 of the Fire Brigades Act, 1916, that the Governor may make regulations for any of the purposes mentioned in the said section, and also for such other purposes as the Governor may by Proclamation order: And whereas it is deemed desirable and expedient that the purposes in relation to which the Governor may make regulations under the said section shall include, in addition to those already specified in the said section, the following purposes, namely:—

- (a) payment of gratuities to volunteer fire brigades for services in fire prevention and fire protection and in keeping the brigade an efficient force by regular attendances of members at drills, practices and hydrant inspections; and
- (b) regulating the storing in or about buildings and the depositing or keeping in yards or upon vacant land, of inflammable matter likely to be a danger by fire to life or property:

Now, therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act and of all other powers in this behalf me enabling, do hereby order that the following purposes, namely:—

- (a) payment of gratuities to volunteer fire brigades for services in fire prevention and fire protection and in keeping the brigade an efficient force by regular attendances of members at drills, practices and hydrant inspections; and
- (b) regulating the storing in or about buildings and the depositing or keeping in yards or upon vacant land, of inflammable matter likely to be a danger by fire to life or property

shall be purposes within section 38 of the Fire Brigades Act, 1916, for which regulations may be made under the said section for the purposes of the said Act.

WHEREAS under the provisions of the Pharmacy and Poisons Act Compilation Act, 1910, it is provided that the Governor may, by Proclamation, declare any article specified in such Proclamation to be a poison within the meaning of this Act: Now, therefore, I, the Lieutenant-Governor, acting with the advice and consent of the Executive Council, and in accordance with the powers conferred by the said Act, do hereby by this Proclamation declare the following, after deleting the present item appearing in Part I. of the Fifth Schedule, to be substituted in lieu thereof:—

Chloroform in all admixtures or preparations containing more than 0.25 per centum of chloroform, except dentifrices in paste form containing not more than 10 per centum of chloroform.

WHEREAS it is enacted by section 5 of the Road Districts Act, 1919-1934, that for the purposes of the said Act the word "Town" or "Townsite" means and includes inter alia any land (including privately owned subdivided land) which the Governor may see fit, as he is hereby empowered, to declare by Proclamation to be a Town or Townsite for the purposes of the said Act: And whereas all that land situate within the Harvey Road District and more particularly described, defined and delineated in the Schedule hereto is land which the Governor may by virtue of section 5 of the said Act declare by Proclamation to be a Town or Townsite for the purposes of the said Act: Now, therefore I, the said Lieutenant-Governor, acting by and with the advice and consent of the Executive Council and in exercise of the power conferred upon me by the said Act and of all other powers in this behalf enabling me, do hereby declare that all that land situate within the Harvey Road District and more particularly described, defined and delineated in the Schedule hereto shall be a Townsite, to be known as "Brunswick Junction," within the meaning and for the purposes of the Road Districts Act, 1919-1934.

#### Schedule.

All that portion of Wellington Location 1 situated at Brunswick Junction bounded by lines commencing at the intersection of the western side of Ommanney road with the left bank of the Brunswick River (L.T.O. Diagram 4346) and extending eastward along said river bank to the western side of the South-Western Railway Reserve; thence southward along part of said side of railway reserve to the northern side of Clifton road; thence eastward along part of the northern side of Clifton road to a south-eastern side of the Collie Railway Reserve; thence north-eastward along said side of the Collie Railway Reserve to the north corner of Lot 1 as shown on L.T.O. Diagram 573; thence south-eastward and southward along north-eastern and eastern boundaries of said Lot 1 and eastward along part of the

northern side of Clifton road to the production north-eastward of the south-eastern side of Brunswick road; thence south-westward along said side of Brunswick road to the south-western side of Rose road; thence north-westward along said side of Rose road and its production north-westward to the western side of Ommanney road; thence northward along part of the western side of Ommanney road and westward along the southern boundary of Lot 123 (L.T.O. Plan 2660) to the western side of Sommers road; thence northward along said side of Sommers road (L.T.O. Diagrams 10293 and 10292) to a south-western boundary of part of Lot 25 (L.T.O. Diagram 2158); thence northward through said part of Lot 25 to the north-eastern side of Clifton road at the western corner of Lot 9 (L.T.O. Diagram 10133); thence north-eastward along the north-western boundary of said Lot 9 and south-eastward along its north-eastern boundary and the north-eastern boundaries of Lots 8 to 5 inclusive and 12 to 10 inclusive (L.T.O. Diagrams 10133 and 10495) and north-eastward along the north-western boundaries of Lots 3 and 4 and south-eastward along the north-eastern boundary of the last-mentioned (L.T.O. Diagrams 8924 and 9801) to the north-western side of Ommanney road; thence north-eastward along the north-western side of Ommanney road to the starting point.

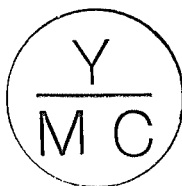
