Entrance Channel to Fremantle Inner Harbour.

Dredging Operations and Alteration in position of Light Buoy.

Details—Owing to the commencement of dredging operations in connection with the widening of the seaward approach to the Entrance Channel, the outer or westernmost green light has been temporarily moved approximately 600 feet further westward along the southern line of the Channel.

The following dredging marks have been erected and should not be mistaken for navigation marks:—

A triangular beacon surmounted by a fixed red light at night at a height of 7 feet 6 inches, at the west end of South Mole and north of the existing Mole light tower.

An inverted triangular beacon surmounted by a fixed red light at night, at a height of 16 feet, on the foreshore adjacent to and south of the Slipway, Arthur Head.

Both of the said fixed red lights will be screened from northward and will be visible only from westward through southward to eastward.

4. (a) The Board may appoint any servant of the Board an inspector under these by-laws.

 (b) Every inspector may demand the name and address of any person whom he considers or suspects to be guilty of a breach of any of the provisions of these by-laws, and such person shall comply with such demand.

 (c) Any inspector may order any person in charge of any horse or dog which is on the foreshore or in the water of the river or on the lands of the Board in contravention of by-law 3 hereof to remove such horse or dog from such prohibited area, and such porson shall or dog from such prohibited area, and such person shall forthwith remove such horse or dog accordingly, without affecting his liability to be prosecuted subsequently by reason of the horse or dog being on such prohibited area.
- 5. Any person not complying with or offending against any of these by-laws shall be guilty of an offence and shall be liable for every such offence to a penalty not exceeding £10.

PROCLAMATION

WESTERN AUSTRALIA, | By His Excellency Sir James Mitchell,
TO WIT. | K.C.M.G., Lieutenant-Governor in and
over the State of Western Australia
its Dependencies in the Commonwealth of Australia.

WHEREAS it is enacted by section 15 of the Wheat Products (Prices Fixation) Act, 1938, that the Governor may from time to time, on the recommendation of the Wheat Products Prices Committee, by Proclamation fix minimum prices and maximum prices at which any of the substances included in the definition of wheat products may be sold in the State, or in any specified part of the State, by any person: And whereas the said Wheat Products Prices Committee has recommended the fixation in accordance with the scale hereunder of the prices (to be both the maximum and the minimum) at which bread may be sold by any person in the Metropolitan Area of the State: Now, therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council and in pursuance of the said recommendation, and in exercise of the powers conferred by the said Act, do by this Proclamation fix the prices (to be both the maximum and the minimum) at which the various kinds of bread specified hereunder, being wheat products within the meaning of the said Act, may be sold by any person in the Metropolitan Area of the State as hereunder: Provided the prices declared in this Proclamation shall not apply to bread sold under contract to public charitable or Government institutions:—

C.—(i) The term "wholesale" shall apply to the sale at the rate of not less than one hundred and twenty 2 lb. loaves per week to the one purchaser, when such sale is made by the baker, and to the resale at the rate of not less than fifty 2 lb. loaves per week to the one purchaser, when the resale is made by the person who purchased them from the baker.

(ii) The term "cash" shall apply to sales in relation to which payment is made in cash at time of sale or regularly at fortnightly payment periods.

(iii) The Metropolitan Area shall be that portion of the mainland within a radius of 25 miles of the General Post Office, Perth.

This Proclamation shall take effect on and from the seventh day of January, 1939.
