WHEREAS by section 8 of the Fisheries Act, 1905-21, it is provided that the Governor may by Proclamation prohibit all persons from.—(a) taking fish of any specified species by any specified means of capture; (b) taking any fish whatsoever by any specified means of capture; (c) taking any fish whatsoever by any means of capture whatsoever, in any specified portion of Western Australian waters, during any specified time in any specified year, or during a specified portion of any year: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the power aforesaid and of any

other power enabling me in this behalf, proclaim and declare as follows:—That the whole of that portion of Western Australian waters known as Leschenault Inlet shall be closed against the use of fishing nets as from the day of publication hereto until the 31st day of December, 1940, inclusive: provided that, subject to the provisions set out in the Proclamation dated 20th December, 1916 (published in the Government Gazette of the 22nd December, 1916) and amended by Proclamations dated 8th July and 27th October, 1931, respectively, it shall be lawful to fish within the waters of the said Leschenault Inlet north of a line drawn from the southwestern corner of Leschenault Location 24 to the northwesternmost part of Point Douro from four o'clock p.m. on Monday to eight o'clock a.m. on Tuesday, from four o'clock p.m. on Tuesday to eight o'clock a.m. on Wednesday, and from four o'clock p.m. on Thursday to eight o'clock a.m. on Friday in each week.

WHEREAS by section 9 of the Fisheries Act, 1905-21, it is provided that the Governor may by Proclamation prohibit all persons from taking any fish whatsoever, in every or any specified portion of Western Australian waters, by means of fishing nets and fishing lines or either of such means of capture, or by any other specified means of capture, for any specified term: Now, therefore I, the said Lieutenant-Governor, do hereby, in exercise of the powers aforesaid and of every other power enabling me in this behalf, proclaim and declare as follows:—That all those portions of Western Australian waters defined in the Schedule hereto shall be closed against the use of fishing nets for a period of three years as from the date of publication of this Proclamation in the Government Gazette.

Schedule.

All that area of Western Australian waters at City Beach extending one hundred and fifty yards in each direction from the Groyne and to a width of one-half mile from high-water mark.

WHEREAS it is enacted by section 5 of the Road Districts Act, 1919-1938, that for the purposes of the said Act the word ''Town'' or ''Townsite'' means and includes *inter alia* any land (including privately owned subdivided land) which the Governor may see fit, as he is hereby empowered, to declare by Proclamation to be a Town or Townsite for the purposes of the said Act: And whereas all that land situate within the Bayswater Road District and more particularly described, defined, and delineated in Schedules A, B, and C hereto is land which the Governor may by virtue of section 5 of the said Act declare by Proclamation to be a Town or Townsite for the purposes of the said Act: Now, therefore I, the said Lieutenant-Governor, acting by and with the advice and consent of the Executive Council, and in exercise of the power conferred upon me by the said Act and all other powers in this behalf enabling me, do hereby declare that all those areas of land situate within the Bayswater Road District, and more particularly described, defined, and delineated in Schedules A, B, and C hereto, shall be Townsites, to be known as "Bedford Park," "Meltham Heights," and "Oakleigh," respectively, within the meaning and for the purposes of the Road Districts Act, 1919-1938.

The Proclamation published in the Government Gazette on the 18th day of June, 1937, is hereby repealed.

SCHEDULE A.

Bedford Park.

All that portion of Bayswater Road District bounded on the north-eastward by a line commencing on the district boundary at the intersection of the south-western side of The Strand with the south-eastern side of old Guildford road and extending south-eastward along said side of The Strand to its intersection with the centre of Hay street (L.T.O. Plans 2703 and 4661); on south-eastward by a line commencing at the said intersection and extending south-westward along the centre of Hay street to the district boundary; on the south-westward and north-westward by lines extending north-westward and north-eastward along parts of the district boundary from the last-mentioned point to the starting point.

Meltham Heights.

Plan 1558) to the centre of Coombe street; thence south eastward along the centre of Coombe and Cox streets to the latter's intersection with the district boundary; on the south-westward by part of the district boundary from the centre of Cox street to the centre of Hay street and on the north-westward by the centre of Hay street from the last mentioned point to the starting point.

SCHEDULE C.

Oakleigh.

All that portion of Bayswater Road District bounded on the north-eastward by a line commencing at the intersection of the production north-westward of the south-western boundary of Lot 13 of Swan Location V with the centre of South erescent (L.T.O. Plan 2683) and extending south-eastward along said production and south-western boundary, the south-western boundary of Lot 43 and the south-western side of Milne street to the right bank of the Swan River (district boundary); on the south-eastward and south-westward by parts of the district boundary from the lastmentioned point to the centre of Cox street; on the north-westward by lines commencing at the intersection of the district boundary with the centre of Cox street and extending along the south-eastern boundary of Meltham Heights to the starting point.

WHEREAS it was enacted by section 2 of the Workers' Compensation Act Amendment Act, 1924 (No. 40 of 1924), that it shall not be necessary to proclaim that the whole of the Workers' Compensation Act, 1912-1924, now the Workers' Compensation Act, 1912-1938, shall Now the workers' Compensation Act, 1912-1938, snam come into operation on one date, but the several sections and schedules may be proclaimed to come into operation on such dates as are respectively fixed by Proclamation: And also that the Governor may by such Proclamation limit the operation of section 5, now section 7 in the said Workers' Compensation Act, 1912-1938, so far as it extends to the diseases mentioned in the first column of the Third Schedule set opposite to the words "mining or quarrying or stone crushing or cutting" as the deor quarrying or stone crushing or cutting" as the de-scription of process in the second column of the said schedule to any defined portion of the State, and may by any subsequent Proclamation extend the operation as aforesaid of that section to any other defined portion of the State: And whereas section 7 aforesaid of the Workers' Compensation Act, 1912-1938, and the Third Schedule to such Act (inclusive of the diseases men-tioned in the first column of the said Schedule set oppo-site to the words "mining or quarrying or stone crush-ing or cutting" as the description of process in the second column of the said Third Schedule) have been from time to time brought into operation in certain from time to time brought into operation in certain defined portions of the State only, being areas within the boundaries of certain goldfields and mineral fields: And whereas it is now deemed further to extend the operation of the said section 7 and the said Third Schedule as hereinafter mentioned: Now, therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the consent of the Executive Council and in exercise of the power conferred upon me as aforesaid, do hereby proclaim that section 7 of the Workers' Compensation Act, 1912-1938 (being the section inserted in the principal Act as sec-tion 6A by the Workers' Compensation Act Amendment Act, 1924) shall, inclusive of the diseases mentioned in the first column of the Third Schedule to the said Workers' Compensation Act, 1912-1938, set opposite to the works ('mining or quarving or stone crushing or the words "mining or quarrying or stone crushing or cutting" as the description of process in the second column of the said Third Schedule, come into operation forthwith upon the publication of this Proclamation in the Government Gazette in the following Goldfield, that is to say, Pilbara Goldfield.

chains herein referred to being ascertained by meas-uring at right angles to the course of the said road. 1B. The erection, keeping, and maintenance of piggeries within the Wanneroo Road District in areas, other than those prohibited in the last pre-ceding by-law, shall be lawful; subject to the pro-visions of the following by-laws:—
