Part 1.

All that portion of land bounded on the east by part of the western boundary of Nelson Location 2672; on the south by the northern boundaries of Locations 7819 and 11283, and on the north by the southern side of Public Road No. 3067, as shown on original Plan 3896 as registered in the Department of Lands and Surveys.

Part 2.

All that portion of land bounded on the east by the western boundary of Nelson Location 11283, a public road, and part of the western boundary of Location 2116, on the south by the northern boundaries of Locations 5634 and 8927, and on the north by the southern side of Public Road No. 3067, as shown on original Plan 3896 as registered in the Department of Lands and Surveys.

The Metropolitan Water Supply, Sewerage, and
Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 828/34.

WHEREAS by the Metropolitan Water Supply, Sewerage, and Drainage Act, 1909, it is provided that the Governor may by Order in Council alter or extend the boundaries of the Metropolitan Water Supply, Sewerage, and Drainage Area, or of any district: And whereas it is desirable that the boundaries of Metropolitan Stormwater Districts Nos. 2 and 1 as at present defined should be altered: Now, therefore I, the Lieutenant-Governor, acting by and with the advice of the Executive Council, do hereby alter the boundaries of Metropolitan Stormwater Districts Nos. 2 and 1, and declare that the said boundaries (as shown on Plans M.W.S.S. & D.D., W.A., Nos. 3449 and 2545) and as described in Order in Council of 18th June, 1919, and subsequent amendments, shall be altered in the following manner, by deleting the area described hereunder from Metropolitan Stormwater District No. 1 and including it in Metropolitan Stormwater District No. 2.

Schedule.

Commencing at a point in the centre of the railway reserve opposite the centre of Veitch street and proceeding in a generally south-easterly direction across the railway reserve to and across South crescent and along the centre of Veitch street and its prolongation to the centre of Murray street; thence south-west along the centre of Murray street to a point opposite the centre of Georges street; thence south-east across Murray street and along the centre of Georges street to a point opposite the south-eastern boundary of Lot 9, Glyde street; thence south-west across Georges street and along the south-eastern boundaries of Lots 9, 8, and 7, Glyde street, and the north-western boundary of Lot 29, Hill street, to the northern corner of Lot 32, Leake street; thence south-east along the north-eastern boundaries of Lots 32, 31, and 30, Leake street, to and across Hill street and along the centre of the first right-of-way north-east of Leake street to the centre of the right-of-way between Hill street and Almondbury road; thence north-east along the centre of the said right-of-way to a point opposite the north-east boundary of Lot 8, Leake street, between Hill street and Almondbury road; thence south-east along the north-eastern boundaries of the said Lot 8 and Lot 9, Leake street, to and across Almondbury road and along the north-eastern boundaries of Lots 10 and 11, Leake street, to the west corner of Lot 14, Nanhob street; thence north-east along the north-western boundaries of the said Lot 14 and Lot 17, Nanhob street, to the north corner of the said Lot 17; thence south-east along the north-eastern boundary of the said Lot 17 and its prolongation to the centre of Nanhob street; thence north-east along the centre of Nanhob street to a point opposite the north-eastern boundary of Lot 32, Nanhob street; thence south-east across Nanhob street and along the north-eastern boundary of the said Lot 32 to its eastern corner; thence south-west along the south-eastern boundary of the said Lot 32 to the northern corner of Lot 11, Georgina street; thence south-east along the north-eastern boundary of the said Lot 11 and its prolongation to the centre of Georgina street; thence south-west along the centre of Georgina street to a point opposite the north-eastern boundary of Lot 19, Leake street, between Georgina and Walton streets; thence south-east across Georgina street and along the north-eastern boundaries of the said Lot 19, and Lots 20 and 21, Leake street, and their prolongation to the centre of Walton street; thence south-west along the centre of Walton street to a point opposite the north-eastern boundary of Lot 8, Leake street, between Walton street and Perth-Guildford road; thence south-east across Walton street and along the north-eastern boundaries of the said Lot 8 and Lots 7 to 3, inclusive, Leake street, to the eastern corner of the said Lot 3; thence north-east along the north-western boundary of Lot 2, Perth-Guildford road, between Leake street and Wisbech street to the northern corner of the said Lot 2; thence south-east along the north-eastern boundary of the said Lot 2 and its prolongation to the centre of Perth-Guildford road; thence westerly along the centre of Perth-Guildford road to the centre of Leake street; thence south-east across Perth-Guildford road and along the centre of Leake street to a point opposite the centre of Williamson street; thence south-west across Leake street and along the centre of Williamson street to a point opposite the centre of the right-of-way between Leake street and Roberts street; thence south-east across Williamson street and along the centre of the said right-of-way to a point opposite the south-eastern boundary of Lot 642, Roberts street; thence south-west across the said right-of-way and along the south-eastern boundary of Lot 642, Roberts street, and its prolongation to the centre of Roberts street; thence south-east along the centre of Roberts street to a point opposite the south-eastern boundary of Lot 588, Roberts street; thence south-west across Roberts street and along the south-eastern boundary of the said Lot 588 to the centre of the right-of-way between Roberts street and Milne street; thence south-east along the centre of the said right-of-way to a point opposite the south-eastern boundary of Lot 578, Milne street; thence south-west across the said right-of-way and along the south-eastern boundary of Lot 578, Milne street, and its prolongation to the centre of Milne street; thence north-west along the centre of Milne street to the centre of Williamson street; thence south-west along the centre of Williamson street to the centre of Garratt road; thence south-east along the centre of Garratt road to a
