PURSUANT to section 6 of the Bank Holidays Act, 1884, I, the said Lieutenant-Governor, with the advice and consent of the Executive Council, do hereby proclaim and declare that it is inexpedient that the day appointed by the Bank Holidays Amendment Act, 1899, as a Bank Holiday (that is to say the 18th day of December, 1939) for the observance of the birthday of His Majesty King George the Sixth, which falls on the 14th day of December, 1939, should be observed on such first-mentioned date, and I appoint the 13th day of November, 1939, as a bank holiday instead of such first-mentioned day.

WHEREAS it is provided by the Game Act, 1912-13, that the Governor may by Proclamation declare from time to time that any bird or animal indigenous to Western Australia shall be at all times strictly preserved, either generally throughout the State or in any one or more portions thereof, and that the Governor may in like manner exempt from the operations of any such declaration under the said Act any defined locality: And whereas by a Proclamation dated the 30th day of July, 1929, and published in the *Government Gazette* on 2nd August, 1929, it is proclaimed and declared that

the close season for Finches and Weaver Finches (exclusive of Silver-eyes) in those portions of District "G" (namely, the Kimberley Division as defined in the Land Act, 1898), mentioned and described in the said Proclamation, shall be the period commencing on the 1st day of September and ending on the 31st day of December in each year: And whereas it is desirable to exempt from the operations of the said Proclamation a defined locality, namely, that portion of the said district comprised within an area outside a radius of 20 miles from the Wyndham Police Station: Now, therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers aforesaid and of every other power enabling me in this behalf, do hereby proclaim and declare that so much of District "G," namely, the Kimberley Division as defined in the Land Act, 1898, as is comprised within an area outside a radius of 20 miles from the Wyndham Police Station shall be and is hereby exempted from the operations of the aforesaid Proclamation for a period commencing on the 1st day of October, 1939, and ending on the 31st day of December, 1939.

Metropolitan Sewerage, Perth District, Reticulation Area No. 48:—18-inch, 6-inch, and 4-inch diameter pipe sewers, with manholes and all other apparatus connected therewith, between Railway crescent and Chatham street and Normanby street and Drummond street, as shown in blue on Plan M.W.S.S. & D.D., W.A., No. 6340.

Every subscriber, his wife and dependants under 16 years of age, shall be entitled to hospital accommodation and treatment, including medicines and dressings free of charge, whilst in hospital for a period of sixty days, in the aggregate, in any one year. This fund does not provide for doctors' or surgeons' fees, nor for X-rays. This fund only applies to accommodation and treatment at the Harvey District Hospital. A period of one month as from the date of joining must elapse before any subscriber is entitled to benefits.

6. Rule 11 is amended by deleting from the third line thereof the figures "21" and inserting in lieu thereof the figure "7."

7. Rule 15 is repealed and a new rule is substituted in lieu thereof as follows:—

15. The appointment of the secretary shall be terminable by one month's notice on either side.

8. Rule 16 is repealed and a new rule is substituted in lieu thereof as follows:—

16. An auditor, who shall not be a member of the Board, may be appointed by the Board.

9. Rule 21 is repealed and a new rule is substituted in lieu thereof as follows:—

21. The Board shall nominate a person to fill any vacancy that may occur during the year within two months of such a vacancy occurring.

10. Rule 24 is repealed and a new rule is substituted in lieu thereof as follows:—

24. The Board of Management shall appoint from amongst themselves a House Committee, to consist of the chairman and one other member, both of whom shall be town members. They shall attend to the internal management of the hospital and such other matters as shall be delegated to them. They shall make a monthly inspection on a day closely preceding the day of the monthly Board meeting, and shall furnish monthly reports to the Board of Management.

11. Rule 28 is amended by deleting the sentence beginning in the tenth line with the word "She," and ending in the last line with the word "pay."

12. Rule 29 is amended by deleting the two sentences commencing in the sixth line with the word "The" and ending in the last line with the word "matron," and inserting in lieu thereof the words, "All nurses shall reside on the premises."

13. Rule 30 is amended by deleting from the last line but one the word "seven" and inserting in lieu thereof the word "Fourteen."

14. Rule 31 is amended by adding to the end thereof after the word "either" a new sentence as follows:—

Any patient or visitor whose conduct does not conform to the reasonable request of the medical officer or matron shall, if necessary, be asked to leave the Hospital.

IN pursuance of the powers in that behalf contained in the Municipal Corporations Act, 1906-38, the Lord Mayor and Councillors of the City of Perth hereby make a by-law, to be numbered 6, as follows:—

1. In this by-law "offensive noise" means any noise, whether made by the human voice or by any gramophone amplifier, wireless appliance, bell, or other instrument or appliance which causes or is likely to cause a nuisance or inconvenience in the nature of a nuisance to occupiers of neighbouring premises or to persons using any street or public place.

2. No person shall on any land or on or in any building cause or permit to be caused any offensive noise for advertisement purposes.

3. No person shall in any street, way, or public place cause any offensive noise for advertisement purposes.

4. No person shall, without the written permission of the Town Clerk, address the public in any street, way, or public place for advertisement purposes, and whether such person shall be in a street, way, or public place or on premises adjacent thereto.

- (d) Cream-ripening rooms.—Cream shall be ripened in vats held in rooms specially protected from flies, and, in the absence of a special room, either the cream vats themselves or all the windows in the manufacturing rooms of the factory shall be protected from flies in a manner approved by an inspector, and also such cream vats shall be placed on a floor or stage made of impervious material.
- (e) Ventilation.—Cream-ripening rooms, butter-making rooms, butter store-rooms, cheese-manufacturing rooms and cheese-curing rooms shall be so ventilated that a reasonably pure atmosphere always obtains therein.
- (f) Water.—Water used for the washing of butter shall be obtained from a pure source, shall be free from avoidable organic matter and from deleterious mineral matter.
- (g) Cream receiving platforms.—The platform on which cream is received in cans shall be constructed of an impervious material, or of wood thoroughly caulked so that it will be practically impervious.
- (4) Can storage accommodation.—At every factory, store, or depot there shall be provided suitable storage accommodation for such cream cans as are not sent out daily to suppliers. The accommodation shall be of a character which will enable the cans to drain, and which will also admit of plenty of pure air. Such accommodation may take the form of a special can house, or the cans may be stored in racks over a verandah with a floor made of impervious material and protected by a lean-to roof or other similar arrangement approved by an inspector.
- (5) Cool-storage rooms.—The cool-storage rooms in butter factories, stores or depots shall be kept free from unnecessary moisture; and any drip from thawing ice shall be carried away in suitably arranged open guttering.
- (6) Can-washing accommodation.—Suitable can-washing accommodation shall be provided in every factory, store or depot; and shall include a supply of both hot and cold water and shall be situated outside the manufacturing and packing rooms.
- (7) Disposal of sewage.—Factory sewage shall be disposed of and in a manner which will preclude the possibility of such sewage contaminating the atmosphere surrounding the factory. Open concrete drains shall, wherever possible, be used for carrying away factory washings.
- (8) Butter-milk tanks.—Tanks used for the purpose of holding butter-milk at dairy produce factories shall be so constructed that they can be easily cleaned. Butter-milk shall be removed from the same daily, and the tanks shall be kept in a clean and sweet condition. Where such tanks are elevated the space underneath the same shall be concreted and graded so that the drip may be washed away without causing offence.
- (9) Curing rooms.—Curing rooms in cheese factories shall be so constructed as to enable an atmosphere not exceeding 60 degrees Fahrenheit to be maintained.
- (10) Protection from flies.—The manufacturing room of a cheese factory shall have all the doors and windows thereof fitted with fly-proof metal gauze.
- (11) Whey tanks.—All tanks used for holding whey in connection with cheese-making shall be situated at a distance of not less than 25 yards from the factory: Provided that, when a farmer manufactures cheese from milk obtained only from his own dairy herd, the distance of the whey tank from the factory need not be more than 10 yards.
- (12) Atmosphere—
- (a) No dairy produce factory, store or depot shall be passed by an inspector for registration under this Act if through proximity to any noxious trade centre or through any other cause whatsoever the atmosphere surrounding the factory, store, or depot becomes tainted in a manner which can be detected by the sense of smell.
- (b) No store shall be registered as suitable for the storage of butter if in the opinion of an inspector the atmosphere therein is tainted to an extent noticeable by the sense of smell by an odour which, when absorbed, would be detrimental to the flavour of the butter.
- (13) Lighting.—The milk testing room, the cream testing room, and the manufacturing room in every butter factory and in every cheese factory shall be sufficiently well lighted to enable accuracy to be assured in all operations.
- (14) Size.—The manufacturing room shall have a floor space of at least 236 square feet, and the height between the floor and the lowest portion of the roof shall be at least 12 feet.
- (15) Storage of cheese for sale.—Where cheese is stored for sale, it must be kept on shelves and at a temperature below 80 degrees Fahrenheit.
- (16) Storage of butter for sale.—Where butter is exposed for sale the temperature of the store in which it is so exposed shall not exceed 70 degrees Fahrenheit.
- (17) Thermometers—
- (a) Every room or chamber used in a dairy produce factory, store, or depot for the storage or holding of dairy produce shall be equipped with a thermometer which accurately registers the temperature of such room or chamber.
- (b) Where thermometers are necessary for use in milk or cream in the manufacture of any dairy produce, such thermometers shall be enclosed in an unbreakable material approved by the Superintendent of Dairying.

SCHEDULE—continued.

Regulation No. *Gazette Notices.*

Amendments of Regulations.

(18) Strainers.—The manager of every dairy produce factory shall cause to be inserted on the cream line between the pasteuriser and the holding vat, and between the holding vat and the churn, an approved strainer having a mesh or openings of not more than one-eighth of an inch.

New regulation

.. New regulations are inserted after regulation 69 as follows:—

Marking of Cheese.

69A. (1) The manufacturer of cheese shall mark in plain legible figures on the side of every cheese manufactured by him as soon as it has been removed from the hoop the date of manufacture and the sequence number of the batch of that date in which it was made.

(2) Before despatch to market the manufacturer of every cheese shall cause the original marking thereon to be reproduced by stencil or stamp on the side thereof in plain figures not less than ½-inch in length, and shall place thereon the factory brand and/or the identification letter of symbol allotted to the factory.

Marking of Cheese Crates.

69B. All crates containing cheese shall be marked by the manufacturer of such cheese on both ends of the crate, in prominent and legible characters, with the following information and in the manner indicated by the illustration hereunder:—

- (1) The word “coloured” stamped in red ink or the word “white” stamped in violet ink, as the case may be, applied by means of a rubber stamp in letters three-quarters of an inch high and three-thirty-seconds of an inch thick.
- (2) A true description of the variety of the cheese.
- (3) Figures seven-eighths of an inch high and one-eighth of an inch thick stamped in violet ink above the trade description by means of a rubber stamp, indicating in one line the number of the vat and the date of manufacture, and immediately below that line the number of crates from the vat.
- (4) Figures indicating the number of the crate applied to the ends of the crate below the word “coloured” or “white” as the case may be.

Cheese Packing.

69C. (1) Only cheeses of the same quality and manufactured on the same date and from the same batch shall be packed together in the same crate by the manufacturer packing the same:

Provided that, where it is unavoidable, odd cheeses may be packed together in the same crate, but in such instances markings shall be placed on the side of the crate clearly indicating the contents of the crate and the position in the crate of each different make of cheese.

(2) Every crate used by a manufacturer for containing cheese shall be provided with scale boards of pine or other material approved by an inspector, to prevent the cheese from adhering to the ends or centre boards of the crate.

(3) Cheese packed for export shall be so packed as not to allow excessive space in the crate.

(4) (a) Cheeses intended for export to overseas and interstate markets shall be graded and packed at the factory before being despatched.

(b) Cheeses intended for local sale may be despatched from the factory without being packed, provided they are placed on shelves or placed singly on the floor of the conveyance in which they are carried from the factory.

Standard Cheese Crate.

69D. A standard crate for the packing of export cheese shall be in accordance with the specifications as laid down in the Second Schedule Statutory Rules, 1938, No. 56 of the Regulations of the Commerce Act, 1901-1936 (Commonwealth), and the Commerce Trade Descriptions Act, 1905-1933 (Commonwealth).

Control of Whey.

69E. No person shall remove any whey from any cheese factory in any receptacle used or which may be used for containing milk or cream unless forthwith after reaching its destination the whey is removed from such receptacle and the receptacle is washed with warm water and finally treated with steam or boiling water.

Containers and Markings.

69F. (1) No person shall use any package as a container of any dairy produce unless such package is clean and suitable for the purpose.

(2) All markings used or placed upon any package used as a container as aforesaid shall be neat and plain and of a reasonably permanent nature.

THE WHALING ACT, 1937.

Regulations.

1. These regulations may be cited as the Whaling Act Regulations, 1939.
2. In these regulations, unless the contrary intention appears, "the Act" means the Whaling Act, 1937.

Prescribed length of Whales.

3. The following lengths of whales are prescribed in pursuance of subsection (3) of section 9 of the Act:—
Blue whales—70 feet.
Fin whales—55 feet.
Humpback whales—35 feet.

Prescribed Authorities under Section thirteen.

4. The Chief Inspector of Fisheries shall be the prescribed authority for the purposes of section 13 of the Act.

Applications for Licenses.

5. (1) An application for a license under the Act shall be made in writing, and shall be forwarded with the appropriate license fee, as prescribed in section 13 of the Act, to the Chief Inspector of Fisheries.

(2) Where the application relates to a ship, it shall be signed by the owner or charterer of the ship, who shall specify in the application the name of the ship and the port of registry of the ship, the names of the registered owner and master respectively, and the number of catchers or chasers attached to the ship.

(3) Where the application relates to a factory, it shall be signed by the occupier of the factory, who shall furnish in the application full particulars with regard to the location and capacity of the factory.

Issue of Licenses.

6. (1) A license issued to the owner or charterer of a ship to engage in taking or killing whales shall be in accordance with Form 1 in the Appendix to these regulations.

(2) A license issued to the owner or charterer of a ship or to the occupier of a factory to engage in treating whales shall be in accordance with Form 2 in the Appendix to these regulations.

Conditions as to grant of Licenses.

7. A license to engage either in taking or killing whales, or in treating whales, shall be granted upon and subject to the following conditions, which shall be in addition to those specified in section 14 of the Act:—

(a) That neither the licensee, nor any person employed by him, shall take, kill, snare, or wound in any way any birds, fish, or seals, or take any eggs,

except for the purpose of providing food for the persons on board the licensed vessel, or on the whale catchers or chasers attached thereto, or the persons employed at the licensed factory;

- (b) That, in the case of a ship or factory licensed for the purpose of treating whales, there shall not be delivered to the ship or factory a greater number of whales than can be treated by the plant therein, efficiently and in accordance with the conditions contained in paragraphs (a), (b) and (c) of subsection (1) of section 14 of the Act, within a period of forty-eight hours after such delivery;
- (c) That the plant used in the ship or factory for the extraction of oil from the blubber, flesh, and bones of whales shall be maintained in good order and operated efficiently, and shall be capable of converting any whale into commercial produce within forty-eight hours of its delivery to the ship or factory.

Returns.

8. (1) The return which shall be furnished each year by the owner or master of a ship licensed to engage in taking or killing whales, in pursuance of paragraph (c) of subsection (1) of section 14 of the Act, shall be in accordance with Form 3 in the Appendix to these regulations.

(2) The return which shall be furnished in each year by the owner or master of any ship or the occupier of any factory licensed to engage in treating whales, in pursuance of section 16 of the Act, shall be in accordance with Form 4 in the Appendix to these regulations.

(3) The returns referred to in this regulation shall be forwarded by the owner or master of the ship, or by the occupier of the factory, as the case may be, to the Chief Inspector of Fisheries, at the earliest possible opportunity after the conclusion of the whaling operations of each season.

Accommodation and subsistence Fees for Officers.

9. The sum to be paid, pursuant to subsection (2) of section 20 of the Act, to the owner or master of a ship in respect of each day on which an officer remains on board and is provided with subsistence and accommodation shall be six shillings.
