WESTERN AUSTRALIA, (By His Excellency Sir James Mitchell, TO WIT. K.C.M.G., Lieutenant-Governor in and over the State of Western Australia and its Dependencies in the Commonwealth of Australia.

Health Act, 1911-1937 (as reprinted under the Amendments Incorporation Act, 1938).

ORDER IN COUNCIL.

WHEREAS it is enacted by section 20 of the Health Act, 1911-1937 (as reprinted under the Amendments Incorporation Act, 1938), that a local board of health shall consist of not more than seven members, to be appointed from time to time by the Governor, and that three members of a local board shall constitute a quorum: And whereas it is enacted by subsection (11) of section 20 aforesaid that the Minister may at any time direct by notice published in the Government Gazette that after the expiry of the term of office of the then existing members of any local board of health named in the notice, the members of such board shall for the future be chosen by election: And whereas the Governor, acting in pursuance of section 20 of the said Act, appointed seven persons to be the members of the Youanmi Local Board of Health under and for the purposes of the said Act, and in accordance with section 20 aforesaid the terms of office of all the said members expired on the 31st day of May, 1939: And whereas the Minister, acting pursuant to subsection (11) of section 20 aforesaid, by notice published in the

Government Gazette on the 21st day of April, 1939, directed that after the said 31st day of May, 1939, the members of the Youanmi Local Board of Health as then constituted shall for the future be chosen by election Instead of being appointed by the Governor as hitherto:
And whereas, at an election held on the 3rd day of
June, 1939, to elect the members of the Youannii Local
Board of Health in the place of the members hitherto
appointed by the Governor as aforesaid, whose terms
of office expired on the 31st day of May, 1939, as aforesaid, only five persons were nominated and elected to be such members as aforesaid: And whereas it is now deemed desirable and expedient to reduce the number of members to constitute the Youanmi Local Board of Health from seven to five: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act and of all other powers in this behalf him enabling, doth hereby declare and direct that as from and after the 31st day of May, 1939, the Youanni Local Board of Health constituted under and for the purposes of the Health Act, 1911-1937, shall be deemed to have consisted of and shall consist of five members instead of seven members as hitherto, and that the number of members to constitute the said Youanmi Local Board of Health shall be reduced accordingly.

Bulk Handling Act, 1935. ORDER IN COUNCIL.

Agric. No. 376/13, Vol. V. WHEREAS it is enacted by the proviso to subsection (1) of section 20 of the Bulk Handling Act, 1935, that the Governor may by Order in Council published in the Government Gazette vary from time to time all or any of the terms and conditions prescribed in the Second Schedule to the said Act: And whereas by an Order in Council dated the 13th day of November, 1936, Condition 6 prescribed in the said Second Schedule was amended: And whereas it is now deemed desirable and expedient further to vary the said Condition 6 amended as aforesaid in the manner hereinafter mentioned: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the power conferred upon him by section 20 of the said Act, doth hereby vary and amend Condition No. 6 as contained in the Second Schedule to the Bulk Handling Act, 1935, as reprinted in the Appendix to the Sessional Volume of the Statutes for the year 1936 in the manner mentioned in the Schedule hereunder, and doth hereby declare that this Order in Council shall have effect as from the date of the publication thereof in the Government Gazette.

Schedule.

Condition No. 6 in the Second Schedule to the Bulk Handling Act, 1935, as reprinted in the Sessional Volume of the Statutes for the year 1936 is amended as fol-

(a) by deleting subparagraph (b) of paragraph (1) and inserting in its place a new subparagraph

(b) as follows:—
(b) In the event of delivery not being so taken the company shall be relieved of its obligation to deliver the wheat under the warrant, and may at any time thereafter sell a quantity of wheat equivalent to that covered by the warrant, either separately or together, with any other wheat by whichever of the fol-lowing methods seems in the opinion of the company most likely to yield the best price to the grower:-

(i) by public tender advertised in the public

press; or

(ii) at market price as defined in section sixteen of the Act; or

(iii) at the best price the company can obtain overseas.

If the company decides to sell the wheat overseas it may make any shipping arrangements which it considers necessary or advisable.

(b) by adding at the end of subparagraph (c) the words "and (as the case may require), together with all expenses incurred in the shipping and selling of the wheat by the company";

(e) by adding to paragraph (1) after paragraph (d) a new subparagraph, to stand as subparagraph (e) in the place of a subparagraph (e) pre-

viously repealed, as follows:

(e) If arrangements cannot be made for the delivery of wheat remaining in store on the thirtieth day of September in any year, the responsibility of the company in relation to the care of wheat shall, except in the case of wilful negligence on the part of its servants, cease after the said thirtieth day of September. The company may at any time thereafter remove such wheat from the bins in which it is stored to any other safe, secure, and sufficient storage it may select or provide, and hold it in such other storage until it is taken by the warrant holders or sold in accordance with the terms of this condition, and may charge the holders of warrants for such wheat all expenses incidental to such removal and storage and sale.
