Road Districts Act, 1919-1938. Irwin Road District-Redivision into Wards.

# ORDER IN COUNCIL.

P.W. 1470/23.

HIS Excellency the Lieutenant-Governor, acting by and with the advice and consent of the Executive Council under the provisions of the Road Districts Act, 1919.

1938, doth hereby redivide the Irwin Road District (hitherto divided into three Wards) into four Wards, by severing portion of the South-East Ward and conby severing portion of the South-East Ward and con-stituting such portion an additional Ward, to be known as the Denison Ward, the boundaries of which are de-scribed in the Schedule hereunder, and to alter the boundaries of the South-East Ward accordingly; and, consequent upon such redivision, His Excellency the Lieutenant-Governor, acting by and with the said advice and consent, under the provisions of section 20 of the said Act, doth hereby determine that the number of members for each Ward of the said District shall be as follows:—North Ward—3 members; Town Ward—1 member; South-East Ward—2 members; Denison Ward —1 member. —1 member.

#### Schedule.

All that portion of the South-East Ward of the Irwin Road District bounded on the eastward by a line com-mencing on the left bank of the Irwin River at its intersection with the eastern boundary of Victoria Location 317 and extending southward along part of the said boundary and the eastern boundary of the Denison Townsite to the latter's south-eastern corner; on the southward by the southern boundary of said townsite from its said south eastern corner to the district boundary at its south-western corner; on the westward by the district boundary from the last mentioned point to its intersection with the left bank of the Irwin River; on the northward by the left bank of the Irwin River from the said intersection to the starting point.

Reservation of Timber, Ravensthorpe District. Department of Lands and Surveys,

1456/21. Perth, 1st September, 1939.

IT is hereby notified that the Hon, the Minister for Lands has been pleased to include within the "Timber Zone," under clause 18 of the regulations under the above Act, all land within 25 miles of the Ravensthorpe Post Office, and from the date of this notice the conditions regarding the reservation of timber as set out herennder shall apply to all leases of land which is now vacant and any land that may in future be made available for selection within the above area:— All marketable timber on the said lands is reserved

All marketable timber on the said lands is reserved to the Crown, save that the lessee may fell such timber in the ordinary course of *bona fide* clearing for cultivation and use any of such timber felled for his own reasonable requirements in connection with farming operations on the said lands, with full liberty to us, our heirs and successors and persons authorised by us or by any person or corporation in whom the control of forests is for the time being vested to enter, fell and remove the same, and for that purpose or for the purpose of extracting timber from any other land in the locality, full liberty for us and any of the persons aforesaid to pass and repass over the said lands with or without workmen machinery, horses or cattle and to take water from any spring, stream, well or water hole, and to lay down and construct pipe lines for conveying such water, and to make roads and ways and construct and maintain timber tramways on the said lands, subject, however (where such road, way, tramway, or pipe line is for the purpose of extracting timber for conveying water from any other land, in the locality) to no other direct and satisfactory route being available through Crown lands reserves or State forests, without making to the grantee his heirs and assigns any compensation in respect of any of the matters aforesaid: Provided that we, our heirs and successors will make good the actual amount of any structural damage done to any buildings, erections or fences in the exercise of such rights, and where a fence forming part of a cattle or sheep proof enclosure is opened, provide and maintain cattle pits and other efficient means to prevent the escape therefrom of sheep and cattle.
