The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 828/34.

WHEREAS by the Metropolitan Water Supply, Sewerage, and Drainage Act, 1909, it is provided that the Governor may by Order in Council alter or extend the boundaries of the Metropolitan Water Supply, Sewerage, and Drainage Area, or of any district; and whereas it is desirable that the boundaries of Metropolitan Stormwater Districts Nos. 2 and 1 as at present defined should be altered: Now, therefore I, the Lieutenant-Governor, acting by and with the advice of the Executive Council,

do hereby alter the boundaries of Metropolitan Stormwater Districts Nos. 2 and 1 and declare that the said boundaries as shown on Plans M.W.S.S. & D.D. W.A., Nos. 3449 and 2545, and as described in Order in Council of 18th June, 1919, and subsequent amendments, shall be altered in the following manner, by deleting the area described in the Schedule hereunder from Metropolitan Stormwater District No. 1 and including it in Metropolitan Stormwater District No. 2.

Schedule

Commencing at a point on the east side of London street opposite the north boundary of Lot 316, London street, and proceeding north along London street to the north boundary of Lot 4028, London street; thence east along the north boundaries of the said Lot 4028 and Lot 4015, Highland street, to and across Highland street and along the north boundary of Lot 4054 Highland street and Lot 4041, Selden street and their prolongation across Selden street to the centre of Eton street; thence

northerly along the centre of Eton street to a point opposite the north-west boundary of Lot 4081, Eton street; thence north-easterly across Eton street and along the north boundaries of the said Lot 4081 and Lot 4100 Charles street and their prolongation to the east side of Charles street; thence southerly along Charles street to the north-west corner of Lot 212, Charles street; thence west across Charles street and Lot 4092, Charles street, and Lot 4078, Eton street, to and across Eton street, and Lot 4115, Eton street, to and across Selden street and Lot 4045, Selden street, and Lot 4050, Highland street, to and across Highland street, and Lot 4019, Highland street, and Lot 4024, London street, to the east side of London street; thence north along London street to the point of commencement, as shown in green on Plan M.W.S.S. & D.D., W.A. No. 3449.

This Order in Conneil shall take effect from the 27th day of October, 1939.

HIS Excellency the Lieutenant-Governor in Conncil, acting pursuant to section 17 of the Public Service Appeal Board Act, 1920-1937, has been pleased to amend the regulations made under and for the purposes of the said Act and published in the Government Gazette on the 15th day of September, 1939, in the manner set forth in the Schedule hereunder.

- 1. Regulation 3 is amended by deleting from paragraph (3) in the first line thereof the figures "14" and substituting therefor the figures "30."
- 2. Regulation 5 is amended by deleting from paragraph (2) the whole of sub-paragraph (b) and inserting in lien thereof a new subparagraph as follows:—
 - (b) be signed by not less than two persons qualified to vote for the nominee.
 - 3. Regulation 6 is repealed.
 - 4. Regulation 7 is amended:-
 - (a) by numbering the regulation as paragraph (1) of regulation 7;
 - (b) by inserting in the third line thereof after the word "lists" the words "or eards";
 - (c) by inserting in the fourth line thereof after the word "order" the words "and the official address";
 - (d) by inserting in the last line thereof after the letter "a" the word "financial";
 - (e) by adding at the end thereof a new paragraph, to stand as paragraph (2), as follows:—
 - (2) Upon completion of an election, the Returning Officer shall return such cards as may be submitted to him under the provisions of the preceding paragraph to the secretary of the association or union concerned.
- 5. Regulation 8 is repealed and in lien thereof a new regulation is inserted as follows:—
 - 8. (1) Every person who fourteen days prior to the date fixed for receipt of nominations is a financial member of the association or of one of the unions shall be entitled to vote for a representative of the association or union to which he belongs, at an election of such representative.
 - (2) For the purposes of this and the preceding regulation a member shall be deemed financial if he has paid the subscriptions for which he is liable up to the end of the calendar year immediately preceding the year in which the election takes place, or, in the case of an extraordinary election, if he is not more than three months in arrear with his subscription.
 - Regulation 9 is amended—
 - (a) by deleting from paragraph (2) in the first line of subparagraph (a) thereof, after the word "paper," the words "with counterfoil attached";
 - (b) by inserting in paragraph (2) a new subparagraph to stand as subparagraph (b) as follows:—
 - (b) one counterfoil in the Form 4 in the Appendix to these regulations;
 - (c) by relettering subparagraphs (b) and (c) of paragraph (2) as subparagraphs (c) and (d) respectively;
 - (d) by inserting in paragraph (3) in the first line thereof after the first words "'ballot paper' the word "counterfoil."

- 7. Regulation 10 is amended by deleting therefrom the words "shall detach the counterfoil from the ballot paper" in lines two and three of the regulation.
 - 8. Regulation 11 is amended-
 - (a) by deleting paragraphs (a) and (e);
 - (b) by relettering paragraphs (b), (c), and (d) as (a), (b), and (c) respectively.
- 9. Regulation 13 is repealed and a new regulation is inserted in lien thereof as follows:—
 - 13. The Returning Officer shall, as soon as practicable after the hour fixed for the closing of the poll, proceed with the scrutiny and count of votes received.
- 10. A new regulation, to stand as regulation 16A, is inserted after regulation 16 as follows:--
 - 16A. The Returning Officer and the officers employed by him, while engaged on the scrutiny and count of votes, shall be paid for such services the fees prescribed for similar duties in the regulations under the Electoral Act, 1907-1936, for returning officers and presiding officers respectively.
- 11. The Appendix to the regulations is amended by deleting Form No. 3 therefrom and in lien thereof inserting a new Form 3, as follows:—

2. The voter must mark his vote on this ballot paper by placing the numeral 1 in the square opposite the name of the candidate for whom he votes as his first preference and must give contingent votes for all the remaining candidates by placing the numbers 2, 3, 4 (and so on as the case requires) in the squares opposite their names, so as to indicate the order of his preference for them.

The voter must then fold the ballot paper and enclose it in the envelope marked "Ballot Paper."

The voter must complete the counterfoil, obtain the signature of a witness to his own signature and enclose the counterfoil with the envelope marked "Ballot Paper" in the addressed envelope provided for the purpose and forward it to the Chief Electoral Officer, Perth, so as to reach him not later than o'clock in the noon on the day of , 19 .

THE ROAD DISTRICTS ACT, 1919-1938.

Gnowangerup Road Board.

P.W. 88/38. WHEREAS by the Road Districts Act, 1919-38, the Road Board of any district is empowered to make bylaws for all or any purposes in the said Act mentioned, the Gnowangerup Road Board, in pursuance of the powers vested in the said Board, under and by virtue of the said Act and of every power enabling it in that behalf, doth hereby make and publish the following by-laws:-

Fencing Townsite Lots.

- (1) No owner of land in the Gnowangerup Townsite shall maintain any fence abutting any street or road in a state of disrepair or in a dilapidated or unsafe condition, and the Board may at its discretion by notice in writing delivered to the last known address of any such owner require that any such fence shall forthwith be repaired or painted.
- (2) The Board may by notice in writing delivered at the last known address of any owner of land within the Gnowangerup Townsite require the owner to forthwith—(a) construct a fence or reconstruct any existing fence on the boundary of any land abutting any road or street within the said Gnowangerup Townsite; (b) and the Board may at its discretion by resolution prescribe the style and description and the materials with which any such fence shall be constructed or recent which any such fence shall be constructed or reconstructed.

Clearing Townsite Lots.

(3) The Board may by notice in writing require any person who is the owner or occupier of land situated within the Gnowangerup Townsite to forthwith clear such land of all trees, sernb, logs of timber, or debris of any description.

Penalties.

Every person who does, permits, or suffers any act, matter, or thing contrary to these by-laws, or commits or permits any breach or neglect thereof, shall be deemed guilty of an offence against these by-laws, and shall be liable to a penalty not exceeding £5 for every such offence.

SCHEDULE.

Definitions.

1. In this Proclamation, unless the contrary intention appears-

"average cost" means, as regards commodities of any particular quality, the cost ascertained by dividing the total cost of old stock and new stock by the total quantity of old and new stock, and any reference to averaging the cost of any commodities has a like meaning; "charged" includes debited or otherwise taken into account.

into account; "cost" means—

(i) as regards commodities of any particular of money paid or agreed to be paid for or in respect of those commodities by the trader together with the expenses of freight, insurance, and exchange where incurred: and curred; and

(ii) as regards commodities manufactured or partially manufactured in Western Australia and held for sale by the manufacturer, the cost of manufacture of those commodities together with such proportion of other expenses as is properly chargeable in respect of the commodities before gross profit is ascertained.

and, when any payment is specified or is made in a currency other than Australian currency, that payment shall be converted into Australian currency at the rate of exchange current on the

date on which the payment is made;

"date of manufacture" means the date on which
the manufacture of the goods is completed;

"materials" includes fuel and supplies for maintenance of plant and for manufacturing pro-

cesses; "old stock," when used in contradistinction to new stock, means-

(i) in relation to a trader-commodities in store and unsold at the date of the receipt of new commodities; and

(ii) in relation to a manufacturer—commodities in store at the date of the manufacture of

new commodities;
"'paid'" includes credited or otherwise taken into

account; "'purchased'' includes acquired by barter, exchange, or otherwise; "'quality' includes grade and description.

Imported Goods.

As regards commodities imported into Western Australia, I fix and declare the maximum wholesale price that may be charged from time to time by any trader upon any sale by wholesale of commodities of any quality to be the prevailing price, with the following exceptions, the operation of which is subject to the provisions of paragraph 5 of this Proclamation:

(a) Where after the prescribed date and either before or after the making of this Proclamation the trader has received or receives new stock substantially identical in quality with stock held by him and remaining unsold on the pre-scribed date, he shall take into account the cost of the new stock received in such a way that of the new stock received in such a way that the maximum price for any sale of stock, whether old stock or new stock, of such com-modities, as on and from the date upon which he so takes into account the cost of that new stock, shall be the sum that represents the average cost of all the stock, both old stock and new stock, plus gross profit thereon, calculated on the same basis as that on which gross profit had been calculated by the trader on the old had been calculated by the trader on the old

(b) Upon the receipt by the trader at any time therepon the receipt by the trader at any time thereafter of any additional parcel of new stock substantially identical in quality with stock already held by him, the provisions of the last preceding subparagraph shall apply from time to time as if the stock held by him and remaining unsold at the time of the receipt of an additional parcel were "old stock" within the meaning of that subparagraph.

(c) Where prior to the prescribed date the trader did not make any sale of commodities substantially identical in quality with stock he receives on or after that date, the maximum price for any sale of such stock shall be the cost of the commodities sold, plus gross profit thereon calculated on the same basis as that on which gross profit had been calculated by the trader on stock of similar class held for sale on the prescribed

Commodities Manufactured in Western Australia and Sold by Trader.

As regards commodities manufactured in Western Australia and held for sale by a trader, other than the manufacturer, I fix and declare the maximum wholesale price that may be charged from time to time by any such trader upon any sale by wholesale of commodities of any quality to be the prevailing price, with the following exceptions, the operation of which is subject to the previsions of paragraph 5 of this Proclamation:—

lowing exceptions, the operation of which is subject to the provisions of paragraph 5 of this Proclamation:—

(a) Where after the prescribed date and either before or after the date of this Proclamation the trader receives or pays for new stock substantially identical in quality with stock held by him and remaining unsold on the prescribed date, he shall take into account the cost of the new stock received or paid for in such a way new stock received or paid for in such a way that the maximum price for any sale of stock, whether old stock or new stock, of such com-modities, as on and from the date upon which he so takes into account the cost of that new stock shall be the sum that represents the average cost of all the stock, both old and new stock, plus gross profit thereon, calculated on the same basis as that on which gross profit had been calculated by the trader on the old stock

(b) Upon the receipt by the trader at any time thereafter of any additional parcel of new stock substantially identical in quality with stock already held by him, the provisions of the last preceding subparagraph shall apply from time to time as if the stock held by him and remaining unsold at the time of the receipt of an additional parcel of new stock were "old stock" within the meaning of that subparagraph;

(c) Where prior to the prescribed date the trader did not make any sale of commodities substantially identical in quality with stock he re-

ceives on or after that date, the maximum price for any sale of such stock shall be the cost of the commodities, plus gross profit thereon, cal-culated on the same basis as that on which gross profit had been calculated by the trader on stock of similar class held for sale on the prescribed date.

Western Australian Manufactured Commodities held for Sale by the Manufacturer.

In the case of commodities manufactured or partially manufactured in Western Australia and held for sale by the manufacturer, I fix and declare the maximum price that may be charged from time to time by the manufacturer for commodities of any quality to be the prevailing price, with the following exceptions, the operation of which is subject to the provisions of paragraph 5 of this Proclamation:—

- (a) Where after the prescribed date the manufacturer manufactures commodities substantially identical in quality with commodities held by him in stock on the prescribed date, he shall take into account the cost of the new commodities so manufactured in such a way that the maximum price for any sale of stock, whether old stock or new stock of such commodities, as on and from the date upon which he takes into account the cost of that new stock shall be the sum that represents the average cost of all the stock, both old stock and new stock, plus gross profit thereon, calculated on the same basis as that on which gross profit had been calculated by the manufacturer on the old stock.
- (b) Upon the manufacture by the manufacturer at any time thereafter of any additional commodities substantially identical in quality with stock already held by him, the provisions of the last preceding subparagraph shall apply from time to time as if the stock held by him and remaining unsold at the date of the manufacture of any additional commodities were "old stock" within the meaning of that subparagraph.
- (c) Where after the prescribed date the manufacturer receives new stocks of materials substantially identical in quality with or interchangeable with old stocks of materials held by him on that date, such materials being for use either in or in connection with the manufacture of commodities of a particular quality, then for the purpose of ascertaining the cost of manufacture of those commodities, he shall take into account the cost of the new stocks of materials he receives in such a way that as on and from the date on which he takes into account the new stocks of materials, whether from old stocks or from new stocks, used in or in connection with the manufacture of those commodities shall be the sum that represents the average costs of all the stocks of the materials, both old stocks and new stocks.
- (d) Upon the receipt by the manufacturer at any time thereafter of an additional parcel of new materials substantially identical in quality with or interchangeable with old stocks of materials held by him at the date of such receipt, the provisions of the last preceding subparagraph shall apply from time to time as if the stock held by him at the date of receipt of an additional parcel were "old stock" within the meaning of that subparagraph.
- (e) Where prior to the prescribed date the manufacturer did not make any sale of commodities substantially identical in quality with stock he receives on or after that date, the maximum price for any sale of such stock shall be the cost of the commodities, plus gross profit thereon, calculated on the same basis as that on which gross profit had been calculated by the manufacturer on stock of similar class held for sale on the prescribed date.

Where on any date a trader makes a sale by wholesale or a manufacturer makes a sale of a commodity of a quantity or on terms and conditions substantially different from the quantity in which or the terms and conditions upon which on the prescribed date the trader or manufacturer sold a commodity substantially identical in quality, then this Proclamation shall extend to such sale, but so that the maximum price declared by this Proclamation for such commodity shall be increased or decreased by an amount corresponding to the amount of the additional cost or saving to the trader or manufacturer consequent on the change in quantity or in the terms and conditions, or both.

Application of Averaging to falling Costs.

6. The system of averaging prescribed in paragraphs 2, 3, and 4 of this Proclamation when adopted by any trader or manufacturer shall apply equally to cases

where new stock is acquired or produced by that trader or manufacturer at lower cost than old stock as to cases where the new stock is acquired or produced at higher cost.

Commodities Sold by Retail.

7. As regards commodities acquired by a trader since the prescribed date for sale by retail, I fix and declare the maximum price that may be charged from time to time by any such trader upon any sale by retail of commodities to be the cost to him of the commodities, together with gross profit thereon calculated on the same basis as that on which gross profit had been calculated by him on commodities of like quality immediately before the prescribed date, but any individual trader may make application to the Commissioner to have the averaging principle applied in respect of stocks on hand on the prescribed date and those subsequently acquired, and such application may be considered by the Commissioner in the light of all the circumstances surrounding the case.

PROCLAMATION

WESTERN AUSTRALIA, | By His Excellency Sir James Mitchell, | K.C.M.G., Lieutenant-Governor in and over the State of Western Australia list Dependencies in the Commonwealth of Australia.

WHEREAS it is enacted by section 15 of the Wheat Products (Prices Fixation) Act, 1938, that the Gover-nor may from time to time, on the recommendation of the Wheat Products Prices Committee as constituted by the said Act, by Proclamation fix minimum and maximum prices at which substances included in the definition of "flour" or in the definition of "wheat products" may be sold in the State, or in any specified part of the State by any person, and by a subsequent Proclamation may revoke, amend, or vary any such Proclamation aforesaid: And whereas by a Proclamation in the state and action and problems in the state. issued under the said section and published in the Government Gazette on the 13th day of July, 1939, the Governor fixed in relation to bread the prices at which bread may be sold by any person respectively in those parts of the State specified in such Proclamation: And whereas the prices fixed in paragraph 1 of the said Proclamation are by virtue of the said paragraph the prices at which bread may be sold within the boundaries of the Townsites of Kalgoorlie and Boulder respectively, and at places outside the said boundaries but within an imaginary circle having a radius of eight miles from an imaginary circle having a radius of eight inles from the principal Post Office at Kalgoorlie as the centre of such circle: And whereas it is now deemed desirable and expedient to vary the prices at which bread may be sold by any person within those parts of the State specified in paragraph 1 aforesaid of the said Proclamation and to vary the said paragraph 1 of the said Proclamation accordingly: Now, therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Couvell and on the recommendation of of the Executive Council and on the recommendation of the Wheat Products Prices Committee aforesaid, and in exercise of the powers conferred upon me by the said Act, do hereby declare that, notwithstanding anything to the contrary contained in paragraph 1 of the Proclamation issued under section 15 of the Wheat Products (Prices Fixation) Act, 1938, and published in the Government Gazette on the 13th day of July, 1939, the prices at which bread, being a wheat product within the meaning of the said Act may be sold by any person within those parts of the State specified in the said paragraph 1 shall be and are, subject as hereinafter provided, hereby fixed in accordance with the prices set forth hereunder: Provided that this Proclamation shall not apply in the case of sales of any such bread aforesaid under contract to public charitable institutions or to Government institutions, and also that to the extent by which this Proclamation is inconsistent with the provisions of the Proclamation issued under section 15 of Act, do hereby declare that, notwithstanding anything visions of the Proclamation issued under section 15 the said Act and published in the Government Gazette on the 13th day of July, 1939, this present Proclamation shall prevail, and the said last mentioned Proclamation shall be and is hereby amended and varied: And also

that nothing in this present Proclamation shall be deemed in any manner whatsoever to interfere with, prejudice, or affect the application of paragraph 6, 7, and 8 of the said Proclamation as issued and published in the Government Gazette on the 13th day of July, 1939, to sales of bread by any person within those parts of the State specified in paragraph 1 of such Proclamation as hereinbefore mentioned, but that, subject to variation of prices as provided in this present Proclamation, the provisions of paragraphs 6, 7, and 8 of the said Proclamation shall apply to sales of bread within the said specified parts of the State as fully and effectually as if the said paragraphs 6, 7, and 8 were expressly incorporated in the present Proclamation.

- 1. The prices for bread sold by any person within the boundaries of the Townsites of Kalgoorlie and Boulder respectively and at places outside the said boundaries but within an imaginary circle having a radius of eight miles from the principal Post Office at Kalgoorlie as the centre of such circle are by this Proclamation fixed as follows:—
- (A) White bread, whole wheatmeal bread, standard wheatmeal bread, and brown bread sold as No. 2 loaves within the meaning of the Bread Act, 1903-1938.
- (i) Retail—
 6d. per loaf.

 Tickets
 6d. per loaf.

 Cash
 6½d. per loaf.

 Booked
 7d. per loaf.

 (ii) Wholesale
 6s. per doz. loaves.
- 2. This Proclamation shall have effect as from and after the date of the publication of this Proclamation in the Government Gazette.
