WHEREAS by section 11 of the Land Act, 1933-1939, the Governor may resume, for any of the purposes specified in section 29 of the said Act, any portion of land held as a Conditional Purchase Lease: And whereas it is deemed expedient that the portion of Conditional Purchase Lease 365/628 (Williams Loca-

tion 12247), as described hereunder, should be resumed for one of the purposes specified in paragraph (f) of section 29 of the said Act, that is to say, for School Site: Now, therefore I, Sir James Mitchell, Lieutenaut-Governor as aforesaid, with the advice of the Executive Council, do by this my Proclamation resume portion of Conditional Purchase Lease 365/628 for the purpose aforesaid.

AT a meeting of the Executive Council held in the Executive Council Chamber, at Perth, this 10th day of October, 1940, the following Orders in Council were authorised to be issued:—

Reciprocal Enforcement of Maintenance Orders Act, 1921.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 14 of the Reciprocal Enforcement of Maintenance Orders Act, 1921, as amended by the Acts No. 29 of 1923 and No. 7 of 1936, that the Governor may, upon being satisfied that reciprocal provisions are about to be made by the Legislature or other competent authority of any part of the King's Dominions, or of any British Protectorate, for the enforcement therein of maintenance orders made by Courts within the State of Western Australia, extend the provisions of the said Act to that part of the

King's Dominious, or to that British Protectorate aforesaid, and thereupon that part of the King's Dominious, or that British Protectorate, shall become a part of the King's Dominions to which the said Act extends: And whereas the State of Sarawak, being a State over which His Majesty extends his protection, constitutes a British Protectorate, within the meaning of the said Act, and the Governor is satisfied that the Legislature of the State of Sarawak is about to make reciprocal provisions for the enforcement within the State of maintenance orders made by Courts within the State of Western Australia: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act, doth hereby extend the said Act to the State of Sarawak.

Mundaring Road Board-Hawkers' By-laws.

P.W. 1494/36.

IN pursuance of the powers in that behalf contained in the Road Districts Act, 1919-1939, the Mundaring Road Board hereby makes the following by-laws:—

- 1. In these by-laws the term "Hawker" shall mean and include any person who in any manner whatsoever carries to sell or to offer or expose for sale any goods, wares, or merchandise.
- 2. No person shall within the district of the Board trade or act as a hawker unless he is the holder of a license as hereinafter provided.
- 3. Applications for a license to trade or act as a hawker shall be made in writing to the secretary of the Board, and shall be accompanied by the prescribed fee.
- 4. A license to trade or act as a hawker may be granted and issued by the Board for a term of three, six, or twelve months from the date of issue, and shall be in the form set forth in the Schedule hereto.
- 5. The Board may in its absolute discretion and without assigning any reason therefor:—
 - (a) refuse to issue a license as aforesaid;
 - (b) refuse to renew a license as aforesaid on the expiration of the current term thereof;
 - (c) cancel a liceuse as aforesaid during the currency thereof, upon giving to the liceusee one mouth's written notice of its intention so to do: Provided that the liceuse fee or a part thereof proportionate to the mexpired term of the said liceuse shall be refunded to the liceusee:
 - (d) grant a license as aforesaid, upon such conditions as the Board may think fit.
- 6. No person to whom a license to trade or act as a hawker has been granted shall, without the written consent of the secretary previously had and obtained, lend, transfer, or assign such license, and no person shall without such consent as aforesaid, borrow or make use of any license granted to a person other than himself.
- 7. Any person to whom a license to trade as a hawker has been granted shall at all times:—
 - (a) keep the vehicle, tray, or basket (if any) used by him in good repair and thoroughly clean and cleansed to the satisfaction of the secretary; and
 - (b) keep affixed to some conspicuous part of his coat or the vehicle, tray, or basket (if any) used by him a board or plate bearing his name and the words "Licensed Hawker" legibly printed thereon in letters not less than one inch in length.
- 8. The fees payable in respect of a license to trade or act as a hawker shall be as follows: —

For a term of three months ... 0 5 0 For a term of six months ... 0 10 0 For a term of twelve months ... 1 0 0 Schedule. Hawkers' License.
