The Game Act, 1912-1913. PROCLAMATION

WESTERN AUSTRALIA, } By His Excellency Sir James Mitchell, TO WIT. } K.C.M.G., Lieutenant-Governor in and JAMES MITCHELL, over the State of Western Australia Lieutenant-Governor. and its Dependencies in the Common-[L.S.] wealth of Australia.

No. 1672/24.

WHEREAS it is provided by the Game Act, 1912-1913, that the Governor may by Proclamation declare from time to time that any bird or animal indigenous to Western Anstralia shall be at all times strictly preserved, Western Australia shall be at all times strictly preserved, either generally throughout the State or in any one or more portions thereof, and that the Governor may in like manuer exempt from the operations of any such declaration under the said Act any defined locality: And whereas by a Proclamation dated the 30th day of July, 1924, it is provided that the portions of the State and localities defined in the Schedule thereto shall be a Reserve for Grey Kangaroos, known scientifically as Macropus giganteur: And whereas it is desirable to a defined locality: Now, therefore I, the said Eroclamation a defined locality: Now, therefore I, the said Lientenant-Governor, in exercise of the power aforesaid, do hereby, by and with the advice and consent of the Executive Conncil, exempt from the operations of the aforesaid Proclamation and the declaration contained therein all those localities mentioned and defined in the Schedule hereto as from the 1st day of May, 1941, until the 31st day of October, 1941.

Schedule.

All that area of the State lying to the eastward of a straight line drawn from Lake Mageuta, in the Roe Land District, to the month of the Fitzgerald River.

ORDER IN COUNCIL.

M.H.D. 821/22.

WHEREAS it is enacted by section 18 of the Health Act, 1911-1937 (as reprinted under the Amendments Incorporation Act, 1938), that every municipal district

shall be a health district within the meaning of the said Act, and the Municipal Council shall be the local authority for such district, and by section 21 of the said Act that the Governor may place any area of land outside a municipal district, and, whether actually adjoining or not, under the jurisdiction of the council of such municipal district for the purposes of the said Act, and such area shall, for all the purposes of this Act, be deemed to be within the municipal district: And whereas it is deemed desirable and expedient that, pursuant to section 21 aforesaid, the área of land hereinafter mentioned and described, which is outside the purposes of the said Act: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by section 21 of the Health Act, J911-1937 (as reprinted under the Amendments Incorporation Act, 1938), doth hereby place under the jurisdiction of the Northam Municipal Council for the purposes of the said Act, and so that the same shall for all purposes of the said Act be deemed to be within the Northam Municipal District, being Avon Location 1343 and part Avon Location 1695.

FARMERS' DEBTS ADJUSTMENT ACT, 1930-1934. NOTICE is hereby given that the following Stay Order has been issued in accordance with section 7, subsection (1) of the Farmers' Debts Adjustment Act, 1930-1934, which reads as follows:—

SCALE OF ALLOWANCES TO WITNESSES.

HIS Excellency the Lieutenant-Governor in Executive Council has cancelled the existing scale of allowances to witnesses and has approved of the scale of fees hereunder coming into operation in lieu thereof as from the 1st July, 1941:—

Witnesses (other than Government officers) duly summoned and attending to give evidence at any Criminal Session of the Supreme Court, before any Court of Session, which shall be considered to include the preliminary hearing, or before Justices in Petty Session and other summary jurisdiction, or on any inquest, shall be paid only in accordance with the following scale:—

I.-For Loss of Time.

1. (a) Labourers, store assistants, apprentices, clerks, mechanics and other qualified tradesmen, farmers and station managers, business proprietors, hotel licensees, miners and prospectors, contractors, shop assistants and salesmen, insurance agents, and all others who do not come within the category of subclause (b) hereunder, per diem, 15s.

(b) Professional men, bank managers and inspectors, merchants, mine managers, practising accountants, station owners, stock brokers, and medical officers not elsewhere provided for, per diem, 21s.

Note:--The term "Professional men" in this subclause refers to qualified men actually engaged in the practice of their profession, or, if retired, who were so engaged at the date of retirement.

2. Female witnesses engaged in remunerative employment shall be paid 10s. per diem.

Other female witnesses shall be paid 7s. 6d. per diem, but if attendance at Court necessitates absence from home for one or more nights, 10s. per diem shall be paid.

3. Children under 15 years of age, accompanied by guardians, shall not be entitled to a witness fee unless attendance at Court necessitates their absence from home for one or more nights, when a fee of 7s. 6d. per diem shall be paid, but the guardian may be paid an allowance on the same basis as if such guardian were in fact a witness: provided such guardian has not been personally summoned to attend as a witness.

In those cases where children are not entitled to a witness fee, a meal allowance not exceeding 1s. 6d. per meal with a maximum of 3s. per diem may be paid.

Children under 15 years of age unattended by a guardian shall be paid 5s. per diem: provided that, if attendance at Court necessitates absence from home for one or more nights, the rate paid shall be 7s. 6d. per diem.

Children over 15 years of age and under the age of 18 years shall be paid the same rates and on the same basis as the fees prescribed for females, *vide* paragraph 2 hereof.

4. Resident Medical Officers shall be paid at the rate of fifteen shillings per diem when attending Court within a radius of thirty-five miles of their headquarters.

Outside that radius they shall be paid the difference between the daily proportion of the salary or subsidy received by them from the Government or from the hospital to which they are attached, and £2 2s. per diem, but in any event shall be paid not less than 15s. per diem. All medical men attached to hospitals receiving Government support shall in the interpretation of these regulations be regarded as Resident Medical Officers.

No allowance will be payable under this regulation to Resident Medical Officers who are engaged on a full time basis by the Government.

5. Notwithstanding anything contained in paragraph 1 (b) hereof, all medical men (other than Resident Medical Officers) attending Court outside a radius of 35 miles from their places of business shall receive an allowance at the rate of £2 2s. per diem.

6. Witnesses (other than Government officers) shall be paid at the prescribed rates for the actual time occupied in travelling to and from the Court.

Should the witness lose a full day's pay, one day's allowance at the prescribed rate shall be paid; in all other cases where loss is incurred, the allowance payable shall be one-half the prescribed daily rate.

7. Where no travelling is incurred a witness shall be entitled to one-half the prescribed daily rate if attending court during the morning or afternoon session.

In the event of an adjournment thereby necessitating the attendance of the witness at both sittings one day's allowance shall be paid.

Witnesses who are regularly working "on shift" or who, as a result of attending Court for any portion of a day, lose a day's pay, shall be paid one day's allowance at the appropriate rate, or an amount equivalent to wages lost, whichever is the lower: Provided the paying officer is satisfied that the actual loss of time has been sustained.

II.—Travelling Expenses.

8. Any Government officer who is required to attend Court away from his headquarters will be paid a travelling allowance at the same rate that such officer would be entitled to receive under the Public Service Regulations. Claims should be rendered through the Department to which the officer is attached.

9. Witnesses shall be paid mileage at the rate of eightpence per mile, one way, where no train or other public conveyance is available: Provided that, should more than one witness travel in the same motor car only one mileage allowance shall be payable; witnesses traveling by railway, steamer, or other public conveyance shall be paid the actual fare.

10. Witnesses who are required to travel by boat or train, the fare for which includes meals and sleeping accommodation, shall be paid an allowance at the rate of 50 per cent. of the prescribed rate while on such conveyance.

Sleeper accommodation will not be paid for unless satisfactory evidence that the expenditure has actually been incurred is produced to the paying officer.

III.—General Instructions.

Railway and Tramway Employees.

11. (a) Every wages employee summoned to attend Court will be provided with a time sheet showing the name of such employee and his location. Thereon will be entered brief details of the case and of the evidence he was called to give, together with the time occupied at the Court.

The correctness of the entry will be verified by the Clerk of Courts, who should sign the sheet (if correct) and return it to the witness.

Any allowance due will be paid by the Railway Department who will render on the Crown Law Department for a refund of the amount so expended.

Agricultural Bank Inspectors.

11. (b) The Clerk of Courts will forward a certificate to the Chief Accountant of the Agricultural Bank, showing the time the inspector was engaged *outside of* his district and the motor mileage involved.

The inspector will be paid by the Bank at its prescribed rates and the Bank will be recouped by the Crown Law Department.

Under no circumstances should payment be made by the Clerk of Courts in either of the above cases.

Commonwealth Forces.

11. (c) Witnesses attached to the Navy, Army or Air Force, whether for home or overseas service, shall not be entitled to receive a witness fee, but shall be recouped actual out-of-pocket expenditure.

Miscellaneous.

12. Jurymen attending inquests under the provisions of the Coroners Act, 1920, shall be paid the rate preseribed by regulations under the Jury Act, 1898, as published in the *Government Gazette* of the 1st November, 1930, or as prescribed by any amendment thereof.

13. The Government does not pay the expenses of witnesses in prosecutions instituted by private persons. 14. In prosecutions for stealing as a servant and similar offences, undertaken by the police, inquiries should be made to ascertain whether the person charged is under bond. If so, the fact should be immediately reported to the Under Secretary for Law, who will take whatever steps are necessary for recovery from the guaranter.

15. In charges of stealing, where the police are the informants and a conviction is obtained and restitution ordered, care should be taken that the order embraces all expenses of witnesses.

16. No allowance will be paid to any member of the Police Force for attendance at any Court or before justices, or at any inquest.

17. Under extraordinary circumstances, or in case of dispute, such remuneration shall be allowed as shall be determined by the Attorney General, after taking the circumstances of the case into consideration.

18. Nothing in this scale shall apply to medical men attending at a Coroner's Court, as special fees are provided under a separate scale

THE HEALTH ACT, 1911-1937.

THE HEALTH ACT, 1911-1937. Offensive Trades By-law.

WHEREAS under the provisions of the Health Act, 1911-1937, a local health authority may make or adopt by-laws, and may amend, repeal, or alter any by-laws so made or adopted: Now, therefore, the Melville Road Board, being a local health authority, doth hereby make the following by-law:—

Offensive Trades.

It shall not be lawful to establish in any part or portion of the Melville Road Board District any of the trades, businesses, or occupations usually carried on, in, or connected with the undermentioned works or establishments, that is to say:---

Abattoirs or slaughter-houses; bone mills or bone manure depots; chemical works; fat rendering establishments; fell mongeries, tanneries, or wool-scouring establishments; glue factories; marine stores; places for storing, drying or preserving bones, hides, hoofs, or skins; tripeboiling establishments; works for boiling down meat, bones, blood or offal, or any trade, business, process, or manufacture whatsoever causing effluvia, offensive fumes, vapours or gases, or discharging dust, foul liquid, blood, or other impurity (excepting piggeries and fish shops); and the establishment of any such trade, business, or occupation is strictly prohibited in any portion of the Board's district.

Rules of the Optometrists Registration Board (made pursuant to

section 17 of the Act).

1. These rules may be cited as the Optometrists Registration Board Rules, 1941.

2. These rules are divided into Parts, as follows :-

Part I.: Rule 3-Interpretation.

- Part III.: Rules 15 to 21-Meetings.

Part V .: Rules 23 to 29-The Register.

Part VIII.: Rule 43-Licenses.

Part IX .: Rules 44 to 52-Charges or Complaints against Optometrists.

Part X.: Rules 53 to 54-Fees and Fines.

Part XI.: Rules 55 and 56-Miscellaneous.

PART 1.

Interpretation.

3. In the construction of these rules section 3 of the Act shall apply.

PART II.

Election of Nominees for appointment to Board.

4. The three registered optometrists to be nominated from time to time by the registered optometrists for appointment to the Board shall be determined by election.

5. The first election shall be held on the second Thursday in the month of October, 1943, and every election thereafter shall be held on the second Thursday in the month of October in each and every succeeding third year.

6. If a casual vacancy occur in the office of any such nominated member, an election shall be held as soon as practicable after such vacancy occurs, to fill the vacancy.

Provided that, if the casual vacancy occur within the period of 60 days before the date fixed by these rules for the holding of the first or any triennial election to select the nominated members, no election need be held to fill such casual vacancy unless the Board shall otherwise direct.

7. At least twenty-eight days before the date of any election, the Registrar shall advertise once at least in the *Government Gazette* and once at least in a newspaper published in Perth a notice drawing attention to such election and requiring nominations of candidates to be forwarded to the Registrar not later than eighteen days before the date of the election.

8. Every person desiring and being qualified to become a member of the Board shall, not less than eighteen days before the date of an election, forward to the Registrar written notice of his intention to seek election, countersigned by at least two persons entitled to vote at such election: such notice to be in the hands of the Registrar by 12 o'clock (noon) on the closing date for nominations.

9. If there be no more candidates than the number of vacancies such candidates shall be declared elected.

10. If there be more candidates than the number of vacancies at any election the Registrar shall, at least ten days before the date of election, post to each person entitled to vote a ballot paper containing the names and addresses of all candidates and setting out the terms of rule 11, and shall initial each of such papers and, together with such ballot paper, the Registrar shall enclose and post a separate envelope, with the name and address of the Registrar printed thereon.

11. (i) The names of the negligibilit princed divided a voter desires to vote shall be left intact and the remaining names scored through with a pen or pencil. If the number of names left intact upon any voting paper be greater or less than the number of members to be elected, or if any mark or writing other than above appear thereon, which in the opinion of the Returning Officer will enable any person to identify the voter, the vote given on and by such paper shall be void and of no effect and shall not be counted by the chairman.

(ii) The voter shall enclose such voting paper in the envelope posted to him by the Registrar, and shall stamp and post the same or deliver the same so that it shall be received by the Registrar not later than 12 o'clock (noon) on the day fixed for holding such election.

12. (i) All ballot papers shall be opened by the chairman at the office of the Board at 12 o'clock (noon) on the day of election, in the presence of any person entitled to vote who may attend at such time and place, and the candidates receiving the largest number of votes shall be declared elected.

(ii) In the case of an equality of votes the chairman shall give a second or casting vote.

13. The omission by the Registrar to send or post to or the non-receipt of any ballot paper by any person entitled to vote within the time aforesaid, or at all, shall not in any manner invalidate or affect the election.

14. The persons so elected shall be deemed the nominees of the registered optometrists for appointment to the Board by the Governor, and their names and addresses shall be conveyed by the Registrar to the Governor on the day following the day of the election, which last-mentioned date, for the purposes of section 5 (5) of the Act, shall be deemed the "prescribed nomination day."

PART III.

Meetings.

15. Ordinary meetings of the Board shall be held at the office of the Board on the second Thursday in every month, at the hour of eight o'clock p.m., or such other place, date and time as the Board may determine.

16. Special meetings shall be called by the Registrar, whenever requested by the chairman or any three members: Provided that three clear days' notice of every such meeting shall be given by the Registrar to the members of the Board.

17. If a quorum of members be not present within fifteen minutes of the time for which the meeting is convened, it may be adjourned to such time and place as any one or more members present may determine.

18. No resolution arrived at or act, matter, or thing done or authorised by any meeting shall be rescinded or amended at any subsequent meeting, unless notice of such intended rescission or amendment be given in the notices convening the meeting at which such rescission or amendment is proposed.

19. Minutes of every meeting shall be kept by the Registrar and such minutes, when signed by the chairman of the same or any subsequent meeting, shall be binding and conclusive evidence for all purposes and before all courts of the proceedings at such meeting.

20. The arrangement of the order for business for each ordinary meeting shall be as follows:—

Reading the minutes of the previous meeting.

Confirmation or otherwise of same.

Registration of optometrists.

Ordinary business, including postponed and adjourned matters.

Special business.

Reading of correspondence and reports of committees.

Letters and business arising therefrom.

Production of bank pass book.

Accounts for payment.

Registrar's statement.

Notices of motion.

Any other business that may be properly brought before the Board.

21. The omission to give due notice of a meeting, as hereinbefore provided, to one or more members of the Board, or the non-receipt thereof, shall in no manner affect or prejudice anything done or agreed at such meeting.

PART IV.

Registrar.

- 22. The Registrar shall-
 - (1) be appointed by the Board and hold the office subject to these rules and during the pleasure of the Board;
 - (2) discharge duties imposed upon the Registrar by the Act;
 - (3) be in attendance at his office at such hours and days as the Board may from time to time direct;
 - (4) consult the chairman on any business requiring attention between the various meetings of the Board and be responsible for the safe custody of all documents and property belonging to the Board;
 - (5) find security to the satisfaction of the Board in the sum of £250:
 - (6) present to the Board a monthly statement showing the receipts and expenditure for the past month, and prepare and present to the Board a yearly balance sheet in the month of September in every year;
 - (7) receive and he responsible for all moneys payable to the Board and shall bank the same within forty-eight hours of the receipt thereof;
 - (8) discharge such other duties as the Board from time to time may direct.

PART V. The Register.

23. The Register of Optometrists shall be in Form 1 in the First Appendix to these rules.

24. The Register shall be open to inspection, at the office of the Registrar, during the hours of 2 p.m. and 4 p.m. on Wednesday and Friday of each week, excepting when any of these days falls on a public holiday.

25. Any registered optometrist desirous of having his name withdrawn from the Register shall lodge with the Registrar an application, in writing, according to Form 4 in the First Appendix to these rules.

26. Every person desirons of having his name re-entered in the Register under section 22 of the Act shall make application to the Board in writing, according to Form 5 in the First Appendix to these rules and shall lodge such application with the Registrar, together with the sum provided by section 22 (3) of the Act, or the sum of £10 10s., whichever is the less, and together with the prescribed re-entry fee.

27. Every person desirous under section 28 of the Act of having his suspension annulled shall lodge with the Registrar an application to the Board in writing according to Form 6 in the First Appendix to these Rules and shall, when and as often as required, attend in person before the Board and answer verbally or in writing all such questions as may be put to him.

The Board may refuse or grant such application.

28. Every person desirous of having his name re-entered in the Register under section 28 of the Act shall lodge with the Registrar an application to the Board in writing according to Form 7 in the First Appendix to these rules, and shall, when and as often as required, attend in person before the Board and answer verbally or in writing all such questions as may be put to him.

If the application is granted by the Board, the Registrar shall notify the applicant thereof, but the applicant's name shall not be re-entered until the sum payable under section 28 (5) of the Act has been paid, together with the prescribed fee for such re-entry.

29. Every person desirous of obtaining under section 31 of the Act a statement of the Board in writing of its reasons for a decision of the Board on any matter mentioned in section 31 of the Act, shall make application to the Board in writing according to Form 8 in the First Appendix to these rules, and shall lodge such application with the Registrar within the time fixed by section 31 of the Act.

PART VI.

Registration of Optometrists.

30. The Board will recognise the following diplomas as a substitute for the examinations of the Board:—

- (a) Dioptrie or Fellowship Diploma of the British Optical Association, London;
- (b) Fellowship Diploma of the Worshipful Spectacle Makers' Company, London;
- (c) Licentiate in Optometric Science of the Australian College of Optometry;
- (d) General Membership Certificates issued by the Western Australian Optometrical Association to those persons who at the commencement of the Act were associate or student members of such Association.

31. Every person applying for registration as an optometrist shall apply in writing and make and foward to the Registrar an application according to Form 2 in the First Appendix to these rules.

32. Each applicant for registration shall supply in writing to the Board the information and evidence required by the Act and shall, when and as often as required, attend in person before the Board and answer verbally or in writing all such questions as may be put to him.

33. Every person whose application for registration has been approved and whose name has been entered upon the Register of Optometrists after payment of the fees prescribed by the rules shall be entitled, upon payment of the prescribed fee, to a certificate in Form 3 in the First Appendix to these rules.

PART VII.

Examinations.

34. The practical test of competency to practise optometry to be passed by persons seeking registration under section 34 (c) of the Act shall be in the following, viz.:---

Refraction; History taking and recording; Face and Frame measurements and fitting; Ophthalmoscopy.

35. Until otherwise prescribed, the examinations to be passed by persons seeking registration under section 35 (1) (d) (i) of the Act shall be as follows:—

- (1) (a) The School Certificate Examination of the University of Western Australia at the Leaving Standard in four subjects, including English, physics, mathematics A or mathematics B; or
 - (b) A pass in an examination deemed equivalent to (a) by the University of Western Australia.
- (2) An examination in the following subjects:—Nature of Light. Reflection and Refraction. Geometrical Optics. Lenses and Prisms and their use. Simple Optical instruments. Resolving power. Physical Optics. Colour and dispersion, interference, diffraction, polarisation and double refraction, fluorescence and phosphorescence. This spherical lenses. Neutralising and transposing. Prismatic action and decentering. Calculations on lens forms; practical experiments in the foregoing. Elementary physiology of the Eye.
- (3) An examination in the following subjects:—Anatomy of the Eye and Orbit. Dissections and miscroscopic study of the eye. Accommodation. Convergence. Nature of Vision. Binocular vision. Ocular movements. Emmetropia and ametropia. Entoptic phenomena. Colour vision. Visual sensations. Visual adaptation, After images, Irradiation and contract,

- (4) An examination in the following subjects:-Refraction. Optometry and Lens actions. Phorometry. Ophthalmoscopy. Retinoscopy. Keratometry. Permietry and Scotometry. External examination. History taking and recording.
- (5) An examination in the following subjects:—Analytical Optometry. Principles and Practice of Orthoptics. Elementary Psychology. Ethics. Professional Relationships. Hygiene. Eyesight conservation. Visual standards. Optometrical Jurisprudence. Practice of Optometry. Practiceal Use of Instruments.

The candidate may be required in the practical examination to use his own material and small instruments; the larger will be provided by the Board.

36. The annual examinations shall be held in the month of November in each year. Every person desiring to be examined shall make application in writing to the Board in Form 11 in the First Appendix to these rules and pay the examination fee. Such application shall be lodged with and the fee paid to the Registrar not later than the first day of the month immediately preceding the examination at which the candidate is to sit.

37. Any candidate who has failed to pass the examination held in November in any one or more subjects may, at the discretion of the Board, be allowed to submit himself at a supplementary examination to be held in the March immediately following in such subject or subjects, but if at such supplementary examination he again fail in any one or more of such subjects he shall not receive credit for any subjects passed at the annual examination or such supplementary examination.

38. Application in writing in Form 12 in the First Appendix to these rules must be made to the Registrar, and the examination fee for such supplementary examination paid not later than the 15th day of the month immediately preceding the examination at which the candidate is to sit.

39. Except as provided by rule 37 no candidate shall be entitled, without special permission from the Board—and then only upon such conditions as the Board may impose—to sit for more than one of the examinations mentioned in rule 35 in any one year.

40. Every person who has in all respects complied with the Act and the rules and qualified himself for registration as an optometrist under the Act shall be entitled to a certificate in Form 13 in the First Appendix to these rules.

41. Every examination under these rules shall be conducted by such person or persons in such manner and at such times or places as the Board may from time to time appoint or direct.

42. The respective examination fees payable are as fixed in the Schedule. No fee paid for any examination at which the candidate shall fail to present himself, or which he shall fail to pass to the satisfaction of the Board, shall be available for any subsequent examination, nor shall any such fee be returned.

PART VIII.

Licenses.

43. The Optometrists License to be issued under section 36 of the Act shall be in Form 9 in the First Appendix to these rules.

PART IX.

Charges or Complaints against Optometrists.

44. A charge or complaint against an optometrist shall be made in writing, and shall distinctly state the conduct complained of, give an address in Perth where notices and other communications may be served, and be signed by the complainant or his agent, and lodged with the Registrar.

45. The Board may require the complainant to file further particulars of any of the matters complained of, or may require the charge or complaint or any part thereof to be verified by statutory declaration of the complainant or of some other person or persons.

46. If the Board be satisfied that there is a *prima facie* case, it shall give or post to the last known place of address of the optometrist, whose conduct is complained of, written notice stating shortly the grounds of the charge or complaint. The said optometrist shall be entitled to obtain a copy of the charge or complaint and all other documents then or thereafter filed by the complainant in connection therewith, on payment of the sum of 6d. per folio of 72 words.

47. The optometrist shall within fourteen days after the giving or posting of such notice file with the Registrar a statutory declaration in answer to the charge or complaint, and shall give an address in Perth where notices and other communications may be served.

48. The complainant may obtain a copy of the said answer and all other documents then and thereafter filed in connection therewith, on payment therefor at the rate fixed by rule 46.

49. Either party shall when required by the Registrar provide him with such number of copies of all documents filed by such party as the Registrar shall require.

50. The Board, if not satisfied with such answer, shall fix a day, place, and time for the hearing of the charge or complaint and shall cause notice thereof to be served on the parties at their respective Perth addresses, not later than ten days before the day of hearing. Provided that, where the optometrist has not furnished an address in Perth for service as required by these rules, the notice aforesaid may be given or posted to the optometrist at his last known place of abode or place of business. 51. Either party may, not less than three days before the day of hearing, apply in writing to the Registrar to issue a summons for the attendance or production of any persons or documents whom or which the party may desire to call or have produced. Such summons shall be in Form 10 in the First Appendix to these rules.

52. The Board may-

- 1. adjourn the hearing from time to time as may be expedient.
- 2. dispense with any requirement of this part of the rules respecting notices, declarations, and documents, or service in any case where it appears to the Board to be just to do.
- 3. extend the time for doing anything under this Part of the rules.

PART X.

Fees and Fines.

53. The fees mentioned in the Second Appendix to these rules shall be payable to the Registrar for and in respect of the several matters and proceedings therein set forth.

54. The fines payable under the proviso to section 37 of the Act shall be 10s. 6d. for each month or part of a month elapsing from the end of the month on which the first unpaid license fee became payable by the optometrist, but in no case shall the total amount of the fines exceed £6 6s.

PART XI.

Miscellaneous.

55. (i) The Board may adopt a seal as the Common Seal of the Board.

(ii) Such seal shall be kept in the custody of the Registrar and deposited at the Office of the Board.

(iii) Such seal shall be affixed by the Registrar, in the presence of the chairman of the Board, to any writing when authorised by a resolution of the Board and not otherwise.

56. (i) The Appendices to these rules and the Forms and notes thereto contained in the First Appendix shall be deemed part of these rules.

(ii) Any form in the First Appendix may be varied, with the sanction of the Registrar, to meet the circumstances of the case.
