ORDER UNDER REGULATION 4 OF THE NATIONAL SECURITY (GENERAL) REGULATIONS.

REGULATIONS.

WHEREAS by regulation 4 of the National Security (General) Regulations it is provided (amongst other things) that if it appears to the Minister to be necessary or expedient in the interests of the Defence of the Commonwealth or the efficient prosecution of the war, or for maintaining supplies and services essential to the life of the community, that special precantions should be taken for the security of any place, he may by Order declare that place to be a prohibited place, either generally or during such hours or during the existence of such circumstances as are specified in the Order for the purposes of the Regulations: And whereas by Instrument of Delegation dated the thirtieth day of January, 1942, made in pursuance of section 17 of the National Security Act, 1939-1940, the Minister of State for War Organisation of Industry, acting for and on behalf of the Minister of State for Defence Co-ordination, delegated to every officer who should at any time during the continuance of the delegation be holding the office or performing the duties of the office of District Commandant of any Military District, the powers and functions

eonferred upon the said Minister by regulation 4 of the National Security (General) Regulations in relation to that Military District: And whereas it appears to me, Colonel Oswald Vick Hoad, Colonel Commanding Western Australia Lines of Communication Area, the officer for the time being performing the duties of District Commandant Fifth Military District, necessary and expedient in the interests of the defence of the Commonwealth and the efficient prosecution of the war, that special precautions should be taken for the security of the places referred to in the Schedule hereto, being places situate within the said Fifth Military District: And whereas by regulation 4 (6) (b) of the National Security (General) Regulations it is provided that the Minister may, if he thinks fit, in any Order made under subregulation (1) of this regulation, or by separate order, authorise any officer or person to issue permits to enter, approach, inspect, pass over, or be in or in the neighbourhood of a prohibited place: And whereas by regulation 4 (6) (e) of the National Security (General) Regulations it is provided that the Minister may, if he thinks fit, in any Order made under subregulation (1) of this regulation, or by separate order, specify an officer or person to exercise and perform the powers and functions of the officer or person in charge of any prohibited place for the purposes of these regulations: Now, therefore I, the said Colonel Oswald Vick Hoad, acting in pursuance of the said regulation and Instrument of Delegation do hereby order as follows:—(1) I hereby declare the place described in the Schedule hereto to be a prohibited place generally for the purpose of the National Security (General) Regulations from the date of the making of this Order; (2) I hereby authorise Henry Doyle Moseley, W. 237400, Temporary Lientenant-Colonel, Intelligence Corps, to issue permits to enter, approach, inspect, pass over, or be in or in the neighbourhood of the said prohibited place; (3) I hereby specify John Salter, M.C., W. 242887,

The Schedule.

Commonwealth of Australia. NATIONAL SECURITY (SUPPLEMENTARY) REGULATIONS.

Friendly Societies (Western Australia) Order.

WHEREAS by regulation 35 of the National Seenrity (Supplementary) Regulations it is provided that not-withstanding anything contained in the law of the State or any provisions governing any friendly society or branch thereof the Premier of any State may by Order published in the Government Gazette of the State make provision for and in relation to the postponement or cancellation of the holding of any meeting or conference, or of any election, or of the making of any appointment, the continuance in any office of any friendly society or branch thereof of any officer, the manner in which provisions governing any friendly society or branch thereof may be amended or added to, or my provision thereof repealed, and the payments to be made during the present war to the funds of any friendly society or branch thereof by the members thereof: Now, therefore I, John Collings Willcock, Premier of the State of Western Australia, do hereby make the following Order:—

- 1. This Order may be cited as the Friendly Societies (Western Australia) Order, and shall come into operation upon publication thereof in the Western Australian Government Gazette.
- 2. In this Order, unless the context otherwise requires:-
 - "the Act" means the Friendly Societies Act, 1894-1939, of Western Australia;
 - "Committee" means the body of persons appointed to manage and direct the affairs of any society or branch by whatever name such body may be called;

- "Registrar" means the Registrar of Friendly Societies appointed under the Act;
- "Society" means any friendly society registered or deemed to be registered under the Act.
- 3. (1) The committee may by resolution —
- (a) postpone for a period not extending beyond two years after the coming into operation of this Order, or cancel the holding of any meeting, conference, or election, or the making of any appointment, by, under, or pursuant to the Act or the constitution or rules of the society or any branch thereof;
- (b) continue in any office of the society (including membership of any committee, trustees, or other body), for a period not extending heyond two years after the coming into operation of this Order, any person holding or occupying that office for the time being;
- (e) during the present war amend, add to, or repeal any provision in the constitution, or rules, or other provisions (however designated) governing the society or branch thereof;
- (d) reseind any previous resolution made under this paragraph.
- (2) The committee of any branch of any society may by resolution, but subject to the consent in writing of the committee of the society, continue in any office of the said branch (including membership of any committee, trustees, or other body) for a period, not extending beyond two years after the coming into operation of this Order, any person holding or occupying that office for the time being, and, subject to the like consent, may by resolution reseind any such previous resolution.

- No amendment of, addition to, or repeal of any 4. No amendment of, addition to, or repeat of any provision of the constitution, rules, or other provisions governing a society shall be valid unless it has been submitted to and registered by the Registrar as an amendment of the rules under the Act.
- The Registrar may refuse to register any such amendment, addition, or repeal-
 - (a) if he is not satisfied that it has been rendered necessary as the result of the operation of this Order or by other circumstances arising out of the present war; or
 - (b) if he is of opinion that the amendment, addition, or repeal involves such a fundamental alteration to the constitution, rules, or other provisions governing the society or branch as renders it desirable that it should be made in accordance with the Act and the rules of the society or branch.
- 6. This Order and the exercise of powers under this Order shall take effect notwithstanding anything in the Act or the constitution or rules or other provisions governing any friendly society or branch thereof, but nothing in this paragraph shall prevent the Registrar

from requiring, in respect of any amendment, addition, or repeal pursuant to this Order, compliance with such provisions of the said Act as he specifies.

CIVIL DEFENCE (EMERGENCY POWERS) ACT, 1940.

Department of Mines, Perth, 6th May, 1942.

HIS Excellency the Lieutenant-Governor in Council, acting in exercise of the powers conferred by section 7 of the Civil Defence (Emergency Powers) Act, 1940, has been pleased to amend the Civil Defence Regulations, 1941, as published in the Government Gazette on the 17th day of October, 1941; the 20th day of February, 1942; the 27th day of February, 1942; the 20th day of March, 1942, and the 24th day of April, 1942, in the manner mentioned in the Schedule hereunder.

The abovementioned Civil Defence Regulations, 1941, are amended as follows:-

- 1. Regulation 2 (Gazettes 17/10/1941, 20/2/1942, 27/2/1942, and 20/3/1942) is amended by adding at the end thereof the words "Part VIII—rr. 102 to 125. Disposal of bodies of civilians killed by enemy action."
- 2. Regulation 19A (Gazette 20/3/1942) is amended by adding at the end of paragraph (2) thereof the words "and may include authority to requisition, take over, or otherwise acquire any house, building, or other premises and any vehicle and any article or thing which in the opinion of the Council is required for any civil defence purposes."
 - 3. Regulation 22 (Gasettes 17/10/1941 and 20/3/1942) is amended as follows:-
- (a) By deleting from paragraph (b) of the proviso to paragraph (1) of the said regulation the words "hereinafter prescribed" in line 2 of the said paragraph (b) and inserting in lieu thereof the words "in whose districts they reside respectively;"
- (b) by deleting from the proviso to paragraph (2) of the said regulation the words "hereinafter prescribed" in line 1 of the said proviso.
 - 4. Regulation 23 (Gazettes 17/10/1941 and 20/2/1942) is repealed.
- 5. Regulation 24 ($\it Gazettes$ 17/10/1941, 20/2/1942 and 20/3/1942) is amended as follows:—
- (a) by deleting from paragraph (1) (formerly (2)) the whole of subparagraph (f) and inserting in lieu thereof a new subparagraph as follows:—
 - (f) to order the manning of posts by the Civil Defence Forces.
- (b) by deleting from paragraph (1) (formerly (2)) the whole of subparagraph (g) and inserting in lieu thereof a new subparagraph as follows:—
 - (g) to requisition any house, building, or other premises, and any vehicle, and any articles or things which in his opinion are required for any civil defence purposes; and
- (e) by deleting the figure (2) from paragraph (2) (formerly (3)) of the said regulation where it appears in the last line of the said paragraph and inserting in lieu thereof the figure "(1);"
- (d) by deleting from paragraph (3) (formerly (4)) the word "and" in line 4 of the said paragraph;
- (e) by deleting from paragraph (3) (formerly (4)) the whole of subparagraph (f) and inserting in lieu thereof a new subparagraph as follows:—
 - (f) to requisition any house, building, or other premises, and any vehicle and any articles or things which in their opinion are required for any civil defence purposes; and
- (f) by inserting in paragraph (4) (formerly (5)) after the word "out" in line 3 of the said paragraph the words "subject to the directions of the Chief Warden or of the Deputy Chief Warden as the ease may require."
- (g) by deleting from subparagraph (g) of paragraph (4) (formerly (5)) the words "in ease of emergency" and inserting in lieu thereof the words "as an air raid precaution;"
- (h) by deleting from subparagraph (h) of paragraph (4) (formerly (5)) the words "in ease of emergency" and inserting in lieu thereof the words "as an air raid precaution;"
- (i) by deleting from subparagraph (i) of paragraph (4) (formerly (5)) the words "during any period of emergency" and inserting in lieu thereof the words "as an air raid precaution;"
- (j) by deleting from subparagraph (j) of paragraph (4) (formerly (5)) the words "during periods of emergency" in line 2 of the said subparagraph and inserting in lieu thereof the words "as air raid precautions;"
- (k) by deleting from paragraph (4) (formerly (5)) the whole of subparagraph (m1) (Gazette 20/2/42) and inserting in lieu thereof a new subparagraph as follows:—
 - (m1) to requisition any house, building, or other premises, and any vehicle and any articles or things which in their opinion are required for any civil defence purposes.
- (1) by deleting from subparagraph (0) of paragraph (4) (formerly (5)) all the words commencing in line 1 with the words "In addition" and ending with the word "following" in line 5 of the said subparagraph, and inserting in lieu thereof the words "In addition, all duly appointed head wardens shall be responsible for the organisation in their centres, in such manner as the Council may direct, of the following:—"
- (m) by deleting from subparagraph (e) of paragraph (5) (formerly (6)) the words "in ease of emergency" and inserting in lieu thereof the words "as an air raid precaution;"

(n) by deleting from subparagraph (f) of paragraph (5) (formerly (6)) the words "in ease of emergency" and inserting in lieu thereof the words "as an air raid (o) by deleting from subparagraph (g) of paragraph (5) (formerly (6)) the words "during any period of emergency" and inserting in lieu thereof the words "as an air raid precaution;"

(p) by deleting from subparagraph (h) of paragraph (5) (formerly (6)) the words "during periods of emergency" in line 2 of the said subparagraph and inserting in lieu thereof the words "as air raid precautions."

- 6. Regulation 54 (Gasette 20/2/1942) is amended by deleting all the words commencing in line 1 with the word "whenever" and ending with the word "shall" in line 4 of the said regulation and inserting in lieu thereof the words "Whenever the Council thinks it necessary as an air raid precantion and by a notice published in the Government Gazette so requires, the controlling authority of every internal sector within the portion or portions of the State which shall be specified in the notice, shall, until such notice is revoked or cancelled by a subsequent notice published in like manner."
- 7. Regulation 76 (Gazette 27/2/1942) is amended by deleting from paragraph (1) thereof the words "During the period of any emergency as proclaimed by the Governor General of the Commonwealth or as declared by the Council or the Commonwealth Military Authorities in this State" in lines 1, 2 and 3 of the said paragraph (1) and inserting in lieu thereof the words "Whenever the Conneil by a notice published in the Government Gazette declares that an emergency exists, and until such notice is cancelled or revoked by a subsequent notice published in a like manner,"
- 8. Regulation 86 (Gazettes 27/2/1942 and 20/3/1942) is amended by deleting from subparagraph (b) of paragraph (1) the word "emergeney" in line 1 of the said subparagraph (b) and inserting in lieu thereof the words "urgent necessity."
- 9. A new Part is added to the Regulations after regulation 101 (Gazette 20/3/1942) as follows:-

PART VIII .-- DISPOSAL OF BODIES OF CIVILIANS KILLED BY ENEMY ACTION.

102. For the purposes of the regulations contained in this Part-

- "Body" means the dead body of any member of the civil population in Western Australia, who, whilst residing in Western Australia, is killed or dies as the direct result of injury caused by any hostile action by the enemies of the Commonwealth of Anstralia during the present war.
- "Funeral Director" means a funeral director in Western Australia who is registered as such with the Council under these regulations, and to whom bodies are delivered for disposal as provided for in these regulations.

"Grave" includes an individual grave, and a communal grave.

"Morgue" shall mean any honse, building, or other place established by the Council for the purpose of holding bodies pending the disposal thereof.

"Owner" includes-

(1) in relation to land-

(a) the registered proprietor of the land, whether as the holder of a freehold or leasehold estate therein and not being a lessee or tenant of the registered proprietor of a paramount estate or interest therein;
(b) a mortgagee in possession of the land;

- (e) a trustee, attorney or authorised agent of any such registered proprietor or mortgagee who is not residing in the State;
- (2) in relation to a vehicle, the person registered as the owner of the vehicle under the provisions of the Traffic Act, 1919-1941.
- "Occupior" in relation to land, means any person in actual occupation of the land as lessee, tenant licensee or otherwise.
- "Police officer" means a member of the Police Force who is stationed at a morgue by the Commissioner of Police for the purposes of these regulations.
- "Unidentified body" means a body the identity of which is not known or cannot be ascertained before the expiration of twenty-four hours from the time when the body is placed in a morgue.
- The Council or a subcommittee of the Council authorised by the Council in that behalf may do all or any of the following things, namely:-
 - (a) keep a register of funeral directors:
 - (b) establish morgues;
 - (c) enter into and take possession of any house, building or premises for use as a morgue;
 - (d) require any funeral director to take delivery at a morgue of any body for disposal and to dispose of such body;
 - (e) requisition any vehicle for the conveyance of any body from the place where it is found to a morgue;
 - (f) requisition any article or thing required in connection with the exercise of any of the powers conferred by this regulation;
 - (g) require any member of the civilian population to render any assistance; in the exercise of any of the powers conferred by these regulations;
 - (h) require any Justice of the Peace to discharge the duties of a coroner and to sign and give any forms or certificates required to be signed or given under these regulations following a coronial inquiry;
 - (i) require the trustees, board, or other controlling person or body of any cemetery to set apart and make available such portions of the eemetery as may be required for use for graves both in those por-tions of the cemetery which are reserved for specified religions denominations and in those portions of the eemetery which are not so reserved.

- 104. (1) Every funeral director shall register himself as such with the Council.
- (2) Every funeral director earrying on business at the time when this regulation comes into operation shall apply for registration within thirty days after the date when this regulation comes into operation, and every funeral director who commences business after this regulation comes into operation shall apply for registration within thirty days after the date upon which he commences business as aforesaid.
- (3) Registration of a funeral director shall be effected by the funeral director making application for registration in writing in the Form No. 15 in the Appendix to these regulations, and by the Council entering in a register book, to be kept for the purpose, a memorandum of the particulars contained in such application.
- 4) Upon a funeral director being registered in accordance with this regulation, the Council shall cause to be issued a certificate of registration in the Form No. 16 in the Appendix to these regulations to the funeral director.
- (5) Any funeral director who fails or neglects to comply with the requirements of this regulation shall be guilty of a contravention of these regulations within the meaning of section twelve of the Act.
- 105. There shall be established at least one morgue, capable of holding at least fifty bodies, in each of the following localities, namely

 (a) the city of Perth;

 (b) the city of Fremantle;

 - (e) the local authority district of Claremont; (d) the local authority district of Guildford;
- (e) the locality known as Victoria Park, in the city of Perth; and, in addition, such other morgues in the localities aforesaid and in other localities as the Council or the subcommittee aforesaid thinks necessary.
- (1) Whenever the Council or the subcommittee aforesaid considers any house, building, or premises suitable for use as a morgue, and obtains the approval of the Commissioner of Publie Health to the use of such house, building, or premises as a morgue, the Council or the subcommittee may, after serving twenty-four hours' notice of its intention so to do, upon the owner or occupier of such house, building, or premises, enter and take possession thereof and establish the same as a morgue for the purposes of these regulations: Provided that, in a case of extreme urgency, the Council or the subcommittee may enter any house, building, or premises without giving any notice as aforesaid to the owner or occupier.
- (2) Whenever the Council or the subcommittee enters and takes possession of any house, building, or premises under this regulation, the owner or occupier thereof shall forthwith give to the Council or subcommittee full vacant and uninterrupted possession and enjoyment of the same.
- (3) If any owner or occupier refuses to give to the Council or the subcommittee possession of any house, building, or premises as provided in paragraph (2) hereof, or resists, hinders, obstructs, or in any manner attempts to prevent the Council or the subeommittee from obtaining such possession, the Council or the subcommittee may use such force as may be necessary to obtain such possession, and the owner or occupier offending as aforesaid shall be guilty of a contravention of these regulations within the meaning of section twelve of the Act.
- Whenever the Council or the subcommittee requisitions any vehicle, article, or thing in exercise of the power in that behalf contained in regulation 103 hereof, the owner, or the person for the time being in control or possession of such vehicle, article, or thing, shall forthwith comply in every respect and duly earry out any direction given to him by the Council or the subcommittee in relation to the taking or use of such vehicle, article, or thing, including the driving of the vehicle by such owner or person:

 Provided that—
 - - (i) this regulation shall not authorise the requisitioning, taking, or using of any vehicle which is employed in any service which the Council declares to be an essential service; and
 - (ii) where the vehicle is a motor vehicle, the owner or person in control thereof shall not be required to drive such vehicle unless he is supplied either by the Council or the subcommittee or some other authority with such motor spirit or other fuel as is necessary for the use of such vehicle.
- (1) Whenever the Council or the subcommittee, in the exercise of the powers contained in regulation 103 hereof, requisitions any vehicle, article, or thing, it shall make such requisition in writing, and serve the same upon the owner or person apparently in control of the vehicle, article, or thing requisitioned, and, if requested so to do by such owner or person, shall give to him a receipt or acknowledgment in respect of the vehicle, article, or thing requisitioned.
- (2) Every receipt or acknowledgment given by the Council or the subcommittee as provided for in this regulation shall, as far as possible, state the nature, number or quantity, condition, and value of the vehicle, article, or thing requisitioned.
- The property in any vehicle, article, or thing requisitioned under these regulations shall remain in the owner thereof, subject to the requisitioning thereof, and where any loss of or damage or injury to any such vehicle, article, or thing (other than fair wear and tear) is occasioned by negligence or wrongful conversion on the part of any person other than the Council or the subcommittee, the owner of such vehicle, article, or thing shall be entitled to recover from such person compensation in respect of such loss, damage, or injury in an action for tort.
- 110. The Conneil and the subcommittee and the members thereof shall not be personally liable for any loss of or damage or injury to any vehicle, article, or thing which has been lawfully requisitioned under these regulations.
- 111. When any vehicle, article, or thing which has been requisitioned is no longer required for the purpose for which it has been requisitioned, the Council or the subcommittee shall cause the same to be returned to the owner or other person from whom it was requisitioned.

- 112. If any owner or person from whom any vehicle, article, or thing is requisitioned under these regulations fails in any respect to comply with the lawful directions of the Council or the subcommittee in relation to the requisitioning of such vehicle, article, or thing, or obstructs or hinders or prevents or attempts to obstruct or hinder or prevent the requisitioning or taking or using of the vehicle, article, or thing requisitioned, he shall be guilty of a contravention of these regulations within the meaning of section twelve of the Act.
- 113. (1) It shall be the duty of every member of the civilian population, when called upon so to do by the Council or the subcommittee, to assist the Council or the subcommittee to the best of his ability, in accordance with its directions in connection with the work in relation to which his assistance is required.
- (2) Any person who, without reasonable excuse, refuses or fails to comply with or carry out any directions given by the Council or the subcommittee in contravention of these regulations, shall be guilty of a contravention of these regulations within the meaning of section twelve of the Act.
- 114. Whenever the Council or the subcommittee requests a Justice of the Peace to discharge the duties of a coroner in relation to a body, the Justice of the Peace, without any further authority than such request, shall have and may exercise all the powers and authorities of a Coroner under the laws of the State relating to Coroners, and, whenever a Justice of the Peace does discharge the duties of a coroner in relation to a body, he shall sign and furnish a certificate in the Form 17 in the Appendix to these regulations.
- 115. Any request by the Council or the subcommittee to the trustees, board, or other controlling person or hody of a cemetery, made under the authority of regulation 103 of these regulations, shall be made in writing, and such trustees, board, or other eontrolling person or body may, without any further authority than such request, and shall, do such acts, matters, and things as may be necessary to comply with and give effect to such request.
- (1) Whenever the Council or the subcommittee, acting under the anthority conferred by regulation 103 of these regulations, requires a funeral director to take delivery of and dispose of a body, such funeral director shall, as soon as reasonably may be, comply with such request.
- (2) Any funeral director who, without reasonable excuse, refuses or fails to comply with any request as provided for in paragraph (1) hereof, shall be guilty of a contravention of these regulations within the meaning of section twelve of the Act.
- 117. (1) Subject to these regulations, bodies shall be removed from the place
- 117. (1) Subject to these regulations, bodies shall be removed from the place where they are found to the nearest morgue, and, whenever possible, shall be so removed by first-aid parties, eivilian ambulanees, or other available means of transport.

 (2) The person in charge of a vehicle who receives a body for removal as aforesaid, or, where such removal is effected otherwise than by means of a vehicle, the person who undertakes such removal shall as soon as possible after receiving the body for removal and before finally giving delivery thereof at the morgue, fill in and attach to the body a label in the Form No. 18 in the Appendix to these regulations.
- 118. When sufficient means of conveyance are not available to remove at the one time all the bodies which may be found at any place from such place to a morgue, any bodies remaining at such place or elsewhere for such removal later shall, pending such removal-
 - (a) be placed inside a canvas container, to be provided and carried for the purpose by any persons who are charged with or undertake the duty of removing bodies to morgues; or

 (b) be covered or removed from public view by any person referred to in paragraph (a) hereof until such time as they are removed to a morgue.
- 119. While a body remains in a morgne, the police officer at such morgue shall have the custody thereof and be responsible in respect thereof.
 - (1) Every morgne established under these regulations-
 - (a) shall be under the charge of a police officer as the person in control thereof;
 - (b) shall contain-
 - (i) a viewing room, in the charge of a superintendent, funeral director, and two attendants, one of whom shall be the holder of a sanitation certificate;
 - (ii) a waiting room, in the charge of a clerical officer;
 - (iii) an office with telephone and security safe installed therein;
 - (iv) where possible a decontamination room;(e) shall be complete with necessary furnishings and fittings, cleansing apparatus, and necessary chemicals;
 - (d) shall contain separate sections for male and female bodies;
 - (e) shall, for the efficient management and administration thereof, have such staff of persons engaged therein as may be required, including such female attendants as may be necessary to assist in the identification and the determination of the sex of bodies.
- (2) The periods of attendance of the police officer and the staff of persons engaged in connection with a morgue shall be so arranged that, on the occasion of every emergency, there will be a police officer and a sufficient number of persons aforesaid in attendance at the morgue throughout the whole twenty four hours of every day during which such emergency continues.
- The functions and duties of the police officer at a morgue shall include the 121. following:
 - (a) he shall receive all bodies delivered at the morgue and give to the person delivering the same a receipt in the Form No. 19 in the Appendix to these regulations;
 - (b) upon receipt of a body at the morgue, he shall fill in and complete the particulars prescribed in the Forms No. 20 and 21 in the Appendix to these regulations;
 - (c) he shall cause the sex of the body to be ascertained;
 - (d) he shall take measures to obtain, if possible, identification of the body
 - (e) where the body is identified, he shall take steps to inform the next-of-kin of the deceased person;

- (f) where the body is not identified, he shall cause the body to be photographed by the Police authorities, and make a record of the particulars in relation to the hair, features, eyes, teeth, odd sears, deformities or other unusual marks in the Form No. 21 in the Appendix to these regulations;
 (g) he shall compile and keep a dossier for and in respect of each body, and
- keep therein, inter alia, all forms or copies of forms prepared in relation to such body;
- (h) he shall take steps for the holding of an inquiry to establish the eause of
- (i) he shall take charge of and keep in a safe place all articles and things found on a body pending the delivery of such article and things to the person who is entitled thereto;
 (j) he shall enter in writing in the Form No. 21 in the Appendix to these regulations a record with full particulars of all articles and things
- found on a body;
 (k) where a body has two identity dises attached thereto, he shall leave one of such dises so attached to the body for burial therewith, and shall attach the other to the dossier compiled in relation to the body;
- (1) where a Commonwealth of Australia identity eard is found on the body, he shall attach such eard to the dossier compiled in relation to the body;
- (m) he shall take measures to arrange within twenty-four hours after the delivery of a body at the morgue for the disposal of the body according to law.
- 122. Where a member of the civilian population is killed outright or dies from the result of any hostile enemy action before being placed under medical supervision, then a certificate in the Form No. 17 in the Appendix to these regulations signed and given by a Coroner or a Justice of the Peace shall, notwithstanding any other law or statutory provision to the contrary, be a sufficient warrant and authority for the burial or cremation of the body of such member of the civil population.
- 123. Where a member of the civil population is injured in consequence of any hostile enemy action, and having been removed to a hospital or placed under medical supervision, dies subsequently thereto, a certificate of the death of such member in the Form No. 22 in the Appendix to these regulations, signed and given by a medical practitioner in charge of such member whilst in the hospital or under the medical supervision aforesaid, shall, notwithstanding any other law or statutory provision, be a sufficient warrant and anthority for the burial or eremation of the body of such member of the civil population.
- 124. (1) For the purposes of these regulations, bodies shall be elassified as follows:-

Class A.—Bodies identified and elaimed; Class B.—Bodies identified and not elaimed; Class C.—Bodies not identified.

(2) Bodies in Class A shall be disposed of by burial or eremation by or on behalf and at the expense of the person who claims or, in accordance with law, is responsible for the disposal of the body.

The claimant or person aforesaid who receives the body aforesaid shall give to the person at the morgue who delivers the body to him a receipt for the same in the Form No. 23 in the Appendix to these regulations.

(3) Bodies in Class B or Class C shall be disposed of either by burial or cremation by the direction and at the expense of the Council.

Provided that any fees or charges, other than those payable for services rendered to a funeral director, shall not be included in any account rendered or charge made by the funeral director, but shall be payable by the Council direct to the person or body entitled thereto.

- 125. (1) No person (other than a person authorised in that behalf by these regulations, or by the Council or a member of the Civil Defence Forces, or a member of the Police Force) shall-
 - (a) remove, interfere with, dispose of or eause to be buried or cremated any body;
 - (b) obstruct or ineite, aid or abet any other person in obstructing any person lawfully earrying out his duties or exercising his powers under these regulations;
 - (c) enter any morgue without authority or adequate reason;
 - (d) remove from a body or detain or withhold any property, articles or effects found on such body;
 - (e) utter any document or form mentioned in the regulations contained in this Part;
- (f) knowingly give any false information regarding a body.(2) Any person who in any respect commits any breach of paragraph (1) of this regulation shall be guilty of a contravention of these regulations within the meaning section twelve of the Act.

follows:

7. (1) Every applicant for registration as a medical practitioner shall, at least five clear days before the then next ordinary monthly meeting of the Board, lodge with the Registrar-

(a) subject as hereinafter provided, all diplomas by virtue of which he

claims to be registered;
(b) a declaration in the Form A in the Schedule; and

(c) a registration fee of three gnineas:

Provided that, wherever for any reason beyond his control an applicant is unable to produce any diploma required under paragraph (a) above, but presents to the Registrar a statutory declaration that he is the grantee of a diploma registrable in the United Kingdom of Great Britain and Northern Ireland and Eire, and setting out the name of the University or College by which and the date upon which such diploma was granted, the Board may dispense with the production of such diploma and grant registration subject to the applicant producing to the Registrar such diploma, or an authenticated copy thereof, if and when required by the Board so to do, and subject to such registration being cancelled if the applicant fulls to comply with any requisition by the Board as aforesaid.

(2) Paragraph (1) of this regulation shall have effect and shall be deemed to have had effect as from and including the first day of January, 1942, in the same manner and to the same extent as if it had already been made and been in force on the said date.

FREMANTLE HARBOUR TRUST.

Amendment of Regulations.

THE Fremantle Harbour Trust Commissioners hereby amend the regulations made under the Fremantle Harbour Trust Act, 1902, and as reprinted by the Government Printer with all amendments up to the thirtieth day of April, 1941, as follows:—

By inserting after regulation 302 the following new regulations:

No. 302A.

Vehicles on Wharves or in Sheds.—(a) The driver of every motor driven vehicle, if he receives permission to drive into any cargo shed or upon the wharves, shall not leave the immediate vicinity of his vehicle and shall not take or permit the vehicle to approach within fifty feet of any inflammable goods.

(b) The driver or person in charge of a motor driven vehicle shall not permit the said vehicle to be present within any cargo shed for any greater length of time than is necessary for the discharging or loading of the vehicle.

No. 302B.

Vehicles equipped with Producer Gas Plant.—(a) A person driving or in charge of a vehicle equipped with and being operated by a producer gas unit shall not drive or take such vehicle upon any wharf or inside any cargo shed upon the wharves unless the unit fitted or attached to such vehicle has been duly licensed under the regulations made under the Traffic Act.

- b) No vehicle so equipped shall be permitted by the driver thereof to come to a stop at any place or in any position within a cargo shed whereby the generator of the producer gas unit attached thereto will then be less than five feet from the tank of any other vehicle containing inflammable liquid.
- (c) The following requirements shall also be observed by the drivers or persons in charge of such vehicles whilst on the premises of the Trust :-
 - (i) An approved fire extinguisher must be provided;
 - (ii) The generator of the producer gas unit must not be opened for any purpose whatsoever and the ash door must be kept securely closed;
 - (iii) The unit must be fitted with an efficient flame trap, and any apparatus installed to create a natural draft through the generator when the engine is stopped must be fitted with a copper gauze cover to prevent escape of naked flame;
 - (iv) Dangerous goods shall not be stacked on any such vehicle within at least twelve inches of the generator of the producer gas unit.

(d) Any person committing a breach of the foregoing regulations shall be liable to a penalty not exceeding one hundred pounds (£100) in respect of each breach.

IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

(Nos. 22, 23, 24, 25, and 26 of 1941.)

Between the Hotel, Club, Caterers, Tea Room, and Restaurant Employees' Industrial Union of Workers, Perth, Applicant, and Messrs. D. Coffey, J. Moran, J. Monaghan, J. Cassady, and A. T. Rex, Hotel Proprietors; H. V. Piesse, Coffee Palace Proprietor, Respondents.

WHEREAS industrial disputes existed between the abovenamed parties: And whereas the said disputes were referred into Court for the purpose of hearing and determination: And whereas the parties subsequently met and conferred and have arrived at agreement on all matters in difference: And whereas the parties have this day appeared before the Court by their respective representatives and requested the Court to declare the said agreements an Award: Now, therefore the Court, pursuant to section 63 of the Act and all other powers therein enabling it, hereby declares the memorandum hereunder written to have the same effect as and be deemed an Award of the Court :-

Memorandum of Agreement.

(Note.-Wherever the word "Award" occurs herein it shall be taken to mean and include "Agreement.")

1.—Area.

This Award shall have effect over the area comprised within a radius of five (5) miles from the Post Office in each of the following towns:—Beverley, Wagin, Narrogin, Katanning, and York.

2.—Term.

The term of this Award shall be one (1) year from midnight Sunday, the 3rd May, 1942.

3.--Hours.

- (a) Forty-four (44) hours shall constitute a week's work.
- (b) A worker who is at liberty to leave the premises of the employer for any time, being not less than half an hour, but elects to remain thereon, the time he remains on the premises shall not be included in his or her working time.

4.—Spread of Shift.

(a) Daily spread of shift shall mean the time which elapses from the worker's starting time to the worker's finishing time for the day.

(b) Weekly spread of shift shall mean the aggre-

5.—Breaks in Shift.

In addition to breaks of at least half an hour but not more than one hour each for meals, there may be a break of at least two (2) hours during each shift. Such break of at least two (2) hours may include a meal break.

6.-Night Work.

Except for night porters, any work done after 12 o'clock midnight and before 5 o'clock a.m. shall be paid at treble time rates, in the ease of females, and time and a half, in the ease of male workers.

7.—Wages.

The following shall be the minimum rates of wages payable to workers per week:-

8.-Definitions.

- "Cellarman" shall mean a worker who is ex-clusively or principally engaged in the breaking down and bottling of spirituous liquors in the cellar of an hotel.
- "Waiter" shall mean a worker who serves at table and attends to all the requirements of guests while having meals.

For the purpose of this Award, "Coffee Palace" means a residential establishment, not being an hotel licensed to sell fermented or spiritnons liquors, nor a boarding-house, where (in addition to permanent or weekly boarders and/or lodgers, or where permanent or weekly boarders and/or lodgers are not necessarily catered for) boarders and/or lodgers are eatered for, for pay or reward, for a period of less than one (1) week at a time, or where, in addition to catering for lodgers, whether permanent or otherwise, a dining room is maintained which is open to the public.

Provided that the term "Coffee Palace" shall not include an establishment where not more than eight (8) boarders and/or lodgers, not being members of the proprietor's family, are received for pay or re-ward and which has no public dining room, but such establishment shall be deemed to be a boarding-house.

9.-Junior Workers.

(a) Male workers—All establishments:—Male workers under the age of twenty-one (21) years may be employed as junior workers in any of the occupations covered by this Award, in the proportion of one junior to every two or fraction of two adult workers employed in the same occupation at the following rates:-

Provided that, where no adult is employed, one junior male may be employed, except in the kitchen.

(b) Female workers-Coffee Palaces only:-Female workers under the age of nineteen (19) years may be employed as junior workers in any of the occupations covered by this Award, in the proportion of one junior to every two or fraction of two adult workers employed in the same occupation, at the following rates, in addition to board and lodging:-

10.-Overtime.

All work done outside the daily spread provided in clause 4 or beyond eight (8) hours in any one day, or beyond forty-four (44) hours in any one week, shall

be deemed to be overtime.

Overtime shall be paid for at the rate of one-third, in addition to the ordinary rate herein prescribed: Provided that any overtime in excess of seven (7) hours in any one week shall be paid for at the rate of double time.

11 .- Weekly Holidays.

All workers (other than night porters) shall be entitled to receive one full day off duty in each week: Provided always, that in the case of an employer employing not more than three (3) workers under the provisions of this Award, two half days may be granted by agreement between the employer and the worker in lieu of one full day. If no agreement can be reached as to whether two half days in lieu of one full day off shall be allowed the matter shall be referred to the shall be allowed, the matter shall be referred to the Board of Reference for decision.

A yardınan, handyman, or ımspecified male worker entitled under this clause to receive one full day off duty in each week may, by agreement between his employer and the union, be granted two half days off duty in each week in heu of one full day.

The half day off shall, if taken in the morning, terminate at 2 p.m., and, if taken in the afternoon, shall commence at 2 p.m. A worker shall not be required to work more than four (4) hours on the day on which his half day off occurs.

Night porters:—Night porters shall be entitled to one night off duty in each week: Provided that, if work is performed by a night porter in lieu of his night off, he shall be paid one-third in addition to his ordinary wage for that night. This provision shall not be availed of more than on six (6) nights in any one year. Any dispute arising out of this provision shall be referred to the Board of Reference.

All work done on Christmas Day or Good Friday shall be paid for at the rate of double time.

12.—Annual Holidays.

- (a) On completion of twelve (12) months' service each worker shall be entitled to two (2) weeks' holiday on full pay, without any deduction for board and/or lodging.
- (b) The annual holiday shall be granted within three (3) months of its becoming due.
- (c) Provided that any worker who shall have served one mouth or over, and whose contract of service shall have been terminated by either party for any cause other than misconduct before the annual holiday became due, such worker shall be entitled to receive a proportionate allowance of holiday pay for the time actually
- (d) A worker dismissed for misconduct shall forfeit all right to holiday pay under this clause.
- (e) Any time in respect of which a worker is absent from work, except time for which he is entitled to claim sick pay in accordance with the provisions of clause 25 hereof, shall not count for the purpose of determining his right to holidays.

13.-Meals.

- (a) Where full board is provided, workers shall be provided with three meals per day, such as are daily served in ordinary family hotels. Such meals shall include a dinner consisting of at least three courses.
- (b) Subject to clause 5 at least one half hour, but not more than one hour, shall be allowed for each meal.

14.—Casual Workers.

- (a) A casual worker shall mean a worker engaged on an hourly contract of service.
- (b) Casual workers shall be paid at the rate of time and a half.
- (c) Casual workers shall not be engaged for less than three (3) hours.

15.—Climbing Ladders.

No waitress shall be permitted or compelled to climb ladders for the purpose of cleaning electric fans, fanlights, walls or windows.

- (a) A roster of the working hours shall be exhibited in the office of each establishment, and in such other place as it may be conveniently and readily seen by each worker concerned.
- (b) Such roster shall denote the hours to be worked by each worker and shall be open for inspection by a duly accredited representative of the union, in the office, at such time and place as the Record Book is so open for inspection.
- (e) Such roster shall be drawn up in such a manner as to show the hours of each worker for one week in advance of the date of the roster, and may only be altered on account of the sickness or absence of a worker, or on account of any contingency that the employer could not reasonably foresee.

17.-Weekly Wage.

Wages shall be paid, at least, weekly.

Except for easual workers, the contract of service shall be on a weekly basis: Provided that one day's notice of termination of service may be given on either side.

18.-Board and Lodging.

For all workers, except in the ease of junior females, where board is provided, the employer shall be entitled to deduct eighteen shillings and twopenee halfpenny (18s. 2½d.) for males and seventeen shillings and ninepenee (17s. 9d.) for females per week; and, where lodging is provided, eight shillings (8s.) for males and seven the form of the period shillings and tenpence halfpenny (7s. 101/2d.) for females per week. The board and lodging deductions prescribed shall vary proportionately with the rise or fall in the

Where a worker notifies the employer on the day immediately preceding his or her day off, or half day off, as the ease may be, that he or she does not desire a meal or meals to be provided on such day off or half day off, the foregoing deductions for board shall be reduced by a proportionate amount for each such meal.

19.—Accommodation.

An employer requiring a worker to sleep in shall provide suitable accommodation. If the worker shall consider the accommodation unsuitable, any party to this Award may refer the matter to the Board of Reference for decision, as provided in clause 27.

20.-Uniforms.

If the employer requires female employees to wear stiff white euffs, collars, or white aprons, he shall pay to such employees the sum of one shilling (1s.) per week for the laundering of same; otherwise he shall eause the same to be laundered at his own expense.

If the employer requires white coats to be worn by his male employers, he shall pay them one shilling (1s.) per week extra for the laundering of the same, or cause such white coats to be laundered at his own expense.

The employer may require plain white headbands to be worn by female employees.

21.-Change and Rest Rooms.

Adequate change and rest rooms shall be provided by the employer, in eases where the employees do not reside on the premises.

22.-Under-rate Workers.

(a) Any worker who by reason of old age or infirmity is unable to earn the minimum wage may be paid such lesser wage as may from time to time be agreed upon in

writing between the union and the employer.

(b) In the event of no agreement being arrived at the matter may be referred to the Board of Reference

for determination.

(c) After application has been made to the Board, and pending the Board's decision, the worker shall be entitled to work for and be employed at the proposed lesser rate.

23.—Record.

(a) The employer shall keep, or eause to be kept at his business premises, or at each of them, if more than one, a Time and Wages Book, wherein shall be entered the name, occupation and, in the ease of junior workers, the age on his or her last birthday, the time each worker eommenees and finishes work each day, and the total honrs worked each week, and the wages paid to each worker.

- (b) The record shall be entered up from day to day.(c) The word "book," for the purpose of this elause, shall include loose leaves, if bound together and numbered consecutively.
- (d) The employer and the worker shall be severally responsible for the proper daily entering of the record, which shall be initialed, if correct, by the worker daily. The hours shown as worked in the Record Book shall be prima facie evidence of the correctness thereof in any proceedings for the enforcement of this Award.
- (e) The book shall be open to inspection by a duly accredited representative of the union, at the office of the employer, on days other than Saturday and Sunday, between the hours of 9 a.m. and 5 p.m. (except from 1 p.m. to 2 p.m.).

24.-Higher Duties.

Any worker performing work for more than two (2) hours in any day on work earrying a higher prescribed rate of wage than that in which he is engaged shall receive such higher wage for the time so employed.

25.—Payment for Siekness.

- (a) A worker shall be entitled to payment for non-attendance, on the ground of personal ill-health, for one half (½) day for each completed month of service: Provided that payment for absence through such ill-health shall be limited to six (6) days in each calendar year. Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the siekness to a greater allowance than that made at the time the siekness occurred. This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.
- (b) A worker shall not be entitled to receive any wages from his employer for any time lost through the result of an aeeident not arising out of or in the eourse of his employment, or for any aeeident, wherever sustained, arising out of his own wilful default, or for siekness arising out of his own wilful default.
- (c) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

26.-Junior Worker's Certificate.

Junior workers, upon being engaged shall, if required, furnish the employer with a certificate containing the following particulars:-

 Name in full.
 Age and date of birth.
 Name of each previous employer.
 Class of work performed for each previous employer.

Such of the foregoing particulars as are within the knowledge of an employer shall be indorsed on the eertificate and signed by the employer, upon request of the

No worker shall have any claim upon an employer for additional pay, in the event of the age of the worker being wrongly stated on the eertificate.

27.—Board of Reference.

(a) The Court hereby appoints, for the purpose of the Award, a Board of Reference.

The Board shall consist of a chairman, to be appointed by the Court, and two other representatives, one to be appointed by each of the parties.

The Board is hereby assigned the following functions, in the event of a disagreement between the parties bound by the Award:-

- (i) elassifying and fixing wages, rates, and conditions for any occupation or calling not specifically mentioned in the Award, but so as not to contravene any of the provisions herein;
- (ii) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of the Award or any of them;
- (iii) deciding any other matter that the Court may refer to the Board from time to time.
- (b) The provisions of regulation 92 of the Industrial Arbitration Aet, 1912-1935, shall be deemed to apply to any Board of Reference appointed hereunder.

28.-No Victimisation.

No employer shall dismiss any worker from his em-No employer shall dismiss any worker from his employment or injure him in his employment, or alter his position to his prejudice, by reason merely of the fact that the worker is a member of the Hotel, Club, Caterers, Tearoom, and Restaurant Employees' Industrial Union of Workers, or by reason of the fact that such worker is entitled to all the benefits of this Award.

INDUSTRIAL AGREEMENT.

(No. 10 of 1942). (Reg. 22/4/42.)

THIS Agreement, made in pursuance of the Industrial Arbitration Act, 1912-1935, this 5th day of March, one thousand nine hundred and forty-two, between The West Australian Shop Assistants and Warehouse Employees' Anstrahan Shop Assistants and Warehouse Employees' Industrial Union of Workers, Perth (hereinafter called 'the Union'), of the one part, and Berryman & Langley, Limited; F. W. Lantzke; B. Mercer, Limited; Producers' Markets Co-operative, Limited; Scanlan & Simper, Limited; T. Newby (hereinafter called "the Employers"), of the other part, witnesseth that, for the considerations hereinafter appearing, the parties hereto mutually covenant and agree the one with the other as follows:

1.—Aren.

This Agreement shall be limited in its effect to the area comprised within a radius of fifteen (15) miles from the General Post Office, in the City of Perth.

The term of this Agreement shall be one (1) year from the date hereof.

3.-Definitions.

(a) "Weekly worker" shall mean a worker engaged by the week and whose contract of service shall be ter-minated by not less than one (1) week's notice on either side, which may be given at any time. Such week's notice enmot be continued from week to week.

(b) "Head storeman" shall mean a person performing the duties of a storeman and who is in charge

of two or more men.

(c) "Casual worker" means a worker engaged by the hour and who may be put off or leave the employer's service at any moment without notice: Provided that, when engaged on Tuesdays, Thursdays, or Saturdays, a casual worker shall receive a minimum payment of not less than two (2) hours' pay. If engaged on Mondays, Wednesdays, or Fridays a casual worker shall receive a minimum payment of not less than four (4) hours' a minimum payment of not less than four (4) hours pay.

4.—Scope.

This Agreement shall apply in respect of all work rans Agreement shall apply in respect of all work performed by any employee who in the course of his duties is employed principally as a storeman in businesses such as those conducted by the parties to this Agreement, but shall not apply in respect of any employee who is employed in the terms of the Road Transport Workers' Award.

5.-Hours.

Forty-four (44) hours shall constitute a week's work,

- which shall be worked by weekly workers as follows:—
 (1) In Fruit and Produce Markets (including Poutry and Carcase Meat Markets), other than Fremantle:-
 - (a) On Mondays, Wednesdays, and Fridays—between 4 a.m. and 5 p.m.: Provided that the spread of hours on those days shall not, in respect of any worker, exceed twelve (12) hours, inclusive of meal times.

Meal times:—In respect of weekly workers, not less than forty-five (45) minutes shall be allowed for lunch, such period to be completed not later than 2 p.m. In respect of weekly workers commencing duty before 5.30 a.m., not less than fifteen (15) minutes shall be allowed for breakfast, to be completed act later than 8 c.m. pleted not later than 8 a.m.

In respect of casual workers, not less than half an hour shall be allowed for lunch, such period to be completed not later than 2 p.m. In respect of casual workers commencing duty before 5.30 a.m., not less than fifteen (15) minutes shall be allowed for breakfast, to be completed not later than 8 a.m.

(b) On Tuesdays and Thursdays-between 8 a.m. and 5 p.m.

Meal times: -Three-quarters of an hour shall be allowed for hunch, to be completed not later than 2 p.m.

- (c) On Saturdays-between 8 a.m. and 12 noon. n Saturdays—between 8 a.n. and 12 noon. Provided that any weekly worker required to work on Monday, Wednesday, Friday, and Saturday in any one week shall be entitled to a full Tuesday or Thursday off during that week, but this shall not apply to any weekly worker who is not, on any day except Friday in that week, called upon to start work before 7 a.n. and who on that Friday is not called upon to start work before 6 a.m.
- (2) Provided that, in Fremantle Fruit and Produce Markets, the hours and conditions stated in subclause (1) hereof shall not apply, but the following shall apply:-

(a) On Mondays and Thursdays-between 5.30 a.m.

and 5 p.m.

Meal times:—Not less than one half-hour shall be allowed for hunch, to be completed not later than 2 p.m. In respect of workers commencing duty before 5 a.m., not less than fifteen (15) minutes shall be allowed for breakfast, to be completed not later than 8.30 a.m.

(b) On Tuesdays, Wednesdays, and Fridays-be-

tween 8 a.m. and 5 p.m.

Meal times:—One (1) hour shall be allowed, to be completed not later than 2 p.m.

- (c) On Saturdays-between 8 a.m. and 12 noon.
- (3) In respect of the employees of Wholesale Fruit and Produce Packers, the following home shall apply:—
 - (a) On Mondays, Wednesdays, and Fridays—between 6.40 a.m. and 5 p.m.
 - (b) On Tuesdays and Thursdays-between 8 a.m.

and 5 p.m.

Meal times:—On any of the days specified in subclauses (3) (a) and (b), one (1) hour shall be allowed for hinch, between 12 noon and 2 p.m.

(e) On Saturdays-between 8 a.m. and 12 noon.

6 .-- Overtime.

For all time worked by weekly or easnal workers:-

- (a) After 12 noon on Saturdays and on the holidays specified in clause 7 (a) hereof, and in respect of casual workers on the holidays specified in clause 7 (b) hereof—double time shall be paid.
- (b) For all time worked prior to the specified starting or after the specified finishing times, or in excess of the specified spread in any one day, or in excess of forty-four (44) hours in any one week—time and a half shall be paid.

7.-Holidays.

Weekly workers shall be entitled to the following holidays:

- (a) Specified holidays:—The following days, or the days observed in lieu, shall be observed as holidays and paid for, namely, Good Friday, Easter Saturday, Labour Day, and Christmas Day.
- (b) Alternative holidays:—If any weekly worker is called upon to work on any of the following days or the days observed in lieu he shall be allowed one day off in lieu of each day so worked, and shall have same added to his annual holidays:—New Year's Day, Easter Monday, Anzae Day, Foundation Day, Anuiversary Day, and Boxing Day.

Margin per Weck.

(e) Annual holidays:—Weekly workers shall be entitled to one week's leave on full pay in respect of each year's service. Subject to completion of one year's service, such employees, on termination of their employment, shall be entitled to leave in the proportion that their incomplete year of service bears to one complete year: Provided that this clause shall not apply in the ease of any worker summarily dismissed for misconduct or dereliction of duty.

(d) Annual leave shall be granted within four (4)

A worker relieving for a period of not less than two days continuously another worker who is engaged on a higher class of work carrying a higher rate of wage under this Agreement shall be paid the higher minimum rate appropriate to the position whilst so employed.

11.-Time and Wages Record.

The employer shall keep and enter up, or cause to be kept and entered up, a record, containing the names of each of his workers to whom this Agreement applies, the class of work performed by and the wages paid to each worker, the age of each junior worker, and the time during which each worker has been employed. Such record shall be open to inspection by a representative of the union between the hours of 10 a.m. and 4 p.m. on any working day from Monday to Friday inclusive.

12 .- Meal Money.

Workers who are required to work for more than one half hour after the prescribed finishing times in clause (5)—Hours—shall be paid one shilling and sixpence (1s. 6d.) meal money.

13.-Under-rate Workers.

(a) Any worker who by reason of old age or infirmity is unable to earn the minimum wage may be paid such lesser wage as may from time to time be agreed upon in writing between the union and the employer.

(b) In the event of no agreement being arrived at, the matter may be referred to the Board of Reference

for determination.

(c) After application has been made to the Board, and pending the Board's decision, the worker shall be entitled to work for and be employed at the proposed lesser rate.

14.-Junior Worker's Certificate.

Junior workers shall furnish the employer with a certi-

Junior workers shall furnish the employer with a certificate showing the following particulars:—

(1) Name in full.
(2) Age and date of birth.

The certificate shall be signed by the worker.
No worker shall have any claim upon the employer for additional wages, in the event of his age being wrongly stated on this certificate: Provided that this subclause shall operate only for the first three (3) months from the date of the worker's first engagement, thereby enabling the employer, if he so desires, to obtain proof of the junior worker's age.
