WHEREAS by section 9 of the Fisheries Act, 1905-1940, it is provided that the Governor may by Proclamation prohibit all persons from taking any fish whatsoever, in every or any specified portion of Western Australian waters, by means of fishing nets and fishing lines, or either of such means of capture, or by any other specified means of capture, for any specified term: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of every hereby, in exercise of the powers aforesaid and of every other power enabling me in this behalf, proclaim and declare as follows:—That all those portions of Western Australian waters defined in the Schedule hereto shall be closed against the use of fishing nets for a period of twelve months as from the date of the publication of this Proclamation in the Government Gazette:-

Schedule.

- (1) Wellstead Estuary:-The whole of the rivers, tributariès, creeks and other streams flowing into the waters of the Wellstead Estuary, more especially the S.W. Bay River and Lizzie Creek.
- (2) Beaufort Estuary:—The whole of the rivers, tributaries, and other streams flowing into the waters of the Beaufort Estuary, more especially the Pallinup and Salt Rivers.
- (3) Eyre River:—The whole of the waters of the Eyre River and its tributaries from its entrance into the Southern Ocean upwards to its source.

WHEREAS by section 9 of the Fisheries Act, 1905-1940, it is provided that the Governor may by Proclamation prohibit all persons from taking any fish whatsoever in every or any specified portion of Western Australian waters, by means of fishing nets and fishing lines, or either of such means of capture, or by any other specified means of capture, for any specified term: And whereas by section 10 of the said Act, every such Proclamation may be revoked or varied at any time. Now therefore may be revoked or varied at any time: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of every other power thereunto me enabling, vary the Proclamation dated 19th December, 1940 (published in the Government Gazette of 3rd January, 1941), by omitting from the Schedule thereto the paragraph numbered (3) and inserting in lieu thereof the following new paragraph (3):—

(3) The waters of the Swan River and its tributaries north, north-west, south, and south-west of a line drawn from a point situated on the western shore of Reserve 1486 and twenty chains south of Point Walter to the southerly beacon marking the Point Walter Sand Spit; thence to the northerly beacon marking the said Sand Spit and thence in an easterly direction to the southwestern extremity of Point Resolution, downwards to a line drawn from the western extremity of the South Mole to the western extremity of the North Mole at Fremantle. WHEREAS by the Fisheries Aet, 1905-40, it is provided that the Governor may by Proelamation deelare, inter alia, that any Western Australian waters shall be elosed against the taking of any prescribed species of fish, by any means whatever, or against fishing generally by any method of eapture, during any specified time, in any year: And whereas it is desirable that the waters of the Dale River should be declared closed against the taking of English Perch: Now, therefore I, the said Lieutenant-Governor, with the advice and consent of the Executive Council, do hereby declare as follows:—That the waters of the Dale River shall be closed against the taking of English Perch by any method of capture whatever for a period of three years as from the 8th day of May, 1942.

The by-laws for the control of the Medical Fund of the Big Bell Hospital, as made by the Big Bell Hospital Board of Management under section 23 of the Hospitals Aet, 1927, and published in the Government Gazette on the 11th day of July, 1941, are amended as follows:—

By-law 7 is amended by deleting therefrom the words "Major operations, with the exception of urgent operations (an urgent operations is one where the postponing of the operation for more than twenty-four hours after the decision to operate has been made would in the opinion of the medical officer be detrimental to the health of the patient) "where they appear in lines 12 to 18 of the said by-law, and inserting in lieu thereof the following words:—"Dental operations and major surgical operations (for which the foat to be paid shall surgical operations (for which the fees to be paid shall be subject to private arrangement between the member and the medical officer) provided that the following surgical procedures, namely:—opening boils or absecsses, suturing wounds, setting fractures and other similar minor operations, when performed without the use of a general anaesthetie, shall not be deemed to be major surgical operations, and shall be free of charge.'

Whereas under the provisions of section 23 of the Hospitals Act, 1927, a Board may itself establish and manage a Medical Fund, the object of which shall be to secure for its subscribers medical attendance, hospital treatment, or other similar benefits; and may, by by-laws, provide for the regulation and control of such Fund: And whereas a Medical Fund has been established by the Board of Management at the Laverton District Hospital: Now, therefore, the said Board of Management, acting pursuant to section 23 of the Hospitals Act, 1927, do hereby make by-laws for the regulation and control of the said Medical Fund in the manner set forth in the Schedule hereunder.

Schedule,

LAVERTON DISTRICT HOSPITAL.

By-laws for the Control of Medical Fund under Section 23 of the Hospitals Act, 1927.

- 1. The term "subscriber" shall mean any person, male or female, who has paid his or her subscription and is financial, and shall include, so far as benefits are concerned, all dependants of the subscriber.
- 2. The subscription to be paid by a subscriber shall be 8s. 6d. per month, £1 5s. 9d. per quarter, £2 11s. 6d. per half year, or £4 19s. 0d. per full year, as the subscriber may elect. The amounts so subscribed shall be inclusive of a levy of 6d. per month for the purpose of ereating a Fund whereby to maintain the ambulance and

seeure free service to subscribers; (b) Non-subscribers and compensation eases shall be charged at the rate of 1s. per mile when use of the ambulance is made.

- 3. The word "dependant" shall mean the wife, parents, and grandparents of a subscriber, the sons, daughters, brothers and sisters not over sixteen years of age of a subscriber who are actually residing with and wholly dependent on him at the date of the illness or accident which the Medical Officer is required to treat.
- (b) If the Medical Officer is not aware or is in doubt as to whether any person is or is not a dependant, he may refer the matter to the secretary and be guided by his decision.
- 4. Every subscriber shall be entitled to medical and hospital treatment as an indoor or outdoor patient and to medicines, dressings, and appliances, subject to the conditions and limitations set forth in these by-laws for so long as the Medical Officer deems necessary, free of charge.
- 5. Subscribers employed by any mining company or any other company, shall be deemed to be financial as from the date of their employment: Provided that the management undertakes the collection of their subscriptions from wages due.
- 6. Subscribers shall not receive free treatment in any of the following eases:---
 - (a) Ineurable diseases.
 - (b) Disorders for the cure of which other establishments are provided.
 - (e) Any person requiring food and not medicine and who is more properly the subject for a benevolent institution.
 - (d) Venereal disease.
 - (e) Aleoholism, or conditions resulting therefrom.
 - (f) Dentistry.
 - (g) Insanity.
 - (h) Accouchements (abortive or otherwise).
 - Any person for any condition for which he is already covered by insurance under the provisions of the Workers' Compensation Act.
 - (j) Sera and vaccines.
 - (k) Pathological examination fees.
 - (1) Dental operations and major surgical operations. (Fees for all operations to be subject to private arrangement between the member and the Medical Officer.) The following surgical procedures, if performed without a general anaesthetic, shall be deemed minor operations and be free of charge—opening boils, absecsses, suturing wounds, setting fractures and other minor operations.
 - (m) No patent medicines or any medicines prepared and sold under any proprietary name will be supplied free of charge to any subscriber or his dependants, unless the Board decide that any particular medicine may be included as a benefit. In all other cases any patent medicine or proprietary line prescribed by the Medical Officer must be paid for by the subscriber at a price to be fixed by the Board.
- 7. Subscribers and their dependants requiring ontpatient attendance shall attend at the Medical Officer's surgery, between such times as shall be fixed by the Board from time to time.
- (b) The Medical Officer shall be in attendance at his surgery for treatment of subscribers at the hours fixed by the Board.
- 8. When a subscriber, residing outside a radius to be fixed by the Board, requires the services of a Medical Officer, he shall pay the Medical Officer mileage at such rates as shall be arranged between the Fund and the Medical Officer.
- 9. The doctor shall keep such records as the Board may determine from time to time.
- Coneessional rates to subscribers—maternity eases £2 10s. 0d. per week, prenatal cases £1 10s. 0d. per week.

WHEREAS an industrial dispute existed between the abovenamed parties: And whereas the said dispute was referred into Court for the purpose of hearing and determination: And whereas the parties subsequently met and conferred and have arrived at agreement on all matters in difference: And whereas the parties have this day appeared before the Court by their respective representatives and requested the Court to declare the said agreement an Award: Now, therefore, the Court, pursuant to section 63 of the Act and all other powers therein enabling it, hereby declares the memorandum hereunder written to have the same effect as and be deemed an Award of the Court:—

Momorandum of Agreement.

(Note:-Wherever the word "Award" occurs herein it shall be taken to mean and include "Agreement.")

1.—Area and Scope.

This Award shall apply to all pilots in the service of the Fremantle Harbour Trust Commissioners and shall operate within or in the vicinity of the boundaries of the Fremantle Harbour as described in the Schedule to the Fremantle Harbour Trust Act.

2.—Definitions.

"Pilot" means any pilot duly licensed by the Governor.

"Trust" means the Fremantle Harbour Trust, and includes the Commissioners constituted under the Act and in office for the time being.

3.—Rates of Pay.

- (a) Basic wage-£4 10s. 5d. per week, representing £235 16s, 9d. per annum.
 - (b) The margins over the basic wage shall be:-

First year's service .. £469 3 3 per annum Second year's service . . £519 3 per annum .. £569 3 3 per amium Thereafter

- (c) In computing the year of service, the period served by pilots with the Trust prior to the date of this Award shall be taken into account.
- (d) Salaries shall be payable weekly up to and including the date of payment.

4.-Hours of Duty.

(a) Each pilot shall be available for duty as and when required during the whole of the twenty-four hours of each of five days in each week. As regards the other two days, which may be consecutive, the Trust shall notify one of the said days one month beforehand, and of the other day twenty-four hours' notice shall be given: Provided that, as regards this last-mentioned day, if, owing to unforeseen circumstances, a pilot is required to work, then he shall be allowed equivalent time off plus twenty-five per cent.: Provided further, that if a pilot's duties are such that through accident or unforcon any portion of his day or days off duty, he shall be allowed equivalent time off, plus twenty-five per cent.

(h) For the purpose of this clause a day shall be from midnight to midnight or from noon to noon.

(c) Provided, however, that the Harbour Master or other officer appointed by the Trust for that purpose other officer appointed by the Trust for that purpose may book off or exempt a pilot from duty during any of the five working days for any period. During the period so hooked off a pilot shall not be required for service nuless in case of urgent necessity or of emergency: Provided further, that the custom hitherto observed of the one pilot heing assigned to a particular ship during her stay in port and on departure shall no longer be operative.

5.-Residential Area.

Pilots shall reside within a radius of three (3) miles of the Pilot Station: Provided that this requirement shall not apply (so long as they occupy their present residences) to those three pilots who at the date of this Award were living ontside this area with the permission of the Trust.

6.-Telephone.

A telephone shall be installed in the residence of each pilot and the rental and a reasonable amount for calls shall be paid by the Trust.

7.—Annual Leave.

After each year of his service, a pilot shall be entitled to annual leave for a period of thirty consecutive days. This leave shall he taken in accordance with a programme to be prepared in January of each year.

8.-Long Service Leave.

A pilot who has served the Trust for a period of seven years shall be entitled to three months' long service leave.

Leave to which pilots are entitled under the provisions of this clause may be allowed to accumulate for such period and under such conditions as may be approved by the Trust, but not otherwise.

(h) A pilot who in the course of his employment and while on duty or acting under the instructions of the Trust, receives an injury or contracts any sickness which incapacitates him from duty, may be granted his usual remuneration for such period as may be determined by

the Trust, and in addition, reasonable medical, surgical, hospital, or other expenses incurred thereby may be paid by the Trust: Provided that, in the event of the pilot electing to proceed with a claim at common law or under the Employers' Liability Act, any payments made by the Trust under this subclause shall be deducted from the amount of any judgment so given against the Trust.

10.-Engagement and Dismissal.

- (a) The contract of service may be determined by three months' notice on either side: Provided that a pilot may be instantly dismissed or suspended for insobriety, misconduct, or neglect of duty.

4.-Rates of Pay.

Basic wage - 84 10s. 5d. per week.

- (a) Margin over hasie wage £4 11s, 1d, per week.
- (h) In addition to the rate prescribed in clause (a) hereof, the senior signalmen at Cantonment Hill and Rottnest Island Signal Stations shall be paid 7/8 per week extra.

(h) All amounts payable under this clause shall be paid in the manner provided for the payment of wages.

16 .- Uniforms.

The employers shall provide all employees with miforms, free of cost, after each eight months' continuous service, an oilskin cant and son'-wester each year. and to coxswains and signalmen only a great coat every four years. Uniforms shall belong to the employers and shall be worn by employees when on duty. Should the service of any employee terminate within one month from the date of issue of uniforms or any portion of them, all the issue last made to that employee shall be returned to the employers before the employee shall be entitled to be paid any moneys which may be due to him.

17 .- Board of Reference.

Should any dispute arise between an employee and the employers, the service concerned shall be continued without any cessation and the matter referred to a Board of Reference, consisting of two representatives each of the employee and employers and a chairman, to be mutually agreed upon by those representatives; failing their agreement the Registrar of the Court of Arbitration shall act as Chairman.

2.—Definitions.

- "Shift or shifts" means a period of eight (8) conscentive hours worked in reliefs of two or three, as may be required by the Commissioners.
- "Employee" means any person employed under the provisions of this Award.
 - "Wages" includes overtime payment.
- "Employer" means the Fremantle Harbour Trust and includes the Commissioners constituted under the Act and in office for the time being.
- "Harbour Master" means the Harbour Master for Fremantle appointed by the Commissioners.

3.-Hours of Duty.

(a) Fifty-six (56) hours shall constitute a week's work, provided that the hours of duty shall not exceed eight (8) per day, to be worked as under or as mutually agreed upon between the employer and the employees, viz.:—

Night shift—11 p.m.-7 a.m. Day shift—7 a.m.-3 p.m. Afternoon shift—3 p.m.-11 p.m.

(b) Employees shall be allowed to relieve one another, to sait their convenience to eatch trains or trams, so long as the full shift is maintained at all times.

4.-Rates of Pay.

Basic wage-£4 10s. 5d. per week.

- (a) The rate of pay for deckhands shall be £6 18s. per week, which amount shall be computed as follows:—Basic wage, plus three elevenths (3/11ths) plus margin £1 2s. 11d. per week.
- (b) The rate of pay for firemen shall be £7 8s. 0d. per week, which amount shall be computed as follows:—Basic wage, plus three-elevenths (3/11ths) plus margin £1 12s. 11d. per week.
- (e) Where a deckhand is called upon for any reason to perform the work of a fireman for a period of two hours or more in any shift, he shall be paid at fireman's rates for the whole of that shift. Where the period is less than two hours, he shall be paid his ordinary rate for the whole shift.
- (d) All wages due shall be payable at 2.30 o'clock p.m. on Friday in each week.
- (e) Wages may be payable on the written order of the employee to the person named in such order, and the Commissioners by paying to such order shall be relieved of all responsibility, on obtaining the signature of the person named in the said order.

5.—Overtime.

- (a) Overtime shall be paid for at the rate of time and half for the first four hours and double time thereafter.
- (b) Overtime shall mean and include all time worked in excess of eight (8) hours in any one shift, and shall, except as otherwise herein provided, start to count as and from the time the employee ontside of his ordinary working hours is ordered to attend and does report for duty in accordance with such orders until released or his turn-to time is reached, included any time he may be waiting or standing by on the job after the time he was ordered and was not released.
- (c) Where a pilot vessel is ordered to attend any vessel coming into or leaving the harbour, and the shift on duty thereby works longer than the eight hours provided for that shift, the employees affected shall be paid the prescribed overtime rates for all time in excess of the eight hours over the first half hour, until the vessel returns to her berth or the shift is relieved. If the first half hour is exceeded, a whole hour shall be paid up to the first full hour and thereafter the computation shall be hourly. Provided that, in the event of any employee not being relieved on the vessel's return to her berth, owing to the relief employee not being in attendance, the relief in default shall have deducted from his pay the amount of extra payment involved by his absence.

6-Engagement and Dismissal.

- (a) Except for casual employees, all employment shall be by the week, and a week's notice on either side shall be given to terminate such employment, or the employer shall pay one week's wages in lieu of such notice.
- (b) The engagement of employees may be made by the Harbour Master or his deputy at the recognised pick-up place at the Shelter Shed adjacent to the Pilot Office, between the hours of 7.45 a.m. and 9 a.m. on any week day. Should it be necessary to fill any vacancy urgently and ontside of the above hours, the man or men required may be picked up at any place convenient to the Harbour Master or his Deputy: Provided that notification shall be sent forthwith to the secretary of the union as to the man or men so engaged. The Harbour Master or his deputy shall at all times retain the right of free selection among members of the union, provided same are available.

- (c) The employer shall not discriminate, without just cause, against any member of the union who bears good conduct record, and who agrees to continue to work under the terms of this Award, and for whom there is a vacancy, and the employer shall consider any representations made to them by the sceretary of the union.
- (d) In cases where an employee misconducts himself, the employer shall have the right to dismiss him instantly.

7.-Meals,

The Pilot Service shall operate continuously (or as directed by the employers) in eight-hour shifts, without cessation for a recognised meal hour: Provided that durreceive a special payment of 5s.

8.-Change Room.

A change room shall be provided, as heretofore, by the employers to allow of employees changing their elothes or taking their meals when ashore.

9.—Annual Leave.

(a) An employee who serves the employers continuonsly for a period of twelve months shall be allowed leave of absence on full pay, as soon thereafter as convenient to the service, for a continuous period of one calendar month of 30 days.

(b) If he serves continuously for one month or more and not for one year, he shall be entitled to payment, in lieu of leave, at the rate of two and a half days for

each completed mouth of service.

(e) The employers shall give at least twenty-four hours' notice to each employee of their intention to give the employee his leave of absence, and his wages for the leave period shall be paid, together with all other moneys due prior to his going on leave.

10 .- Siekness and Accident when on Duty.

- (a) If in the course of his employment an employee engaged under this Award, whilst on duty or whilst acting under the instructions of the employer, receives an injury or contracts any sickness arising out of or in the course of his employment, he shall be entitled to receive the wages prescribed in this Award from the date of his said incapacity up to and including the date of his recovery, as certified by his medical attendant: Provided that the maximum period of payment under this clause shall not exceed three months of thirty days each.
- (b) The illness or injury which so entitles the employee to the benefits provided for in this clause shall be suffered while on duty and shall be:
 - such as wholly to incapacitate him from performing his duty;
 - so far as ean be ascertained, an illness or injury contracted or sustained whilst on duty in the service of the employer.

Provided that, if the illness or injury is due to his own wilful act or to his misbehaviour, the employee shall not be entitled to the benefits provided in this

clause.

- (c) In the ease of an aecideut suffered while on duty the expenses of providing the necessary medicines, surgical, and medical advice and attendances shall be paid by the employer without any deduction from the wages on that account until the employee is certified as recovered by his medical attendant: Provided that the aggregate amount so paid shall not exceed the amount that would have been paid had such payment been made under the provisions of the Workers' Compensation Act, 1912-1924.
- (d) All wages payable under this claim to the employee while siek or injured shall be paid on Fridays of each week and as provided for in clause 4.

11.—Siek Leave.

(a) An employee who is incapacitated through sickness (a) An employee who is incapacitated through siekness or injury other than that arising out of or in the course of his employment may be granted sick leave, with pay, for a period or periods not exceeding in the aggregate two weeks in any year, upon production within 48 hours of the commencement of any such period of absence, of a medical certificate as to his incapacity.

(b) Where any such incapacity arises through the wilful act or misconduct of the employee, or where a medical certificate is not furnished as required, or where the employee has already had sick leave with pay for a

the employee has already had sick leave with pay for a period of or periods aggregating two weeks during the preceding 12 months, the employee shall not be entitled to any pay for the period he is absent from duty.

(e) Upon the period of absence in any instance exceeding two weeks, or in the ease of paragraph (b) hereof, immediately an employee absents himself, the contract of service shall be deemed to have been terminated without requiring further notice by the employers, who shall thereby be relieved of any further obligation to the employee: Provided that any such period of incapacity may, at the discretion of the employers, be regarded as leave without pay.

12.--Uniforms.

The employers shall provide for the use of each emone oilskin coat and sou'-wester hat each year. One suit of dangarees shall also be supplied to employees on the completion of the following periods of service, viz., Deckhands—each eight months; firemen—each is x months.

Uniforms shall belong to the employers, to be worn on service, and shall be kept clean and tidy. Should the service of any employee terminate within one month of the date of issue of uniforms or any portion of same, all the issue last made shall be returned to the employers before the employee is paid any moneys which may be due to him.

13.—Casual Employees.

- (a) A casual employee is one who is engaged in a temporary capacity, and the contract of service in respect of such employees shall be a daily one. The services of casual employees may be terminated at any time without previous notice.
- (b) The daily rates of pay for easnal employees shall he:
 - 1. For the first fourteen consecutive working days one seventh of the rates prescribed in clause 4 hereof, plus 10%
 - 2. Thereafter—one-seventh of the rates prescribed in clause 4.
- (e) A casual employee shall be entitled to annual leave in accordance with clause 9 hereof, but shall not be entitled to any issue of uniform.

14.—Board of Reference.

Should any dispute arise between the employee and Should any dispute arise between the employee and the employers, the matter shall be referred to a Board of Reference, consisting of a representative of the employers, a representative of the mnion, and a chairman to be mutually agreed upon by those representatives; failing their agreement, the Registrar of the Arbitration Court of Western Australia shall act as chairman. The decision of the Board shall be final and binding.

15.—Term.

This Award shall operate for twelve months as from and including the 28th March, 1942.

WHEREAS an industrial dispute existed between the abovenamed parties: And whereas the said dispute was referred into Court for the purpose of hearing and determination: And whereas the parties subsequently met and

conferred and have arrived at agreement on all matters in difference: And whereas the parties have this day appeared before the Court by their respective representatives and requested the Court to declare the said Agreement an Award: Now, therefore, the Court, pursuant to section 63 of the Act and all other powers therein enabling it, hereby declares the memorandum hereunderwritten to have the same effect as and he deemed an Award of the Court:—

Memorandum of Agreement.

(Note:-Wherever the word "Award" occurs herein it shall be taken to mean and include "Agreement.")

1.--Area.

This Award shall operate over the undermentioned areas as defined under the Metropolitan Milk Act, 1932-1939, number one area, being that described in "The Schedule" of the said Act and number two area, being such area or areas as may be prescribed from time to time by the Minister for Agriculture under the powers vested in him in the said Act.

2.—Scope.

This Award shall apply to all persons permitted under the Metropolitan Milk Act, 1932-1939, to treat milk either of their own production or on behalf of other producers or milk vendors.

(f) In the event of an adult female	worker	being

- (f) In the event of an adult female worker being called upon to do testing and grading or pasteurising, or to take charge of the hottling machine, such female shall be paid the appropriate margin prescribed in subclause (h) of this clause for adult male workers.
- (g) Any worker called upon to start work at any time hetween 4 p.m. and 6 a.m. of the day following shall be paid at the rate of six shillings (6/-) per week extra.
- (h) No junior worker under seventeen (17) years of age shall be permitted to start work between 4 p.m. and 6 a.m. of the day following.

4.—Hours.

- (a) Forty-four (44) hours shall constitute a week's work for all workers, but this provision shall be deemed to have been complied with if an eighty-eight (88) hour fortnight (namely, one week of forty (40) hours and one week of forty-eight (48) hours) is worked. Provided that the eighty-eight (88) hour fortnight referred to herein shall only be applied after written permission to work same has been granted by the union.
- (h) The prescribed weekly working hours may be worked in shifts—day, afternoon or night—at the discretion of the employer.

5.-Overtime.

- (a) All time worked in excess of the hours prescribed in clause (4) shall be deemed to be overtime and paid for at the rate of time and a half.
- (b) All work performed on New Year's Day, Good Friday, Labour Day, Xmas Day, and Boxing Day shall be paid for at the rate of time and a half.
- (c) Except as provided in subclause (a) of this clause work performed on Sunday shall be paid for at ordinary
- (d) When a worker, without heing notified on the previous day, is required to continue working after his usual brock off time for more than one (1) hour, he or she shall be provided with any meal required, or shall he paid one shilling and sixpence (1/6) in lien thereof.

6.-Casual Workers.

Workers employed for less than one (1) week shall be classed as easnal hands and paid ten per cent. (10%) in addition to the rates prescribed in clause (3).

7.-Holidays.

- (a) All workers, except casual workers, shall be entitled to and shall take two (2) weeks annual leave, on full pay, at the expiration of each twelve (12) months' service: Provided that, if the contract of service is terminated during the year, the worker shall be entitled to and shall be paid holiday pay in the proportion that his or her length of service bears to the full year's employment. Annual leave shall be given and taken within three (3) months of becoming due.
- (h) Where a worker is dismissed for misconduct, or where the worker illegally severs his or her contract of service, he or she shall lose all rights under this clause.
- (c) Haliday pay shall not accrue during a worker's absence from his or her employment for any cause whatsoever.

8.—Higher Duties.

A worker employed for more than one half day or shift on duties carrying a higher rate than his or her classification shall be paid the higher rate for such day or shift. If employed for less than half of one day or shift he or she shall be paid the higher rate for the time so worked.

9.-Absence Through Sickness.

A worker other than a casual worker shall be entitled to payment for non-attendance, on the ground of personal ill-health, for one half (½) day for each completed month of service; provided that payment for alsence through such ill-health shall be limited to six (6) days (one (1) week's pay) in each calendar year.

days (one (1) week's pay) in each calendar year.

Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act. A worker shall not be entitled to receive any wages from his employer for any time lost through the result of an accident not arising out of or in the course of his employment, or for any accident, wherever sustained, arising out of his own wilful default.

No worker shall be entitled to the hencits of this

No worker shall be entitled to the henefits of this clause unless he produces proof satisfactory to his employer of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

10 .- Time and Wages Record.

- (a) The employer shall keep, or cause to be kept at his office, a record, in which shall be entered—
 - (i) The name of each worker to whom this Award applies.
 - (ii) The nature of the work performed.
 - (iii) The hours worked each day.
 - (iv) The amount of wages and overtime (if any) received by the worker each week.
 - (v) The ages of the junior workers.
- (b) the said record shall be signed by the worker, if correct.
- (c) The employer and the worker shall be severally responsible for the proper posting of the said record; which shall be open to the inspection of an accredited representative of the union during ordinary working hours, and he shall be allowed to take necessary extracts therefrom.

11.—Representative Interviewing Workers.

In the case of a disagreement existing or anticipated concerning any of the provisions of this Award, an accredited representative of the union shall be permitted to interview the workers, during the recognised meal hour, on the business premises of the employer, but this permission, without the consent of the employer, shall not be exercised more than once in any one week.

12.-No Reduction.

Nothing herein contained shall entitle the employer to reduce the wage of any worker who at the date of this Award was being paid a higher rate of wage than the minimum prescribed in this Award for his class of work.

13 .- Uniforms and Overalls.

If a worker is required to wear a uniform or overall the employer shall provide same free for use by the worker. Such uniform or overall shall remain the property of the employer and shall be returned, when required, in good order and condition, fair wear and tear excepted.

14.-Board of Reference.

The Court appoints, for the purpose of this Award, a Board or Boards of Reference. Each Board shall consist of a chairman and two (2) other representatives, one to be nominated by each of the parties. There are assigned to each such Board, in the event of no agreement being arrived at between the parties to the Award, the functions of:—

- (i) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of this Award or any of them;
- (ii) classifying and fixing wages, rates, and conditions for any occupation or calling not specifically mentioned in the Award;
- (iii) deciding any other matter that the Court may refer to such Board from time to time.

An appeal shall lie from any decision of such Board, in the manner and subject to the conditions prescribed in the Industrial Arbitration Act, 1912-1935, which, for the purpose are embodied in this Award.

15.—Term.

This Award shall come into operation from its date and shall remain in force for one year.

16 .- Aged and Infirm Workers.

- (a) Any worker who by reason of old age or infirmity is unable to earn the minimum wage may be paid such lesser wage as may from time to time be agreed upon between the union and the employer.
- (b) In the event of no agreement being arrived at the matter may be referred to the Board of Reference for determination.
- (c) After application has been made to the Board, and pending the Board's decision, the worker shall be entitled to work for or be employed at the proposed lesser rate.

17.-Breakdowns, Etc.

The employer shall be entitled to deduct payment for any day or portion of a day upon which the worker cannot be usefully employed because of any strike by the union or unions affiliated with it, or by any other association or union, or through the hreakdown of the employer's machinery, or any stoppage of work by any cause which the employer cannot reasonably prevent.

18 .- Junior Workers' Certificate.

Junior workers shall furnish the employer with a certificate, containing the following particulars:-

- 1. Name in full.
- 2. Age and date of birth.
- 3. Name of each previous employer.
- 4. Periods of employment with each previous employer.

This certificate shall be signed by the worker. No worker shall have any claim upon the employer for additional wages, in the event of his or her age or period of service with a previous employer being wrongly stated in the certificate.
