88a.-The Trespass Scale.

Trespass on unenclosed country land :-

- For every entire horse, ass, or bull, in the daytime-a sum of two pounds.
- For every such horse, ass, or bull, in the nighttime-a sum of three pounds.
- For every other head of "Great cattle," by night or day-a sum of threepence.
- For every head of "small cattle," by night or day-a sum of one penny.

Trespass on enclosed land, whether town, country, or suburban, not being a public street or thoroughfare in a city, town, or public cemetery:----

- For every entire horse, ass, or bull, in the daytime-a sum of two pounds.
- For every such horse, ass, or bull, in the night-time—a sum of three pounds.
- For every other head of cattle, by night or daya sum of ten shillings.

- For every entire horse, ass, or bull-a sum of three pounds. For every other head of cattle—a sum of twenty
- shillings.

Mileage-one shilling per mile; sustenance-three shillings per day.
