ORDER UNDER REGULATION 4 OF THE NATIONAL SECURITY (GENERAL) REGULATIONS.

Order made under Regulation 5 of the National Security (General) Regulations 7th December, 1942, is hereby cancelled and the Order following is substituted:-WHEREAS by regulation 4 of the National Security (General) Regulations it is provided (amongst other things) that if it appears to the Minister to be necessary or expedient in the interests of the Defence of the Commonwealth or the efficient prosecution of the war, or for maintaining supplies and services essential to the life of the community, that special precautions should be taken for the security of any place, he may by order declare that place to be a prohibited place either generally or during such hours or during the existence of such circumstances as are specified in the Order for the purposes of the regulations: And whereas by Instrument of Delegation dated the seventh day of May, 1942, made in pursuance of section 17 of the National Security Act, 1939-1940, John Curtin, the Minister of State for Defence, delegated to every officer who should at any time during the continuance of the delegation be holding the office or performing the duties of the office of Commander of a Lines of Communication Area the powers and functions conferred upon the said Minister by regulation 4 of the National Security (General) Regulations in relation to that Lines of Communication Area. And whereas by regulation 4 (6) (b) of the National Security (General) Regulations it is provided that the Minister may, if he thinks fit, in any Order made under subregulation (1) of this regulation, or by separate order, authorise any officer or person to issue permits to enter, approach, inspect, pass over or be in or in the neighbourhood of a prohibited place: And whereas by regulation 4 (6) (c) of the National Security (General) Regulations it is provided that the Minister may, if he thinks fit, in any order made under subregulation (1) of this regulation, or by separate order, specify an officer or person to exercise and perform the powers and functions of the officer or person in charge of any prohibited place for the purposes of these regulations: And whereas it appears to me, Oswald Vick Hoad, Brigadier Commanding Western Australia Lines of Communication Area, necessary and expedient in the interest of the Defence of the Commonwealth and the efficient prosecution of the war that special precautions should be taken for the security of the place referred to in the Schedule hereto, being a place situate within the said Western Australia Lines of Communication Area: Now, therefore I, the said Oswald Vick Hoad, acting in pursuance of the said recrulation and Justicular and Justician a regulation and Instrument of Delegation, do hereby order as follows:

> (1) that the places described in the Schedule hereto are declared to be prohibited places generally for the purpose of the National Security (General) Regulations from the date of the making of this Order;

- (2) that WX29331 T/Major Colin Ednie Brown, G.S.I. W. Aust. L of C Area, is authorised to issue permits to enter, approach, inspect, pass over, or be in or in the neighbourhood of the said prohibited places;
- (3) that W237570 T/Captain Joseph George Frederick Senior, M.C., W. Aust. L. of C. Area Section, Intelligence Corps, is specified as the officer to exercise and perform the powers and functions of the officer in charge of the said prohibited places for the purpose of these regulations.

The Schedule.

- (a) All that area of land situate near the Western Australian coast off Fremantle, in the State of Western Australia, and known as Carnac Island, and all that area of sea surounding the said Carnac Island at a distance of one mile from every part of the coastline thereof.
- (b) All that area of land situate near the Western Australian coast off Fremantle, in the State of Western Australia, and known as Garden Island, and all that area of sea surrounding the said Garden Island at a distance of one mile from every part of the coastline thereof.
- (c) All that area of land situate near the Western Australian coast off Fremantle, in the State of Western Australia, known as Penguin Island, and all that area of sea surrounding the said Penguin Island at a distance of one mile from every part of the coastline thereof.
- (d) All that area of land situated to the west of Rockingham, in the State of Western Australia, and contained within the following boundaries:—Commencing at a point on the coastline, as defined at low water-mark, in Mangles Bay, at a distance of 10 chains east of the Peron House Jetty and proceeding thence in a general south-westerly direction on a bearing of 214deg. Omin. to cut the coastline, as defined at low water-mark in Shoalwater Bay; thence north-westerly along the coastline, as defined at low water-mark, to Cape Peron and John Point; thence southeasterly along the coastline, as defined at low water to the point of commencement, and all that area of sea adjacent to the said area of land to a distance of one mile from every part of the coastline thereof.

(3) that Temporary Captain Joseph George Frederick Senior, M.C. (WX237570), W. Aust. L. of C. Area Section, Intelligence Corps, is specified as the officer to exercise and perform the powers and functions of the officer in charge of the said prohibited places for the purpose of these regulations.

ORDER UNDER REGULATION 55 OF THE NATIONAL SECURITY (GENERAL) REGULATIONS.

WHEREAS by regulation 55 of the National Security (General) Regulations it is provided that a Minister may by Order authorise subject to any restrictions and conditions imposed by the Order, the use of land specified therein for Naval, Military, and/or Air Force purposes during the period specified in the Order; and that any such Order may further provide as set out in paragraphs (a) and (b) of the said regulations: And whereas by Instrument of Delegation dated the 18th day of September, 1942, made in pursuance of section 17 of the National Security Act, 1939-1940, Francis Michael Forde (the Minister of State for the Army) delegated to every officer who should at any time during the continuance of the delegation be holding the office or performing the duties of the office of Commander of a Lines of Communication Area the powers and functions conferred upon the said Minister by regulation 55 of the National Security (General) Regulations in relation to that Lines of Communication Area: And whereas it appears to me, Oswald Vick Hoad, Brigadier Commanding Western Australia Lines of Communication Area, necessary and expedient to authorise for purposes of training Naval, Military, and/or Air Force personnel and purposes incidental thereto, the use of the land referred to in the Schedule and more particularly described therein, being land situate within the said Western Australia Lines of Communication Area: Now, therefore I, the said Oswald Vick Hoad, acting in pursuance of the said regulation and Instrument of Delegation, hereby authorise the use of the land referred to in the Schedule hereto and more particularly described therein, for purposes of training Naval, Military, and/or Air Force personnel and purposes incidental thereto from the date of the making of this Order for the duration of the present war, and I do hereby order further as follows:

- (1) that the Naval, Military and/or Air Forces of the Commonwealth and of the Allied Forces at war with the Axis powers shall be entitled to use the said land and do such acts in relation to the said land as are necessary and expedient for the purpose of training the said Naval, Military, and/or Air Forces;
- (2) that the aforesaid Naval, Military, and/or Air Forces shall have power to prohibit or restrict the exercise of rights-of-way over the said land and any rights relating thereto which are enjoyed by any other person whether by virtue of an interest in the land or otherwise.

The Schedule.

All that area of land contained within the following boundaries:—Commencing on the west coast of Western Australia at Fremantle and proceeding easterly along the Eastern Goldfields railway line to Meekering; thence southerly to Greenhills townsite on the York-Bruce Rock Railway; thence south-westerly to Holyoake townsite on the Pinjarra-Narrogin Railway; thence southerly to Busselton on the west coast; thence northerly along the coast to the point of commencement at Fremantle.
