WHEREAS it is provided by section 244 of the Road Districts Act, 1919-1942, that rates through the district shall be nuiform, except insofar as a board may fix the rates for any townsite or for any special area defined for that purpose by Proclamation, at a higher figure within the limits set forth in the said section; and whereas by a Proclamation issued under the said section and published in the Government Gazette on the 1st day of Augnst, 1941, in relation to the Mosman Park Road District the Governor defined a special area comprised within the said Mosman Park Road District as set forth in the schedule to the said Proclamation so that the rateable lands situate therein might be assessed to rates at a figure higher than that fixed in relation to lands situate in the said road district out-side the special area aforesaid; and whereas it is now deemed desirable and expedient that as from the 30th day of June, 1943, rates shall be uniform throughout the said Mosman Park Road District: Now, therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act, and of all other powers in this behalf enabling me, do hereby cancel and revoke the Proclamation published in the Government Gazette on the 1st day of August, 1941, as afore-said as from the 30th day of June, 1943, to the intent that after the said last mentioned date, rates shall be nuiform throughout the said Mosman Park Road District.

WESTERN AUSTRALIA, } By His Excellency Sir James Mitchell, TO WIT. } K.C.M.G., Lieutenant-Governor in and JAMES MITCHELL, over the State of Western Australia Lieutenant-Governor. and its Dependencies in the Common-[L.S.] wealth of Australia.

WHEREAS it is enacted by section 4 of the Vermin Act, 1918-1942, that "Vermin" means and includes inter Act, 1918-1942, that vermin means and includes over alia any animals, birds, or insects the names of which the Governor may by Proclamation add to the Third Schedule to the said Act and that any Proclamation whereby the names of animals, birds, or insects are added to the said Third Schedule may be restricted in its operation to any portion of the State to be defined by the Proclamation; and whereas it is deemed desir-able and expedient to add the name of the animal or bird commonly known as the Emu so that such animal or bird shall be "Vermin" for the purposes of the said Act in the portion of the State hereinafter specified: Now, therefore I, the said Lientenant-Governor acting with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act, do by this Proclamation add to the Third Schedule of the Vermin Act, 1918-1942, the name of the animal or bird commonly known as the Emu so that such animal or bird shall be "Vermin" for the purposes of the said Act, but I do hereby declare and direct that this Proclamation shall be restricted in its operation to that portion of the State comprised in the Merredin Vermin District as constituted now and from time to time hereafter under the said Act.

Native Administration Act, 1905-1941. ORDER IN COUNCIL.

WHEREAS it is enacted by section 63, subsection (4) of the Native Administration Act, 1905-1941, that where it appears that any native has in pursuance of any It appears that any native has in pursuance of any tribal custom committed an offence against another native, then the Court may in the case of a charge which under the Criminal Code may involve punishment of death or imprisonment without the option of a fine for any period in excess of ten years, sentence the offender to any term of imprisonment of not more than ten years with hard labour or order that the offender be banished from his country and kept during the Governor's pleasure in prison or in some place reserved by the Governor for native prisoners under sentence of banishment; and whereas two natives, to wit, Gunyanya alias Bobby, and Canowie alias Tommy, having been found guilty of the wilful murder of another native, to wit, Lemargie alias Dicky, were in accordance with the said section ordered to be banished from the country and to be kept ordered to be ballshed from the country and to be kept during the Governor's pleasure in prison or in some place reserved by the Governor for native prisoners under sentence of banishment; and by an Order in Council dated the 14th day of August, 1940, were ordered to be kept in the prison at Broome until the Governor by a further Order in Council shall otherwise direct; and whereas it is now deemed desirable that the said two natives shall be released: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council, and the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act and of all other powers in this behalf enabling him, doth hereby order and direct that the said two natives, namely, Gunyanya *alias* Bobby, and Canowie *alias* Tommy, now being detained in the prison at Broome under and in accordance with the Order in Conneil barging for martianad shall for the with a publica hereinbefore mentioned, shall forthwith on the publication of this Order in Council in the Government Gazette be released and discharged from the said prison at Broome.

The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 252/43. WHEREAS by the Metropolitan Water Supply, Sewerage, and Drainage Act, 1909, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend Water Works, Sewerage Works and Stormwater Drainage Works; and whereas the preliminary requirements of the said Act have been complied with, and plaus, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Lieutenant-Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage, and Drainage, to undertake the construction of the following works under the said Act, namely:—

Metropolitan Water Supply Improvement—City of Perth.—Proposed construction of 8-inch and 6-inch diameter water mains (length about 36 chains and 15½ chains), respectively, and the lifting of 8-inch and 6-inch diameter water mains (length about 14 chains and 15½ chains), respectively, as shown in red on Plan M.W.S.S. & D.D., W.A. No. 6714.

This Order in Council shall take effect from the 9th day of September, 1943.

Local Authorities (Reserve Funds) Act, 1942. ORDER IN COUNCIL.

P.W. 404/43.

WHEREAS it is enacted by section 4 of the Local Anthorities (Reserve Funds) Act, 1942, that the Governor may, on the recommendation of the Minister but subject to the requirements of the proviso to the said section, by Order in Council, authorise a local authority to establish during the present war and to maintain a reserve fund for the purpose of accumulating therein any surplus of ordinary revenue of the local authority and of applying the moneys in such reserve fund and any income or profit derived from the investment of moneys in such reserve fund in the carrying out, after the cessation of the present war, of works and undertakings authorised by the Local Government Act of the local authority which the local authority may not be able conveniently to earry out during the present war: And whereas it is desirable that such a reserve fund shall be established by the local authorities as set forth in the schedule hereto: Now, therefore, His Excellency the Lieutenant-Governor, acting pursuant to the recommendation of the Minister by and with the advice and consent of the Executive Connecil and in exercise of the power conferred by the said Act, after being satisfied as required by the proviso to section 4 of the said Act, doth hereby authorise the local authorities as set forth in the schedule hereto, to establish and maintain a reserve fund.

NATIONAL SECURITY (GENERAL) REGULATIONS.

The State of Western Australia—Safety Precantions (Bombs) Order No. 2.

WHEREAS by regulation 35A of the Commonwealth National Security (General) Regulations it is provided *inter alia* that the Premier of any State may after consultation with the Minister of State for Home Security or an officer of the Department of Home Security authorised by that Minister to act on his behalf and with the Commandant of a military district or an officer authorised by the Minister of State for Defence or the Minister of State for the Army to act on behalf of such Commandant, by order make such provision as he deems necessary to protect the persons and property of the civil population in that State or any part thereof in case of emergency; and whereas I, John Collings Willcock, Premier of the State of Western Australia acting under the authority of the said regulation 35A made and issued an order dated the 19th day of March, 1942, which was published in the *Government Gazette* of Western Australia on the 20th day of March, 1942, was therein cited as the Safety Precautions (Bombs) Order and is still in force; and whereas it is now deemed desirable and expedient to revoke the said order and in lieu thereof make and issue this present order: Now, therefore I, the said John Collings Willcock, as such Premier aforesaid, acting under the authority of the said regulation 35A, and after due consultation as therein required do hereby order as follows:—

1. This order may be cited as the Safety Precautions (Bombs) Order No. 2.

2. The hereinbefore mentioned Safety Precautions (Bombs) Order, dated the 19th day of March, 1942, and published in the *Government Gazette* on the 20th day of March, 1942, is hereby revoked.

3: This order shall apply and have effect throughout the State of Western Anstralia.

4. (1) In this order, unless the contrary intention appears-

- "Buried bomb" means any unexploded high explosive bomb which has penetrated below the surface of the ground and of which no part thereof can be seen from the surface.
- thereof can be seen from the surface. "Officer of Police" means any member of the Police Force, not below the rank of sergeant, or authorised, in writing by a member of the Force not below that rank, to act under this order.
- "Unburied bomb" means any unexploded high explosive bomb of less than 1,800 kilogrammes in weight which is either on the surface of the ground or of which some part thereof can be seen from the surface. "Warden" means a person appointed as such under
- 'Warden'' means a person appointed as such under the Civil Defence (Emergency Powers) Act, 1940.
- "Parachute mine" includes an unexploded high explosive bomb which is not a buried bomb and which is of the weight of 1,800 kilogrammes or more.

(2) Where any distance is specified in this order, that distance may be increased or extended by any officer of Police, and any distance so varied shall be deemed to be the distance specified in this order in lieu of that distance.

- 5. Nothing in this order (other than subparagraph (3) of paragraph 8) shall apply to-
 - (a) any member of any of the Armed Forces of His Majesty or of any power which is allied or associated with His Majesty in any war in which His Majesty is engaged, while such member is acting in the ordinary course of his duty; or
 - (b) any land, building or vehicle occupied by or under the control of or being used by any of those Armed Forces.

An officer of Police or a warden may give such directions and take such action as he considers necessary, and may enter any premises or place (by force if necessary), for securing or enforcing compliance with the provisions of this order.

(1) The fall of any unexploded bomb, includ-7. ing an unignited incendiary bomb, unexploded shell and unexploded parachute mine, shall be immediately reported by a warden or a member of the Police Force having knowledge thereof to the air raid precautions control centre in the area within which the fall occurred.

(2) The fall of any unexploded bomb, including an unignited incendiary bomb, unexploded shell or unex-ploded parachute mine, shall be immediately reported by any member of the public having knowledge thereof to a warden or a member of the Police Force.

8. An officer of Police or a warden having reason-able ground for believing that an unexploded bomb or parachute mine has fallen, may thereupon take the following action-

- (1) In the case of a buried bomb-
 - (a) direct all or any persons to depart immedi-ately from, or not to enter, any building, street, or open space within fifty yards from the bomb;
 - (b) endeavour to ensure that within one hundred yards from the bomb all windows of buildings on the same side of a building as the bomb are opened wide;
 (c) endeavour to ensure that there is no vehicular or pedestrian traffic within fifty yards of
 - the bomb;
 - (d) endeavour to ensure that a person shall not be in any street or open space between fifty and one hundred yards from the bomb un-less the officer of Police or warden considers that it is reasonably necessary for the person to be there to enable him to visit premises within that area not required to be evacuated under this order, or for such other reason as the officer of Police or warden may consider adequate;
 - (e) endeavour to ensure that, in unevacuated buildings within one hundred yards from the bomb, all rooms on the same side of any such building as the bomb are evacuated.
- (2) In the case of an unburied bomb-
- (a) endeavour to ensure that all buildings within-

 - (i) fifty yards from the bomb, if such bomb is 250 kilogrammes or less; or
 (ii) one hundred yards from the bomb, if such bomb is 250 kilogrammes or less or less is a such bomb is suc such bomb is more than 250 kilogrammes,
 - are cleared of people;
- (b) endeavour to ensure that all rooms, the windows or doors of which are not screened from the bomb by an intervening building or part of a building, and which are within
 - (i) one hundred and fifty yards from the bomb, if such bomb is 250 kilogrammes or less; or
 - (ii) three hundred yards from the bomb if such bomb is more than 250 kilogrammes,

are cleared of people, and the windows of such rooms are opened wide;

(c) endeavour to ensure that there is no vehicular or pedestrian traffic within a distance of three hundred yards from the bomb unless such vehicular or pedestrian traffic is screened from the bomb by an intervening building or brick wall when the distance

may in the discretion of the officer of Police or warden be reduced to-

- (i) fifty yards from the bomb if such bomb is 250 kilogrammes or less; and
- (ii) one hundred yards from the bomb if such bomb is more than 250 kilo-

grammes, Provided that if the officer of Police or warden considers it reasonably necessary for a person to obtain access to a building any rooms of which have been evacuated he may permit such person to enter or leave such building through a door of the build-ing which is screened from the bomb by the building or some other building.

- (d) endeavour to ensure that a person shall not be in any street or open space within two hundred yards from the bomb,
- (3) In the case of an unexploded parachute mine-
 - (a) direct all persons to vacate all or any part of any building which building or part is within two hundred yards of the mine;
 - (b) direct any persons to vacate any room between two hundred and four hundred yards from the mine a window or door of which room is not screened from the mine by an intervening building or part of a building;
 - (c) endeavour to ensure that no loud noise or vibration is made or caused within four hundred yards from the mine;
 - (d) endeavour to ensure that, within eight hun-dred yards from the mine, all windows of any building or any part of a building are opened wide;
 - (e) endeavour to ensure that no vehicle is moved and that there is no pedestrian traffic within a distance of four hundred yards from the mine: Provided that, if the officer of police or
 - warden considers that it is reasonably necessary for a person to obtain access to a building which has been wholly or partially evacuated he may permit such person to enter and leave the building by a door on a side of the building screened from the mine;
 - (f) endeavour to ensure that a person shall not be in any street, or open space within four hundred yards from the mine.

(1) A person shall comply with every direction 9 given to him by an officer of police or warden in pur-snance of this Order, and any such direction shall remain in force-

- (a) in the case of a buried bomb, until the bomb has been removed or rendered safe or, except in the case of any wheeled vehicle (exclud-ing a bicycle) within a radius of fifty yards from the bomb, for a period of one hundred and thirty hours from the time the bomb fell, whichever is the lesser period;
- (b) in the case of an unburied bomb, until the bomb has been rendered safe; and
- (c) in the case of a parachute mine, until the mine has been removed:

Provided that, where there is a railway line within fifty yards of any bomb, any direction given shall continue in force until the bomb has been removed or rendered safe.

(2) Nothing contained in this Order shall prohibit any member or employee of an essential service, public utility undertaking, fire brigade or any member of an organisation which has been declared to be an approved civil defence organisation for the purposes of the National Security (Civil Defence Workers' Compensa-tion) Regulations, from entering or remaining in or upon any area or place required to be evacuated under this Order in the course of his duty as such member or employee, unless in the case of an unexploded parachute mine, he is given a direction to the contrary by the Naval Officer in Charge of the Rendering Mine Safe Party.

10. (1) The Naval Officer in Charge of the Render-ing Mine Safe Party shall endeavour to consult with the officer in charge of the nearest police station to a

parachute mine which has fallen and is unexploded before he permits any effort to be made to render the mine safe.

(2) Where a parachute mine has fallen and is unexploded and has not been removed or rendered safe-

- (a) fire pumps shall not be operated within two hundred yards of the mine whilst a Rendering Mine Safe Party is working on the mine;
- (b) a stake or post shall not be driven into the ground within four hundred yards of the mine; and
- (c) if the mine is in water, the level of the water shall not be lowered without the permission of the Naval Officer in Charge of a Rendering Mine Safe Party.

11. The powers and authorities conferred upon an officer of Police or Warden by this Order shall apply during any period within which efforts are being made to remove or render harmless the bomb, irrespective of the length of time that has elapsed since the bomb originally fell.

12.This Order shall operate and have effect as from the date of the publication thereof in the Government Gazette of Western Australia.

FARMERS' DEBTS ADJUSTMENT ACT, 1930-1934. NOTICE is hereby given that the following Stay Order has been issued in accordance with section 7, subsec-tion (1) of the Farmers' Debts Adjustment Act, 1930-1934, which reads as follows:-

A Stay Order shall direct that no action, execution, distress for rent, proceedings on default for

breach of covenant under any mortgage or other security for money, or under an agreement for sale and purchase of lands, or other process or proceeding, shall be commenced or proceeded with, or put in force against the farmer or any of the farmer's assets, whether utilised in connection with or form-ing portion of the assets comprised in his farming business or not, during the operation of such Stay Order: Provided that, by leave of a Judge, any action may, notwithstanding the Stay Order, be instituted and/or carried on against the farmer but not beyond judgment.

INDUSTRIAL AGREEMENT No. 11 of 1943. (Filed 1/4/43.)

THIS Agreement made in pursuance of the Industrial Arbitration Act, 1912-1941, this eighth day of February, one thousand nine hundred and forty-three, between The Western Ice Company (1919), Limited; Fremantle Cold Storage Company, Limited; Mount Lawley Ice and Cold Storage, Limited; Victoria Park Ice and Cold Storage Works; Cartwright Dairy and Ice Company; Brownes, Limited; Bantocks, Limited; The Westralian Farmers, Limited (hereinafter called "the Employers"), of the one part and the Australian Workers' Union, Westralian Branch, Industrial Union of Workers (hereinafter called "the Union") of the second part, witnesseth that for the considerations hereinafter appearing, the parties hereto mutually covenant and agree the one with the other as follows:—

(2) Area.

This Agreement shall be limited in its operation to the area comprised within a radius of twenty (20) miles from the General Post Office at Perth in the State of Western Australia.

(3) Scope.

This Agreement shall apply to all workers employed in the manufacture and/or handling of ice from tanks into store in the Employers' Works: Provided that it shall not apply to workers who are at present provided for in any Award of the Court of Arbitration of Western Australia or in any Industrial Agreement registered in accordance with the Industrial Arbitration Act, 1912-1941.

(4) Term.

The term of this Agreement shall be twelve months from its date.

(5) No Reduction.

Nothing herein shall in itself operate to reduce the wage of any worker below the rate actually received by him at the date hereof.

(6) Hours.

Forty four (44) hours shall constitute a week's work. For the sake of convenience in the rostering of shifts an eighty-eight (88) hour fortnight may be worked if the employer so desires.

(7) Overtime.

(a) All time worked in excess of eight (8) hours in any one day shall be deemed overtime and shall be paid for at the rate of time and a half.

(b) All time worked on Sunday shall be paid for at the rate of time and a half.

(c) Work done on New Year's Day, Labour Day, Xmas Day or Boxing Day shall be paid for at the rate of double time.

(8) Holidays.

(a) Each worker, other than a casual worker, shall be entitled to twelve (12) days annual leave each year on full pay, or should the period of continuous employment be less than one year, the worker shall be paid holiday pay in proportion as his length of service is to the full year's employment. Annual leave shall be taken at a time suitable to the convenience of the employer.

(b) Holidays without deduction of pay shall be limited to twelve days per annum as aforesaid.

to twelve days per annum as aforesaid. (c) The following shall be the days upon which, if the employer's establishment be closed, payment may be deducted, namely:---New Year's Day, Good Friday, Easter Saturday, Easter Monday, Auzac Day, Labour Day, Foundation Day, King's Birthday, Xinas Day, and Boxing Day.

(d) If Xmas Day falls on a Sunday, the following Monday shall be kept.

(e) If the employer's establishment remains open on any of the abovenamed ten days, ordinary rates shall apply except in the case of New Year's Day, Labour Day, Xmas Day and Boxing Day.

(f) A worker who is dismissed for misconduct shall not be entitled to the benefits of the holiday clause.

(9) Rotation of Shifts.

(a) Where a worker works afternoon shift only or afternoon and night shifts in rotation, but does not work day shift one week out of three, he shall receive one shilling (1/-) per shift in addition to the rates prescribed in clause (1).

(b) Where a worker is called upon to work night shift continuously, such worker shall be paid five per cent. (5%) in addition to his ordinary rate, plus one shilling $(1/\cdot)$ per shift.

(10) Casual Workers.

A casual worker shall mean and include a worker competent to do the work he is engaged to do and who is, without any fault of his own, dismissed or refused work (as it is hereby agreed he may be) before the expiration of six (6) days from and including the date he starts work.

Casual workers shall be paid ten per cent (10%) in addition to the rates prescribed in clause (1).

(11) Weekly Engagement.

Except as provided in clause (10), all employment shall be by the week.

(12) Time and Wages Book or Record.

A time and wages book or other record shall be kept by each employer, in which book or record shall be entered:---

- (a) The name of each worker.
- (b) The nature of the work performed.
- (c) The hours worked each day.
- (d) The wages and overtime (if any) paid each week.

Such book or record shall be open to the inspection of an accredited representative of the union at any time during working hours and he shall be allowed to take necessary extracts therefrom.

(13) Board of Reference.

The Court may appoint, for the purpose of this Agreement, a Board or Boards of Reference. Each Board shall consist of a chairman and two (2) other representatives, one to be nominated by each of the parties, as prescribed by the regulations. There are assigned to each such Board, in the event of no agreement being arrived at between the parties to the Agreement, the functions of:—

- (i) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of the Agreement or any of them;
- (ii) classifying and fixing wages, rates, and conditions for any occupation or calling not specifically mentioned in the Agreement;
- (iii) deciding any other matter that the Court may refer to such Board from time to time.

An appeal shall lie from any decision of such Board, in the manner and subject to the conditions prescribed in the regulations to the Industrial Arbitration Act, 1912-1941, which for this purpose are embodied in this Agreement.

(14) Payment for Sickness.

(a) A worker shall be entitled to payment for nonattendance on the ground of personal ill-health for one-half (½) day for each completed month of service: Provided that payment for absence through such illhealth shall be limited to six (6) days in each calendar year. Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

A worker shall not be entitled to receive any wages from his employer for any time lost through the result of an accident not arising out of or in the course of his employment or for any accident, wherever sustained, arising out of his own wilful default or for sickness arising out of his own wilful default. No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer of sickness, but the employer shall not be en-titled to a medical certificate unless the absence is for three (3) days or more.

(b) Any time in respect of which a worker is absent from work except time for which he is entitled to claim sick pay under the preceding provision shall not count for the purpose of determining his right to holidays.

(15) Breakdowns, Etc.

The employer shall be entitled to deduct payment for any day or portion of a day upon which the worker cannot be usefully employed because of any strike by the union or unions affiliated with it, or by any other association or union or through the breakdown of the employer's machinery or any stoppage of work by any cause which the employer cannot reasonably prevent.
